### NOTICE OF SECOND MODIFICATION TO TEXT OF PROPOSED AMENDED REGULATIONS AND FORMS JUS-TOB1 (Rev. 11/2021), JUS-TOB3 (Rev. 11/2021), JUS-TOB4 (Rev. 11/2021), JUS-TOB5 (Rev. 11/2021), JUS-TOB8 (Rev. 11/2021), and JUS-TOB15 (would be repealed) and ADDITION OF SUPPLEMENT TO THE INITIAL STATEMENT OF REASONS.

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the California Department of Justice (the “Department”) is providing notice of additional changes made to the Text of Proposed Amended Regulations, and Tobacco Directory Forms incorporated by reference in proposed regulations concerning the California Tobacco Directory, Title 11, Division 1, Chapter 16 of the California Code of Regulations. These regulations were originally the subject of a Notice of Proposed Rulemaking Action published in the California Regulatory Notice Register (Register 2020, No. 2020-1207-02) on December 18, 2020. In response to public comments, on May 5, 2021, the Department posted on its website a Notice of Modifications to Proposed Forms. The changes proposed in this Notice are in response to comments from the Office of Administrative Law.

Additionally, pursuant to the requirements of Government Code section 11346.8, subdivision (d), 11346.9, subdivision (a)(1), and 11347.1, the Department is providing notice that an additional document has been added to the rulemaking file and is available for public inspection and comment. The document added to the rulemaking file is the Supplement to the Initial Statement of Reasons.
