

BEAT THE DEALER PROMOTION

The Beat the Dealer promotion is a drawing where a player may win a fixed and pre-determined prize amount ranging from \$10 to \$100,000 in cash, casino chips or merchandise. A player may qualify for entry to the drawing by receiving a ticket for being dealt a designated hand in a live or no purchase necessary game during the promotion period. The drawing times, rules of promotion and prizes will be pre-determined and posted in advance and throughout the promotional period. The eligible games will be any Bureau approved games at Hawaiian Gardens Casino.

Qualifying Hands:

POKER GAMES (all poker style games)

- **Any Full House beaten by Any Four of a Kind.**
 - Both of the players will receive a ticket and they must use both hole cards.
 - If the player folds prior to the final betting round the player needs to ask the dealer to hold his/her cards to the side until after the winner of the pot is determined in order to receive a ticket

- **Four of a Kind beaten by a better Four of a Kind. Both hole cards must be used.**
 - Both of the players will receive a ticket and they must use both hole cards.
 - If the player folds prior to the final betting round the player needs to ask the dealer to hold his/her cards to the side until after the winner of the pot is determined in order to receive a ticket.

CALIFORNIA GAMES

Pai Gow Poker and Joker's Wild Pai Gow Poker and Fortune Pai Gow Poker

- **Ace-Jack or better front, complete hand behind (no Joker).**
 - A complete hand is any straight or better.
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - When determining if the players hand qualifies, all seven cards are considered regardless of how that player sets their two-card and five-card hand during the play of the game.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.

Pan 9, Super Pan-9 and Bonus Pan 9

- **Three Aces, Twos, Threes, Fours, Fives or Sixes on the first three cards.**
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.
 - The player hand and banker hand may qualify for a ticket.

Pai Gow Tiles

- **Dealt pair-pair or Gong-Gong or better.**
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - When determining if the player's hand qualifies, all four tiles are considered regardless of how that player sets their two-tile hands during the play of the game.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.

Blackjack Poker

- **Two Aces, Kings or Queens on the first two cards.**
 - The cards may be suited or unsuited.
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - When determining if the player's hand qualifies, only the initial two cards are considered, regardless of whether that player requests an additional card(s), surrenders their hand, splits cards, etc.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.

13-Card (Chinese Poker)

- **10 High straight flush or better in back hand.**
 - The hand qualifies regardless of whether the hand wins, losses or pushes.
 - When determining if the player's hand qualifies, not all thirteen cards are considered. The player shall be required to set their five-card back hand in the correct combination in order to qualify. However, there are no requirements for the three-card front hand or five-card middle hand. If a player receives a qualifying "Clean Sweep" hand, that player may still qualify if the cards in that player's hand can make the qualifying hand.

Baccarat and EZ Baccarat

- **A tie with any natural 8 or 9 (any color).**
 - The cards may be suited or unsuited.
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - When determining if the player's hand qualifies, only the initial two cards are considered, regardless of whether the hand is required to receive an additional card.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.

Three Card Poker

- **Dealt Three of a Kind or better.**
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - If the player folds their hand and does not place the Ante wager, the player's hand will still qualify.

- If the player-dealer's hand does not qualify, all players with a qualifying hand are still eligible.
- The hand qualifies regardless of whether the hand wins, losses or pushes.

Pokara

- **Dealt Straight Flush**
- **Dealt Three of a Kind**
 - The player-dealer may qualify for a ticket if they complete the qualifying hand.
 - Backline bettors are eligible to receive a ticket if the hand they wager on qualifies.
 - If the player folds their hand and does not place the Ante wager, the player's hand will still qualify.
 - If the player-dealer's hand does not qualify, all players with a qualifying hand are still eligible.
 - When determining if the player's hand qualifies, only the initial three cards are considered, regardless of whether that player requests an additional card and their hand is or is not improved.
 - The hand qualifies regardless of whether the hand wins, losses or pushes.

Customers will be awarded a ticket for every qualifying hand. The ticket will be filled out by the customer with Name and I.D. information and placed in a locked drawing drum located in plain sight on the casino floor.

Drawing dates and times will be posted in advance in the casino. The winner of the drawing will be announced immediately following the drawing and must present the matching ticket stub and proper I.D. to claim the prize within 3 minutes of the announcement. If a player loses their matching ticket stub, they shall be ineligible to win. When a player's ticket is drawn and he/she claims their prize(s), their ticket shall be removed from the drawing drum for future drawings. However, if that player has multiple drawing tickets in the drum, those not selected shall remain in the drum and shall be eligible for later drawings. A player may only win one prize per day.

After verification of the winning ticket the winner will be offered the option of taking the pre-determined cash prize or attempting to double that prize amount by playing a hand of Baccarat and choosing the winning hand (Banker or Player). If the player fails to select the winning hand a consolation prize (the original cash prize) will be awarded the player. Should the player choose the correct outcome he/she will have the opportunity to keep the double prize or attempt once again to select the winner of a second hand with a result of either a win for four (4) times the original prize or a loss for a consolation (the original cash prize). A second hand winner will then be offered to keep the 4 times amount or play a third hand with the opportunity of winning ten (10) times the original bet for a winning player/banker selection or the consolation of the original cash prize for a losing selection. If during this play a Tie bet is the hand outcome, the player will be awarded the original cash prize and allowed to continue. If a Dragon 7 appears the player will win 10 times the original cash prize and the contest ends.

- There is no disadvantage for a player electing to double, quadruple, or increase the prize amount by 10 times by playing Baccarat. If the player loses during any round of the Baccarat, he/she will still receive the same prize amount as if they had not played Baccarat.
- If a tie occurs during the first, second, or third hand of Baccarat, the player will be permitted to replay the hand until a win or loss occurs.

- If a Dragon 7 occurs during the first, second, or third hand of Baccaat, the player will automatically win 10 times the original cash prize amount.

In the instance merchandise is the prize awarded for the drawing, if the winner chooses to double, quadruple, or increase the prize amount ten fold by playing a hand(s) of Baccarat, the value of the merchandise prize may not exactly correlate to those exact figures. For example, a player may win a drawing and receive a pair of stereo headphones. If the player chooses to double up, the prize may be a Blue Ray D VD player, and then perhaps a surround sound system for the next prize, and finally a 65" television. In all accounts where merchandise is awarded as a prize for the drawing, the prize would increase exponentially in value.

A qualifying hand must come from a game made up of two to ten customers.

Employees and Third Party Proposition players are not eligible.

Players may accumulate more than one ticket and the tickets are non-transferrable.

The promotion is funded by the Jackpot Fund maintained by the Casino consisting of jackpot collection fees paid by players. Jackpot Collections are Bureau-approved pre-determined, fixed fees and are not based on a percentage of the amount wagered.

BIG SPIN PROMOTION

Hawaiian Gardens Casino's Big Spin Promotion is a drawing where a large wheel decorated in sections with dollar amounts ranging from \$50 to \$100,000.00 is spun in plain view of the Casino floor. The wheel has a pointer, which is used to indicate the amount of the prize to be awarded. **The person who is eligible to win a prize is selected through a ticket drawing.** Participants in the Big Spin Promotion must be at least 21 years of age or older. Casino employees are not eligible to participate in the Big Spin Promotion.

Rules for the Big Spin Promotion

1. A player will be given a ticket if he or she is "seated" at an eligible game. A player is deemed "seated" if he or she is engaged in the play of card games at a gaming table. A player "seated" at a No Purchase Necessary table is eligible to receive a ticket.

2. The eligible games are as follows:
 - a. Texas Hold 'Em (Hold 'Em)
 - b. Omaha and Omaha High/Low Split
 - c. Crazy Pineapple
 - d. Seven-Card Stud and Seven-Card Stud High-Low Split (8-or-better)
 - e. Lowball
 - f. Mexican Poker
 - g. Razz
 - h. Pai Gow Poker and Joker's Wild Pai Gow Poker
 - i. Pan 9 and Super Pan 9
 - j. Pai Gow Tile
 - k. Blackjack Poker
 - l. 13-Card (Chinese Poker)
 - m. Baccarat
 - n. Three Card Poker
 - o. Pokara

3. Tickets will be distributed to "seated" players during the promotional period. The distribution times will be pre-determined and posted in advance, and throughout, the promotional period.
4. CSR's will collect tickets every half-hour after the ticket distribution and give them to the Card Desk Attendant, who will place the tickets into the drawing drum in plain view of the Casino floor. The drawing drum will be locked and placed in plain view of the Casino floor. The player is responsible for tearing off and retaining the ticket stub from each ticket placed into the drawing drum. The winner of the ticket drawing will be required to present the matching ticket stub.
5. The tickets distributed during the promotion will be drawn at a pre-determined date and time. The drawing date and time will be posted in advance, and throughout, the promotional period. The winner of the ticket drawing will be announced immediately after the ticket is drawn.
6. The winner of the ticket drawing must be "verified" in order to be eligible to **win a prize**. In order to be "verified," the winner of the ticket drawing must be present at the Casino at the time of the drawing and must present both proper identification and the matching ticket stub. Proper identification includes a valid driver's license or identification card, passport, or government identification with photo. Spelling and the order of the name must match the identification presented. If the winner of the ticket drawing is not present at the time of the drawing, another ticket may be drawn from the drawing drum until a winner is found. The winner may forfeit his or her chance to spin the wheel, and the Casino will treat it as if there was no winner for that drawing.

7. Before each drawing, the current prize will be posted and announced prior to the drawing of each winning ticket. Once the winning ticket has been drawn and the winner has been "verified", he/she will win a predetermined and fixed amount of cash, a predetermined prize or the opportunity to spin the wheel. If spinning the wheel, they are eligible to receive the prize that is indicated in the section where the pointer comes to rest after the wheel stops spinning. If the pointer lands in between two (2) sections, he/she will be required to re-spin the wheel until the pointer lands within one (1) section. Only one prize will be awarded per ticket drawing.
8. The winner of the ticket drawing may receive a predetermined and fixed amount of cash, a predetermined prize or the opportunity to spin the wheel.
9. Tickets are non-transferable.
10. The rules associated with this promotion will be posted in plain view within the Casino for the duration of the promotional period.
11. The Big Spin Promotion will be funded by the Hawaiian Gardens Casino Jackpot Fund.

BLACKJACK POKER CAR DRAWING PROMOTION

Hawaiian Gardens Casino's Car Drawing Promotion is a promotion where players have a chance to win a new car. Participants in the Car Drawing Promotion must be at least 21 years of age or older. Casino employees are not eligible to participate in the Car Drawing Promotion.

Qualifications

The Blackjack Poker Car Drawing Promotion will be available to all qualifying customers, including at no cost to any player who requests the opportunity to play at a No Purchase Necessary ("NPN") table. Those players at a NPN table will receive 1 ticket per qualifying hand.

Any player who gets a 2 card "natural" (pair of same suited aces), will receive the following:

1. NPN Table / \$5.00 Table = 1 ticket
2. \$10.00 and over table = 2 tickets

Participants will receive a ticket when the designated hand is obtained at any gaming table or No Purchase Necessary instructional table, which is available twenty-four hours a day, seven days a week. All participants will be informed of the designated hand prior to the start of this promotion, and this information will be posted in a conspicuous place in the Casino during the promotion.

Once the hand is confirmed by a CSR and Shift Supervisor, the tickets will be distributed to the player.

CSR's will collect tickets and give them to the Card Desk Attendant, who will place the ticket into the drawing drum in plain view of the Casino floor (players who tickets are collected may choose to witness their ticket being placed in the drum). The drawing drum will be locked and placed in plain view of the Casino floor. The player must write his or her full name on the ticket (initials are not permitted) prior to being collected by the CSR. The player is responsible for tearing off and retaining the ticket stub from each ticket placed into the drawing drum. The winner of the ticket drawing will be required to present the matching ticket stub. Tickets will be collected in the drawing drum over the course of the promotion. A total of three drawings will be held during a three day period. During each drawing, sixteen (16) tickets will be drawn. The date and time of each drawing will be announced prior to the start of the Promotion. The winner of each ticket drawing will be announced immediately after the ticket is drawn.

Rules

1. The promotion will be either four (4) weeks or six (6) weeks in duration. The duration of the promotion (both start date and end date) and the designated dates of the drawings will be posted in the Casino and on the promotional materials well in advance of the start of the promotion.
2. The winner of the drawing must be present at the time of the drawing and will have three (3) minutes to announce themselves to the Casino. If the winner of the drawing does not present himself or herself within three minutes of the winner announcement, the ticket will be thrown away, and another ticket will be drawn from the drawing drum.

3. The ticket drawing will continue until a winner of each ticket drawing is determined. 16 Winners will be selected from the drawing. Each of the 16 eligible winners of the ticket drawing on the specified date will receive a "tournament entry pass," i.e., a pass which will allow the player to enter the Blackjack Tournament which will determine the winner of the Car. Players will only be allowed to receive one "tournament entry pass" per drawing.
4. The 16 winners of each daily drawing will enter into Part 2 of the Contest immediately following the drawing. Part 2 of the contest will consist of two 8-player tables playing a 24-hand Blackjack Tournament. The 1st-4th place winners (those players with the most chips at the end of the last hand) of each table will then sit at the "final table" to play a final 16-Hand Tournament. The player with the most chips after the final hand will win the car.
5. All sixteen (16) winners of the drawing will receive a prize. The prizes will be awarded as follows:
 - a. FIRST ROUND (Two 8-player Tables):
 - i. Places 5 - 8 = \$200.00
 - ii. Places 1-4 = Entry to final table
 - b. FINAL TABLE (8-players)
 - i. Places 2 - 8 = \$300.00
 - ii. 1st Place Winner = New Car
6. The winners of the drawing must be "verified" in order to be eligible to win the tournament pass. In order to be "verified," the winners of

the drawing must be present at the Casino at the time of the drawing and must present both proper identification and the matching ticket stub. Proper identification includes a valid driver's license or identification card, passport, or government identification with photo.

If the winner of the drawing does not have proper identification at the time of the drawing, the winner will have until the designated start time of the tournament to produce proper identification in order to participate in the car giveaway.

7. The Blackjack Tournament will take place at a designated time the same day as that days drawing. All sixteen (16) drawing winners must be present and must be "verified" (see requirements for verification above) at this time in order to be eligible to participate in the car giveaway tournament.
8. All Federal and/or State withholding and reporting forms must be completed before Tournament Prizes are awarded. Tournament participants must present proper identification in order to claim any Tournament Prize. (Proper identification includes a valid driver's license; a valid identification card; a valid passport; or government identification. Identification without a photograph of the participant will not be accepted.)
9. Hawaiian Gardens Casino provides all monies used to fund this Tournament.
10. All participants must be 21 years of age or older.
11. All Tournament Rules apply.

Blazing Sevens Progressive Jackpot

Although the Bureau has approved this jackpot, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of Blazing Sevens Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines Blazing Sevens Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play Blazing Sevens Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.

Bureau Requirements

Advertising

Hawaiian Gardens Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001128) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hawaiian Gardens Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands
- Prize payout structure
- The prize amount to be awarded
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Blazing Sevens Progressive Jackpot shall be attached to the following Bureau approved controlled game offered at Hawaiian Gardens Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Blackjack Poker (GEGA-001470)
- Hawaiian Blackjack (GEGA-001461)

Object and Summary

A player that receives one of the qualifying hands listed below for the Blazing Sevens Progressive Jackpot is eligible to win either a fixed or progressive prize.

1. To begin each round, players must place a base game wager in order to qualify for the jackpot. Along with any optional bonus bets, players have the option to place a \$1 jackpot fee and become eligible for the jackpot.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up. Should the sensor malfunction, the chips will be returned to the players and no jackpot will be offered until the machine is fixed.

Blazing Sevens Progressive Jackpot

3. Once all players place their controlled game wagers and jackpot fees, the house dealer will press "Start Game" on the keypad. The sensors will then light up, indicating participation in the gaming activity. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the controlled game. Any player who makes a qualifying hand will be paid out, as described below.

Qualifying Hands

Players who make one of the advertised qualifying hands (based on the player's initial two cards and the player-dealer's up card), as shown below, shall be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands within a chart must be offered together at all times.

Blazing Sevens Progressive Jackpot Qualifying Hands Chart

Qualifying Hand	
Three 7s of the Same Color	100% of the posted prize
Three 7s	\$500
First two cards are suited 7s	\$100
First two cards are any 7s	\$50

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- Only seated players are eligible for prize payouts.
- There is no minimum number of players required for the jackpot, other than the number of players required per the base game rules.
- A player may qualify for the jackpot element of the game, regardless of the outcome of the controlled game.
- There is no limit on the number of times that a player may win during a promotional period.
- In the event more than one progressive jackpot qualifying hand occurs, all players who qualify shall be paid the posted prize.
- Casino employees are eligible to participate in the gaming activity only when off duty and out of uniform.
- Tournament games are not eligible for this promotion.
- The player-dealer position is not eligible for this promotion.

Prize

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

1. Three 7s of the same color is paid 100% of the progressive jackpot amount shown on the progressive meter.

Blazing Sevens Progressive Jackpot

2. All other hands are paid a fixed amount from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall. In the event the Casino is required to cover any shortfall, they shall be reimbursed once there are sufficient monies in the reserve fund.
3. In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize or the posted fixed prize amount. In the event the reserve fund is depleted, the casino will make up any shortfall. In the event the Casino is required to cover any shortfall, they shall be reimbursed once there are sufficient monies in the reserve fund. All hands will be paid the posted prize.
4. All progressive prizes will be paid out from the table once verified by a casino floor person. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in live casino chips.
5. All fixed payouts will be paid by a casino floor person. Once the proper paperwork has been filled out, the floor person will pay the winner(s) in live casino chips. All fixed payouts will be deducted from the reserve fund.

Funding

The Blazing Sevens Progressive Jackpot is a player funded jackpot which features both fixed prizes and a progressive prize. There is a \$1 jackpot fee that is required to be eligible for the prize. The \$1 jackpot fee paid by each player will be broken down as follows:

- a. \$0.20 will be immediately posted on the meter.
- b. \$0.80 will be tracked in the reserve fund.

Hawaiian Gardens Casino will initially seed the jackpot at a minimum of \$1,000 to a maximum of \$50,000. Once there is sufficient monies in the Blazing Sevens Progressive Jackpot reserve fund, the initial seed amount will be reimbursed to Hawaiian Gardens Casino from the reserve fund and shall be documented in the accounting records. There is no cap to the Blazing Sevens Progressive Jackpot fund.

After the progressive jackpot is hit, the jackpot fund will be re-seeded by the reserve fund at an amount ranging between a minimum of \$1,000 to a maximum of \$50,000. In addition, the reserve fund will be used to pay out all fixed prize amounts. In the event that the reserve fund is depleted, Hawaiian Gardens Casino will make up any shortfall. Once there are sufficient monies in the Blazing Sevens Progressive Jackpot reserve fund, the re-seed amount will be reimbursed to Hawaiian Gardens Casino from the reserve fund and shall be documented in the accounting records. All increases and decreases to the Blazing Sevens Progressive Jackpot fund shall be documented in the accounting records.

Administrative Fees

Hawaiian Gardens Casino will take an administrative fee ranging from \$8 - \$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.

Blazing Sevens Progressive Jackpot

No Purchase Necessary

The Blazing Sevens Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Blazing Sevens Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. When a player has a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.
2. The house dealer shall then contact a supervisor.
3. Once the casino verifies the progressive win, the dealer will press the confirm button. To complete the action, a casino floor person's card swipe is required. This records the win onto the Game Manager computer and adjusts the meter appropriately for the prize won. House procedures are then followed for paying the prize. (Reviewing the monitor connected to the Game Manager will show the prize amount to be paid, and pressing the "money bag" icon will print a win page, which can be used to help record the payout for accounting.)
4. Once the house dealer reconciles all action, the house dealer presses "End Game." This resets the system to begin the next hand.
5. Once the casino floor person's card is swiped the prize is logged into Game Manager. If the progressive pay needs to be backed out at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.

CA/Asian Progressive Bad Beat Jackpot

Bureau Requirements

Advertising

Hawaiian Gardens Casino may advertise various names for this gaming activity. Should the Hawaiian Gardens Casino advertise a different name, the BGC ID (GEGA-002323) shall be referenced on all advertisements relating to the CA/Asian Progressive Bad Beat Jackpot.

Furthermore, all rules and procedures for this promotion, including but not limited to the following, shall be prominently displayed in Hawaiian Gardens Casino at all times the promotion is being offered:

- Eligible games and time periods
- Eligible qualifying hands
- Number of players required to be eligible for the jackpot
- Prize payout structure
- Jackpot prize amount
- Availability of No Purchase Necessary
- Any other restrictions that apply to this jackpot

Eligible Controlled Games

3. Aces in front with a straight or better in back.
4. Aces in front.

Pan 9, Super Pan 9 and Baccarat 9:

1. Three Threes same color.
2. Three Threes suited.
3. Two, Three and Four same color.
4. Two, Three and Four of same suit.

Blackjack Poker:

1. Suited Aces.
2. Three Sevens.
3. Three Sevens same color.
4. Three Sevens suited.

13 Card (Chinese Poker):

1. Dragon Hand Ace to King (13 card Straight).
2. Home Run of 15 points or greater.
3. Two Straight Flushes in the same hand.
4. 13 cards of the same color.

Pai Gow Tiles:

1. Any pair in front with number one hand in back.
2. Any pair-pair.

Pokara:

1. Three Aces of Hearts.
2. Trip Flush.
3. Royal Flush.
4. Straight Flush.
5. Three of a Kind.

Baccarat:

1. Four of a Kind (same suit)
2. Four of a Kind (any suit)
3. Two pair (One in player hand and one in banker hand)
4. Four cards of the same suit (flush)

THIRD PARTY PROVIDER OF PROPOSITION PLAYER SERVICES

Third Party Provider of Proposition Player Services (TPPPPS), as defined in Section 19984 of the California Business and Professions Code, will not be eligible to participate in this promotion. If a hand is made by a TPPPPS employee, the monies will remain in the jackpot fund.

BASE GAME RULES

All base game rules that have been approved by the Bureau of Gambling Control for the listed games and the jackpot will be followed. There are no changes whatsoever.

CAR DRAWING PROMOTION

Hawaiian Gardens Casino's Car Drawing Promotion is a promotion where players have a chance to win a new car. The car to be given away by the Casino will be displayed at the Casino for the duration of the promotion.

Participants in the Car Drawing Promotion must be at least 21 years of age or older. Casino employees are not eligible to participate in the Car Drawing Promotion.

The Car Drawing Promotion will be funded by the Hawaiian Gardens Casino Jackpot Fund.

Qualifications

There are two different ways to become eligible to participate in the car giveaway, Version A – Ticket Drawing and Version B – Computerized Player Tracking Drawing. Only one version will be offered at any one time. Both versions will be available to all qualifying customers, including at no cost to any player who requests the opportunity to play at a No Purchase Necessary ("NPN") table.

A. **Ticket Drawing:** A player is eligible to receive one (1) ticket every three (3) hours. A player will only be given a ticket if he or she is "seated" at an eligible game. A player is deemed "seated" if he or she is engaged in the play of card games at a gaming table. A player "seated" at a No Purchase Necessary table is eligible to receive a ticket. Tickets will be distributed to "seated" players every three (3) hours on the hour, starting at 12:00a.m. (midnight). For example, tickets will be distributed to "seated" players at 12:00a.m., 3:00a.m., 6:00a.m., 9:00a.m., 12:00p.m., 3:00p.m., 6:00p.m. and 9:00p.m. each day during the duration of the promotion. A player is eligible to place one (1) ticket every three (3) hours into the drawing drum. CSR's will collect tickets every half-hour after the ticket distribution and give them to the Card Desk Attendant, who will place the ticket into the drawing drum in plain view of the Casino floor. The drawing drum will be locked and placed in plain view of the Casino floor. The player must write his or her full name on the ticket (initials are not permitted) prior to being collected by the CSR. The player is responsible for tearing off and retaining the ticket stub from each ticket placed into the drawing drum. The winner of the ticket drawing will be required to present the matching ticket stub. Tickets will be collected in the drawing drum over the course of the promotion. The first drawing will start at 12:00p.m. (noon) on the designated end date of the promotion. A total of ten drawings will be held in one (1) hour intervals from the first drawing. For example, one (1) ticket will be drawn from the drawing drum at 12:00p.m. (noon), 1:00p.m., 2:00p.m., 3:00p.m., 4:00p.m., 5:00p.m., 6:00p.m., 7:00p.m., 8:00p.m. and 9:00p.m. The Casino will continue to distribute tickets as noted

above until all ten (10) winners have been determined. The winner of each ticket drawing will be announced immediately after the ticket is drawn. If the winner of the drawing does not present himself or herself within three minutes of the winner announcement, the ticket will be thrown away, and another ticket will be drawn from the drawing drum. The ticket drawing will continue until a winner of each ticket drawing is determined. Each of the ten eligible winners of the ticket drawing will receive a "car pass," i.e., a pass which will be traded in on the designated date of the car giveaway for an envelope containing a key that could potentially start the displayed car. Only one (1) car pass will be awarded per ticket drawing.

B. Computerized Player Tracking Drawing: Every customer at the Casino may request a free, no cost, Player Club Card from the Card Desk at any time by filling out a form with his or her name, address and identification (see Attachment 1 below for a sample of the Player Club Card). The Club Card barcode contains information as to the player's identification and pin number. Once a player receives his or her Club Card, the player becomes eligible to participate in the Player Tracking Drawings, whether playing at the live tables or at a NPN table. During the Car Drawing Promotion, players who wish to participate in the drawing must have their Player Club Cards swiped hourly by a CSR or Concierge. Once the card is swiped, a player receives a computerized entry recording his or her accrued time at any gaming table or NPN table, equal to one (1) entry point for each complete hour of play at any table during the promotional period. Each completed hour of play will add one (1) entry point. Only one (1) entry point per hour will be added to the player's Club Card. The players whose Club Card numbers are selected by the computer will be announced immediately after the numbers are drawn. If the winner of the drawing does not present himself or herself within three minutes of the winner announcement, another Club Card number will be "drawn" by the computer. The drawing will continue until a winner of each drawing is determined. Each of the ten eligible winners of the Computerized Player Tracking Drawing will receive a "car pass," i.e., a pass which will be traded in on the designated date of the car giveaway for an envelope containing a key that could potentially start the displayed car. Only one (1) car pass will be awarded per Card Club number.

Rules for the Car Drawing Promotion

(Note: The rules below apply to both versions of the Car Drawing Promotion)

1. The promotion will be either four (4) weeks or six (6) weeks in duration. The duration of the promotion (both start date and end date) and the designated date of the car giveaway will be posted in the Casino and on the promotional materials well in advance of the start of the promotion.
2. Only one version will be offered at any one time. The version to be utilized in the promotion will be posted in the Casino and on the promotional materials well in advance of the start of the promotion.

3. The winner of the drawing must be present at the time of the drawing and will have three (3) minutes to announce themselves to the Casino. If the winner of the drawing does not present himself or herself within three minutes of the winner announcement, another winner will be chosen according to the rules noted above based on the version that is being utilized in the promotion. The drawing will continue until a winner of the drawing is determined. Each of the ten eligible winners of the drawing will receive a "car pass," i.e., a pass which will be traded in on the designated date of the car giveaway for an envelope containing a key that could potentially start the displayed car. Only one (1) car pass will be awarded per drawing.
4. The winner of the drawing must be "verified" in order to be eligible to win the car pass. In order to be "verified," the winner of the drawing must be present at the Casino at the time of the drawing and must present both proper identification and either the matching ticket stub or the player's Club Card, depending on the drawing version utilized in the promotion. Proper identification includes a valid driver's license or identification card, passport, or government identification with photo. Spelling and the order of the name must match the identification presented.
5. If the winner of the drawing does not have proper identification at the time of the drawing, the winner will have until the designated start time of the car giveaway to produce proper identification in order to participate in the car giveaway. If the winner fails to present proper identification at the time of the car giveaway, the winner forfeits the chance to win the car, and the Casino will treat it as if there was no winner for that drawing.

Each eligible winner will draw a card from a deck of cards that contains only ten (10) cards, Ace through 10 of one suit. 8. The eligible winners will select an envelope according to the order of the card drawn. After all eligible winners have selected an envelope, each eligible winner will take a turn to use the key contained in the envelope to start the car. The order will be the same order as was used for their selection of an envelope. Each eligible winner will try their key until the key that actually starts the displayed car is found. The eligible winner whose key starts the car wins the displayed car.
9. Tickets, Club Cards and car passes are non-transferable.

Object and Summary

Players who make a designated qualifying hand during a pre-determined and posted time period will qualify for a ticket(s) according to the qualifying hands chart listed below. When a player makes a qualifying hand, the player wins the posted amount of tickets and will have the ticket(s) entered into a drawing to win a prize. When a qualifying hand is achieved, the casino dealer will call for a customer service representative to verify the qualifying hand and distribute the applicable number of tickets as listed below.

Car Giveaway Promotion

The ticket is a duplicate style ticket with perforations on two sides. One half of the ticket goes to the player and the other half of the ticket (Casino half) goes into the ticket drum. The Casino half of the ticket contains fields for the player's first and last name, player card number if applicable, date, time, table number and seat number. The Casino half of the ticket is filled out by the player receiving the ticket and then placed in a locked drum, by the patron or Casino employee. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Car Giveaway Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

CARIBBEAN STUD POKER DESIGNATED BONUS HANDS JACKPOT

Summary of Game

The Caribbean Stud Poker Designated Bonus Hands Jackpot is a progressive jackpot element of play that will attach to the Caribbean Stud Poker game approved for play at the Hawaiian Gardens Casino (the "Casino"). Players will be assessed a fixed fee per hand and will qualify for a prize when a designated player hand is beat or beaten by a player-dealer hand. Jackpot Prizes are paid from a prize pool ("Jackpot Fund") which is funded by a fee paid by participating players. Players may qualify for the Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection Fees and no Regular or Designated Table Fees. In all Jackpot games, at least four (4) players must have active dealt-in hands for the table to qualify for a Jackpot Prize.

The rules of play for the underlying Caribbean Stud Poker game will not change. The number of cards used, the type of deck, the function of the Casino dealer, the number of players, rotation of the player-dealer position, the provisions for collection of table fees, the betting limits and schemes and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

The Jackpot Fund

Jackpot Prizes will be paid from a prize pool ("Jackpot Fund") which is funded by the fees paid by participating players ("Jackpot Collection Fees"). The Jackpot Collection Fee is a predetermined, fixed fee, not based on a percentage of the amount wagered. The Jackpot Collection Fee is posted by each player that wishes to participate in the jackpot promotion, prior to the start of the hand. Players can qualify for the Jackpot Prize without paying a fee, or other consideration, by

participating in free instructional games where there is no live wagering, no Jackpot collection, and no table fees (see "No Purchase Necessary" below).

Since this is a progressive jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and frequency in which players obtain a Qualifying Hand. The Casino will control the allocation of the Jackpot Collection Fees to the Jackpot Prize. The Casino may, from time to time, provide the initial seeding of the Jackpot Fund in order to enhance the game, in the Casino's discretion, in accordance with applicable regulations. The minimum amount of the Jackpot Fund, and the amount of the initial seed that the Casino will pay is set forth on the chart attached below entitled, "Jackpot Promotion Prize Schedule and Seed."

The available Jackpot Prize will be posted on the Casino floor via an electronic message board when the promotion is offered, so that prize information will be available to all players at tables and to anyone interested in qualifying under the No Purchase Necessary provision of the Casino's Game Rules. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize.

No Change in the Underlying Game Rules

A round of play for any game incorporating the Jackpot element will not change or deviate from the approved rules or format of the Caribbean Stud Poker game. Should a player obtain the hand that qualifies the player for a Jackpot Prize, the round of play will conclude. Thereafter, the existence of a qualified Jackpot hand will be confirmed and the posted Jackpot Prize will be awarded as stated above. Then, a new round of play can begin.

The rules for the Caribbean Stud Poker game and the Caribbean Stud Poker Designated Bonus Hand Jackpot Promotion will be available on the Casino floor.

Equipment

The only equipment change will be the addition of a separate Jackpot Collection box, to be secured to the table and clearly marked as the "Jackpot Collection Box," used only for the collection of the Jackpot Funds. This will help insure that the Jackpot Collection Fees are kept separate and apart from the table fee collections through the time of deposit into the bank account.

Jackpot Collection Procedure

The Jackpot Collection Fee will be posted by the Casino within view of each participating table and collected prior to the start of each hand, per table, per hand as follows:

The Jackpot Collection Fee will be posted by the player in the first player position. When there is more than one player participating in the player's hand, the player who has the most money in action on the hand will be responsible for posting the full Jackpot Collection Fee.

No Purchase Necessary Play

The Caribbean Stud Poker Designated Bonus Hand Jackpot Promotion will be offered for free on a "general and indiscriminate" basis twenty-four hours a day to patrons who wish to participate in a No Purchase Necessary game. The Casino will provide instructional tables for patrons who request to participate in the Caribbean Stud Poker Jackpot without paying a Regular or Designated Table Fee or Jackpot Collection Fee.

When a player wishes to qualify, the Casino dealer will explain which prizes are

available, and verbally ask the player which prize he or she wishes to qualify for, and the prize requested by the player will be the prize for which he or she is eligible. If the Jackpot is being offered at the Casino at that time, a Casino dealer will deal at least four hands, which is the minimum number of hands necessary for the player to have a chance at the promotion. Each No Purchase Necessary player will play only one hand, and the Casino dealer will play the remaining hands, if any. To the extent that a Casino dealer is playing the hand for a vacant seat, he or she will accept the opportunity to act as player-dealer and will play all hands according to the Logical Way.

In No Purchase Necessary games, no Regular or Designated Table Fee or Jackpot Collection Fee will be posted or collected. There will be no live wagers at these tables. Participants at a No Purchase Necessary table will be eligible for the posted Jackpot prize if they participate in a game where a player obtains, or where an empty seat is dealt, the designated Jackpot hand, and they requested eligibility for the Jackpot before the start of the game. If the player wins the jackpot, the player will receive only the portion of money for which his or her hand qualifies; the remainder will remain in the Jackpot Fund.

Notice of Collection and Accounting Procedures

Jackpot rules and collection procedures will be posted, in writing, on the Casino floor, in advance of the game, framed and attached to the outside of the Cage, as well as included in the Casino's Gaming Activity Rulebook, which is available at the Card Desk. Applicable Jackpot Collection Fees will be posted at each participating table.

Jackpot Collection Fees from each hand played at participating tables will be deposited into a separate Jackpot Collection box (see "Equipment" above). Each Jackpot Collection box will be transferred to the Casino's Count Room, where it will be unlocked and the contents counted, subject to the same accounting principles and safeguards as the Casino uses in the collection, counting and recording of its

Regular and Designated Table Fees. All count team activity is closely monitored. The Casino will follow all applicable laws and regulations that pertain to reporting of winnings.

Once the Jackpot Collection has been collected, counted, and secured, the Accounting Department will record the results on a Jackpot Prize Pool Collection Report, which will be available for audit and inspection. The Jackpot Prize Pool Collection Report will document the amount of Jackpot Collections received at each participating gaming table in a 24-hour period.

Jackpot Funds will be deposited and maintained in a secure and separate Jackpot Fund bank account in a financial institution. When a player qualifies for a Jackpot Prize, the amount of the Jackpot Prize will be paid directly to the player by the Cage in cash and/or chips. The Casino will draw the amount paid out as Prizes and Administrative Fees from the Jackpot Fund bank account, and the Jackpot Fund will immediately be reduced by the amounts paid out.

Administrative Fee

All Jackpot Collection Fees will become part of the total Jackpot Fund available for prizes, with the exception of an administrative fee, which will be withheld and accounted for by the Casino. The amount of the administrative fee will be determined in advance and will take into consideration market conditions and the cost of operating the Jackpot promotion. The administrative fee will not fluctuate based on the amount of money deposited into the Jackpot Fund. The Casino will collect an administrative fee of \$4.00 per table hour when a Caribbean Stud Poker Designated Bonus Hand Jackpot is offered for play, and reserves the right to change the amount as necessary, and in accordance with applicable regulations. The administrative fee will be drawn from the Jackpot Fund Money Market account. Players will be advised of the administrative fee in advance of a Jackpot promotion. The Casino's Accounting Department will maintain the records of table activity, including the time a table is opened, the duration of play at the table, and

the time the table closes, along with all transactions that take place at the table.

Third Party Proposition Players

Third Party Proposition Players, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Players"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, his or her portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. If a Prop Player is a participant in a Qualifying Hand with another player(s), the Prop Player will not be eligible to receive his or her portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players at the table.

Eligibility for the Jackpot Prize

If there is more than one player with a wager in the player position, the Jackpot Prize will be divided pro-rata based on the amounts of the respective wagers between the players.

Qualifying Designated Bonus Hands

When a qualifying Jackpot hand (described below) is confirmed, if the player with the designated bonus hand wins or pushes with the player-dealer's hand, the player will receive ninety percent (90%) of the posted Jackpot Prize, and the player-dealer will receive ten percent (10%) of the posted Jackpot Prize; if the player with the designated bonus hand loses to the player-dealer's hand, the player will receive eighty percent (80%) of the posted Jackpot Prize, and the player-dealer will receive twenty percent (20%) of the posted Jackpot Prize.

CARIBBEAN STUD POKER JACKPOT

Summary of Game

Caribbean Stud Poker Jackpot is a progressive jackpot element of play that will attach to the Caribbean Stud Poker game approved for play at the Hawaiian Gardens Casino (the "Casino"). Players will be assessed a fixed fee per hand and will qualify for a prize when a designated second hand is beaten by a designated first hand ("Jackpot Prize"). Jackpot Prizes are paid from a prize pool ("Jackpot Fund") which is funded by a fee paid by participating players. Players may qualify for the Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection Fees and no Regular or Designated Table Fees. In all Jackpot games, at least four (4) players must have active dealt-in hands for the table to qualify for a Jackpot Prize.

The rules of play for the underlying Caribbean Stud Poker game will not change. The number of cards used, the type of deck, the function of the Casino dealer, the number of players, rotation of the player-dealer position, the provisions for collection of table fees, the betting limits and schemes and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

The Jackpot Fund

Jackpot Prizes will be paid from a prize pool ("Jackpot Fund") which is funded by the fees paid by participating players ("Jackpot Collection Fees"). The Jackpot Collection Fee is a predetermined, fixed fee, not based on a percentage of the amount wagered. The Jackpot Collection Fee is posted by each player that wishes to participate in the jackpot promotion, prior to the start of the hand. Players can qualify for the Jackpot Prize without paying a fee, or other consideration, by participating in free instructional games where there is no live

wagering, no Jackpot collection, and no table fees (see "No Purchase Necessary" below).

No Change in the Underlying Game Rules

A round of play for any game incorporating the Jackpot element will not change or deviate from the approved rules or format of the Caribbean Stud Poker game. Should a player obtain the hand that qualifies the player for a Jackpot Prize, the round of play will conclude. Equipment

This will help insure that the Jackpot Collection Fees are kept separate and apart from the table fee collections through the time of deposit into the bank account.

Jackpot Collection Procedure

The Jackpot Collection Fee will be posted by the Casino within view of each participating table and collected prior to the start of each hand, per table, per hand as follows:

No Purchase Necessary Play

The Caribbean Stud Poker Jackpot Promotion will be offered for free on a "general and indiscriminate" basis twenty-four hours a day to patrons who wish to participate in a No Purchase Necessary game. The Casino will provide instructional tables for patrons who request to participate in the Caribbean Stud Poker Jackpot without paying a Regular or Designated Table Fee or Jackpot Collection Fee.

When a player wishes to qualify, the Casino dealer will explain which prizes are available, and verbally ask the player which prize he or she wishes to qualify for,

and the prize requested by the player will be the prize for which he or she is eligible. If the Jackpot is being offered at the Casino at that time, a Casino dealer will deal at least four hands, which is the minimum number of hands necessary for the player to have a chance at the promotion. Each No Purchase Necessary player will play only one hand, and the Casino dealer will play the remaining hands, if any. To the extent that a Casino dealer is playing the hand for a vacant seat, he or she will accept the opportunity to act as player-dealer and will play all hands according to the Logical Way.

In No Purchase Necessary games, no Regular or Designated Table Fee or Jackpot Collection Fee will be posted or collected. There will be no live wagers at these tables. Participants at a No Purchase Necessary table will be eligible for the posted Jackpot prize if they participate in a game where a player obtains, or where an empty seat is dealt, the designated Jackpot hand, and they requested eligibility for the Jackpot before the start of the game. If the player wins the jackpot, the player will receive only the portion of money for which his or her hand qualifies; the remainder will remain in the Jackpot Fund.

Notice of Collection and Accounting Procedures

Jackpot rules and collection procedures will be posted, in writing, on the Casino floor, in advance of the game, framed and attached to the outside of the Cage, as well as included in the Casino's Gaming Activity Rulebook, which is available at the Card Desk. Applicable Jackpot Collection Fees will be posted at each participating table.

When a player qualifies for a Jackpot Prize, the amount of the Jackpot Prize will be paid directly to the player by the Cage in cash and/or chips. The Casino will draw the amount paid out as Prizes and Administrative Fees from the Jackpot Fund bank account, and the Jackpot Fund will immediately be reduced by the amounts paid out.

Administrative Fee

All Jackpot Collection Fees will become part of the total Jackpot Fund available for prizes, with the exception of an administrative fee, which will be withheld and accounted for by the Casino. The amount of the administrative fee will be determined in advance and will take into consideration market conditions and the cost of operating the Jackpot promotion. The administrative fee will not fluctuate based on the amount of money deposited into the Jackpot Fund. The Casino's Accounting Department will maintain the records of table activity, including the time a table is opened, the duration of play at the table, and the time the table closes, along with all transactions that take place at the table.

Third Party Proposition Players

Third Party Proposition Players, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Players"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, his or her portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. For the Bad Beat Jackpot: When a qualifying Bad Beat Jackpot is confirmed, the player with the Second Hand of that game will receive sixty percent (60%) of the posted Jackpot Prize amount for that game; the player with First Hand will receive twenty percent (20%) of the Jackpot Prize for that game; and, the remaining twenty percent (20%) of the Jackpot Prize for that game will be evenly distributed among all other active players at the qualifying table where the Caribbean Stud Poker game was played.

For the Super Jackpot: When a qualifying Super Jackpot is confirmed, the player with the Second Hand of that game will receive sixty percent (60%) of the posted Jackpot Prize amount for that game; the player with the First Hand will receive twenty percent (20%) of the Jackpot Prize for that game; and, the remaining twenty percent (20%) of the Jackpot Prize for that game will be evenly distributed among all other active players at the qualifying table where the Caribbean Stud Poker game was played.

For the Royal Jackpot: When a qualifying Royal Jackpot is confirmed, the player with the Second Hand of that game will receive twenty percent (20%) of the posted Jackpot Prize amount for that game; the player with the First Hand will receive sixty percent (60%) of the Jackpot Prize for that game; and, the remaining twenty percent (20%) of the Jackpot Prize for that game will be evenly distributed among all other active players at the qualifying table where the Caribbean Stud Poker game was played.

CASH DRAWING PROMOTION

Hawaiian Gardens Casino's Cash Drawing Promotion is where the customer gains entry by receiving a drawing ticket for participating in a designated Department of Justice approved casino game or by being dealt, or completing, a qualifying hand in a designated Dept. of Justice approved casino game. Participants in the Cash Drawing Promotion must be at least 21 years of age. Casino employees are not eligible to participate in the Cash Drawing Promotion.

Rules for the Cash Drawing Promotion

1. A customer will be given a drawing ticket if he or she is "seated" at an eligible game or completes the pre-determined designated hand during the promotion period. A customer is deemed "seated" if he or she is engaged in the play of a designated card game at a gaming table. A customer "seated" at a No Purchase Necessary table is eligible to receive a ticket.

 - a. Texas Hold 'Em (Hold 'Em)

3. Tickets will be distributed to "qualified" customers during the promotional period. The distribution times, rules of promotion, drawing times and prizes will be pre-determined and posted in advance, and throughout, the promotional period.
4. CSR's will collect tickets every half-hour after the ticket distribution, or when designated hand occurs, and give them to the Card Desk Attendant who will place the tickets into the drawing drum in plain view of the Casino floor. The drawing drum will be locked and placed in plain view of the Casino floor. The customer is responsible for placing his/her name legibly on one half of the ticket and tearing off and retaining the other half of each ticket placed into the drawing drum. The winner of the ticket drawing will be required to present the matching ticket stub.
5. The winner of the ticket drawing must be "verified" to qualify for a prize. In order to be "verified," the winner of the ticket drawing must be present at the Casino at the time of the drawing and must present both proper identification and the matching ticket stub. A customer is eligible to win one prize per day. Proper identification includes a valid driver's license or identification card, passport, or government identification with photo. Spelling and the order of the name must match the identification presented. If the winner of the ticket drawing is not present at the time of the drawing, that ticket will be forfeited and another ticket may be drawn from the drawing drum until a winner is found. Once the winner of the ticket drawing has been "verified", he or she is awarded the pre-determined prize indicated for the promotion.

CASH IN A FLASH PROMOTION

Summary of Game

Cash in a Flash is a Jackpot element of play that will attach to games approved for play at the Hawaiian Gardens Casino (the "Casino"), specifically, 13-Card (also known as Chinese Poker), Pai Gow Poker (including Joker's Wild Pai Gow Poker), Hawaiian Blackjack, Blackjack Poker and Pan 9 (collectively referred to as "Asian-Style games").

The number of cards used, the type of deck, the dealer, the number of players involved, provisions for collection of table fees, betting limits and schemes, and how winners are determined and paid will all be consistent with the Casino's game procedures and rules, and the rules and regulations of the City of Hawaiian Gardens and the State of California, including the Department of Justice, Division of Gambling Control and the Gambling Control Commission regulations and the Business & Professions Code (hereinafter "applicable regulations"). The rules of play for the underlying games will not change. In all Jackpot games, at least three (3) players must have active dealt-in hands for the table to qualify for a Jackpot Prize.

Prizes will be paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players ("Jackpot Collections"). Players can qualify for the Jackpot Prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot collection, and no table fees (see "No Purchase Necessary" below).

Funding

A separate collection fee paid by players ("Jackpot Collections") will fund the Jackpot Fund. Jackpot Collections are predetermined, fixed fees, not based on a percentage of the amount wagered. The Casino may, from time to time, provide the initial seeding of the Jackpot Fund in order to enhance the game, in the Casino's discretion, in accordance with applicable regulations. The minimum amount of the Jackpot Fund, and the amount of the initial seed that the Casino will pay is set forth on the chart attached hereto entitled, "Jackpot Promotion Prize Schedule and Seed." The term, "players" as used in these rules include any person who places a wager on a gaming table and pays the corresponding collection fee.

No Change in the Underlying Game Rules

A round of play for any game incorporating the Jackpot element will not change or deviate from the approved rules or format for any game. Should a player obtain the hand that qualifies the player for a Jackpot Prize, the round of play will conclude. Thereafter, the existence of a qualified Jackpot hand will be confirmed and the posted Jackpot Prize will be awarded as stated above. Then, a new round of play can begin.

Equipment

The only equipment change will be in the addition of a separate Jackpot Collection box, to be secured to the table and clearly marked as the "Jackpot Collection Box," used only for the collection of the Jackpot Funds. This will help insure that Jackpot Collections are kept separate and apart from the table fee collections through the time of deposit into the bank account.

Jackpot Collection Procedure

The amount and method of payment of the Jackpot Collection will be announced to each participating table in advance of the game being played. The Jackpot Collection Rate is posted on the tables selected for participation and contributed in accordance with the applicable regulations. The Jackpot Collection Rates will range from \$0.50 to \$10.00 per table, per hand, in accordance with the Rate Chart below, regardless of the particular game being played. The amount of the Jackpot Fund will be announced at the beginning of the Jackpot Game.

No Purchase Necessary Play

Players participating at No Purchase Necessary tables are eligible to win the Jackpot Prize twenty-four hours a day. This game is offered to them on a general and indiscriminate basis at no cost.

Anyone interested in qualifying for the Jackpot Prize under the No Purchase Necessary provision of the Casino's Game Rules may request to qualify for a Jackpot Prize. When a player wishes to qualify, the table's dealer will explain which prizes are available, and verbally ask the player which prize he wishes to qualify for, and the prize requested by the player will be the prize for which he or she is eligible.

Jackpot prizes will also continuously be posted on the Casino floor via electronic message board(s) when the promotion is offered, so that prize information will be available to all players at tables and to anyone interested in qualifying under the No Purchase Necessary provision of the Casino's Game Rules. Cash in a Flash promotion rules will also be available on the Casino floor in promotional flyers.

Consistent with the general procedures for an instructional table, a person can request the opportunity to qualify twenty-four hours a day. If the Jackpot is being offered at the Casino at that time, a Casino dealer will deal at least four players dealt-in, which is the minimum number of hands necessary for the player to have a chance at the promotion. If the player should request, then the dealer will deal additional hands up to a maximum of eight hands for stud games, and a maximum of nine hands for poker games, at the instructional table. This way, there will be at least four players dealt-in so that the player can qualify to win the Jackpot.

In No Purchase Necessary games, no table fee or Jackpot Collection will be posted or collected. There will be no live wagers at these tables. Participants at a No Purchase Necessary table will be eligible for the posted Jackpot prize if they participate in a game where a player obtains, or where an empty seat is dealt, the designated Jackpot hand, and they requested eligibility for the Jackpot before the start of the game.

Notice of Collection and Accounting Procedures

Jackpot rules and collection procedures will be posted, in writing, on the Casino floor, in advance of the game, framed and attached to the outside of the Cage, as well as included in the Casino's Gaming Activity Report Rulebook, which is available at the Card Desk. Applicable Jackpot Collection Fees will be posted at each participating table.

Jackpot Collections from each hand played at participating tables will be deposited into a separate Jackpot Collection box (see "Equipment" above). Each Jackpot Collection box will be transferred to the Count Room, where it will be unlocked and the contents counted, subject to the same internal control standards used by the Casino in counting table fees. All count team activity is closely monitored.

Once the Jackpot Collection has been collected, counted, and secured, the Accounting Department will record the results on a Jackpot Prize Pool Collection Report, which will be available for audit and inspection. The Jackpot Prize Pool Collection Report will document the amount of Jackpot Collections received at each participating gaming table in a 24-hour period.

The same accounting principles and safeguards as the Casino uses in the collection, counting and recording of its table fees will be used when dealing with Jackpot collections. The Casino will follow all applicable laws and regulations that pertain to reporting of winnings.

All Jackpot Collections will become part of the total Jackpot Fund available for prizes, with the exception of an administrative fee, which will be withheld and accounted for by the Casino. The amount of the administrative fee will be determined in advance and take into consideration market conditions and the cost of operating the Jackpot promotion. The administrative fee will not fluctuate based on the amount of money deposited into the Jackpot Fund. The Casino will collect an administrative fee of \$4.00 per table hour when a Cash in a Flash is offered for play, and reserves the right to change the amount as necessary, and in accordance with applicable regulations. The administrative fee will be drawn from the Jackpot Fund Money Market account. Players will be advised of the administrative fee in advance of a Jackpot promotion. The Casino's Accounting Department maintains records of table activity, including the time a table is opened, the duration of play at the table, and the time the table closes, along with all transactions that take place at the table.

Jackpot Funds will be deposited and maintained in a secure and separate Jackpot Fund bank account in a financial institution. When a player qualifies for a Jackpot Prize, the amount of the Jackpot Prize will be

paid directly to the player by the Cage in cash and/or chips. The Casino will draw the amount paid out as Prizes and Administrative Fees from the Jackpot Fund bank account, and the Jackpot Fund will immediately be reduced by the amounts paid out.

Note: Third Party Proposition players are not eligible to win a Jackpot, and, in the event his or her hand is a qualifying Jackpot hand, then his or her share of the Jackpot Prize will be immediately returned to the Jackpot Fund.

The Casino reserves the right to change the participating games, the qualifying hands for any Jackpot Prize, and the distribution of the Jackpot Prize among the qualified players; and will give ample notice to players in advance of any changes and obtain prior approval from the Division of Gambling Control.

Object and Summary

Fast Cash Jackpots features progressive and fixed jackpot prizes attached to the games listed above. Players will receive a cash prize when they are dealt a qualifying hand, as shown below. The qualifying hands and prize amounts will be posted for each game prior to the beginning of the promotion. Once a qualifying hand is verified and confirmed by surveillance, the prize may be awarded. There is no time limit a player has to collect their prize. The prize will remain in the cage until it is claimed. In all instances, patrons shall be provided with ample advance notice of the rules and restrictions in order to qualify for the Fast Cash Jackpots Promotion.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no limit to how many times a player may achieve a qualifying hand or win a prize.
- At least two players must be playing in order to participate in the Fast Cash Jackpots Promotion.

Prize

The Fast Cash Jackpots Promotion features progressive and fixed prize amounts paid in the form of cash and/or live casino chips. The progressive prize will start at \$1,000 and will increase daily by \$100. The progressive prize will have no cap. The actual prize amount shall depend on how many days have transpired. Players who achieve a progressive prize qualifying hand shall receive 100% of the posted jackpot prize. In addition, the amount of the progressive jackpot prize shall be updated daily and displayed prominently within the Casino at all times the Fast Cash Jackpots Promotion is being offered for play. The fixed prize amounts shall range between \$400 and \$1,000 depending on the achieved qualifying hand and shall be paid to each eligible player at the table.

Funding

The Fast Cash Jackpots Promotion features progressive and fixed prize amounts. The Fast Cash Jackpots Promotion is fully funded by the Hawaiian Jackpot (GEGA-001477) reserve account. The progressive prize amount is seeded by the Casino in the amount of \$1,000. The Casino will be reimbursed by the Hawaiian Jackpot (GEGA-001477) reserve fund after the seed money becomes available. \$100 is added daily to the progressive prize pool and will be funded from the Hawaiian Jackpot (GEGA-001477) reserve fund. Once the progressive prize is hit, the progressive prize pool shall be reseeded at \$1,000 from the Hawaiian Jackpot (GEGA-001477) reserve fund. If there is not sufficient funds in the Hawaiian Jackpot (GEGA-001477) reserve fund to increase the progressive prize pool by \$100 a day or to reseed, the Casino will cover the shortfall. If the Casino covers any shortfall, Casino will be reimbursed by the Hawaiian Jackpot (GEGA-001477) reserve fund once sufficient funds are available.

Administrative Fees

The Hawaiian Gardens Casino will not retain an administrative fee as this promotion is funded from the Hawaiian Jackpot (GEGA-001477) reserve fund.

All advertisement material shall state "No Purchase Necessary" when referencing the Fast Cash Jackpots Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.



Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review.

- No Purchase Necessary Information.
- Any other restrictions that apply to this gaming activity.

The Fortune 7 Baccarat Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Hawaiian Gardens Casino, as shown below, at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Fortune 7 Baccarat (GEGA-004346)

Object and Summary

1. Fortune 7 Baccarat Progressive Jackpot adds a player funded progressive jackpot element to the game of Fortune 7 Baccarat played in California Cardrooms. The base game of Baccarat must be approved by the Bureau to be eligible to add the Fortune 7 Baccarat Progressive.
2. Fortune 7 Baccarat Progressive considers both the player and banker hands.
3. To begin each round, players must make their regular base game wager. They may optionally place any bonus bet wagers along with the jackpot fee of \$1. A minimum of two (2) players (which may include the player in the player-dealer position) are required to play for the progressive jackpot.
4. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
5. Once all players place their bets and/or jackpot fee, the house dealer will use the keypad to start the game. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.



6. The house dealer then follows standard approved procedures for dealing the base game. The final outcome of the player and banker hands will be considered for the jackpot wager. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

Qualifying Hands

When Fortune 7's (3 card total of 7) are dealt on the player and banker hands that are exact matches in suit and rank, eligible players who placed a jackpot collection are paid from the progressive jackpot shown on the progressive meter. When Fortune 7's are dealt on the player and banker hands, the eligible players who place a jackpot collection will receive a fixed prize amount, paid from the reserve fund, according to the payable below. They do not get deducted from the amount shown on the meter.

Eligibility Requirements

The eligibility requirements are as follows:

- Only seated players are eligible for payouts.
- Back-line bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.
- In the event that during a round of play, two or more players have qualifying hands, each player will receive the posted prize amount for their designated hand.
- Casino employees are eligible for the Fortune 7 Baccarat Progressive gaming activity prize when off duty and out of uniform.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the Fortune 7 Baccarat Progressive gaming activity when either in the player-dealer or player capacity.

Prize Amount

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

Progressive Winners

- a. An exact match player and dealer 3-card total of 7 is paid 100% of the progressive jackpot amount shown on the progressive meter.
- b. All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the casino will make up any shortfall.
- c. Because the progressive wager is based on community hands, all participating players will evenly divide the posted progressive award when the 100% award is won. The \$5,000 fixed prize will be evenly divided among all participating players and the \$100 fixed prize will be paid individually to each participating player.
- d. When there is a progressive winning hand, the dealer shall press the appropriate hand button on the keypad.
- e. The house dealer shall then contact the floor person.



- f. Once the casino verifies the progressive win, the floor person shall authorize the award. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
- g. When the house dealer reconciles all action (on behalf of the player/dealer), he/she presses "Game Over." This resets the system to begin the next hand.
- h. Once the floor person authorizes the award, the prize is logged into Game Manager.

Fixed Prize

- When a player is dealt a Double Fortune 7 of the same ranks or a Double Fortune 7, they are paid a fixed prize amount according to the Prize Distribution table below.
- All fixed payouts will be paid by a Casino floor person. Once the proper paperwork has been filled out, the floor person will authorize payment to the winner(s) in casino chips. All fixed payouts will be deducted from the amount in the reserve fund.

Funding

The Fortune 7 Baccarat Progressive Jackpot is a player funded progressive jackpot. The Casino will initially seed the jackpot with at least \$1,000. Once there are sufficient monies in the Fortune 7 Baccarat Progressive jackpot fund, the initial seed will be reimbursed to the Casino from the reserve fund and shall be documented in the accounting records. After the progressive jackpot is hit it will be re-seeded by the reserve fund with at least \$1,000.

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- a. \$0.20 will be immediately posted on the meter.
- b. \$0.80 will be tracked in a reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot prize with at least \$1,000. In addition, this reserve fund will payout all fixed amounts.

Administrative Fees

The Casino will take an administrative fee ranging from \$8-\$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer system and program in addition to technicians having to service the systems.



No Purchase Necessary Table Requirement

The Fortune 7 Baccarat Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Fortune 7 Baccarat Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Four of a Kind Poker Promotion

Advertised Names

The Hawaiian Gardens Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID listed below shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Hawaiian Gardens Casino at all times that the gaming activity is being offered for play:

- Eligible game(s).
- Eligible time period(s).
- Qualifying Hand.
- Prize Amount.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

Controlled Game

The Four of a Kind Poker Promotion shall be attached to all limits and versions of the currently approved games offered at the Hawaiian Gardens Casino, as listed below. All base game rules shall be played as previously approved by the Bureau of Gambling Control.

- Texas Hold'em (GEGA-001462)
- Seven Card Stud High-Low Split (GEGA-001454)
- Omaha (GEGA-002303)
- Crazy Pineapple (GEGA-001455)
- Seven Card Stud (GEGA-001453)
- Mexican Poker (GEGA-001452)
- Omaha High-Low Split (GEGA-003824)

Rules of Play

Players who make a designated Four of a Kind poker hand during a pre-determined and posted time period shall win the posted prize. Players who are seated at the table and dealt in where the designated Four of a Kind has been hit shall also win a prize.

For example: Make four 2's from 10am – 11am to win \$500 for yourself. Each dealt in player at your table shall win \$100.

Qualifying Hands

A random Four of a Kind hand will be selected by a designated employee of Hawaiian Gardens Casino. A shuffled deck of cards shall be spread face down across a table in plain view of the Casino floor. This shall take place at the closest empty table in front of the Poker card Desk. The designated Hawaiian Gardens Casino employee shall then select one card and that card shall determine the designated Four of a Kind hand. In order to qualify for the promotion the player must use two hole cards, if applicable.

For example: the designated employee selects a 2 of Hearts. The designated winning Four of a Kind hand shall then be four 2's.

Once a Four of a Kind hand has been selected, it shall be displayed prominently within Hawaiian Gardens Casino, in plain view of the Casino floor, along with the eligible games, the eligible time period and the prize amount.

Four of a Kind Poker Promotion

Prize

The prize shall be cash prizes, casino chips, or merchandise ranging in value from \$1 to \$100,000. An additional prize, known as the table share, ranging from \$1-\$100,000, will be awarded to all the players who have participated on that round of play. The prize amounts for this promotion shall be pre-determined and prominently displayed on the gaming floor.

Prize Payout Structure

Players who make a qualifying hand shall receive the posted prize. Players who have been dealt in at a table where the designated hand has been dealt shall receive that posted prize.

Eligibility

The promotion shall be open to all players who are seated and playing in an eligible game during the pre-determined and specified hours designated for this gaming activity.

- Only players seated at the table, and dealt a designated hand, are eligible to win.
- Tournament games do not qualify.
- Casino employees on and off duty, in and out of uniform are eligible for the promotion.
- There is no minimum or maximum number of players needed to qualify for the promotion, other than what is already required for game play.
- All qualifying hands must be verified by a floor person in order to be eligible.
- All winning players will have their ID checked by Card Room personnel.
- In order to qualify for the promotion, the player must complete play on all four rounds of the hand, which includes the pre-flop, the flop, the turn, and the river, and not fold their hand.
- In order to qualify for the promotion, the player must complete the applicable bets on each round. If the player goes all-in, this is considered to have completed all bets.
- In order to qualify for the promotion, the player must win the hand on the showdown, after the final round of betting.

Funding

The player who is dealt the highest hand during the eligible time period shall win a prize. If more than one player(s) are dealt the same high hand, those players shall split the posted prize.

Rules of Play

Patrons are awarded match play certificates via advertisements in magazines, websites, mailing advertisements, etc. Players who receive a match play certificate will be eligible to win the specific amount printed on the certificate when he/she either places a wager on an eligible game equal to the amount listed on the match play certificate or plays the match play certificate alone without a live wager depending on the notice prominently posted at the table.

If the certificate is a single-play certificate, the certificate will be collected by the player-dealer once the round of play is over. If the player loses the hand in which the certificate was used, the player shall lose their wager in addition to the certificate, no matter if it is a multi-play or single-play certificate. The player-dealer will collect and void all losing certificates. If the player pushes the hand in which the certificate was used, the certificate may be used again until the hand wins or loses.

Free Play Certificate

The Casino will offer free play certificates having a face value from \$5 to \$500 per certificate. The amount will be clearly stated on the certificate. If the player wins the hand in which the certificate was used, the player shall win the value printed on the certificate. All winning certificates shall be paid in casino chips by the player-dealer. If the certificate is a multi-play certificate, the certificate will be returned to the player after every time the hand has been won, to be used again until the hand loses. Whether the player wins or loses, the player dealer shall record the use of the certificate for redemption purposes and shall redeem all certificates at the cage on a regular basis. If the certificate is a single-play certificate, the certificate will be collected by the player-dealer once the round of play is over. If the player loses the hand in which the certificate was used, the player shall lose the certificate, no matter if it is a multi-play or single-play coupon. The player-dealer will collect and void all losing certificates. If the player pushes the hand in which the certificate was used, the certificate may be used again until the hand wins or loses.

Eligibility

The promotion will be open to all players who are seated and playing at the above listed games during the pre-determined and specified hours designated for the promotion.

- There is no minimum or maximum number of players required to be playing in any of the games in order for the game to qualify.

Once a player is issued a Club Card, then the player becomes eligible to participate in the Player Tracking Rewards Promotions, regardless of whether playing at the live tables or at a No Purchase Necessary table. 1. CSR's are to consider the best interests of the game and fairness as the top priority in the decision-making process. Unusual circumstances can, on occasion, dictate the technical interpretation of the rules be ignored in the interest of fairness. The CSR's decision is final.
2. Odd Chips: In case of a split pot, the odd chip(s) will go to the hand(s) left of the button.

3. Side Pots: Each side pot will be split as a separate pot. They will not be mixed together before they are split.
4. Dead Button: Sit-N-Go play will use a dead button.

11. When raising, a player must either put the amount of the raise out in one motion or state the raise amount. By stating the word "raise", a player protects his/her right to raise, but the raise must be made in one additional motion unless he states the amount.
12. In no-limit, less than a full raise (all-in) does not reopen the betting to a player who already has acted.
13. If a player states "raise" and throws in an oversized chip, the raise will be the maximum amount allowable up to the size of that chip.
14. The one-player-to-a-hand rule will be enforced.
15. The English-only rule will be enforced during the play of hands.
16. A player who wants to use a cellular phone must step away from the table.
17. There will be no racks or foreign chips on the table except for a maximum of one card cap.
18. Deck changes will be on the dealer push. Players may not ask for deck changes. Dealers may scramble only on player request (one request per round, per player).
19. When time has elapsed and a new round is announced, the new limits apply to the next hand. A hand has begun with the first riffle.

20. A player may not miss a hand. Dealers shall deal to all eligible seats with chips.
21. CARDS SPEAK- Verbal declarations as to the content of a player's hand are not binding; however, at management's discretion, any player deliberately miscalling his hand may be penalized.
22. All players dealt in the hand have a right to see any called hand. No rabbit hunting is allowed.
23. All chips must be visibly displayed at all times with the highest denominations toward the front. Players may not have tournament chips in their pockets at any time.
24. Dealers cannot kill a winning hand that was turned face-up and was obviously the winning hand.
25. Verbal declarations in turn are binding. Action out of turn may be binding.
26. Management reserves the right to cancel or alter any event at its sole discretion in the best interest of the Casino or its players.
27. Players are obligated to act in turn and protect the other players in the tournament at all times. Discussing cards discarded or hand possibilities are not allowed.
28. Verbally disclosing the contents of our hand or advising a player how to play and hand may result in a penalty.

- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Splash Pot Promotion shall be attached to all Bureau approved poker games offered at Hawaiian Gardens Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

Object and Summary

The Splash Pot Promotion gaming activity features a promotional element which shall be attached to the above listed approved controlled games at the Casino. During predetermined times and intervals of the promotional period, a casino representative shall splash the pot by adding a predetermined and posted prize to the pot at the start of the hand.

The qualifying times for the promotion will be determined by one of two methods:

- Option 1- The prize will be added to the pot at designated times and days which will be clearly specified and announced to the players beforehand.
- Option 2- The prize will be added to the pot when certain qualifying events occur, such as when a score is made during a televised sporting event being shown at the Casino.

The Splash Pot Promotion gaming activity involves a drawing where a bin, basket, lottery ball machine, or other non-electronic randomizer shall be used. During predetermined times and intervals of the promotional period, a casino employee shall announce the commencement of the drawing. The casino employee shall then select an eligible table by randomly choosing a card, ball, or other lamer from the randomizer. A card, ball, or other lamer shall depict a number that corresponds to each eligible poker table. The cards, balls, or other lamers, which are pre-printed, equally sized and colored, shall be mixed within the randomizer, and one will be selected and announced.

Once the table number is determined, the casino employee shall place the predetermined and posted prize into the pot at that table and can be won at the start of the selected table's next hand. If seats are available, new players may enter the game in between these hands. Betting procedures and play shall proceed as a normal round of play would. The player with the winning

hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot evenly.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is no minimum amount of time played required for a table to qualify for this promotion.
- In the event that two or more players tie, the pot shall be evenly distributed between each player with the winning hand. If the prize is a non-cash prize it will be doubled, and each player shall receive a prize of equal value.
- A minimum of four players must be dealt into the game in order to qualify for the promotion. A table without four players will not be represented by a card, ball or other lammer when the table selection occurs.

- One or more tables may be selected at each drawing. The number of tables to receive prizes will be clearly posted.
- When an eligible table is drawn, the card, ball, or other lammer will be placed back into the bin, basket, or lottery ball machine with the availability to be drawn again.
- New players may be seated at the chosen table number in between the time that the table number is drawn and the start of the next round of play, when the prize shall be added to the pot.
- A table can be selected and receive the “splashed prize” amount multiple times in a promotional period with no limit.

Prize

The fixed prize for the Splash Pot Promotion shall be a fixed amount ranging from \$1 to \$100,000. The prize shall be paid in the form of live casino chips, merchandise, event tickets or gift certificates.

Funding

This promotion will be fully funded from the previously approved Hawaiian Jackpot (GEGA-001477) reserve fund. In the event that that reserve fund has been depleted Hawaiian Gardens Casino will make up any potential shortfall and will not be reimbursed. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion.

Administrative Fees

Hawaiian Gardens Casino shall not retain an administrative fee as this promotion is funded from the Hawaiian Jackpot (GEGA-001477). No additional fees shall be taken for this promotion.

Splash Pot Promotion

No Purchase Necessary

The Splash Pot Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Splash Pot Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

SPORTS PROMOTION

Rules

1. A square grid will be designed on a "dry erase board" approximately 4ft by 4ft. The grid will consist of 10 cubes to each side, totaling 100 cubes. The table numbers will be placed manually by random selection on the face of the grid. On the top side, each column of cubes will be headed by a single digit, 0 to 9, with no digit repeating. The left vertical side will be numbered in the same manner. These 0 to 9 numbers on each axis are chosen randomly by draw from a drum. The eventual combinations of horizontal and vertical numbers will decide the winners. Tables will have their numbers displayed on them.
2. When a sport contest of choice takes place, one team name will be placed horizontally along the top numbers and the other team name will be placed vertically along the left side.

4. This promotion will be attached to all limits and versions of the currently approved California and Poker games offered at the Casino.
5. All rules and procedures for this promotion will be displayed conspicuously and prominently in The Hawaiian Gardens Casino prior to and at all times the promotion is being offered. Examples of prizes, other than cash, include: chips, merchandise, electronics, and/or clothing.
6. The scoring period in which the prize will be awarded will be decided by casino management and advertised prior to the start of the promotion.

7. The designated prize will be distributed to that table to all active players. A no purchase necessary will be available, with that table number being included on the grid.
8. This promotion will be limited to the first one hundred tables.
9. Only, the players seated at the winning table will each win. The prize will be a fixed and predetermined amount or item ranging in value between \$10 - \$100,000.
10. If the prize is cash, it will be divided equally among seated players at the winning table.
11. If the prize is an item, each seated player at the winning table will receive that prize.
12. Only tables with live games are entered onto the board. If a blank space ends up as a winner, the payout is carried over to the next pay period. If this occurs on the final score, the new table number will be randomly drawn from a bowl of table numbers. For example, ping pong balls containing all the live table numbers participating in the promotion, could be used to select the winning table.
13. Players may change tables at any time during the promotion following existing casino procedures. Only players seated at a winning table at the end of the scoring period will be eligible for the prize.
14. The Casino will fund all the prizes for the promotion. No fee of any type will be collected from players for this promotion.
15. There is not a minimum number of players required to participate in this promotion.
16. A No Purchase Necessary Table will be available.

17. Only live games will be eligible to participate in the promotion.

Tournament tables are not eligible to participate.

18. Employees of Hawaiian Gardens Casino are eligible to participate in the promotion; however, Third Party Proposition players are not eligible to participate.

19. Backline bettors are not eligible to participate in this promotion.

Three Card Poker Progressive Jackpot

Bureau Requirements

Advertising

The Hawaiian Gardens Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-003954) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Hawaiian Gardens Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Administrative fees.
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Three Card Poker Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Hawaiian Gardens Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker 6 Card Bonus (GEGA-000329)

Object and Summary

Three Card Poker Progressive Jackpot considers the best hand possible among each individual player's hand.

- To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the jackpot fee of \$1.
- "Hockey Puck" discs will be attached to the table in front of each betting position. The discs will have a sensor and will detect when a Casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up.
- Once all players have placed their bets and/or jackpot fee, the house dealer will press the "Coin In" button on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then collect all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the gaming table.
- The Casino verifies play through surveillance.
 - Therefore, if the sensor is not functioning properly at the start of the hand the Casino dealer marks the bet by placing either the dollar or a house button on top of the sensor until the hand is over.
- The house dealer then follows standard approved procedures for dealing the base game.
- When a player wins a progressive prize, the house dealer shall press the appropriate button on the keypad and then contact the floor person.
- Once the Casino verifies the progressive win, the floor person shall insert a key and rotate it to the "JPH" position and then press the "J-Pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.

Three Card Poker Progressive Jackpot

- Returning the key to the “Run” position, will restore the normal operation of the table and adjust the meter appropriately for the prize won.
- When the house dealer reconciles all action (on the behalf of the player-dealer), the house dealer then presses the “Game Over” button. This resets the system to being the next hand.

Qualifying Hands

When a player is dealt an ace, king, queen, of the same suit, they are paid the jackpot shown on the progressive meter. Any straight flush, a hand consisting of three cards of the same suit in consecutive ranking, other than ace, king, and queen, receives a fixed amount.

Envy Bonus:

- A player paying the \$1.00 jackpot fee also qualifies to win an envy payout, if another player at that table hits a hand associated with the envy pay. All other players who paid the \$1.00 jackpot fee win the envy bonus. The player with the hitting hand receives the normal prize pay only, and does not receive the envy bonus.
- If a player’s hand triggers an envy bonus payout, the house dealer will leave the hand face-up on the layout; otherwise, the house dealer will lock up the cards and then move to the next player.
- The Envy Bonus is paid regardless, of whether or not the player completes their hand.
- The house dealer pays any envy bonuses at the end of the round. In the event, that more than one player is involved in a qualifying envy pay, then all players will win multiple envy bonus payouts.
- Envy Bonus payouts will be deducted from the Three Card Poker Progressive Jackpot reserve fund.

Note: Envy and Straight Flush payouts of \$100.00 are paid out of the house dealer’s tray after the CSR fills out the prize agreement. The dealer gets the yellow copy in receipt and is then reimbursed at the cage.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- Only seated player who are dealt a designated hand are eligible for payouts.
- A minimum of two players (a player and a player-dealer) are required to play for the progressive jackpot.
- The player must complete their hand in order to be eligible for the progressive payout and fixed prize payout.
- In the event that during a round of play, two or more player have qualifying hands, then each player will receive the prize amount for their designated hand.

All monies collected and paid shall be tracked both electronically and on a handwritten log that will be maintained for examination by regulatory and law enforcement personnel.

Progressive Prize

- When a player is dealt an ace, king, queen of the same suit, they are paid from the progressive jackpot shown on the progressive meter.
- There is no cap to the progressive prize.
- All other hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter.
- In the event, that more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize.

Fixed Prize

When a player is dealt a straight flush, they are paid a fixed prize amount according the Prize Distribution Table.

- All fixed prize payouts will be paid by the Hawaiian Gardens Casino floor person.
- Once the proper paperwork has been filled out, the floor person will pay the winner(s) in Casino chips.
- Straight flush payouts of \$100.00 are paid out of the house dealer's tray after the CSR fills out the prize agreement. The house dealer gets the yellow copy in receipt and is then reimbursed at the cage.
- All fixed prize payouts will be deducted from the amount in the reserve fund.

Prize Payout Structure

When a player is dealt an ace, king, and queen of the same suit, they are paid the jackpot shown on the progressive meter. Any straight flush (a hand consisting of three cards of the same suit, and of consecutive ranking) other than ace, king, and queen, receives a fixed prize amount paid from the reserve fund, according the pay table below. The fixed prize payout is not deducted from the progressive prize meter.

Three Card Poker Progressive Jackpot

Funding

The Hawaiian Gardens Casino will initially seed the jackpot at \$3,000. Once there are sufficient monies in the Three Card Poker Progressive Jackpot reserve fund, the initial \$3,000 will be reimbursed to the Hawaiian Gardens Casino. The Hawaiian Gardens Casino will cover any shortfall.

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- \$0.31 will be immediately posted on the meter.
- \$0.69 will be tracked in the reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot at \$3,000. In addition, this reserve fund will payout all fixed amounts.

Administrative Fees

The Hawaiian Gardens Casino, shall retain an administrative fee of \$8 to \$16 per table hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with the complicated computer systems and program, in addition to the technicians having to service the systems.

No Purchase Necessary

The Three Card Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Equipment

The electronic software and digital reader related to and used in conjunction with the jackpot, which is used on each table for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International (GLI), LLC.

Three of a Kind on the Flop Promotion

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Hawaiian Gardens Casino at all times the gaming activity is being offered for play:

- Eligible games
- Eligible time periods
- Qualifying hand
- Qualifying hand for double prize amount
- Prize amount, description and funding source
 - Hawaiian Gardens Jackpot reserve fund (GEGA-001477)
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Three of a Kind on the Flop Promotion shall be attached to the following Bureau approved controlled games offered at Hawaiian Gardens Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- No Limit Hold'em (GEGA-001465)
- Texas Hold'em (GEGA-001462)
- Limit Buy In, No Limit Hold'em (GEGA-001471)

Object and Summary

Active players in any of the above listed controlled games who have not folded their hand when the house dealer has placed the first three face-up community cards on the table, referred to as "the flop," are eligible to win. Eligible players win when the flop contains the pre-selected and advertised qualifying hand. If any active players fold before the flop, then those active players who have folded will be in-eligible for the promotion. Additionally, there is an opportunity for an active player to be rewarded with twice the amount of the posted by prize by achieving a Four of a Kind using one of their hole cards. The customer service representative on duty will verify the qualifying hand at the table and through video surveillance before any payout is made. The prize will be paid from the cage by the customer service representative on duty to the winning players at the table, once the appropriate paperwork has been completed. - Employees are eligible to play when they are off duty and out of uniform.
- Tournament play does not qualify for this promotion.
- There is no set/fixed amount of time a player must play to be eligible for the promotion.
- The winning or losing of the hand is irrelevant for this promotion. If any active players fold before the flop, then those active players who have folded will be in-eligible for the promotion.
- If a player achieves the Three of a Kind on the Flop Double Prize qualifying hand, the player will only be paid the double prize amount. This prize is funded by the Hawaiian Gardens Jackpot reserve fund (GEGA-001477)

Prize

The prize value will range from \$100-\$10,000. Prizes will include cash, live chips, merchandise, and/or sports and concert tickets. All prizes will be pre-determined and posted in advance. The prize will be paid from the cage by the customer service representative on duty to the winning players at the table, once the appropriate paperwork has been completed. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.



Although the Bureau has approved this jackpot modification, jackpots with an electronic component are currently under Bureau review. The Bureau reserves the right to: (1) review the lawfulness of the modified Ultimate Texas Hold'em Progressive Jackpot; (2) notify all law enforcement agencies and gambling establishments if further review determines the modified Ultimate Texas Hold'em Progressive Jackpot to be unlawful; (3) require gambling establishments to cease and desist offering for play the modified Ultimate Texas Hold'em Progressive Jackpot if found to be unlawful; and (4) take action against those gambling establishments that decline to abide by the Bureau's cease and desist notification.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in the Hawaiian Gardens Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods.
- Qualifying hands and corresponding prize amounts.
- Gaming activity collection fees.
- Prize Payout Structure.
- Availability of No Purchase Necessary.
- Any other restrictions that apply to this gaming activity.

Eligible Controlled Games

The Ultimate Texas Hold'em Progressive Jackpot gaming activity shall be attached to the following Bureau approved games offered at the Hawaiian Gardens Casino, as shown below. The jackpot features a fixed and a progressive jackpot prize. All controlled game rules shall be played as previously approved by the Bureau.

- Ultimate Texas Hold'em (GEGA-003345)

Object and Summary

Ultimate Texas Hold'em Progressive Jackpot considers the best advertised qualifying hand(s) among each individual player's cards.

1. To begin each round, players must make their regular base game wager. The players may optionally place any bonus bets along with the jackpot fee of \$1.00.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players who wish to participate in the jackpot must place the optional jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.



- The house dealer then follows standard approved procedures for dealing the base game. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.

- Only seated players, who have paid the jackpot collection fee and dealt a designated hand, are eligible for payouts.
- Backline bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.
- Casino employees are eligible for the Ultimate Texas Hold'em prize when off-duty and out of uniform.
- A Third-Party Provider of Proposition Player Services (TPPPS) is not eligible to place a jackpot collection fee and become eligible for the Ultimate Texas Hold'em Progressive gaming activity when either in the player-dealer or player capacity.

Prize

Fixed Prizes

All fixed payouts will be paid by a Casino floor person. See the Ultimate Texas Hold'em Progressive Jackpot Qualifying Hands payable above for qualifying hands and payouts.



Progressive Prizes

A Royal Flush pays 100% of the progressive jackpot amount shown on the progressive meter.

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise for examination by regulatory and law enforcement personnel.

Prize Payout Structure

Once the proper paperwork has been filled out, the floor person will pay the winner(s) in live casino chips. Payouts will not be made from the house dealer's tray unless they are under \$600.

If the payout is under \$600 and made from the house dealer's tray, the house dealer shall be reimbursed at the cage. All fixed payouts will be deducted from the amount in the reserve fund. *This payout shall be documented appropriately in the accounting records.*

- All fixed jackpot qualifying hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall.
 - Each player who placed the \$1.00 wager receives the \$1,000 prize for the community royal flush.
- The progressive jackpot qualifying hand is paid the total amount shown on the progressive meter.
- In the event more than one progressive meter pay or any other qualifying hand hits during the same round, all winning players will be paid the posted progressive prize or the posted fixed amount.
- When more than one progressive meter pay hits, one progressive pay will be paid from the meter and the others will be paid from the reserve fund.
- In the event the reserve fund is depleted, the Casino will make up any shortfall. All hands will be paid the posted prize.

Funding

The Casino will initially seed the jackpot in an amount between \$1,000 and \$100,000. Once there are sufficient monies in the Ultimate Texas Hold'em Progressive Jackpot fund, the initial seed will be reimbursed to the Casino and shall be documented in the accounting records. After the progressive jackpot is hit, it will be re-seeded by the reserve fund in an amount between \$1,000 and \$100,000. The progressive prize pool shall increase daily based solely on the number of jackpot collection fees placed and collected each day. Furthermore, there is no cap on this progressive prize pool.

Each \$1.00 jackpot fee paid by a player will be broken down as shown in the payable below.

Administrative Fees

The Casino will take an administrative fee ranging from \$8-\$16 per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the costs associated with maintaining and servicing the computer systems.

No Purchase Necessary

The Ultimate Texas Hold'em Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**, to patrons who wish to participate in a No Purchase Necessary game. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Ultimate Texas Hold'em Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Equipment

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
2. The house dealer shall then contact the floor person.
3. Once the Casino verifies the progressive win, the floor person shall insert the key and rotate it to "JPH" and then press "J-pot" button. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
4. Returning the key to the "Run" position will restore normal operation of the table, and adjust the meter appropriately for the prize won.
5. When the house dealer reconciles all action (on behalf of the player-dealer), he/she presses "Game Over." This resets the system to begin the next hand.
6. Once the "J-pot" button is pressed, the prize is logged into Game Manager.

“WHEEL OF CARDS” DRAWING PROMOTION

Hawaiian Gardens Casino is pleased to sponsor the “Wheel of Cards” promotions described in these Rules. There are two versions of this promotion.

From time to time, as determined by the Casino in its discretion and announced in advance, customers on the premises of the Casino may have the opportunity to spin the Casino's Wheel of Cards and win prizes.

Qualifications

There are two different ways to get to the Wheel. Only one way will be offered at any one time. Either way will be available to all qualifying customers, including at no cost to any player who requests the opportunity to play at a No Purchase Necessary (“NPN”) table. Please see the rules below for more details.

A. Table Drawing: Participants become eligible for one spin of the Casino's Wheel of Cards (“Wheel”) when a Shift Manager draws a marked Ping-Pong ball from a drum. Ping-Pong balls will be marked with numbers that correspond with the number on active tables (including NPN tables), and then placed in a drum which will be conspicuously displayed to all participants. When the Shift Manager draws a ball from the drum, the table with the matching number becomes eligible, whereupon, the CSR (Customer Service Representative) will spread up to a maximum of nine (9) cards, numbered Ace through Nine, at the eligible table. Every player at the eligible table is qualified to participate if he or she was dealt an active hand at that table prior to the ball being drawn from the drum. This is intended to prevent “table hopping.” The player who draws the Ace card from the cards spread may spin the Wheel of Cards, as described below; keeping the value

awards. The awarded monetary prizes will be divided *equally* among all qualified participants at that table.

NPN: Any one who wishes to do so, may, at no cost, request that a NPN table be activated before the time of the drawing from the drum, and the number matching the instructional table will be included among the Ping-Pong Balls placed into the drum before the drawing of the ball. If the number on the Ping-Pong Ball that is drawn from the drum matches the number at the instructional table, then the players at the instructional table are qualified to participate. If there is only one player at the NPN, then the CSR will spread as many cards on the instructional table as the CSR would spread at the live table playing the same game as the customers at the instructional table requested to play. If there is more than one live table active with the same game in play at the time of the drawing, then the CSR will spread as many cards as there are players at the most occupied matching live table. In any drawing, at least one card spread will be an Ace. If there is more than one player at the NPN before the ball is drawn from the drum, the CSR will spread as many cards as there are players, up to a maximum of nine cards, starting with Ace through Nine. Every player at the eligible table is qualified to participate if he was dealt an active hand at that table prior to the ball being drawn from the drum. This is intended to prevent "table hopping." The player who draws the Ace card from the cards spread will spin the Wheel of Cards, as described below; keeping the value awards. The awarded monetary prizes will be divided *equally* among all qualified participants at that table.

- B. Computerized Player Tracking Drawing:** Every customer at the Casino may request a free, no cost, Player Club Card from the Card Desk at any time by filling out a simple form with his or her name, address and identification (see sample below). The Club Card barcode contains information as to the

player's identification and pin number. A player can use the Club Card with the pin number to check on his accrued playing time. Once a player is issued a Club Card, then the player becomes eligible to participate in the Player Tracking Drawings, whether playing at the live tables or at a NPN table. During the drawing promotion, players who wish to participate in the drawing must have their Player Club Cards swiped hourly by the Floor Managers. Once the card is swiped, a player receives a computerized entry recording his accrued time at any gaming table or non-fee instructional table, equal to one (1) entry point for each complete hour of play at any table during the drawing promotion period. Each completed hour of play will add one (1) entry point. The more entry points a participant accrues, the greater his chances of his Club Card number being selected by the computer. At the designated time, posted in advance and conspicuous throughout the Casino floor, the computer will randomly "draw" a Club Card number, chosen from among the Club Cards that were swiped during the particular drawing promotion period which reflect at least one entry point. The player whose Club Card number is selected by the computer will spin the Wheel of Cards. In this version of the drawing, the player who spins the Wheel is not required to divide the awards and prizes earned with other players.

Rules

(Note: The Rules Apply To Both Versions Of The Wheel of Cards Drawing Promotion)

1. The versions of the drawing promotions described above offered by the Casino will be announced in advance and notice will be posted in plain view of the Casino floor, along with the rules for play. Only one version will be offered at a time.

2. Drawing times and awards will be posted throughout the Casino in plain view of the Casino floor, as well as announced and/or advertised, prior to drawing.
3. The "Wheel of Cards" is a large, circular disk with a pointer and pegs attached which divide the wheel into sixty (60) equally spaced sections. Each section of the wheel is decorated with a facsimile of a playing card or a value award. Fifty-two (52) sections of the wheel depict playing cards (one of each card from a deck of regular poker cards). Eight (8) sections depict *value awards* which include, two (2) sections for Hawaiian Gardens Casino logo baseball caps, two (2) sections for Hawaiian Gardens Casino logo polo shirts, two (2) sections for dinner for two at the Hawaiian Gardens Casino restaurant, the Ka'anapali Lounge, and two (2) sections are for Hawaiian Gardens Casino logo jackets. The value awards may change from time to time, without notice.
4. When winning the opportunity to spin the Wheel, either through the Table Drawing or Computerized Player Tracking Drawing described above, the eligible participant will have one (1) opportunity to spin the Wheel at least five (5) times. Each card section that the Wheel's pointer points to will be recorded by Casino personnel until the pointer has indicated five (5) card sections, so that a hand of five (5) cards has been spun and recorded. If the Wheel points to a card that has already been recorded, the person may spin again until the Wheel points to a different card. Once the person has landed on five (5) different card sections, the person will be eligible for a *monetary award* based on the cards in the person's "hand," according to the Chart attached hereto, which is a sample of the Chart to be posted at the Casino in advance. The value of the possible winning hands will be

posted in full view of the Casino floor prior to and during the spinning of the Wheel. Once the person spinning the Wheel has landed on five (5) different card sections, his or her opportunity to spin the Wheel ends. In addition, the person spinning the Wheel will receive all of the value awards that the Wheel points to during the spinning session.

5. Possible value awards and cash prizes for the hands spun on the Wheel will be posted in plain and full view of the Casino floor prior to the promotion and may be announced and advertised in advance of the promotion.
6. There may be more than one pre-announced drawing period in a twenty-four (24) hour day. Therefore, a customer can be eligible more than once in a twenty-four (24) hour day, depending on the number of pre-announced drawing periods that the customer qualifies for. However, regardless of how many times a customer qualifies to spin the Wheel, no one may spin the Wheel more than one (1) time in any twenty-four (24) hour calendar day. For example, if a customer has already spun the Wheel, and his Club Card is selected by the computer during the same twenty-four (24) hour day, the customer will not be eligible to spin the Wheel, and the computer will select, at random, a Club Card number belonging to a different customer, who will be eligible to spin the Wheel. The same rules apply for each of the versions of this drawing.
7. Drawing Promotion participants must be present in the Casino at the time of the drawing and *immediately* furnish proper photo identification (such as unexpired driver's license or California DMV issued identification, unexpired passport, unexpired military identification) to be eligible to spin the Wheel and/or receive any award. If the winner cannot furnish proper identification, or if no one

claims an award, then a new drawing will be held as soon as possible. No further notice will be given by the Casino to any promotion winner.

8. Forms for the Player Club Cards must have been completely filled out in advance of the drawing, with accurate identification, including full name, current residence address, and I.D. information for the player to be eligible to spin the Wheel.
9. A person must be 21 years of age or older to participate in any Casino promotion including the Wheel. Casino employees are not eligible for this promotion.
10. The Casino reserves the right to cancel promotions at any time, and to modify promotions and game rules as approved in advance by the Division of Gambling Control.

Bureau Requirements

Advertising

Hawaiian Gardens Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-003976) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hawaiian Gardens Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Prize payout structure
- Gaming activity jackpot fees
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

Eligible Controlled Games

The Fortune Pai Gow Poker Progressive shall be attached to the following Bureau approved controlled games offered at Hawaiian Gardens Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Pai Gow Poker with the Fortune Bonus Bet (GEGA-002814)

Object and Summary

The Fortune Pai Gow Poker Progressive considers the best qualifying hand possible among each individual player's cards.

1. To begin each round, players must make their regular base game wager. They may optionally place any bonus bets along with the optional jackpot fee of \$1. A minimum of two players are required to play for the progressive jackpot.
2. "Hockey Puck" discs will be attached to the table in front of each betting position. These discs have a sensor and will detect when a casino chip is placed on them. Players who wish to participate must place the optional jackpot fee on the sensor. The sensor will then light up.
3. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees shall be dropped into a separate and locked jackpot collection box and accounted for separately.
4. The house dealer then follows standard approved procedures for dealing the base game. All seven cards will be considered with the five card and two card hand. A player can qualify for the jackpot element of the game regardless of the outcome of the base game.
5. When a player has achieved a winning hand, the house dealer shall press the appropriate button on the keypad. A casino representative will then be responsible for verifying the winning hand.

Players that make one of the advertised qualifying hands, as shown below, will be eligible to win their share of the posted prize amount, according to the payout options, as shown below. All qualifying hands must be offered together at all times this gaming activity is offered for play.

Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Only seated players who are dealt a designated hand and placed the optional jackpot fee are eligible for payouts.
- Backline bettors are not eligible to place a jackpot collection fee or receive the prize amount for a qualifying hand.
- A minimum of two players are required to play in order to be eligible for the jackpot.
- There is no limit to the number of times a player can win a fixed or progressive prize during this promotion.
- Players do not need to win the hand to qualify for a fixed or progressive prize.
- Casino employees are eligible for the Fortune Pai Gow Poker Progressive only when off duty and out of uniform.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to place a jackpot fee or become eligible for the Fortune Pai Gow Poker Progressive.
- Tournament games are not eligible for this promotion.
- Players who are playing multiple hands can place a jackpot fee and win on each hand.
- The player-dealer position is eligible to place a jackpot fee or win this promotion.

Prize

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

- A 7 Card Natural Straight Flush hand will pay 100% of the progressive jackpot amount shown on the progressive meter, as shown below in the 7 Card Natural Straight Flush Payout Table.
- A 7 Card Wild Straight Flush is paid 25% of the progressive jackpot amount shown on the progressive meter.
- A 5 Aces hand is paid 10% of the progressive jackpot amount shown on the progressive meter.

Fortune Pai Gow Poker Progressive

- All fixed hands are paid from the reserve fund. They do not get deducted from the amount shown on the meter. In the event the reserve fund is depleted, the Casino will make up any shortfall. The payouts will not be made from the house dealer's tray unless they are under \$600. If the payout is under \$600 and made from the House dealer's tray, the House dealer's tray will be reimbursed at the cage.
- All payouts will be paid by a casino representative. Once the proper paperwork has been filled out, a casino representative will pay the winner(s) in live casino chips.
- In the event more than one progressive meter qualifying hand hits during the same round, all winning players will be paid the posted progressive prize. One progressive pay prize will be paid from the meter and the others will be paid from the reserve fund. In the event the reserve fund is depleted, the Casino will make up any shortfall. The room share will be paid once.
- In the event more than one fixed qualifying hand hits during the same round, all winning players will be paid the posted fixed prize from the reserve fund. In the event the reserve fund is depleted, the Casino will make up any shortfall.

Prize Payout Structure

When a player(s) achieves a 7 Card Natural Straight Flush hand, 100% of the posted progressive meter prize shall be awarded as structured below in the 7 Card Natural Straight Flush Payout Table. The player dealt the hand will receive a percentage of the total progressive amount. The remaining percentage shall be evenly divided and distributed amongst all players who placed the optional Fortune Pai Gow Poker Progressive jackpot fee at all eligible tables when the qualifying hand was hit, known as the room share. The full amount of the progressive prize will be prominently displayed at all times the gaming activity is being offered for play. Only one of the options listed below can be utilized at any one time, and it must be prominently posted on the casino floor.

Funding

The Fortune Pai Gow Poker Progressive is a player funded jackpot with both fixed and progressive elements, which is funded by an optional \$1.00 jackpot fee. The Casino will initially seed the jackpot at an amount between \$1,000 to \$100,000. Once there are sufficient monies in the Fortune Pai Gow Poker Progressive reserve fund, the initial seed will be reimbursed to the Casino from the reserve fund and will be documented in the accounting records. The Fortune Pai Gow Poker Progressive does not have a prize cap.

After the progressive jackpot is hit, it will be re-seeded from the reserve fund at an amount between \$1,000 to \$100,000. In addition, this reserve fund will payout all fixed prize amounts. In the event the reserve fund is depleted, the Casino will make up any shortfall. All increases and decreases to the Fortune Pai Gow Poker Progressive reserve fund will be documented in the accounting records.

Fortune Pai Gow Poker Progressive

The progressive prize meter shall increase daily based solely on the number of jackpot collection fees placed and collected each day. Each \$1.00 jackpot fee will be broken down as follows:

- a. \$0.14 will be immediately posted on the meter.
- b. \$0.86 will be tracked in a reserve fund.

All monies collected and paid out shall be tracked both electronically and on a hand written log that shall be maintained by the gambling enterprise, for examination by regulatory and law enforcement personnel.

Administrative Fees

The Casino will retain an administrative fee ranging in an amount between \$8 and \$16, taken per table per hour. The administrative fee will be taken from the reserve fund. The fee will cover the cost associated with the computer system and program in addition to technicians having to service the systems.

No Purchase Necessary

The Fortune Pai Gow Poker Progressive shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Fortune Pai Gow Poker Progressive. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Equipment

The electronic software and digital reader related to and used in conjunction with this gaming activity has been tested, approved, and certified by the Gaming Laboratories International LLC (GLI). If there is a malfunction or the digital reader breaks a dice cup will be used.

- When a player has a progressive qualifying hand, the house dealer will press the appropriate hand button on the keypad.
- The house dealer will then contact a supervisor.
- Once a supervisor verifies the progressive win, the supervisor will insert the key and rotate it to "JPH" and then press "J-pot" button. This records the win onto the Game Manager computer. House procedures are then followed for paying the prize.
- Returning the key to the "Run" position will restore normal operation of the table and adjust the meter appropriately for the prize won.
- When the house dealer reconciles all action, they press "END GAME." This resets the system to begin the next hand.
- Once the "J-pot" button is pressed, the prize is logged into the Game Manager..
 - If the progressive pay needs to be backed out (voided) at this point, the prize will need to be manually backed out using the Game Manager manual adjustment feature.
