

## **Three Card Poker Progressive Jackpot**

### **Bureau Requirements**

#### **Advertising**

The Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001268) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands and corresponding prize amounts
- Administrative fees
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Three Card Poker Progressive Jackpot shall be attached to the following Bureau approved controlled games offered at Hotel Del Rio & Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Three Card Poker 6 Card Bonus (GEGR-002172)

#### **Object and Summary**

This promotion is attached to the base game of Three Card Poker 6 Card Bonus. The players participate by paying \$1.00 jackpot entry fee per hand. The Progressive Jackpot awards three types of prizes.

1. A participating player wins a progressive jackpot by acquiring a specific hand in their initial three cards.
2. A participating player wins fixed cash prizes for acquiring specific hands in their initial three cards.
3. A participating player wins an Envy payout if any other player (excluding the play-dealer) wins the Progressive Jackpot.

To begin each round, players must make their regular base game wager. They may optionally place any bonus bet wagers along with the jackpot fee of \$1.00. A minimum of two players, a player and a player-dealer, are required to play for the Progressive Jackpot. The maximum number of players involved corresponds to the maximum number of players to participate in the base game of Three Card Poker 6 Card Bonus. The amount is collected from each player by placing their chip in the electronic "hockey puck" wagering circles on the gaming table. These wagering circles have a sensor and will detect when a casino chip is placed on them. Players must place the optional jackpot fee on the sensor. The sensor will then light up. Once all players place their bets and/or jackpot fee, the house dealer will press "Coin In" on the keypad. The sensors will then light up, indicating participation in the progressive jackpot. The house dealer will then remove all jackpot fees from the table. The jackpot fees are dropped in a separate and locked jackpot collection box affixed to the left side of the gaming table. The electronic software and digital reader related to and used in conjunction with this jackpot, which

is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI). The house dealer then follows standard approved procedures for dealing the base game.

### Qualifying Hands

When a player is dealt an ace, king, queen, of the same suit, they are paid from the progressive jackpot shown on the progressive meter. Any Straight Flush, a hand that consists of three cards of the same suit in consecutive ranking, other than ace, king and queen, receives a fixed prize amount according to the pay table below.

Hand	Payout/Prize	Envy Payout/Prize
Ace, king, queen of the same suit	100% of Posted Prize	\$25 - \$500
Straight flush	\$25 - \$350	\$0

### Envy Bonus:

- A player paying the \$1.00 jackpot fee also qualifies to win an envy payout. If another player at the table hits a hand associated with an envy pay, all other players who paid the \$1.00 jackpot fee win the envy pay. The player hitting the hand received the progressive jackpot prize pay only, but does NOT receive the envy pay.
- If a player's hand triggers an envy payout, the house dealer will leave the hand face-up on the layout; otherwise, the dealer will lock up the cards. The house dealer will then move on to the next player.
- All Envy Bonus payouts will be paid by a casino representative at the end of the round. Once the proper paperwork has been filled out, the casino representative will pay the winner(s) in live casino chips. The payouts will not be made from the house dealer's tray. All Envy Bonus payouts will be deducted from the amount in the reserve fund.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- When a potential prize-eligible circumstance arises, an authorized casino representative will verify that all conditions are met. The Casino may opt to review footage from surveillance before payout commences. The deck used in play may be sorted to verify integrity.
- The Casino reserves the right to photograph hand(s) in question, inspect all qualifying hands, and to refuse payment of a prize if it is determined that proper rules and procedures were not followed and/or cheating has occurred. The Casino will maintain records, including available surveillance footage, of all instance where the prize was not paid for the purposes of future Bureau of Gambling Control review.
- All necessary forms will be filled out by the players according to IRS requirements before any prizes are awarded. Any necessary forms of identification as designated by casino policy will be verified. After all conditions are met, the employee will declare that the jackpot is valid and the payout commencement will begin.

## Three Card Poker Progressive Jackpot

- If a player cannot provide proper documentation to claim their prize, they will have ninety (90) calendar days to obtain the required documentation. Their share shall be set aside by the casino and paid once IRS requirements have been met. In the event that the player cannot provide the necessary forms, the casino will absorb the forfeited funds.
- Casino employees are not eligible for the Three Card Poker Progressive Jackpot when on duty.
- Third-Party Provider of Proposition Player Services (TPPPS) employees are not eligible for the Three Card Poker Progressive Jackpot when on duty.
- Tournament games do not apply.

### **Prize**

The prize may be cash, merchandise, food, event entries, coupons, tickets, vehicles/recreational transport, live casino chips and/or entry into tournaments. The prize ranges from \$100 up to 100% of the amount in the Progressive Jackpot fund. The prize pool increases when players opt to pay the entry fee for the next hand. The prize has the following payouts:

### **Progressive Payout**

- The 100% progressive payout winning hand is paid the progressive jackpot shown on the progressive meter prominently displayed on the gaming table. This hand is called a "Mini-Royal Flush". In the event of a tie hand in the 100% Progressive payout, the prize shall be equally divided among the eligible participants, rounded down to the nearest dollar. Leftover funds will be distributed clockwise starting from the player-dealer until the entire jackpot amount is disbursed.

### **Fixed Payout**

- A winning hand of a non-royal Straight Flush is paid a fixed value from the reserve fund ranging from \$25 to \$350, to be determined by the casino prior to commencement of the promotion. In the event two or more players have qualifying hands during a round of play, each player will receive the posted prize amount for their designated hand.

### **Additional Payouts**

- A participating player wins an Envy payout with a fixed value ranging from \$25 to \$500 if any of the players (excluding the play-deal) wins the progressive jackpot. The player dealt the Mini-Royal Flush hand receives the jackpot progressive payout only but does not receive the Envy payout.

### **Funding**

The Hotel Del Rio & Casino guarantees the initial seed money of the Progressive Jackpot at \$100 - \$5,000. Once there is a sufficient amount of money in the Three Card Progressive Jackpot fund, the initial \$5,000 will be reimbursed to the Hotel Del Rio & Casino.

Each \$1.00 jackpot fee paid by a player will be broken down as follows:

- \$0.31 will be immediately posted on the meter.
- \$0.69 will be tracked in a reserve fund. The reserve fund will be utilized to immediately reseed the metered progressive jackpot prize. In addition, this reserve fund will payout all fixed amounts.

## Three Card Poker Progressive Jackpot

Gaming day revenues are calculated on the next business day. At the end of each gaming day, the Three Card Poker Progressive Jackpot drop box will be collected and delivered in the designated secured count room. Under the surveillance cameras, the count team will then empty all chips from the Jackpot drop box onto the count table. Chips will be counted and recorded on a Count Room Drop Box log. The designated agent in charge of receiving revenue gaming chips counted will then record the Three Card Poker Progressive Jackpot monies into the appropriate sections on the Progressive Jackpot log and Reserve fund log accordingly. A log is recorded in the cage.

In the event that the Progressive Jackpot is awarded to a player, the prize pool will be reseeded from a player-funded reserve account with \$100 - \$5,000. In the event there is not enough in the reserve account, the Casino will reseed the prize pool and will be reimbursed the reseed amount in the exact manner as the initial seed amount.

### **Administrative Fees**

The Casino shall retain an administrative fee of \$10 to \$20 per table per hour from the reserve fund. The administrative fee shall be utilized to cover expenses incurred by the Casino for administering the Three Card Poker Progressive Jackpot.

### **No Purchase Necessary**

The Three Card Poker Progressive Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Three Card Poker Progressive Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

### **Equipment**

An electronic meter will be on display in clear view of the gaming table. Also, a "hockey puck" style wagering circle will be used for placement of the \$1.00 jackpot fee.

The electronic software and digital reader related to and used in conjunction with this jackpot, which is used on each table eligible for this jackpot, has been tested, approved, and certified by the Gaming Laboratories International, LLC (GLI).

1. When a player has a progressive winner, the house dealer shall press the appropriate hand button on the keypad.
2. The house dealer shall then contact the floor person.
3. Once the Casino verifies the progressive win, the floor person shall select the appropriate hand button then swipe the electronic access card. This records the win onto the Game Manager. House procedures are then followed for paying the prize.
4. Processing the jackpot through the computer system will restore normal operation of the table, adjust the meter appropriately for the prize won, and reset system for the next hand.

# Splash Pot Promotion

## **Bureau Requirements**

### **Advertising**

The Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001267) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Eligible time period(s)/qualifying event(s)
- All specific qualifying conditions
- Amount to be added to the pot (prize amount)
- No Purchase Necessary Information
- Any other restrictions that apply to this gaming activity

### **Eligible Controlled Games**

The Splash Pot Promotion shall be attached to the following Bureau approved controlled games offered at Hotel Del Rio & Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000843)
- Omaha (GEGR-002170)

### **Object and Summary**

At the predesignated time, all players will be dealt a hand in the base game in operation. The player(s) who obtain the highest required hand ranking at the end of the hand will win the posted prize. The Casino may opt to offer this promotion face-up with no wagering on the pot, or face-down with regular wagering involved.

The Splash Pot Promotion gaming activity features a promotional element which shall be attached to the above listed approved controlled games at the Casino. During predetermined times and intervals of the promotional period, a casino representative shall splash the pot by adding a predetermined and posted prize to the pot at the start of the hand.

The qualifying times for the promotion will be determined by the following method:

- The prize will be added to the pot at designated times and days which will be clearly specified and announced to the players beforehand.

During the predetermined times and intervals of the promotional period, a casino representative shall announce the commencement of the drawing before commencing with the splashing of the pot. When more than one eligible table is running, a card drawing method will be used to determine the table that receives the "Splash Pot." In the event of a tie, the suit of the cards will be considered, with Spades being the highest, then Hearts, then Diamonds, and then Clubs being the smallest. The cards, which are pre-printed, equally sized and colored, shall be drawn by an applicable casino representative that represents each eligible table. The highest ranked

card drawn will be allocated the "Splash Pot." The live casino chips will be placed in the center of the table in the same location as a typical pot for a poker hand. The hand will then be dealt normally but as a "free hand." The button will not move after the hand, no binds will be posted and no collection will be collected. Once the promotion has ended all procedures and play shall proceed as normal.

### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Any player dealt in during the previous hand is eligible for the Splash Pot Promotion.
- The Casino may opt to review footage from surveillance before payouts commence.
- The Casino reserves the right to photograph hand(s) in question, inspect all qualifying hands, and to refuse payment of a prize if it is determined that proper rules and procedures were not followed and/or cheating has occurred. The casino will maintain records, including available surveillance footage, of all instance where the prize was not paid for the purposes of future Bureau of Gambling Control review.
- Any necessary forms of identification as designated by casino policy will be verified.
- Winner must be present.
- Casino employees are eligible for the Splash Pot Promotion whether they are on or off duty and in or out of uniform.
- Tournament games are eligible.
- In the event the hand is a tie, the prize shall be split equally between the eligible winners. If the prize is merchandise, all winning hands will receive the posted prize.
- The minimum and maximum players involved correspond to the necessary amount of players needed to participate in the attached base games.

### **Prize**

The fixed prize for the Splash Pot Promotion shall be a fixed amount ranging from \$1 - \$500. The prize shall be paid in the form of cash, merchandise, food, event entries, coupons, tickets, vehicles/recreational transport, live casino chips and/or entry into tournaments. 100% of the designated prize will be awarded to the winner.

### **Funding**

Splash Pot Promotion is house funded. There shall be no additional jackpot fees or collection fees taken in order to fund this gaming activity or for players to participate.

### **Administrative Fees**

Hotel Del Rio & Casino shall not retain an administrative fee because the promotion is house-funded. No additional fees shall be taken for this promotion.

### **No Purchase Necessary**

The Splash Pot Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Splash Pot Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## **Aces Cracked Bonus**

### **Bureau Requirements**

#### **Advertising**

The Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004446) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Qualifying hands
- Prize amount and prize description
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Aces Cracked Bonus gaming activity shall be attached to the following Bureau approved controlled game offered at the Hotel Del Rio & Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000843)

#### **Object and Summary**

The Aces Cracked Bonus gaming activity features a fixed prize element attached to Texas Hold'em. A prize is awarded to players participating in an eligible game when a hand containing a Pocket Pair of aces is beaten by a better hand at the showdown. In all instances, patrons shall be provided with ample advance notice of the rules and restrictions in order to qualify for the Aces Cracked Bonus gaming activity.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is a minimum of two players required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the promotional prize
- When a qualifying hand is announced, a casino representative will verify that the hand qualifies. Any deviation from a standard deck will nullify the prize.
- In order to qualify for the promotion, the player dealt the qualifying losing hand must use both hole cards.
- In order to qualify for the promotion, the player must complete the play on all four rounds of the hand, which includes the pre-flop, the flop, the turn, and the river, and not fold their hand.
- In order to qualify for the promotion, both players must complete all applicable bets. If the player goes all-in, this is considered to have completed all bets.
- In order to qualify for the prize, the player must lose the hand at the showdown, after the final round of betting.

## **Aces Cracked Bonus**

- In the event that during a round of play, two or more players have qualifying hands, each qualifying hand will receive the full amount of the promotion.
  - In the event there is an odd number of chips, the odd chip will be awarded to the player that is closest in position to the action button.
- There is no limit to the amount of times a player is eligible to win a prize during any given promotional period.
- Tournament games are not eligible for this promotion.
- Casino employees are eligible to participate in the promotion when they are on or off duty and in or out of uniform.

### **Prize**

A player that receives the qualifying losing hand will receive a fixed amount ranging from \$5 - \$500,000 in the form of cash or live casino chips. All prizes for this gaming activity shall be predetermined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

A casino representative will pay all prizes. The hand time, date, and winning player name will be recorded at the cage or at the designated location to be turned in to the cage for daily accounting purposes. The casino representative will pay the winner(s) in cash or live casino chips that will be placed in their chip stack.

### **Funding**

The Aces Cracked Bonus gaming activity shall be fully funded by the Hotel Del Rio & Casino. At no time will any fees be collected from the players for the purpose of funding the promotion.

### **Administrative Fees**

The Casino shall not retain any administrative fee, as this promotion is house funded.

### **No Purchase Necessary**

The Aces Cracked Bonus gaming activity shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Aces Cracked Bonus. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.



## **Match Play Coupon Promotion**

### **Bureau Requirements**

#### **Advertising**

Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001272) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Value of the coupons
- Any applicable collection fee required to be paid
- Procedures for players to redeem coupons
- Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The Match Play Coupon promotion shall be attached to the following Bureau approved California games offered at Hotel Del Rio & Casino at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

#### **Object and Summary**

Patrons may receive Match Play Coupons via, advertisements in magazines, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament. The Match Play Coupons can only be used in conjunction with a live bet of the same or greater value than the printed required minimum wager amount.

- Match Play Coupons are used in live games exactly like regular chips; the difference being they must have a matching live bet and cannot be exchanged for cash.
- All Match Play Coupons used to place a wager are collected after the round of play concludes regardless if the hand wins or loses. However, if the hand is a push (tie) the coupon may be replayed again.
- In conjunction with a minimum wager, players can use the coupon to place a higher bet up to the face value of the coupon.
- Only one Match Play Coupon can be played at a time.
  - Players place their Match Play Coupon along with the live bet in the same betting circle.

## Match Play Coupon Promotion

- If the wager wins, the player will be paid the amount of the live bet plus the amount stated on the Match Play Coupon by the player-dealer. The Match Play Coupon will be collected by the person in the player-dealer position. The player-dealer will then have a casino representative verify the coupon has been played and won.
- The coupons shall only be redeemed by the player-dealer after having been played and won and verified by an employee and exchanged for the amount listed on the coupon(s) in cash to the person in the player-dealer position.
- If the wager loses, the Match Play Coupon will be collected by the house dealer (and cannot be used again) and the live bet is collected by the player-dealer.
- If the wager is a tie, the coupon can be replayed.

**EXAMPLE:** *A person receives a Match Play coupon with a value of \$5 with a required wager value of \$0.00 that specifically states it may be used to place a wager on the Pai Gow Poker table. The person would place the coupon on the gaming table; place a bet that matches (or is greater than) the amount on the coupon, and pay the posted collection (if applicable) for a single hand of play. If the player wins the hand, they will receive \$0.00 for their base game wager and an additional \$5.00 for the Match play, just as if they had placed a \$5.00 wager and the player-dealer will collect the coupon.*

### **Eligibility Requirements**

This gaming activity shall be open to all players who are playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- A minimum of two players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Each coupon will state the specific qualifying game(s) a player may use the coupon at.
- Match Play Coupons cannot be used for collection fees or to place a jackpot/promotion bet or fee.
- Match Play Coupons can be used by backline bettors to place a bet.
- Match Play Coupons are valid only for the hours of the day in which they may be used as well as the expiration date printed on the coupon.
- Players who receive a Match Play Coupon will be eligible to win the specific amount printed on the coupon if they placed the minimum wager on a predesignated game table printed on the coupon.
- Tournament games are not eligible for this promotion.
- Casino employees are not eligible for this promotion while on duty.
- TPPPS are not eligible for this promotion while on duty.

### **Prize**

The Match Play Coupon shall have a specific cash value ranging between \$5 and \$500 per coupon. When a player uses the Match Play Coupon to place a wager and wins the wager, they will win the amount of the Match Play Coupon in live cash.

### **Funding**

The Match Play Coupon promotion shall be fully funded by Hotel Del Rio & Casino.

### **Administrative Fees**

Hotel Del Rio & Casino shall not collect any additional fees for the Match Play Coupon Promotion as it is house funded.

## **Match Play Coupon Promotion**

### **No Purchase Necessary**

The Match Play Coupon Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## **Bureau Requirements**

### **Advertising**

Hotel Del Rio & Casino may advertise various names for this gaming activity. Should Hotel Del Rio & Casino advertise a different name, the BGC ID (GEAR-001271) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Requirements for qualifying hands
- Whether the prize will increase every twenty-four hours, weekly, or monthly
- Qualifying hands and corresponding jackpot prize amounts
- Availability of No Purchase Necessary
- Any other restrictions that apply to this jackpot

### **Eligible Controlled Games**

The Bonus Hand Progressive shall be attached to the following Bureau approved controlled games offered at Hotel Del Rio & Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000053)

### **Object and Summary**

The Bonus Hand Progressive features a progressive jackpot prize that is awarded to a player that achieves a qualifying hand.

1. To determine qualifying hands, the following procedures will be used:
  - a. Each player will use two hole cards and three community cards to complete their five-card hand for the purpose of this gaming activity.
2. All prize amounts will be paid by a casino representative. Once the proper records have been completed.

### **Qualifying Hands**

Players who make one of the following advertised qualifying hands, with all requirements satisfied, are eligible to win the posted prize amount. The qualifying hand(s) and corresponding prize amounts will be displayed prominently within Hotel Del Rio & Casino at all times while this gaming activity is being offered for play. Only one of the qualifying hand options below shall be offered at any one time.

### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players must be seated and playing at a designated table in order to qualify for this gaming activity.
- Players must be present to win a prize.
- The progressive prize shall increase every twenty-four hours, weekly, or monthly. The time will be predetermined and posted before the promotion starts.
- If a player cannot provide proper documentation to claim their prize, they will have ninety (90) days to return and claim the prize with their required documentation. If the player does not claim the prize within the ninety (90) days, the prize will be returned to the prize fund.
- In order to qualify for this gaming activity, the player must use their two hole cards.
- There is no minimum amount of players required to be seated and actively playing in an above mentioned game for the table to qualify for the jackpot other than what is required in the base game.
- In the event two or more players make a qualifying hand, all qualifying players will share the posted cash prize amount divided equally. In the event of a prize that is not divisible (*Example: merchandise, etc*), each qualifying player will win the posted prize amount. Any odd chip amount shall be awarded to the first player clockwise from the dealer button.
- When a qualifying hand is announced, a casino representative will verify that the hand(s) qualify. Any deviation from a standard deck will nullify the gaming activity. The Casino may opt to review footage from surveillance before payouts commence.
- The player(s) with the qualifying hands must complete the applicable bets on each round in order to qualify for the jackpot. No minimum round is required as long as all applicable bets are made (*Example: Players going All-in are eligible*). If a player folds a hand that would eventually qualify, they are not eligible for a qualifying hand. A player does not have to win to be eligible if the applicable bets are made as described above.
- There is no restriction on the number of times a player may qualify for or win a prize.
- Casino employees are eligible for this promotion while on or off duty.
- Tournament games do not qualify for the gaming activity.

### Prize

The Casino shall reseed the progressive prize pool at an amount ranging from \$100 to \$5,000 after the Bonus Hand Progressive is hit.

### **Funding**

The Bonus Hand Progressive will be fully funded by the Casino. There will be no additional fees or collections taken for this gaming activity.

### **Administrative Fees**

Hotel Del Rio & Casino will not retain any administrative fees as this gaming activity is house funded.

### **No Purchase Necessary**

The Bonus Hand Progressive shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Bonus Hand Progressive. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# Bad Beat Jackpot

## **Bureau Requirements**

### **Advertising**

Hotel Del Rio & Casino may advertise various names for this gaming activity. Should Hotel Del Rio & Casino advertise a different name, the BGC ID (GEAR-001270) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Requirements for qualifying hands
- Qualifying hands and corresponding jackpot prize amounts
- Availability of No Purchase Necessary
- Any other restrictions that apply to this jackpot

### **Eligible Controlled Games**

The Bad Beat Jackpot shall be attached to the following Bureau approved controlled games offered at Hotel Del Rio & Casino, as shown below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGA-000843)

### **Object and Summary**

The Bad Beat Jackpot features a total of three jackpot prizes. A prize is awarded to players participating in an attached controlled game when a designated second hand is beaten by a better qualifying hand at the showdown.

1. When the winning and losing hands are confirmed, those players with the qualifying jackpot hands will receive the posted percentage of the jackpot prize. Additionally, a posted percentage of the jackpot prize, known as Table(s) Share, will be evenly distributed amongst all other players at the qualifying table(s) who have participated in the hand.
2. In the event the more than one player has a qualifying losing hand, only the highest qualifying losing hand will receive the "Losing Hand" payout. The other players with qualifying losing hands will participate only in the Table(s) Share.
3. In the event that more than one player has the same qualifying losing hand, the "Losing Hand" payout will be evenly distributed amongst the players with that qualifying losing hand.

### **Qualifying Hands**

Players who make one of the following advertised qualifying hands, with all requirements satisfied, are eligible to win the posted prize amount. The qualifying hand(s) and corresponding prize amounts will be displayed prominently within Hotel Del Rio & Casino at all times while this gaming activity is being offered for play. ### Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- Players must be seated and playing at a designated table in order to qualify for this gaming activity.
- Both hole cards must be used for each qualifying hand.
- Players must be present to win a prize.
- If a player cannot provide proper documentation to claim their prize, they will have ninety (90) days to return and claim the prize with their required documentation. If the player does not claim the prize within the ninety (90) days, the prize will be returned to the prize fund.
- In the event two or more players make the same qualifying hand, each player with a qualifying hand will receive the prize value that is equally divided between the players.
- In the event of multiple winners with the same losing hand and the prize is in the form of merchandise, the Casino will honor each guaranteed prize amount to all eligible winners.
- When a qualifying hand is announced, a casino representative will verify hands qualify. Any deviation from a standard deck will nullify the jackpot.
- The player(s) with the qualifying hands must complete the applicable bets on each round and play through the final betting round (the showdown) in order to qualify for the jackpot. In order to qualify for this gaming activity, qualifying hands must be tabled and considered live at the time all action is considered complete.
- There is no restriction on the number of times a player may qualify for or win a prize.
- Casino employees are eligible for this promotion while on or off duty.
- Tournament games do not qualify for the gaming activity.



## Bad Beat Jackpot

### **Prize**

Players who make the predetermined and posted qualifying hands shall be eligible to win the corresponding prize amount. The prize will be paid out in cash, merchandise, food, event entries, coupons (GEAR-001272), tickets, vehicles/recreational transport, live casino chips, and/or entry into tournaments (GEGA-000032) from the cage.

Each Jackpot prize pool is a fixed prize with a minimum amount of \$100 and a maximum amount of \$500,000. All prize amounts will be paid by a casino representative. Once the proper records have been completed. When a prize pool is hit, the prize pool will be reseeded by the Casino at a minimum of \$100 and a maximum of \$500,000.

### **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, will be eligible to win their share of the posted Bad Beat Jackpot prize pools, according to the payout as shown below. For the prize payout structure, 40% of the posted progressive jackpot prize amount will be awarded to the player that makes the qualifying losing hand, 20% of the posted progressive jackpot prize amount will be awarded to the player that makes the qualifying winning hand, and 40% of the posted progressive jackpot prize amount will be evenly divided and distributed amongst all other players who are seated and participating at the qualifying table, referred to as the Table(s) Share. All monies will be rounded to the nearest dollar. Any leftover monies will be distributed clockwise from the button in equal amounts to the table share winners. The odd chip shall be awarded to the first player clockwise from the dealer button.

The Bad Beat Jackpot shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with **no restrictions**. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Bad Beat Jackpot. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## **Bonus Chips Promotion**

### **Bureau Requirements**

#### **Advertising**

Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001266) will be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, will be prominently displayed in Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Buy-in Amount
- Bonus chip(s) amount
- Amount of time needed to play to qualify
- Predetermined (maximum) number of participants (if applicable)
- If there is a cap to the number of participants, the Casino will advertise the predetermined number of participants
- Any other restrictions that apply to this promotion

#### **Eligible Controlled Games**

The Bonus Chips Promotion shall be attached to all Bureau approved poker games offered at Hotel Del Rio & Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The Bonus Chips Promotion will be open to all patrons who buy-in to a predetermined game, for a predetermined amount, and at predetermined times. Players who buy-in to a poker game for a predetermined amount at a predetermined time will be given an additional predetermined amount of bonus chips in the form of live casino chips for the poker game based on the length of time they participate in the poker game. Players will receive the chips (live and bonus) at the time they buy-in.

Players are required to play between one minute and three hours to retain the additional bonus chips that was given to the player.

- This requirement is nullified if the player loses all of their bonus chips before the predetermined amount of playing time is met (as no bonus chips are able to be retained if all are wagered and lost).
- In the event that a customer has to leave before the required amount of playing time has been fulfilled, then that customer shall return the entire bonus chip amount or any remaining amount of chips up to the bonus chip amount. If the amount of chips left in play does not equal the amount of bonus chips given, Hotel Del Rio & Casino shall not require a player to pay the difference.

In order to keep track of the bonus chip distribution and time of play, a casino representative shall maintain a daily log during the promotional period, which will track the time of play for each player that participates in the promotion. The Log will contain the player's first and last name, the current date, time in, time out, and the starting and ending date of the promotional period.

## **Bonus Chips Promotion**

**Example:** *Players will receive an additional fixed amount of \$30.00 in live chips for the purchase price of \$30.00 in cash during live play and will retain any leftover bonus chips after playing for an hour.*

### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours designated and posted for the gaming activity.

- The Casino reserves the right to cap a number of participants as long as the predetermined (maximum) number of participants is prominently displayed.
- The required buy-in amount in order to qualify for the bonus live casino chips shall be posted and advertised.
- There is a minimum of two players required to qualify for this promotion.
- Players must take the prize in the form of live casino chips.
- If continuing to play, the chips must be placed on the table and added to the players other live casino chips.
- Casino employees are eligible for this promotion while on or off duty.
- Tournaments are not eligible for this promotion.
- A player is eligible to participate in this promotion once per day.

### **Prize**

The prize amount will be a fixed, predetermined amount ranging from \$5 to \$10,000 in the form of bonus chips (live casino chips) when a player buys-in for a predetermined amount (will be posted and advertised).

### **Funding**

The Bonus Chips Promotion will be fully funded by Hotel Del Rio & Casino. There will be no additional fees or collections taken for this gaming activity.

### **Administrative Fees**

There will be no administrative fees collected by Hotel Del Rio & Casino, as this promotion is house funded.

### **No Purchase Necessary**

The Bonus Chips Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## Poker Tournaments

### Bureau Requirements

#### Advertising

Hotel Del Rio & Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-000032) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in the Hotel Del Rio & Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- Any other restrictions that apply to the Poker Tournaments.

#### Tournament Log

Hotel Del Rio & Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of Gambling Establishment
- Day, date, time and name advertised for the tournament
- Total number of tables used
- Name of controlled games offered
- Method of entry
- Number and amount of rebuys and/or add-ons offered
- Number of participants
- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount collected
- Source of all funds for tournament prize pool
- Amount of the prize pool
- Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
  - Funding source
  - Prize amount
  - Total number of prizes awarded
  - Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the total amount paid out and amount paid for each place in the tournament

## Poker Tournaments

- Printed name and signature of the casino staff responsible for administering the tournament

### Eligible Controlled Games

The Poker Tournaments shall be attached to all Bureau approved Poker controlled games offered at the Hotel Del Rio & Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

### Gaming Activities Offered During Tournament Play

There will be no gaming activities attached to Poker Tournaments.

### Tournament Entry

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- **Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.**
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal for the initial buy-in and posted for all players.
- Entry may be earned by winning a previous tournament, playing a daily tournament or live game, points earned in tournament and live play, or a Bureau approved gaming activity. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.
- Partial entry may also be used to offset full entry fees for specified tournaments.

\*The Entry Fee may be retained by Hotel Del Rio & Casino to offset the cost of the tournament and/or to pay expenses and tips for house dealers and staff. This fee shall not be included in the tournament prize pool.

\*\*The Service Fee may be retained by Hotel Del Rio & Casino as income. This fee shall not be included in the tournament prize pool.

## **Poker Tournaments**

### **Tournament Prize Amounts & Source of Funds**

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed the payouts will be a cash value ranging from \$1 - \$100,000,000. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Hotel Del Rio & Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons, Hotel Del Rio & Casino will determine and set the payout structure.
- Hotel Del Rio & Casino may add a fixed amount to any tournament prize pool.

### **Tournament Prize Structure**

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100%. In the event the players decide to forgo the payout structure and “split” the total prize pool among them, it shall be permitted and shall be noted in detail on the casino’s tournament log.

Other prizes may include entry into any tournament event. The number of entries offered as a prize will be determined by the amount in the prize pool. The prize pool must reach the amount that will cover at least one entry into said tournament event. The number of winners is determined by the number of entries available to win. Rather than the top finisher receiving a percentage of the prize pool, they will receive entry into the tournament event. In addition, the Casino may or may not offer to pay for winner’s hotel accommodations while at the event and/or travel arrangements for getting to/from the event.

### **Entities Involved Other Than the House**

At any time, Hotel Del Rio & Casino may offer a charity tournament that would include other organizations. These organizations shall be reputable and federally recognized as non-profit or charity organizations. These organizations will not be involved in running the tournament; however, their name may be used in conjunction with the advertising and promoting of the event. Hotel Del Rio & Casino may donate prizes such as entries into Hotel Del Rio & Casino tournaments at no cost to the charity.
