The Department has extended the comment period until Friday, February 4, 2022.

Pursuant to the requirements of Government Code section 11346.8, subdivision (c), and section 44 of Title 1 of the California Code of Regulations, the Department of Justice (Department) is providing notice of changes made to proposed regulation sections 999.224, 999.226, and 999.228. These proposed modifications to existing regulations were the subject of a Notice of Proposed Rulemaking published in the California Register (Register 2021, No. 28-Z) on July 9, 2021 as file number Z2021-0629-05 and the subject of virtual public hearings on August 20, 2021 and September 1, 2021. These further modifications to existing regulations are in response to comments received regarding the proposed regulations and for clarification purposes as well as feedback the Department received internally and from its subject matter expert.

Additionally, pursuant to the requirements of Government Code sections 11346.8, subdivision (d), 11346.9, subdivision (a)(1), and 11347.1, the Department is providing notice that additional documents have been added to the rulemaking file and are available for public inspection and comment.
