

# Rogelio's Bonus Chips Promotion

## **Advertisement Requirements**

Rogelio's may advertise various names for this gaming activity. Should Rogelio's advertise a different name, the BGC ID listed above must be referenced on all advertisements relating to the Bonus Chips Promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in Rogelio's at all times:

- Eligible games and time periods.
- Buy-in amount and corresponding prize amount.
- No Purchase Necessary opportunity.
- Time played requirements.
- Any other applicable restrictions.

## **Controlled Games**

The Bonus Chips Promotion is attached to all Bureau approved games currently being offered at Rogelio's. All base game rules will be played as previously approved by the Bureau of Gambling Control.

## **Rules of Play**

This promotion will award players with a pre-determined amount of bonus chips who buy-in for a pre-determined amount to any game and play for a pre-determined amount of time, never to exceed three (3) hours. Rogelio's will keep a log of the player's time and identification information for the Bonus Chips promotion. Patrons will be given ample written notice of the amount of chips awarded and the amount of time that will be required to retain the bonus chips. Bonus Chips will be the same as Rogelio's standard live chips. There will not be separate chips for this promotion. If the player loses all bonus chips before the required playing time has elapsed, the player owes nothing to Rogelio's. If the player leaves before the required time has passed, they will owe the full amount of bonus chips awarded or the remainder of their chips if they have less than the amount of bonus chips received remaining. A patron will never owe money at a future date. In these instances, Rogelio's will incur all losses, and the player will not be responsible to make up the difference. There is no minimum or maximum number of players required to be dealt into a game for this promotion.

## **Prize**

The prize will be a fixed amount of additional casino chips ranging in value from \$10 to \$100 that will be received after buying in for a posted amount ranging from \$10 to \$100. All prizes for this promotion will be pre-determined and posted in advance, throughout the gaming floor and in all literature promoting such an event.

## **Eligibility**

The promotion will be open to all players who buy-in for the pre-determined and specified amount of money and play in a game for a specified amount of time. After the player has bought into a game, they will receive a pre-determined amount of additional bonus chips.

- There is no minimum number of players required to be in a game in order for a player to qualify for the promotion.

## **Rogelio's Bonus Chips Promotion**

- Each player will be eligible for this promotion once per day. Players will be given a coupon to sign when they receive their bonus chips. The signed coupons are kept in accordance with accounting records. A day starts when Rogelio's opens and concludes when Rogelio's closes. If Rogelio's should be open for a full 24 hours, then a day will be determined as calendar days (midnight to midnight).
- Player's time will be tracked by the Casino through a log.
- On and off duty employees shall not be eligible for the promotion
- Third Party Proposition Players shall not be eligible to participate in this promotion.
- Tournament Games are not eligible to participate in this promotion.
- All procedures, times and prize amounts shall be displayed prominently via any form of advertisement that Rogelio's wishes to use, including but not limited to printed flyers, digital display, the associations website, or any other form of advertisement.

### **Funding**

The Bonus Chips Promotion is house funded by Rogelio's. Therefore, there will be no additional jackpot fees or collection fees taken for this promotion. All fee collections and table limits are for the designated base games and are Bureau approved, pre-determined and posted at each table.

### **No Purchase Necessary**

The Bonus Chips Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

**1) Name of proposed gaming activity:**

Super Jackpot

**2) Name of each controlled game that is associated with this gaming activity:**

Texas Hold-em poker.

**3) Describe any jackpot or any other type of prize awarded:**

The Super Jackpot will be a fund that is used to award chips to players.

**4) If a cash prize is involved, is the amount of the prize progressive (increases) or a fixed amount?**

Many of the awards will be fixed the top award will be progressive.

**5) Explain if the gaming activity is house funded or player funded.**

The Super Jackpot will be player funded.

**6) Describe any special fee collection involved in this gaming activity, for example, a jackpot fee collection.**

One dollar (\$1.00) will be collected from each hand of Texas Hold-em poker at the same time the (time) collection is made. The Super Jackpot collection will be deposited in the tables drop box. The licensee uses non-denominational (no-value) chips to represent the time collection and will use one dollar (\$1.00) chips (value chips) to represent the Super Jackpot collection.

**7) Describe how the jackpot will be seeded and how any prizes will be awarded.**

The licensee will put up five thousand dollars (\$5,000) to seed the Super Jackpot.

Prizes will be awarded to players that make hands of various values and the Super Jackpot will be awarded when a bad beat situation occurs as listed below.

A) Aces full of: tens, jacks, queens, kings a fixed award of \$20.00

B) Four of a kind or better, fixed award of \$50.00

C) Royal Flush (ace high straight flush), fixed award of \$200.00 plus \$50.00 to everyone at the table that doesn't have a missed blind button.

D) Bad Beat, a progressive amount that will be updated and posted daily at 6:00 pm. The amount awarded would be minus any smaller jackpot payout during that day.

**8) Explain any prize distribution including prizes given to the winner, loser, or any other player or patron.**

To win a jackpot prize, players must use both cards in their hand to qualify. When a player makes a hand of Aces full of: tens, jacks, queens or kings they will be awarded twenty dollars (\$20.00) from the Super jackpot fund. When a player makes a hand of four of a kind and the player has two of those cards in their hand, or a player makes a straight flush using both of their cards they will be awarded fifty dollars (\$50.00) from the Super Jackpot fund. If a player

makes an Ace high straight flush (royal flush) and both cards in the players hand are part of that hand they will be awarded two hundred dollars (\$200.00) plus all seated players that received a hand will get fifty dollars (\$50.00). A Bad Beat situation for this promotion will be anytime a player has Aces full of Kings or better and loses to a hand of higher value. The distribution of the bad beat Super Jackpot will be; 30% to the winning hand, 45% to the losing hand and 25% to be divided between the other players that received cards in that hand. If the board ties a kicker (high card) in a players hand it does not counterfeit or cause that players hand not to qualify for a bonus or bad beat.

**9) Explain any re-seeding of the fund once the prize is won.**

The Super Jackpot fund should be self supporting, 15% of each jackpot dollar collected will be retained separately to re-seed the fund. When this re-seed or "reserve" fund amount has reached \$5,000 (the amount of the original seeding) the 15% previously collected for re-seeding will be added to the daily progressive. 40% of each jackpot dollar collected will be retained to payback the initial seeding. After payback of the original seeding is completed the amount will be reduced to 20% and added to the 15% re-seeding fund, totaling .35 out of every dollar collected. After both the original seed and the re-seed amount are collected 100% of each dollar collected will be added to the Super Jackpot fund minus any administrative fee as explained below.

**10) Explain any minimum or maximum number of players required to be dealt in to the game for the table to be eligible for the gaming activity and prize.**

The maximum number of players to take a hand and still be eligible for Super Jackpot awards is ten (10). The minimum number of players to be dealt in to qualify for any Super Jackpot award is five (5).

**11) Explain if the house is retaining any administrative or any other type of fee for operating the gaming activity.**

The licensee will retain a 10% administrative fee.

**12) Describe any opportunity(s) for a person to play for the prize without placing any live wagers or playing any table fees.**

No purchase is necessary for the opportunity to receive a Super Jackpot Award. Anyone wanting the opportunity to win a portion of the Super Jackpot Pool must notify card room personnel of their intent. Each person will be assigned a seat at an empty poker table and one hand of Texas Hold-em poker will be played. Any person having a qualifying hand will be paid the appropriate amount. This hand of poker will be played once a day at 8:00pm. If there are more than ten persons that had signed up for the opportunity to win, a second and subsequent hand(s) will be dealt until everyone has had an opportunity to win.

**13) Provide copies of any published/proposed promotion or advertisement literature.**

**14) Identify any entity or person other than those licensed as the house involved in the gaming activity.**

No person or entity other than those licensed as the house are involved in this proposed gaming activity.

**15) Describe the type of table and equipment utilized for the gaming activity.**

Currently approved tables and other equipment will be used and no changes will be necessary to conduct this new gaming activity. A white display board will be used to display the amount of the Super Jackpot and how the awards are won.

Re: Request for approval –Texas Hold'em tournament Rogelio's GE#0231

Dear Mr. Adamson:

Rogelio's would like to request an amendment, to modify tournament entry to read as follows

1. The tournaments are open to the public to enter and a buy in of \$ 5.00 to \$ 5,000.00, with an entry fee of no more than 20%. Ample notice will be given to the players as to what the entry fee will be.

Entry fee is retain by Rogelio's and not part of prize pot. In some tournaments, a re-buy might be allowed. Any and all re-buy amount will be posted and made available to patrons prior to all tournaments.

2. Prize pot

The prize pot is funded by the buy-ins, less the entry fee. In some cases, Rogelio's will add \$ 200.00 additional money to the prize pot.

There is no guaranteed prize pool. A player wins by eliminating their opponents. The tournament continues until one person has won all the chips. The payout structure is as follows based on the number of entrants:

**Payout structure for less than 40 entrants:**

1 <sup>st</sup> place	50% of prize pool
2 <sup>nd</sup> place	30% of prize pool
3 <sup>rd</sup> place	20% of prize pool

**Payout structure for 40 or more entrants:**


1 <sup>st</sup> place	50% of prize pool
2 <sup>nd</sup> place	30% of prize pool
3 <sup>rd</sup> place	15% of prize pool
4 <sup>th</sup> place	5% of prize pool

**Games played**

The game offered in the tournaments is Texas Hold'em. All rules are on file with and have been reviewed by the division. A review of the game rules indicates that they are a Poker style game. Banked games are games in which the gambling establishment takes on all comers, pays all winners, and collects from all losers. The game played during these tournaments is a Poker style game. Players use their skill and knowledge of Texas Hold'em to eliminate other players and win a percentage prize of the event's prize pool. Players will play a round of each game during the tournament until they run out of chips or collect all of the tournament event players' chips. A review of the game rules indicates these are games of skill and the participants play against each other, not the house.
