NUMBER 8 LAW ENFORCEMENT ADVISORY June 15, 2007

"Poker Night Fundraisers"

As you may know there are many organizations hosting charity poker night fundraisers throughout California. The Division of Gambling Control has been receiving information that there are many organizations not in compliance with AB 839¹, and continue to host these events without registering.

Currently, the Division conducts background checks on all applicants. The processing time frame is approximately 1 business week. Once eligible applicants are approved, they are issued a Certificate which must be posted where controlled games² are being conducted. Example certificates are enclosed for your convenience.

Beginning January 1, 2007, AB 839 was passed allowing eligible nonprofit organizations to hold charity poker night fundraisers using controlled games. Nonprofit organizations and Suppliers of gambling equipment and/or services for such fundraising events must submit an application for registration to the Division for approval. This new law establishes limitations on each fundraising event, including but not limited to, each eligible nonprofit organization can host one fundraiser per any calendar year using controlled games, each event will be limited to no more than five consecutive hours, no more than four fundraisers may occur at the same location, no cash prizes or wagers may be awarded, individual prizes must not exceed a cash value of \$500, and total value of prizes awarded must not exceed a cash value of \$5,000. Additionally, no one under the age of 21 is allowed to participate at these fundraising events.

Division staff work directly with local law enforcement agencies, ABC, and the State Franchise Tax Board to ensure compliance with the provisions and regulations of AB 839.

¹ Assembly Bill 839 is directed at nonprofit organizations who want to host "poker night" fundraisers using controlled games.

² Controlled games as defined in California Penal Code, section 337j(e)(1) are "...any poker or pai gow game, and any other game played with cards or tiles, or both, and approved by the Division of Gambling Control, and any game of chance, including any gaming device, played for currency, check, credit, or any other thing of value that is not prohibited and made unlawful by statute or local ordinance."
