The Bad Beat Jackpot will be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a no purchase necessary (NPN) game. The Cordova Restaurant Casino will provide no purchase necessary tables for all patrons who request to participate in the jackpot without paying a table fee or placing a live wager. The NPN player must adhere to all rules as the live player. All advertisements state "No Purchase Necessary" for the Bad Beat Jackpot.

When players buy into any listed promotional game for a pre-designated dollar amount ranging from \$40 to \$1,000, The Casino will add additional chips ranging from \$20 to \$200, to their chip stack. There would be a minimum of two (2) hours of play (or the player would return the bonus UNLESS s/he went busted/lost their money), unless stated and posted otherwise. The range of cash required, the bonus chips given and the playing time requirement will all be pre-designated and posted before the promotion begins in a clear and conspicuous area. A player is only eligible for this promotion once per day.

For example, The Casino decides to offer a \$60 for \$40 in the \$2-\$4 Texas Hold'em game between the hours of 10a and 11a. The bonus will be paid up front to any player who plays for a minimum of two hours.

In the event that a player busts out before the required play hours are up, then The Casino will incur the loss of the bonus chips. In the event that a customer has to leave before the required amount of play has been met, then that customer will need to pay back the bonus chips, as long as they have enough left in play. The Casino will **not** require a customer to owe the money at a future time. The time of play will be tracked by a Casino employee.

Another example, a player buys in during the above mentioned \$2-\$4 promotional time. He buys in for \$40 and receives \$60 in chips (\$20 in bonus chips). An hour later, the player has an emergency at home and has to leave but only has \$15 left in front of him. The Casino will pick up the \$15 as these are still bonus chips. #### **Rules of Play**

The Bonus Chip Promotion will be open to all patrons who buy-in to a pre-determined game for a pre-determined amount ranging from \$10 to \$100,000. Participants will receive a specific amount of Bonus Chips in any controlled game listed above.

#### **Purchasing Bonus Chips**

Players may purchase bonus chips at the cage at pre-determined and posted times. #### **Object and Summary**

The California Games Jackpot gaming activity features a fixed and progressive jackpot prize. A prize is awarded to players, who have paid the \$1 jackpot fee, in any designated California game, when the player-dealer has been dealt a qualifying hand. After the hand has been confirmed, those players who paid the jackpot fee shall receive the posted prize from the progressive jackpot.

#### **Qualifying Hands**

When the player-dealer makes one of the following advertised qualifying hands during the play of an eligible California game, all players who paid the jackpot fee shall be eligible to win their share of the posted California Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who placed a jackpot bet and the posted fixed amount will be given to each player who placed a jackpot bet. Only the following hands that have been Bureau approved, pre-determined, and designated by the Casino are eligible. The qualifying hands within the chart below must be offered together at all times.

Example: Prior to the play of the hand, five players placed a jackpot wager. The jackpot hand was made by the player-dealer and the posted prize is \$42,000. Each of the five players would then receive \$8.400.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no minimum or maximum number of players required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the California Games Jackpot prize amount.
- Players are eligible to win this promotion more than once.
- Only off duty, out of uniform, Casino employees shall be eligible to participate in the California Games Jackpot promotion.
- Third Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the California Games Jackpot promotion.
- Patrons playing in tournament games are not eligible to participate in the promotion.

#### **Prize**

The jackpot prize is fixed and progressive with a minimum value of \$500 and a maximum of \$500,000. The jackpot prize shall be paid in the form of cash, casino chips, merchandise, trips, poker tournament entries, electronics, or other prizes. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

#### **Funding**

The California Games Jackpot gaming activity utilizes one Jackpot account which shall be funded by a \$1 jackpot collection which shall be dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Cordova. Parkwest Casino Sonoma will not be reimbursed the seed amount. When the \$1 jackpot collection has been taken, a portion of the fee will go to the main jackpot account and the rest shall be placed in the reserve account. The jackpot has a \$500,000 cap. Once the jackpot reaches the cap amount, all other jackpot collection fees collected shall be placed in the jackpot reserve account. All fixed prizes will be taken from the reserve account. The Parkwest Casino Cordova shall cover any shortfall and shall be refunded by the reserve.

#### **California Games Jackpot**

### Administrative Fees

The Parkwest Casino Cordova shall retain an administrative fee of \$5-\$10 per table per hour from all approved California games. This fee will be used to cover security to pull and count the boxes, accounting, equipment, surveillance, and the cost of the gambling establishment personnel that administer the jackpot.

#### **No Purchase Necessary**

The California Game Jackpots Promotion gaming activity shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. The Parkwest Casino Cordova shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. Within a reasonable amount of time of a No Purchase Necessary player requesting to play one of the specific games within the gaming activity, a No Purchase Necessary table will be made available. The casino dealer will deal a hand to the No Purchase Necessary player and to all other seated positions, including what would be the player-dealer position. The casino dealer will play/monitor all of the hands dealt except for the No Purchase Necessary player's. If the player-dealer makes one of the qualifying hand(s), listed above, they will be awarded that associated prize or their portion thereof. There shall be no time restriction placed on the No Purchase Necessary player regarding the number of hands dealt. There shall be no live wagering or cash/casino chips used at this table. All advertisement material shall state "No Purchase Necessary" when referencing the California Games Jackpots gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

#### Cordova Casino

#### **Advertisement Requirements**

The Cordova Casino may advertise various names for this tournament. Should the Cordova Casino advertise a different name, the BGC ID listed above shall be referenced on all advertisements relating to the California Games Tournaments.

Furthermore, all rules and procedures for California Games Tournaments, including but not limited to the following, shall be displayed conspicuously and prominently in the Cordova Casino at all times that a California Games Tournament is offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- When offering a Team Tournament structure, the rules and procedures will
  clearly state how the teams will be formed, the tournament rounds of play and
  the prize structure.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Cordova Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.

- The prize pot may consist of the sum of all buy-ins, re-buys, and add-ons for each event, and the payouts shall be a percentage.

#### **Team Tournament Prize Structure for Baccarat**

As shown in the Team Prize table below, the team with the highest combined chip count wins first place money in the tournament. The second highest chip count wins the second place money, and so forth, up to four places. Each member of the winning teams receives an equal share of the "Team Prize" money.

### **Object and Summary**

The Cash and Prize Drawing Promotion is house funded and awards players with 1-20 drawing tickets for achieving a designated qualifying hand or for playing in designated games for a predetermined amount of time. Players shall have their time tracked via the Customer Incentive Program (GEGA-004454). The drawing tickets allow players to win predetermined and posted prizes during a drawing to be held at a later time. The drawing ticket is divided into two sections, one for the player to retain and one for the Casino to retain. The portion of the tickets retained by the Casino are placed in a clear, plastic, non-electronic, rotating container to be used for the

drawing. At the time of the drawing, the tickets are mixed up in the container and one is selected by a casino representative. The winner will then see a casino representative to claim their prize.

#### **Bonus Tickets**

During predetermined and posted time periods, the Casino may award players who achieve a qualifying hand or meet the minimum amount of time played with an additional 1-20 "bonus" tickets. Players will be given ample notice of time periods and controlled games that are eligible for bonus tickets.

The Cordova Restaurant and Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEGA-004454) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be prominently displayed in The Cordova Restaurant and Casino at all times the gaming activity is being offered:

- Corresponding time played and points earned or awarded.
- The date(s) and time(s) the gaming activity shall be offered.
- The number of points earned corresponding to the prize amount.
- The time frame in which the points earned are valid.
- The possible prize(s) offered for meeting the requirements of the gaming activity.
- When the bonus prize(s) will be offered throughout the promotion.
- Availability of No Purchase Necessary.
- Any other applicable restrictions.

#### **Eligible Controlled Games**

The Customer Incentive Program shall be attached to all Bureau approved California and Poker controlled games offered at The Cordova Restaurant and Casino at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### Rules of Play

The Customer Incentive Program features a promotional element attached to the games listed above. This gaming activity is a loyalty reward program open to all Cordova Restaurant and Casino patrons. This promotion will reward players with points based on time of play at designated table games during pre-determined and eligible periods ranging from 10 minutes to 90 days.

#### **Player's Card and Computer System Description**

The Player's Card shall include the Casino name on the card, some descriptive language regarding restrictions for the card, and the problem gambling phone number. It shall also include a bar-code. This card will look different from the card used for the Player Loyalty Rewards Program (GEGA-003083).

- The card shall be non-transferable and can only be used by the player who the card is assigned.
- If a player's card has been lost or stolen, they can ask a Floor Service Representative for a new one at no cost to the player.
- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management.
- Player's time played is tracked by having their card scanned. They will receive a
  player's card once they sign up for the Customer Incentive Program at the cashier. An
  iTouch, iPad, or similar tablet computer device, with a bar code reader, will be affixed to
  the gaming table and a gambling establishment employee will scan the player's card.
  The gambling establishment employee will then input the player's average wager and
  time played into the computer tablet device.

### **Customer Incentive Program**

- Player information shall be maintained in a secure database accessed only by casino management. Access to the database shall also be tracked by casino management. No one except the network administrator(s) has access to the back-end systems where the data is stored. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing managers will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.)
- A printable record of the amount of time a player has accumulated during the period of time that the gaming activity is being offered, shall be available at anytime at their request.

#### How Player Rewards Points are Earned Based on Time Played

Points shall be earned based on the amount of time played. Each player that plays a certain table game during live play will, at certain times, receive points, which will gain them eligibility to win pre-determined and designated prizes. #### **How Player Rewards Points are Redeemed**

Players may either redeem their points at any time during the promotion or at the end of the promotional period. The redemption period will be displayed in The Cordova Restaurant and Casino to give players ample notice. Points not redeemed by the end of the promotional period will expire within 30 days of the promotional period. All prizes shall have a pre-determined and designated value. The point to dollars ratio for the rewards program is 1 point is worth \$0.10 - \$100. After a player has accumulated a pre-determined and specific amount of points, based on time of play, a player may redeem the accrued points for a pre-determined and designated prize.

The Customer Incentive Program does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require No Purchase Necessary tables to be offered while conducting this gaming activity.

# Cordova Restaurant & Casino Food Reward Program

#### **Advertising Requirements:**

Cordova Restaurant & Casino may advertise various names for this program. <u>Should the Casino advertise a different name, the BGC ID (GEGA-004106) shall be referenced on all advertisements relating to this gaming activity.</u>

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in Cordova Restaurant & Casino at all times the gaming activity is being offered:

- The date(s) and time(s) the gaming activity shall be offered.
- The prize(s) offered for meeting the requirements of the gaming activity.
- Time required to earn food.
- How time will be tracked.
- Procedures for players having their card stamped.
- Any other applicable restrictions.

### **Summary**:

Based on customer demand and industry trends, The Cordova Restaurant and Casino proposes to add a gaming activity for all currently approved controlled games. The promotion will allow a player to eat for free/or at a substantially discounted rate from a selected menu when they play for a qualifying period of time, which is tracked through their Player Rewards Card or on a log if they do not have a players' rewards card. In all instances, patrons shall be provided with ample advance notice of the amount of time that a player must play in order to be eligible for the "Player's Menu." Furthermore, the time requirements and "Player's Menu" shall be displayed prominently within The Cordova Restaurant and Casino at all times this gaming activity is being offered for play.

#### **Controlled Game:**

The Food Reward Program shall be associated with all currently approved BGC games offered at Cordova Restaurant & Casino.

#### Prize:

The prize will be allowing a player to eat a menu item for free/or at a substantially discounted rate from a selected "Player's Menu." For players that complete the time requirement, certain items on the "Player's Menu" with a value of \$1 - \$25 will be offered for free.

#### Funding:

This promotion will be solely funded by Cordova Restaurant & Casino. There will be no extra collection or fees of any kind assessed to the players.

#### Rules of Play

The player who obtains the highest ranking poker hand during a pre-determined and posted time period will win a prize ranging in value from \$25 to \$5,000. At the beginning of a pre-specified time period, the qualifying high hand of "Full House or better" shall be announced. When a player receives a full house or better, an announcement shall be made and all players will then try to make a higher hand. The Minimum qualifying hands shall be tracked on a white board or an electronic display located in the area that the eligible games are being offered for play. If no one receives a higher hand, the player with the full house or better receives the posted prize. The High Hand Progressive Promotion shall be offered for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a no purchase necessary (NPN) game. The Cordova Restaurant and Casino shall provide no purchase necessary tables for all patrons who request to participate in the promotion without paying a table fee or placing a live wager.

The player will then be awarded double the amount that the wheel stops on. Should the wheel stop on the "double" space again, he will win the jackpot amount. The jackpot will be within the prize range listed above \$10 to \$25,000. The wheel must make two complete rotations for the spin to be valid. Once the wheel has been spun and is in motion, no one may interfere with the rotation of the wheel. Any interference with the rotation of the wheel shall invalidate the spin, and the wheel shall be re-spun. The wheel must come to a complete stop before a determination is made as to amount won. For a spin to be valid, the pointer must come to rest between two of the pegs. If the pointer gets stuck or rests upon one of the pegs, the spin shall be invalid and the wheel shall be re-spun. All spins that are declared invalid by the supervising floor-person shall be re-spun as per these rules.

wager is collected by the player/dealer, and the voucher is voided and collected as well. If the player pushes (receives no action), the voucher may be played again until the player wins or loses a hand.

#### "Free Play Chip(s)"

The Casino will offer free play chips having a face value from \$5.00 to \$500.00 per chip. The chips are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash.

The free play chips are initially in the form of a coupon which will be offered to all patrons that wish to come into the Casino and use them to play. Patrons may be awarded free play coupons via advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, etc. When a patron receives a free play coupon he/she shall take the coupon to the cage for verification, logging, and redemption of the free play chip(s) to be used in a live game. Promotional chips are used as the player's bet and placed on the betting circle. Promotional chips are never taken into the dealer's tray, nor are they ever paid from the dealer's tray.

EXAMPLE: A person receives a free play chip coupon for \$10.00 that specifically states it can be used to place a wager on the No Bust Blackjack table. The player would take the coupon to the cage. Cage personnel would log the redemption code of the coupon and exchange the coupon for a promotional free play chip. The player would then place the free play chip on the gaming table, pay the posted collection (if applicable), and the game would play. If the player wins the hand, he/she would be paid \$10.00 by the person in the player/dealer position just as if he/she had placed a \$10 bet. The free play chip will be collected by the person in the player/dealer position. The player/dealer will then have a key employee verify that the chip has been played. All played free play chips are verified by a key employee. The free play chip is taken to the cage by a key employee, logged, and exchanged for the value listed on the chip. If the player loses the hand, the free play chip is forfeited and will be collected by the casino dealer and dropped in the drop box for accounting purposes. If the player pushes (receives no action), the chip may be played again until the player wins or loses a hand.

If a player wins a hand on a base game where they have played a match play coupon or free play chip, he/she will be awarded 100% of the face value on the coupon or chip.

The promotion will award players who play a predetermined amount of time at the Cordova Restaurant and Casino in a particular game.

#### **PRIZE**

This promotion will reward players with points based on the amount of time played at designated table games during pre-determined and posted eligible periods or based on pre-determined and posted designated qualifying hands. Players that make any of the following pre-determined and posted hands will be awarded points. Please see attached chart of qualifying hands. The range of points will be from one (1) to one hundred (100) points per hour of play.

The casino may offer pre-determined and posted bonus earn rates, schedules (double, triple, etc.) on play during off-peak hours or in specific games, within the range, as shown above.

Players will be given ample notice of how many points will be awarded, as well as the amount of time required to earn points of which pre-determined and posted qualifying hands will be eligible to earn points for each eligible game.

#### **Object and Summary**

The Poker Games Jackpot gaming activity features a fixed and progressive jackpot prize. A prize is awarded to players, who are playing at a predetermined and posted Poker table, and paid the \$1 jackpot fee. At the final round of play, if the community cards make a qualifying hand, as shown in the chart below, all players who were dealt in at the beginning of that round of play and paid the \$1 jackpot fee shall receive the posted prize.

#### **Qualifying Hands**

When a qualifying hand is made in an eligible poker game, all players who paid the \$1 jackpot fee shall be eligible to win their share of the posted Poker Games Jackpot progressive prize amount, as shown below. The payout shall be split evenly for the posted progressive amount among the players who were dealt into the hand and the posted fixed amount will be given to each eligible player. Only the following hands that have been Bureau approved, predetermined, and designated by the Casino are eligible. The qualifying hands within the chart below must be offered together at all times.

Example: At the beginning of a round of play, five players are dealt into a poker game where each player paid the \$1 jackpot fee. The qualifying community cards were dealt and the posted prize is \$42,000. Each of the five players would then receive \$8,400.

#### **Eligibility Requirements**

This gaming activity shall be open to all players who are seated and playing at an above listed controlled game during the pre-determined and specified hours designated and posted for the gaming activity.

- When a qualifying hand is announced, a floor person shall verify that the hand qualifies. Any deviation from a standard deck will nullify the jackpot.
- There is no minimum or maximum number of players required to be dealt in during an eligible game in order for players to be eligible and the tables to qualify for the Poker Games Jackpots prize amount.
- Players are eligible to win this gaming activity more than once.
- Only off duty, out of uniform, Casino employees shall be eligible to participate in the Poker Games Jackpots gaming activity.
- Third Party Provider of Proposition Player Services, on and off duty, shall not be eligible to participate in the CA Games Jackpots gaming activity.
- Tournament Games are not eligible to participate in the gaming activity.

#### **Prize**

The jackpot prize is fixed and progressive with a minimum value of \$5 and a maximum of \$500,000. The jackpot prize shall be paid in the form of cash, casino chips, merchandise, trips, poker tournament entries, electronics, or other prizes. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how much time was accumulated in order for the jackpot to increase progressively each day.

#### Funding

The Poker Games Jackpot gaming activity utilizes one jackpot account which shall be funded by a \$1 jackpot collection fee that is dropped in a separate drop box marked as "Jackpot." The prize pool shall be initially seeded at a minimum of \$5,000 by Parkwest Casino Cordova. Parkwest Casino Cordova will not be reimbursed the seed amount. If one of the qualifying hand(s) is dealt in the community cards, as listed above, the player will be awarded that associated prize or their portion thereof. There shall be no time restriction placed on the No Purchase Necessary player regarding the number of hands dealt. There shall be no live wagering or cash/casino chips used at this table. All advertisement material shall state "No Purchase Necessary" when referencing the Poker Games Jackpots gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

#### **Advertisement Requirements**

Cordova Casino may advertise various names for this gaming activity. Should Cordova Casino advertise a different name, the BGC ID listed above shall be referenced on all advertisements relating to the Rack Attack Promotion.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be displayed conspicuously and prominently in Cordova Casino at all times the gaming activity is being offered:

All controlled game rules shall be played as previously approved by the Bureau.

#### **Rules of Play**

The Rack Attack Promotion features a promotional element which shall be attached to above listed games currently approved at the Casino. The Rack Attack Promotion involves a drawing drum with specially marked ping pong balls that are numbered with the table numbers. During pre-determined times and intervals of the promotional period, a casino employee shall announce the commencement of the drawing. The casino employee shall then select an eligible table by randomly choosing a ping pong ball from the drum. A ping pong ball shall depict a number that corresponds to each eligible poker table. The ping pong balls, which are equally sized and colored, shall be mixed within the randomizer. Then, one shall be selected. Once that table number is determined, the employee shall place the pre-determined and posted prize into the pot on the table, at the start of the next hand. Players must have been dealt into the previous hand in order to qualify for the promotion. Betting procedures and play shall proceed as a normal round of play would. The betting structure for the promotional hand for No Limit Texas Hold'em and Pot Limit Omaha will be changed to limit betting rounds. All games will be restricted to one bet and one raise for the betting rounds. The player with the winning hand shall win the pot, including the added prize amount. In the event of a tie, the winning players shall split the pot and the added bonus amount evenly.

#### **Prize**

When a table is selected, the prize amount shall be added to the pot of that table. The Rack Attack Promotion is fully funded by Cordova Casino. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion. All fee collections and table limits are for the designated base games and are Bureau approved, pre-determined and posted at each table.

#### **Administrative Fees**

Cordova Casino shall not retain an administrative fee as this promotion is house funded.

#### No Purchase Necessary Table Requirement

The Rack Attack Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary (NPN) game. Cordova Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the jackpot without paying a table fee or placing a live wager. The NPN player must adhere to all rules as the live player. All advertisement material shall state "No Purchase Necessary" when referencing the Rack Attack Promotion. - The amount by which the jackpot increases daily.
- Opportunity for No Purchase Necessary.
- Any other restrictions that apply.

#### **Controlled Games Offered**

The Super Bad Beat Poker Jackpot may be attached to all limits and versions of all currently approved Poker games offered at the Cordova Restaurant and Casino. All base game rules will be played as previously approved by the Bureau of Gambling Control.

#### **Rules of Play**

The Super Bad Beat Poker Jackpot features a progressive jackpot prize. A prize is awarded to players participating in a designated poker game when a designated second hand is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed, those players with the qualifying hands will receive the posted percentage of the jackpot prize. The posted percentage of the jackpot prize, know as the table share, will be evenly distributed among all other players at the qualifying table who have participated in the designated games. Finally, the posted percentage of the jackpot prize, know as the room share, will be evenly distributed among all other players in the Casino who are participating in a designated game that was eligible for the jackpot when the jackpot is awarded. In all instances, patrons will be provided with amply advance notice of the percentage division of the posted jackpot prize.

#### **Qualifying Hands**

Players that make any of the following advertised qualifying hands will be eligible to win their share of the Super Bad Beat Poker Jackpot prize amount. In order to qualify for the promotion, the player dealt the qualifying losing hand must use both hole cards, and the player dealt the winning hand must use both hole cards. Only qualifying hands that have been Bureau approved and pre-determined and designated by the casino are eligible. The qualifying hands shall be offered together at all times the promotion is offered for play. Patrons shall be provided with ample advance notice of the qualifying hand being offered for play, as well as the requirements for the qualifying hand. #### **Prize Payout Structure**

Players that make one of the advertised qualifying hands, as shown above, shall be eligible to win their share of the posted Super Bad Beat Poker Jackpot progressive prize amount, according to the payout option as shown below. For the prize payout structure, 45% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying losing hand, 25% of the posted progressive jackpot prize amount shall be awarded to the player that makes the qualifying losing winning hand, and 20% of the posted progressive jackpot prize amount shall be evenly divided and distributed amongst all other players who are seated and participating at the qualifying table, referred to as the Table Share. #### **Prize Amount**

The jackpot prize is progressive with a minimum value of \$1,000 and a maximum value of \$10,000. The jackpot prize shall be paid in the form of cash. The actual progressive jackpot prize amount shall depend on the amount the jackpot was originally seeded at, as well as how many days have transpired in order for the posted jackpot prize to increase progressively each day. Patrons shall be given ample notice of the actual jackpot prize amount. Furthermore, the amount of the progressive jackpot prize pool shall be displayed prominently within the casino at all times the Super Bad Beat Jackpot is being offered for play.

#### **Eligibility**

This gaming activity will be open to all players who are seated and playing at an above listed game during the pre-determined and specified hours designated for the gaming activity.

- A minimum of five (5) players are required to be dealt in during a qualifying game in order for players to be eligible and the table to qualify for the jackpot. The Cordova Restaurant and Casino will initially seed the jackpot with an amount ranging between \$1,000 and \$10,000. Once there are sufficient funds in the jackpot reserve, the initial amount that the Cordova Restaurant and Casino used to seed the jackpot will be repaid to the casino from the jackpot reserve. The NPN player must adhere to all rules as the live player. All advertisements must state "No Purchase Necessary" when referencing the Super Bad Beat Poker Jackpot.

Parkwest Casino Cordova may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001300) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed in the Parkwest Casino Cordova at all times the gaming activity is being offered for play:

- Procedures for purchasing the VIP Prime Membership
- Monthly price of membership
- The date(s) and time(s) the promotion shall be offered
- Any limits to the amount of prizes a VIP Prime Member may win during the promotional period.
- Any limitations to the quantity of a prize.
- The games eligible for the promotion
- Eligible prizes, prize quantities, and prize values
- · Any other restrictions that apply to this gaming activity

#### **Eligible Controlled Games**

The VIP Prime Membership promotion shall be attached to all Bureau approved California games offered at Parkwest Casino Cordova at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

#### **Object and Summary**

The VIP Prime Membership promotion is an enhancement to the Customer Incentive Program (GEGA-004454). In order to participate in the VIP Prime Membership promotion patrons need to first be members of the Customer Incentive Program. They will then sign-up and pay a corresponding monthly fee. All VIP Prime Members who buy-in to the Bonus Chip promotion for \$2,000 will receive an additional \$100 in Bonus Chips for a total of \$350 in Bonus Chips.

#### **Object and Summary**

The Poker Pyramid Promotion is a house funded promotion that awards players, who are participating in an eligible controlled game, and who achieve a qualifying hand, a predetermined and posted prize from the pyramid. A Poker Pyramid board is used to track eligible prizes and eligible qualifying hands. The board consists of two parts: the qualifying hands, which make up the base, and the prizes, which make up the pyramid (see below for an example of a pyramid). There are a total of 36 qualifying hands and a total of 36 prizes.

#### **Poker Pyramid Promotion Procedures:**

- The Casino will advertise the eligible game(s) and promotional period for the Poker Pyramid Promotion.
- The Casino will post the Poker Pyramid board prominently near the eligible gaming tables.
  - If more than one game is eligible, the casino will post a Poker Pyramid board for each eligible game.
  - o Each eligible game will be independent of any other eligible games.
  - All tables participating in the same eligible game will share the corresponding Poker Pyramid board.
- Staff and surveillance cameras will monitor and maintain the Poker Pyramid board's accuracy, thus ensuring patrons and employees do not tamper with the Poker Pyramid board.

- Players will participate in the eligible game(s) as a seated player.
  - Backline bettors cannot participate in this promotion.
- If the player achieves an eligible qualifying hand, listed in the base of the Poker Pyramid, a casino representative will confirm the hand.
- Once the hand has been confirmed the player will immediately receive the corresponding prize.
  - Prizes are not determined by the qualifying hand, but rather by the order in which a qualifying hand has been achieved.
- The casino representative will then remove the qualifying hand from the Poker Pyramid board and that qualifying hand will no longer be eligible to receive a prize.
  - The hand will remain ineligible to receive a prize for the remainder of the promotional period.
- The casino representative will also remove the corresponding prize and that prize will no longer be eligible to be won.
  - o The prize will be ineligible to be won for the remainder of the promotional period.
- Prizes are awarded in sequence from left to right, one row at a time until the row is empty.
  - An entire row of prizes must be completed before the next row of prizes will be offered.
- After the removal of a prize, the next prize in sequence will be awarded to the next qualifying hand achieved.

#### **Qualifying Hands**

Players who achieve an advertised qualifying hand, as shown below, will be eligible to win a predetermined prize. Both the qualifying hand and the eligible prize must be available based on the Poker Pyramid board. All qualifying hands within the chart below must be offered together at all times when the promotion is offered for play.

- For Ace Up Pai Gow Poker and Lucky Pai Gow Poker, base game rules for jokers apply, no deviation is allowed. #### **Eligibility Requirements**

This gaming activity will be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours posted for the gaming activity.


- Each game will have a corresponding pyramid for payouts.
- Each above mentioned controlled games will be independent of the other controlled games.
- Each of the above mentioned controlled games will have its own pyramid board.
  - o If multiple tables of the same controlled game are in play, all tables for the controlled game will be eligible for the promotion and will share the same board.
- Backline bettors cannot participate in the promotion nor win a prize even if the base game rules allow backline betting.
- Multiple prizes may be awarded during the same round of play.
  - o Prizes will be awarded in the order the qualifying hands are achieved.
- If multiple players have qualified with different eligible hands at the exact same time;

  - This process of awarding available prizes followed by removing eligible prizes and hands from the Poker Pyramid board will continue until all eligible hands have received an available prize.

- If multiple players have qualified with the same eligible hand at the exact same time;
  - For purposes of the Poker Pyramid board the win will be treated as if only one player had won.
    - One eligible hand and one prize will be removed from the Poker Pyramid board.
  - For purposes of prize payout each eligible hand will receive the full prize.
    - The prize will not be shared.
    - For instances where the prize is not a cash/chip item the player closest to where the action begins, per the base game rules, will receive the prize item and the other players will receive the items listed cash value in live casino chips.
- There is no limit to the amount a prizes a player may win during a promotional period.
- Two players minimum are required for the game of Texas Hold'em.
- Two players minimum are required for the above mentioned eligible controlled California games, the player and player-dealer.
- In all California games, except 3 Card Poker, patrons who assume the player-dealer position are eligible to win a prize.
  - In 3 Card Poker patrons who assume the player-dealer position are not eligible to win a prize.
- Third Party Provider of Proposition Player Services, on and off duty, will not be eligible to participate in the promotion.
- Off-duty, out of uniform employees are eligible to participate in the promotion and win.
- Tournament games do not qualify for the promotion.

#### **Prize**

The promotion has fixed prizes with amounts ranging in value from \$10 to \$10,000. Payout for prizes may be in the form of cash, live casino chips, merchandise, trips, poker tournament entries (GEGA-002073), or electronics. In all instances the prizes shall be predetermined and posted in the casino.

#### Funding

Parkwest Casino Cordova will fund the Poker Pyramid Promotion. There will be no additional jackpot fees or collection fees taken in order to fund this gaming activity or for players to participate.

#### **Administrative Fees**

Parkwest Casino Cordova will not retain any administrative fees for this gaming activity as it is house-funded.

#### **No Purchase Necessary**

The Poker Pyramid Promotion will be offered to customers who wish to participate for free, on a general and indiscriminate basis, with <u>no restrictions</u>, to patrons who wish to participate in a No Purchase Necessary game. The Casino will provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. <u>All advertisement material will state "No Purchase Necessary" when referencing the Poker Pyramid Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.</u>
