## Object and Summary

The California Games Qualifying Hand Promotion features a fixed promotional prize(s) attached to all the above listed games being played at the Village Club Casino. A player will be given the opportunity to enter the California Games Qualifying Hand Promotion drawing and be awarded a prize when a player in a game obtains a designated qualifying hand, as described below. When a qualifying hand is announced, a casino employee shall verify that the hand qualifies for the drawing. If the player has a qualifying hand, he/she shall be given the appropriate amount of drawing tickets, as advertised, and a casino employee shall enter the players first and last name and the date on each ticket. At a pre-determined and posted time, tickets are placed in the drawing bin and the bin shall be rotated. Once the tickets are thoroughly mixed, a casino

employee shall randomly draw one ticket from the bin. The winner shall be verified by a casino employee. Tickets are accumulated until the promotion is over and then discarded.

## Qualifying Hands

## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the controlled games, as stated above, during the pre-determined and specified times designated and posted for the gaming activity.

- There is no minimum or maximum number of players that must be seated and playing at a table in order for the table to be eligible for the drawing.
- If a ticket is drawn and the winner of the drawing is not present or does not claim the prize by reporting to the drawing area with two minutes, the ticket shall be put back in the drawing bin and another ticket will be drawn. This process will continue until a winner is present and receives a prize.
- Tournament game tables are not eligible for this gaming activity.
- Casino employees are not eligible to participate in this promotion, on or off duty.
- A Third Party Provider of Proposition Player is only eligible to participate in this gaming activity when off duty.
- Tickets are non-transferrable and can only be used by the player who earned them. The winning player will have their ID checked by card room personnel.


## Prize

The California Games Qualifying Hand Promotion features a fixed prize element. A player that has his/her ticket drawn shall be awarded a prize(s). The cumulative value of any and all prizes won shall range from $\$ 1$ to $\$ 100,000$. Prizes include: casino chips, cash, players club points (GEGA-004304), jewelry, electronics, clothing, vehicles, travel, entry into Bureau approved tournaments (Poker or California Games) or tickets into the Cash Drawing Promotion (GEGA004267). The prize(s) shall be pre-determined and posted by the card room.

## Funding

The California Games Qualifying Hand Promotion is fully funded by the Village Club. Therefore, there shall be no additional jackpot fees or collection fees taken for this promotion.

## Administrative Fees

The Village Club shall not retain an administrative fee as this promotion is house funded.

## No Purchase Necessary Table Requirement

The California Games Qualifying Hand Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions, to patrons who wish to participate in a No Purchase Necessary game. The Village Club will provide a table for all patrons who request to participate in the California Games Qualifying Hand Promotion without paying a table fee. There will not be live wagers at these tables. All advertisement material shall state "No Purchase Necessary" when referencing the California Games Qualifying Hand Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

# CARIBBEAN STUD POKER JACKPOT 

## SUMMARY OF GAME

Village Club proposes to add a progressive jackpot element to the game of Caribbean Stud Poker. Similar to the Jackpot games attached to Poker and Pai Gow Poker. The Player/ Dealer will be assessed a fixed fee, per hand and players will qualify for a prize when a designated second hand is beaten by a designated first hand. Prizes are paid from a prize pool ("Jackpot Fund") funded by a fee paid by participating players. Players may qualify for the full Caribbean Stud Poker Jackpot prize without paying a fee, or other consideration, by participating in free instructional games where there is no live wagering, no Jackpot Collection and no table fees ("No Purchase Necessary").

The rules and standards of play for the Caribbean Stud Poker Jackpots are the same as in Pai Gow Poker Jackpot Games currently been offered in Commerce and The Bicycle Casinos. The number of cards in the deck, the type of deck, the function of the dealer, the number of players, rotation of the player-dealer position, collection of table fees, betting limits and how winners are determined and paid will all be consistent with the approved version of Caribbean Stud Poker.

Since the jackpot element will be added to an existing game, the only change to the equipment will be in the addition of a separate collection box, which will be secured to the table and will be designated for the Jackpot Collection and used only for the collection of the jackpot funds. This will insure that Jackpot Collections are kept separate and apart from the table fee collection.

## The Prize

A prize ("Jackpot Prize") will be awarded when one player at a game obtains a specified second hand but loses to a player who obtains a better specified first hand ("Qualifying Hand"). As this is a progressive jackpot, the amount of the Jackpot Prize will vary depending on the volume of play and frequency in which players obtain a Qualifying Hand. Village Club will control the allocation of the Jackpot Collection to Jackpot Prize. The available Jackpot Prize will be posted on either an electronic board or poster centrally located in the California Games section of the casino. The posting will be updated as the prize is increased or decreased so that all players will have ample notice of the current Jackpot Prize.

When players obtain the specified hand combination and claim the Jackpot Prize, the qualifying hands will be verified by the dealer and a floorperson. Surveillance cameras will be utilized to assure all employees and customers followed the required procedures. The winning players' identification will be obtained and necessary paper work completed prior to the payout of the Jackpot Prizes. Village Club will record all
prizes awarded and the names of the winners as part of its Caribbean Stud Poker Jackpot accounting records.

## Funding

Caribbean Stud Poker Jackpot Prizes will be funded by a separate collection fee paid by players prior to the start of each hand ("Jackpot Collection"). The Jackpot Collection will be either $\$ 1.00$ per hand depending on the stakes of the game. The amount of the Jackpot Collection will be posted within view of each participating table.

Jackpot Collections are determined and collected prior to the start of each hand. Jackpot Collections are not calculated based on a percentage of the amount wagered. Village Club will provide the initial seeding of the Jackpot Fund and may from time-totime provide additional infusions of money to add to the size of the pool and the excitement of the game.

The Jackpot Collection will be posted by the player in the first Player-Dealer position. When there is more than one player participating in the first Player-Dealer position, the player who has the most money in action in the first Player-Dealer position will be responsible for posting the full Jackpot Collection.

## Jackpot Collection \& Accounting Procedures

The Jackpot Collection from all Caribbean Stud Poker will be collected, counted, secured and recorded in the same manner as the table fees paid to Village Club. The dealer will collect this fee (in the form of chips) prior to the start of each hand and deposit the fee in a locked Jackpot Collection Box at the table. The Jackpot Collection Box will be different from the box used for table fees. The locked Jackpot Collection Boxes will be gathered by casino security staff at designated times and transported to the secure Village Club count room. In the count room, the Jackpot Collection Boxes will be unlocked and the contents counted subject to minimum internal control standards similar to those used by Village Club in collecting its table fees and in other United States gaming jurisdictions. In addition, all count team activity is under constant observation of video cameras. The total dollar volume of the chips taken from each Jackpot Collection Box will be recorded on a Daily Jackpot Collection Report (AJackpot Collection Report@) that will be maintained as an accounting record and shall be available to the Division of Gambling Control and the City for audit and inspection. The Jackpot Collection Report will document the amount of Jackpot Collections received at each participating Caribbean Stud Poker gaming table during each shift.

## No Purchase Necessary Procedures

Caribbean Stud Poker Jackpots will be offered for free, on a "general and indiscriminate" basis, to patrons who wish to participate in a No Purchase Necessary game. Village Club will provide instructional tables for all patrons who request to participate in Caribbean Stud Poker Jackpots without paying a table fee or a Jackpot Collection. There will not be live wagers at these tables. Participants in No Purchase Necessary instructional tables will be eligible to win the full-posted Jackpot Prize if they participate in a game where players obtain the designated Jackpot Hands.
A person(s) that comes to play the jackpot at the "no purchase necessary" table will be dealt the maximum of eight hands. The no purchase necessary player will play only one hand and the casino dealer will play the remaining.

If the player wins the jackpot, only the portion of money that his/her hand qualifies for will be paid. The remainder will remain in the jackpot fund.

This will be done in the interest of fairness and in the spirit of the law, and as to give the no purchase necessary player the maximum opportunity to win the a portion of the jackpot prize. No purchase necessary tables follow the identical rotation procedure as regular player-dealer games. A no purchase necessary player will be offered the opportunity to act as the player dealer for two consecutive hands per round of play. If there are eight live players and everyone accepts the player-dealer position, each player will have the opportunity to act as player-dealer two hands per round.
If there are not eight players, the house dealer will play the hands for the vacant seats according to House Way. The house dealer will accept the opportunity to act as the player-dealer each time the opportunity arises.

Village Club will follow the regular game procedure for no purchase necessary tables. The player-dealer button will rotate around the table after every second hand. Players have the opportunity to decline to act as player-dealer. To the extent that a house dealer is playing the hand for a vacant seat, she will accept the opportunity to act as player-dealer and will play all hands House Way.

Village Club will do everything possible to make a no purchase necessary table available to patrons within fifteen minutes of a request. If no other patrons are available to participate in a no purchase necessary table within fifteen minutes of a request, Village Club will provide a table where the no purchase necessary player will play only one hand and the casino dealer will play the remaining hands according to House Way.

## Third Party Providers of Proposition Player Services

Third Party Providers of Proposition Player Services, as defined by Section 19980 of the California Business and Professions Code, their agents and employees ("Prop Player'"), are not eligible to win any portion of the Jackpot Prize. If a Prop Player receives a Qualifying Hand, its portion of the Jackpot Prize will not be paid and will remain in the Jackpot Fund. If a Prop Player is a participant in a Qualifying Hand with another player(s), the Prop Player will not be eligible to receive its portion of the Jackpot Prize and the full Jackpot Prize will be paid to the other players.

## Flat Administrative Fee

Village Club will retain a flat administrative fee from the Jackpot Fund based on the number of table hours that Caribbean Stud Poker Jackpots are offered ("Administrative Fee"). The Administrative Fee will not fluctuate based on the amount of money placed into the Jackpot Fund. Village Club reserves the right to adjust its flat Administrative Fee based on market factors and cost of operating Caribbean Stud Poker Jackpots. Village Club projects that its Administrative Fee will be in the range of $\$ 3.00$ to $\$ 6.00$ per table hour. Village Club will designate the flat Administrative Fee and will provide advance ample notice of its flat fee to all customers in accordance with Regulations adopted by the California Gambling Control Commission and/or the California Division of Gambling Control Regulations.

## Eligibility For the Jackpot Prize

Only patrons participating in the first Player-Dealer position is eligible to win the Jackpot Prize. If there is more than one player with a wager in the first player-dealer position, the Jackpot Prize will be divided pro-rata based on the amounts of their respective wagers between the players. All players in the player position, who have made a wager and have paid the table fee for any betting circle, regardless the amount wagered, are eligible to win and share the Jackpot Prize. Eligible players in the player position will share the Jackpot Prize in equal shares regardless of the amount of their wagers.

## QUALIFYING HAND FOR CARIBBEAN STUD POKER

In all California games, the player-dealer's hand plays against each of the other player's hands. If the player-dealer's hand has a lower ranking than a player's hand, the playerdealer loses the wager. If the player-dealer's hand has a higher ranking that a player's hand, the player-dealer wins the wager. If the player-dealer's hand ties with the other player's hand, the wager is a push. The no purchase necessary game rules are the same as regular rules. By definition, therefore, one of the Qualifying Hands in all California

Game Jackpots must be the player-dealer's hand. The player-dealer's hand must be one of the Qualifying Hands in all California Game Jackpot hands.

The Qualifying Hands for Caribbean Stud Poker Jackpots are:

1. Bad beat Jackpot Any flush (Second hand) beaten by higher flush or better ("First hand")

After the winning hands in a Bad Beat Jackpot are confirmed, the player who lost with the designated second hand will receive sixty ( $60 \%$ ) percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty ( $20 \%$ ) percent of the posted Jackpot Prize and the remaining twenty ( $20 \%$ ) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand
2. Super Jackpot: A full house ("second hand") beaten by the higher full house or better ("first hand").

After the winning hands in a Super Jackpot are confirmed, the player who lost with the designated second hand will receive sixty $(60 \%)$ percent of the posted Jackpot Prize for that game, the player with the designated first hand will receive twenty ( $20 \%$ ) percent of the posted Jackpot Prize and the remaining twenty ( $20 \%$ ) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.
3. Royal Jackpot: A Straight or less ("second hand") beaten by a Royal Flush ("first hand").

After the winning hands in a Royal Jackpot are confirmed, the player who lost with the designated hand will receive twenty (20\%) percent of the posted Jackpot Prize for that game, the player with the designated best hand will receive sixty ( $60 \%$ ) percent of the posted Jackpot Prize and the remaining twenty ( $20 \%$ ) percent of the posted Jackpot Prize will be evenly distributed among all other players at the table who have made a wager and paid a table fee collection for that particular hand.

To increase or decrease the frequency (odds) of the Caribbean Stud Poker Jackpots Qualifying Hands, Village Club reserves the right to adjust, the Qualifying Hands. Village Club will give ample advance notice to all patrons of any changes to the Qualifying Hands once the request to change the Qualifying Hand has been submitted and approved by the Division of Gambling Control. No change in the Qualifying Hand will be effective until a letter of approval by the Division of Gambling Control has been received.

## Advertising

Seven Mile Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001144) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in Seven Mile Casino at all times the gaming activity is being offered for play:

- Specific drawing dates and times
- Eligible games and time periods
- Designated qualifying hands
- Specific prize amount
- Eligibility of consolation prizes
- Specific number of tickets to be drawn
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

## Object and Summary

Players qualify for either drawing tickets (Option A) or envelopes (Option B) containing a prize by earning a qualifying hand based on the chart below. The below qualifying options shall be predetermined and posted before the beginning of the promotion. Only one option shall be used per promotion. Ticket and envelope earnings will range from 1 to 1000 tickets or envelopes per qualifying event.

## Option A

Drawings can take place from every minute to annually. There can be between 1 and 10,000 tickets with player's names drawn for each drawing time out of the drawing drum. Players that are not present when their name is drawn may be eligible for a predetermined consolation prize (described in the prize section). There may be from 1 to 100 additional tickets drawn for each drawing time until a winner is present. Prize amounts will range from $\$ 1$ to $\$ 500,000$.

## Option B

The Casino will place a small folded piece of paper with the prize written on the piece of paper inside an envelope. The patron will choose an envelope(s) from a predetermined and posted number of envelopes being held by a casino representative after the player achieves a predetermined qualifying hand. Once the patrons chooses an envelope, the casino representative will hand the envelope to the patron so the patron can open the envelope to reveal the piece of paper with the prize written on it the patron has won. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed among all other players at the qualifying table who have participated in the designated game, as shown below. Another posted percentage of the jackpot prize, known as the room share, shall be evenly distributed among all other players playing at Texas Hold'em games in the card room at the time the jackpot is hit. In all instances, patrons shall be provided with ample advance notice of the rules and restrictions when completing a qualifying jackpot hand. Furthermore, the jackpot prize shall be displayed prominently within the Seven Mile Casino at all times the jackpot is being offered for play.

## Qualifying Hands

Players that make the following qualifying hands shall be eligible to win their share of the Hold'em Bad Beat Jackpot prize amount, as shown below. Only a winning and losing hand that has been Bureau approved and pre-determined and designated by the Seven Mile Casino is eligible. Patrons shall be given ample notice of the specific hands that are being offered. Furthermore, the qualifying jackpot hands shall be displayed prominently within the Seven Mile Casino at all times.

All hands will be verified by the Seven Mile Casino house dealer and floor person. Two separate tally sheets, one for Omaha and one for Texas Hold'em, will be used to record all club flushes obtained during the promotional period. The club flush hand and the patron's name will be recorded.

All advertisement material shall state "No Purchase Necessary" when referencing the Lucky Charm Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## Object and Summary

The Omaha Bad Beat Progressive Jackpot features a progressive jackpot prize element. This promotion shall be available at predetermined dates and times posted in the Seven Mile Casino. During the promotion, players playing in the above listed controlled games will be eligible for $100 \%$ of the Omaha Bad Beat Progressive Jackpot prize. A prize is awarded to players participating in a jackpot qualified game when a designated hand is beaten by a better qualifying hand at the showdown. When the winning and losing hands are confirmed, players with the qualifying hands will receive the posted percentage of the jackpot prize. Additionally, a posted percentage of the jackpot prize, known as the table share, shall be evenly distributed amount all other players at the qualifying table who have participated in the designated game. Another posted percentage of the jackpot prize, known as the room share, shall be evenly distributed among all other players playing at qualifying tables in the card room at the same time the jackpot is hit.

## Qualifying Hands

Players that make the following qualifying hands shall be eligible to win their share of the Omaha Bad Beat Jackpot prize amount, as shown below. Both players holding those qualifying hands and all of those players who played at that table during the round of play in which jackpot occurred will receive a predetermined portion of the posted jackpot, known as table share. In addition, a percentage of the jackpot will be distributed among all other players playing at a qualifying table, called a room share. The qualifying hands are as shown below:

## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- A minimum of two (2) players are needed to participate in a live game in order for the table to be eligible for the jackpot. Nine (9) players is the maximum number of players allowed at a table.

## Prize

The Omaha Bad Beat Progressive Jackpot amount will start at $\$ 2,000$ and may be increased daily, by the Seven Mile Casino, from $\$ 1,000$ to $\$ 200,000$.

At the Seven Mile Casino's discretion, the jackpot may also be increased, from $\$ 1,000$ to $\$ 200,000$, during specific time periods ranging from one half hour to one month.

In addition to the table share, players who are playing on the table where the jackpot hits will be eligible for a bonus payout. They must have scanned hours on their Player's Club Promotion Card (GEAR-001085) ranging from 20 to 80+ hours one week prior to the jackpot hitting.

Bonus payouts will range from:
A. 20-29 hours will receive $\$ 100-\$ 500$

If the percentage breakdown of the jackpot prize pool for the room share exceeds $\$ 200$ per player, the monies above and beyond $\$ 200$ per player will be placed back in the jackpot prize pool for future jackpot payouts, which will immediately be used to re-seed the jackpot.

## Funding

The Omaha Bad Beat Jackpot utilizes a progressive prize pool which shall be house funded. Therefore, there shall be no additional jackpot fees or collection fees taken for this jackpot. All fee collections and table limits are for the designated controlled game and are Bureau approved, pre-determined, and posted at each table.

The jackpot shall initially be seeded by the Seven Mile Casino in the amount of $\$ 2,000$. Furthermore, the progressive jackpot prize pool will progress until it is won. At management's discretion, the jackpot may be capped and a reserve jackpot may be used as progressive. Once the main jackpot is hit (paid out) the reserve would be posted. When the jackpot is hit, it will be re-seeded in an amount between $\$ 1,000$ and $\$ 100,000$, and will increase in the values previously listed.

## Administrative Fees

The Seven Mile Casino shall not retain an administrative fee as the Omaha Bad Beat Jackpot is house funded.

- Qualifying winning and losing hands.
- Prize amount and prize types.
- Any other applicable restrictions.
- Availability of No Purchase Necessary tables.


## Eligible Controlled Games

The Pocket Aces Promotion shall be attached to the following Bureau approved controlled games offered at Seven Mile Casino, as show below, at all times this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau.

- Texas Hold'em (GEGR-0001769)


## Object and Summary

The Pocket Aces Promotion features a fixed promotional prize element attached to the games listed above. A prize shall be awarded to a player participating in a Bureau approved attached game when that player is dealt two aces in their initial hand.

- A player that receives a qualifying hand will fill out their name and Seven Mile Player's Club Card number (GEAR-001085) on a ticket, which will then be placed in a drum for a drawing. Tickets will be collected over the course of the promotion and securely stored for the duration of the promotion.
- During pre-determined times and intervals of the promotion, Seven Mile Casino staff will announce the commencement of the drawing. The tickets placed in the drum will be mixed.
o The drum will be made of clear plastic with a size of about three feet in length and sixteen inches wide. A handle on the side of the drum will be used to rotate the drum and mix the tickets.
- Once the tickets are thoroughly mixed, a casino employee will randomly draw one ticket from the drum. If a ticket is drawn and the winner of the drawing is not present, the ticket will be placed back in the drawing drum and another ticket will be drawn. ## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- There is no minimum or maximum number of players required to be participating in a game in order for the table to qualify for the promotion.
- The qualifying hand must contain both hole cards in order to be eligible for this promotion.
- A player with an advertised hand must complete the showdown in order to be eligible for a ticket.
- When a player's ticket is selected during the drawing and he/she becomes eligible to spin the prize wheel, that player will receive $100 \%$ of the posted and pre-determined prize amount based on where the wheel stops. A prize will only be awarded to the player whose ticket is drawn and spins the wheel.
- The drawing times will be pre-determined and posted in advance during the promotional period.

The NPN player must adhere to all rules as the live player, with exception to the number of necessary players required at a live game. All advertisement material shall state "No Purchase Necessary" when referencing the Pocket Aces Promotion gaming activity. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

Seven Mile Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GETR-000126) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in the Seven Mile Casino at all times the gaming activity is being offered for play:

- How a player may enter the tournament.
- The game(s) that will be offered during the play of the tournament.
- The fees that will be charged for entering the tournament, including a description for each fee charged and whether it shall be retained by the Casino, added directly into the tournament prize pool, or any other method of retention or distribution.
- The amount of tournament chips that will be awarded to each player upon entry into the tournament.
- The tournament prize structure that will be offered and the number of players that will be paid.
- When the patron(s) will be paid and the manner in which they will be paid.
- Any other restrictions that apply to the Poker Tournaments.


## Tournament Log

Seven Mile Casino shall maintain all completed tournament logs for at least seven years. These logs shall be maintained in either paper or electronic format. The cardroom shall also retain and make available the most recent three months of the tournament logs for inspection by a representative of the Bureau during all hours of operation. Upon request of the Bureau, a licensee shall provide the Bureau with copies of such tournament logs. Tournament logs shall contain the following information:

- Name of Gambling Establishment
- Day, date, time and name advertised for the tournament
- Total number of tables used
- Name of controlled games offered
- Method of entry
- Number and amount of rebuys and/or add-ons offered
- Number of participants
- Name of each fee charged, amount of each fee charged, total number of each fee collected, and cumulative amount collected
- Source of all funds for tournament prize pool
- Amount of the prize pool
- Amount and reason for any deductions from the total collected prize pool
- Name of gaming activities offered (when applicable)
o Funding source
o Prize amount
o Total number of prizes awarded
o Total amount deducted from prize pool (when applicable)
- Results of the tournament, including the total amount paid out and amount paid for each place in the tournament
- Printed name and signature of the casino staff responsible for administering the tournament


## Eligible Controlled Games

The Poker Tournaments shall be attached to all Bureau approved Poker controlled games offered at the Seven Mile Casino at all times that the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

## Gaming Activities Offered During Tournament Play

There will be no gaming activities attached to Poker Tournaments.

## Tournament Entry

- Tournament entry is open to all customers.
- The specific structure will be on any and all advertisements and must be made available to patrons prior to the start of the tournament. The structure of a tournament will not change once sign-ups begin.
- Promotional materials will not advertise gender-based discounts nor imply a gender-based entrance policy.
- Patrons may enter a tournament by paying the buy-in and entry fee. All fees, prices charged, and the amount of tournament chips provided will be equal for the initial buy-in and posted for all players.
- Entry may be earned by winning a previous tournament, playing a daily tournament or live game, points earned in tournament and live play, or a Bureau approved gaming activity. All gaming activities and/or promotions shall be approved by the Bureau prior to being offered for play.
- More than one method of entry for a specific tournament may be utilized.
- Partial entry may also be used to offset full entry fees for specified tournaments.

*The Entry Fee may be retained by Seven Mile Casino as income, and/or to pay expenses and tips for house dealers and staff. This fee shall not be included in the tournament prize pool.
**The Administrative Fee is used exclusively to pay tournament staff. This fee shall not be included in the tournament prize pool.
${ }^{* * *}$ The Staff Appreciation Fee is used exclusively to pay tournament dealers. This is an optional fee that tournament entrants can pay in exchange for additional starting tournament chips. This fee shall not be included in the tournament prize pool.

## Tournament Prize Amounts \& Source of Funds

The prizes will be the cumulative amount of buy-ins, re-buys, and add-ons. The prizes may also be guaranteed. The cardroom may provide prizes or add funds to the prize pool for special events.

- When the prize amount is guaranteed the payouts will be a cash value ranging from \$1$\$ 100,000$. The cash will be paid to players from the buy-ins, re-buys, and add-ons. If there is not enough cash to cover the guaranteed prize amount, Seven Mile Casino will fund the difference.
- When the prize pool is not based solely on buy-ins, re-buys and add-ons, Seven Mile Casino will determine and set the payout structure.
- Seven Mile Casino may add a fixed amount to any tournament prize pool.


## Tournament Prize Structure

When the prize is not guaranteed, the prize structure will be broken down by the number of paid entries and percentage paid. The percentage paid out will always equal 100\%. In the event the players decide to forgo the payout structure and "split" the total prize pool among them, it shall be permitted and shall be noted in detail on the casino's tournament log.

Promotional prizes may consist of cash, live casino chips, Promotional Chips (GEAR-001152), jewelry, electronics, clothing, vehicles, watercrafts, gift certificates, sporting events, concert tickets, gift certificates, entertainment, food comps, drawing tickets (GEAR-001144, GEAR000976, GEAR-001145), spinning the wheel (GEAR-001150), entry into future Poker Tournaments, and travel. Patrons shall be given ample notice of what prize is being offered and it shall be displayed prominently.

## Entities Involved Other Than the House

At any time, Seven Mile Casino may offer a charity tournament that would include other organizations. These organizations shall be reputable and federally recognized as nonprofit or charity organizations. These organizations will not be involved in running the tournament; however, their name may be used in conjunction with the advertising and promoting of the event. Seven Mile Casino may donate prizes such as entries into Seven Mile Casino tournaments at no cost to the charity.

## Bureau Requirements

## Advertising

Seven Mile Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001150) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in Seven Mile Casino at all times the gaming activity is being offered for play:

- Specific drawing dates and times
- Eligible games and time periods
- Specific prize amounts
- Specific number of table and seat numbers to be drawn
- Restricted to Player's Club Members (GEAR-001085)
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity


## Eligible Controlled Games

The Progressive Drawing Promotion gaming activity shall be attached to all currently Bureau approved controlled games offered at Seven Mile Casino at all times that this gaming activity is being offered for play. All controlled game rules shall be played as previously approved by the Bureau

## Object and Summary

The Progressive Drawing Promotion involves a drawing where a bin, basket, lottery ball machine, or other non-electronic randomizer will be used. During pre-determined times and intervals of the promotional period, a casino representative will announce the commencement of the drawing. The drawing to determine a lucky table and lucky seat using cards, balls, or lammers, which are pre-printed, equally sized and colored. For the lucky table drawing, a card, ball or lammer that represents each active table will be mixed within the randomizer. A casino representative will then select one to determine the winning table. Once the eligible table is determined, the lucky seat will be determined by placing cards, balls, or lammers into the randomizer and selecting one. The number of seats at the winning table determines the amount of cards, balls, or lammers that will be placed into the randomizer (e.g. if the table has 7 seats, then 7 cards, balls, or lammers would be placed into the randomizer). If no one is sitting at the selected seat, another card, ball, or lammer will be drawn until a winner is chosen. Once the table number and seat number are determined, the player sitting at the selected seat will spin a wheel to determine their prize.

The prize will be awarded when the player spins the prize wheel and it stops on a spot on the wheel.

- The wheel contains between 10 and 100 spots. One or more of the spots on the wheel will have progressive prize amounts (described below).
- Each spot on the prize wheel will have a designated cash prize value or other eligible prizes between $\$ 1$ and $\$ 500,000$. Prize amounts will be predetermined prior to the guest spinning the wheel.
- Other eligible prizes will have words representing the prize, such as double spin, triple spin, or other eligible prizes listed in the prize section below.

In the event that any prize other than the progressive is won, the progressive prize amount will increase between $\$ 50$ and $\$ 10,000$ until the progressive prize reaches the predetermined and posted cap valued between $\$ 2,000$ and $\$ 50,000$. Regardless, the updated progressive amount will be displayed prior to the table and seat number drawing.

The final drawing of the promotional period will be a "must go" and all the advertised progressive prize money will be distributed. If the player that spins the wheel for the last promotional time does not win the progressive prize the progressive prize pool will be awarded by drawing a predetermined number of table and seat numbers, between 1 and 50 table/seat numbers will be drawn and split evenly between the players that are in those seats.

Example: The final progressive spin is at 11:00 pm on Tuesday and the progressive prize amount is $\$ 3,500$. The 11:00 pm winner spins the wheel and does not win the progressive amount. The casino representative will draw ten (10) additional table and seat numbers and these players will split the $\$ 3,500$ evenly (\$350 each player).

## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the predetermined specified hours posted for the gaming activity.

- There is no minimum amount of time played in order to be eligible for this promotion. A player must be actively playing to be eligible to spin the wheel.
- Lucky seat qualifications will be posted prior to and during the time that the gaming activity is offered.
- Players that are playing multiple hands on a California game will be eligible to win at each seat they are wagering in. Players wagering in multiple seats can only win in one seat per drawing.
o For example; a player is playing on table 4 and placing wagers in seats 2,3 and 4 . If table 4 seat 3 is drawn, the player is eligible to spin the wheel but cannot spin multiple times on that drawing time.
- There is no minimum or maximum number of players that must be seated and playing at a table in order for the table to be eligible for this promotion other than what is required by the Bureau approved game.
- Backline bettors are not eligible for this promotion.
- This promotion is restricted to Player's Club Members (GEAR-001085).
- The winning player will have their ID verified by a casino representative.
- There is no limit to how many prizes a player can win during a promotional period.
- Casino employees are not eligible to participate in this promotion when off duty and out of uniform.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible to participate in this gaming activity.
- Tournament games are eligible for this gaming activity.
- The player-dealer position is not eligible to spin the wheel. In the case the playerdealer's seat is chosen, a new lucky seat will be drawn.
- A wheel spin must complete three rotations in order to be valid.
- If a valid spin is not completed, the player shall be warned. If on the player's second attempt, the wheel does not complete three spins, they shall forfeit their chance at a prize. A new player shall then be drawn through the lucky seat process.
- If a pointer is stuck or rests on a wheel peg, the player shall choose one of the two applicable prizes.
- Any interference to the wheel shall void the spin and the player will re-spin the wheel. If it is the player who interferes with the spin, he or she shall be warned. If it occurs on the subsequent spin, he or she will forfeit their chance at a prize and a new player will be drawn through the lucky seat process.


## Prize

Prizes will be in the form of cash, live casino chips, Promotional Chips (GEAR-001152), jewelry, electronics, clothing, vehicles, watercrafts, gift certificates, sporting events, concert tickets, entertainment, food comps, drawing tickets (GEAR-001144, GEAR-000976, GEAR-001145), entry into tournaments (GETR-000126) and travel, and hotel accommodations ranging in value from $\$ 1$ to $\$ 500,000$.

## Funding

The Progressive Drawing Promotion is funded by Seven Mile Casino. There shall be no additional fees collected for this gaming activity.

## Administrative Fees

The Seven Mile Casino shall not retain an administrative fee for this promotion as this promotion is house funded.

## No Purchase Necessary

The Progressive Drawing Promotion shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Progressive Drawing Promotion. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## Bureau Requirements

## Advertising

Seven Mile Casino may advertise various names for this gaming activity. Should Seven Mile Casino advertise a different name, the BGC ID (GEAR-001170) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in Seven Mile Casino at all times the gaming activity is being offered for play:

- Eligible dates and time period(s)
- How to purchase Promotional Chips (GEAR-001152)
o Necessary amount of Promotional Chips (GEAR-001152) to buy, and the amount of additional chips that will be received
o The maximum number and value of Promotional Chips (GEAR-001152) buy-ins available to purchase (if a limit is in place)
- Eligible games and tables
- Any other restrictions that apply to this gaming activity


## Eligible Controlled Games

The Promotional Chip Bargain Buy-In shall be attached to all Bureau approved California games offered at Seven Mile Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

## Object and Summary

The Promotional Chip Bargain Buy-In will award players who play during the pre-determined and specifically posted hours with an opportunity to purchase Promotional Chips (GEAR001152) at a discount to the face value of the chip or receive an extra amount of Promotional Chips (GEAR-001152) with the purchase of live casino chips from the California games attendant or at the cashier cage. The Promotional Chips (GEAR-001152) can only be wagered during pre-determined dates and times. Players who purchase Promotional Chips (GEAR001152) will be eligible to wager the chips during the play of any Bureau approved California game offered at Seven Mile Casino as described in the Promotional Chips (GEAR-001152) Bureau approved rules. All rules, including wagering methods related to Promotional Chips (GEAR-001152), must be followed as described in the GEAR-001152 Bureau approved rules.

Example A: Players will receive $\$ 60.00$ in Promotional Chips (GEAR-001152) for the purchase price of $\$ 30.00$.

Example B: Players will receive $\$ 30.00$ in live casino chips, plus (an extra) $\$ 30.00$ in
Promotional Chips (GEAR-001152) for the purchase price of $\$ 30.00$.

## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- The promotion will be open only to the players who have purchased Promotional Chips (GEAR-001152), seated and playing at an eligible game during the pre-determined and specified hours designated for the promotion.
- The Casino may place a limit on the maximum number of players who can participate in the Promotional Chip Bargain Buy-In. When a limit applies, the promotion will be awarded on a first-come, first serve basis.
o Example: The promotional period is from 7pm to $9 p m$ and it is offered to the first 100 players.
- Promotional Chips (GEAR-001152) are available for purchase only during the predesignated day/hour selected and posted at the Casino.
- Casino employees are eligible to participate and win when off duty and out of uniform.
- Third-Party Provider of Proposition Player Services (TPPPS) are not eligible to participate in this promotion as a player.


## Prize

The Promotional Chip Bargain Buy-In features a fixed prize element ranging in value from $\$ 5$ to $\$ 50,000$ in the form of promotional chips (GEAR-001152), as pre-determined and designated by Seven Mile Casino.

## Funding

The Promotional Chip Bargain Buy-In is house funded by Seven Mile Casino. There shall be no additional promotion fees, jackpot fees, or collection fees taken in order to fund this gaming activity or for players to participate.

## Administrative Fees

Seven Mile Casino shall not retain any additional administrative fee for this gaming activity as the promotion is house funded.

## No Purchase Necessary

The Promotional Chip Bargain Buy-In does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## Promotional Chips

## Bureau Requirements

## Advertising

Seven Mile Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001152) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in Seven Mile Casino at all times the gaming activity is being offered for play:

- Eligible games and time periods
- Match play, free play, or one-time free play chips or coupons value(s)
- Procedures to redeem vouchers for match play, free play, or one-time free play chips
- Collection fee procedures
- Any other restrictions that apply to this gaming activity


## Eligible Controlled Games

The Promotional Chips promotion shall be attached to all Bureau approved California games offered at Seven Mile Casino at all times the gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

## Object and Summary

Patrons are awarded match play, free play, or one-time free play coupons, vouchers, or chips via hand-outs, advertisements in magazines, websites, mailing advertisements, winning a Bureau approved promotion, winning or signing up for a Bureau approved tournament, transportation to the Casino via the Casino's bus system, etc. When a patron receives a match play, free play or one-time free play voucher, he or she shall take the voucher to the cage or casino representative for verification, logging, and redemption. The casino representative in the cage will then exchange the voucher for the corresponding promotional chip or coupon, which can then be used for play. Players who receive a match play chip or coupon will be eligible to win the specific amount printed on the chip or coupon if he or she places a wager on an eligible game equal to or greater than the amount listed on the match play chip or coupon. Players who receive a free play or one-time free play chip or coupon will be eligible to win the specific amount printed on the chip or coupon on an eligible game equal to the amount listed on the free play or one-time free play chip or coupon. Players may add live chips to a free play or one-time free play chip or coupon.

## Match Play Chips and Coupons

- Seven Mile Casino will offer match play chips or coupons having a face value of $\$ 1$ to $\$ 10,000$ per chip or coupon. The amount will be clearly stated on the chip or coupon.
- Match play chips and coupons can be played on any Bureau approved California game unless otherwise advertised. If there are any limitations to which game(s) a match play chip or coupon can be used on, each chip or coupon will state the specific qualifying game(s) that the chip or coupon may be used on.
- The player must place the match play chip or coupon on the table and must place a wager equal to or greater than the amount of the match play chip or coupon. Match play chips and coupons shall not be taken into the dealer's tray, nor shall they be paid from the house dealer's tray.


## Promotional Chips

- When the player uses a match play chip or coupon and the hand wins, the player will be paid for the total wager (live chip(s) plus the match play chip or coupon value) and the used match play chip or coupon is collected by the house dealer and dropped into the drop box for accounting purposes.
- When the player uses a match play chip or coupon and the hand loses, the player will only lose his or her original wager and the used match play chip or coupon is collected by the player-dealer. Match play chips and coupons are given to a casino representative and is taken to the cage, logged, and exchanged for the value listed on the chips or coupons. The exchanged value (in live chips) is then brought back to the player-dealer.
- If the player pushes (receives no action), the chip or coupon may be played again until the player wins or loses a hand.

EXAMPLE: A person receives a match play chip with a value of $\$ 5$ that specifically states it may be used to place a wager on the Fortune Pai Gow Poker table. The person would place the match play chip on the gaming table; place a bet that is at least the amount on the match play chip, and pay the posted collection (if applicable) for a single hand of play. The collection fee is based on the combined total of the wager and the match play chip. If the player wins the hand, he/she will receive $\$ 10$ just as if they had placed a $\$ 10$ bet and the player-dealer will collect the match play chip.

## Free Play Chips and Coupons

- The Casino will offer free play chips or coupons having a face value from $\$ 1$ to $\$ 10,000$ per chip. The free play chips or coupons are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash. The amount will be clearly stated on the chip or coupon.
- Free play chips and coupons can be played on any Bureau approved California game unless otherwise advertised. If there are any limitations to which game(s) a free play chip or coupon can be used on, each chip or coupon will state the specific qualifying game(s) that the chip or coupon may be used on.
- Free play chips or coupons shall be used as the player's bet and placed on the betting circle. Free play chips or coupons shall not be taken into the house dealer's tray, nor shall they be paid from the house dealer's tray.
- When the player uses a free play chip or coupon and the hand wins, he or she would be paid in live chips by the person in the player-dealer position just as if he or she had placed a normal wager. The free play chip or coupon may be played again until the player loses the hand.
- When the player uses a free play chip or coupon and the hand loses, the free play chip or coupon is forfeited and will be collected by the player-dealer. The player-dealer will then have casino representative verify that the chip or coupon has been played. Vouchers are given to a casino representative and is taken to the cage, logged, and exchanged for the value listed on the chips or coupons. The exchanged value (in live chips) is then brought back to the player-dealer.
- If the player pushes (receives no action), the chip or coupon may be played again until the player wins or loses a hand.

EXAMPLE: A player receives a free play chips or coupons coupon for $\$ 10$ that specifically states it can be used to place a wager on the Fortune Pai Gow Poker table. The player would then place the free play chips or coupons on the gaming table, pay the posted collection (if applicable), and the game would play.

## Promotional Chips

## One-Time Free Play Chips and Coupons

- The Casino will offer one-time free play chips or coupons having a face value from $\$ 1$ to $\$ 10,000$ per chip. The one-time free play chips or coupons are used in live games exactly like regular chips, the difference being that they cannot be exchanged for cash. The amount will be clearly stated on the chip or coupon.
- One-time free play chips and coupons can be played on any Bureau approved California game unless otherwise advertised. If there are any limitations to which game(s) a onetime free play chip or coupon can be used on, each chip or coupon will state the specific qualifying game(s) that the chip or coupon may be used on.
- One-time free play chips or coupons shall be used as the player's bet and placed on the betting circle. One-time free play chips or coupons shall not be taken into the house dealer's tray, nor shall they be paid from the house dealer's tray.
- When the player uses a one-time free play chip or coupon and the hand wins, he or she would be paid in live chips by the person in the player-dealer position just as if he or she had placed a normal wager. The one-time free play chip or coupon is forfeited and collected by the house dealer and then dropped in the drop box for accounting purposes.
- When the player uses a one-time free play chip or coupon and the hand loses, the onetime free play chip or coupon is forfeited and will be collected by the player-dealer. The player-dealer will then have casino representative verify that the chip or coupon has been played. Vouchers are given to a casino representative and is taken to the cage, logged, and exchanged for the value listed on the chips or coupons. The exchanged value (in live chips) is then brought back to the player-dealer.
- If the player pushes (receives no action), the chip or coupon may be played again until the player wins or loses a hand.


## Eligibility Requirements

This gaming activity shall be open to all players who are seated and playing at any of the above listed controlled games during the pre-determined specified hours designated and posted for the gaming activity.

- A minimum of two (2) players, a player and a player-dealer, is required to be playing in any of the games, as listed above, in order for the game to qualify.
- Each coupon will state the specific qualifying game(s) for which the player may use the coupon.
- Match play, free play, and one-time free play coupons, vouchers, and chips will not expire unless there is an expiration date printed on them. After that date has passed, the coupons will be void and unusable.
- Casino employees are eligible for the promotion when off duty and out of uniform.
- Third-Party Providers of Proposition Player Services (TPPPS) are not eligible for the promotion.
- Match play, free play, or one-time free play chips and coupons shall only be used in the player position and not in the player-dealer position.
- There is no limit to how many times a player may participate in this gaming activity within a promotional period.
- Match play, free play, and one-time free play coupons, vouchers, and chips cannot be used to pay collection fees, place bonus bets or jackpot fees.
- All applicable collection fees shall be paid as if the player was using live casino chips.
- Players shall not exchange the coupons for live chips or give them to another player.
- Coupons are not eligible with tournament games.
- Backline bettors are eligible to participate in this gaming activity.


## Promotional Chips

## Prize

The match play, free play, or one-time free play chips, coupons, or vouchers shall have a value ranging from $\$ 1$ to $\$ 10,000$ for each coupon or chip.

## Funding

The Promotional Chips Promotion shall be fully funded by the Casino.

## Administrative Fees

Seven Mile Casino shall not retain an administrative fee as part of this promotion, as this promotion is house funded.

## No Purchase Necessary

The Promotional Chips Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this gaming activity.

## Bureau Requirements

## Advertising

Seven Mile Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001145) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for the gaming activity, including but not limited to the following, shall be prominently displayed or readily available in Seven Mile Casino at all times the gaming activity is being offered for play:

- Specific drawing dates and times
- Eligible games and time periods
- Designated qualifying hands
- Specific prize amount and prize type
- Specific number of tickets to be drawn
- Availability of No Purchase Necessary
- Any other restrictions that apply to this gaming activity

## Object and Summary

Seven Mile Casino allows patrons to earn tickets for the Qualifying Hand Drawings by obtaining a qualifying hand according to the chart below. Player's Club members (GEAR-001085) who obtain a designated qualifying hand shall receive a number of ticket(s) for a random, nonelectronic Qualifying Hand Drawings to be conducted at a specified day and time. Qualifying hands will be verified by a casino representative. Tickets are generated from the Player's Rewards Program (GEAR-001085) and contain the following information: Player's Name, Player's Rewards Number, and information regarding when the drawing will take place. Once the ticket is printed, the ticket will automatically be placed in the drawing drum by a casino representative for the eligible drawing and drawn at the predetermined and posted times. On the day of the Qualifying Hand Drawings, Seven Mile Casino will draw a predetermined number of tickets throughout each drawing period.

Example: The Casino may draw one ticket per 30 minutes from 8 am to midnight. The player whose ticket is drawn will be awarded a predetermined and designated prize.

## Qualifying Hands

A player who has one of the qualifying hands listed below shall earn a predetermined amount of tickets to be entered into the Qualifying Hand Drawings for a predetermined and posted prize.

## Qualifying Hand Drawings

## Administrative Fees

Seven Mile Casino shall not retain an administrative fee for this promotion as this promotion is house funded.

No Purchase Necessary
The Qualifying Hand Drawings shall be offered to customers who wish to participate for free, on a general and indiscriminate basis, with no restrictions. The Casino shall provide No Purchase Necessary tables for all patrons who request to participate in the gaming activity without paying a table fee or placing a live wager. All advertisement material shall state "No Purchase Necessary" when referencing the Qualifying Hand Drawings. This requirement extends to all forms of advertising including electronic message boards, computer monitors, posters, and flyers.

## Bureau Requirements

## Advertising

The Casino may advertise various names for this gaming activity. Should the Casino advertise a different name, the BGC ID (GEAR-001085) shall be referenced on all advertisements relating to this gaming activity.

Furthermore, all rules and procedures for this gaming activity, including but not limited to the following, shall be readily available to guests and prominently displayed in the Seven Mile Casino at all times the gaming activity is being offered:

- Corresponding time played and possible points to accrue
- The date(s) and time(s) the gaming activity shall be offered
- The corresponding points and prize amount
- The prize(s) offered to players meeting the requirements of the gaming activity
- Player Card Tier levels and corresponding tier points required at each level
- Any other applicable restrictions


## Eligible Controlled Games

The Players Club Promotion shall be attached to all Bureau approved games offered at Seven Mile Casino at all times this gaming activity is being offered for play. All controlled game rules shall be played as approved by the Bureau.

## Object and Summary

The Players Club Promotion features a promotional element attached to Bureau approved games offered at the Casino. This gaming activity is a player reward loyalty program open to all casino patrons. This promotion will reward players with points based on time played and /or average wagers at designated table games during pre-determined and eligible periods.

## How Prizes and Tiers are Earned Based on Time Played and/or Amounts Wagered

 Prizes shall be earned by the amount of time played and/or the average amount of money wagered per seat. Each player that plays a Bureau approved game shall have a designated casino employee swipe, scan, tap, or otherwise track their Player's Club Card or card number and have their hours played and average wagers tracked. The Casino may create $1-16$ tiers, in which players can earn between 1 to 100,000 points at different rates and/or be eligible for different tiers and prizes. Each hour will account for 1 to 10,000 points. Each point will be worth $\$ .005$ to $\$ 1$ per point. The Casino may select one or more of the following thresholds to create multiple tiers, ranging from the following minimum points:1. $0+$ Points earned in 3-6 months
2. 1,000+ Points earned in 3-6 months
3. $2,500+$ Points earned in 3-6 months
4. $5,000+$ Points earned in 3-6 months
5. $7,500+$ Points earned in $3-6$ months
6. $10,000+$ Points earned in 3-6 months
7. $15,000+$ Points earned in $3-6$ months
8. 20,000+ Points earned in 3-6 months
9. $25,000+$ Points earned in $3-6$ months
10. 30,000+ Points earned in 3-6 months
11. 40,000+ Points earned in 3-6 months

12. $50,000+$ Points earned in 3-6 months
13. $75,000+$ Points earned in 3-6 months
14. 100,000+ Points earned in 3-6 months
15. 125,000+ Points earned in 3-6 months
16. 150,000+ Points earned in 3-6 months

For example, the casino may choose to offer a bronze and silver tier in the Players Club Promotion and designate the bronze tier at threshold \#1 and the silver tier at threshold \#6 for a 4-month earning period. Players earning 10,000+ points during the period would earn a silver tier.

## How Prizes are to be Redeemed

Players may redeem their points for prizes at any time during the promotion. All prizes shall have a pre-determined and designated value. Prizes shall be earned by the amount of time played and/or the value of the wager during the promotional period. After a player has accumulated a predetermined and specific amount of points, a player may redeem the accrued points for a predetermined and designated prize(s).

- After a player has been awarded a prize, they may also be eligible for multiple and subsequent prize(s) until the end of the promotion.
- A player may be eligible for prizes based on their tier category.
- A player may view the amount of points they have earned by (1) scanning their card at an available Player's Club Card kiosk, (2) asking an employee at the Board Ops Desk, or (3) through their mobile application.
- Points are non-transferrable, and can only be used by the player who earned them.
- The system shall redeem points by redeeming the oldest points first.


## Player's Club Card Computer System Description

The Player's Club Card shall include the Casino logo and name on the card, the player's name, some descriptive language regarding restrictions for the card and/or where to find all of the rules, and the problem gambling phone number. It shall also include a RFID chip, magnetic strip, bar code, or other technology used to identify the unique player card number for each player in Seven Mile Casino player tracking system.

- The card shall be non-transferable, and revocable at management's discretion.
- The Player may use an electronic version of the card located on their mobile device through the Casino's mobile application.
- Lost or damaged cards shall be replaced by the Seven Mile Casino free of charge to the guest. If a player repeatedly loses their card, the Casino reserves the right to charge a replacement fee based on the cost of the card, not to exceed $\$ 5$.
- Player information shall be maintained in a secure database accessed only by casino employees. Access to the database shall also be tracked by casino management.
- Points in accounts with no player card activity (points accrued) for a period of six months automatically expire at the beginning of the following month.
- The system shall automatically expire points that have been unused after 365 days from their accrual regardless of whether the player is active or inactive.


## Player's Club Promotion

- Player's time played and/or average wager are tracked by having the player place their card on the table top, scanning the card into the system, or by other means where the casino representative records that a player has presented their Player's Card when they sit down to start playing. The player remains in the system accruing time until one of the following occurs: a) the player leaves the game and removes their card from the table; b) the player temporarily leaves the game and the casino representative puts them in lobby mode and then back in when they resume play; c) the player leaves the game and the casino representative clocks them out of the system.
- Tier points may be earned during a designated time period to determine the Players Club Card level. The Tier points have no cash value.
- Management reserves the right to adjust account points due to computer error, machine malfunction, operator error, or the misuse of the player account.
- Player information shall be maintained in a secure database accessed only by authorized casino representatives. Access to the database shall also be tracked by casino management. No one except the network administrator(s) has access to the back-end systems where the data is stored. The data may be securely transmitted to a separate electronic tracking system related to Bank Secrecy Act and/or Anti-Money Laundering compliance review. Access to the data is by user level with multiple levels based on what the user will be doing. Marketing manager will have access to customer data for marketing purposes (i.e., emails, texts, mass mailing, etc.) The Compliance Department will have access to information necessary for reviewing transactions in compliance with Title 31 requirements and any other applicable federal or state laws.
- A printable record of the amount of time and/or average wagers a player has accumulated during the period of time that the gaming activity is being offered, shall be available at any time, upon their request.
- All data is backed up to an on-site computer. All data is stored on a system so that single hard drive failures won't affect it. The system is backed up every 24 hours.


## Eligibility Requirements

This gaming activity shall be open to all players 21 years of age and older with valid I.D. who sign up for a Player's Club Card and participate in an eligible game for a designated period of time to earn points. When the player chooses to exchange their accrued points, they shall win a corresponding prize.

- Eligible time periods will range from one minute to ten thousand hours.
- Eligible dates will range from one day to one year.
- At least two players shall be playing at a Poker game or California game in order for the players at the table to be eligible for this promotion.
- The player is responsible for presenting their card/player's card number and ensuring it is placed on the table and/or recorded. Players can verify their card is earning time by inquiring with a casino representative to confirm time played and points earned.
- The Casino may require enrollment in the player rewards system as a condition to participate in a Casino gaming activity, as long as that provision has been approved by the Bureau in advance.
- Players must be seated and playing at a designated table in order to qualify for the promotion.
- Employees are eligible to have a Player's Club Card, and can participate in the promotion at any time they are off the clock (not working).
- Third-Party Proposition Players shall not be eligible to participate in this promotion; however, an employee of a Third Party Proposition Player may participate when they are not working for the Third Party.
- A player in the player-dealer position is eligible to participate in this gaming activity in the same manner as a patron in the player position.
- Tournament games do not qualify for this promotion.
- Backline bettors are eligible for this gaming activity.


## Prize

The prize amount shall be a fixed value ranging from $\$ 0.005$ to $\$ 100,000$. Prizes include cash, live casino chips, player's club points, jewelry, hand bags and accessories, electronics, clothing, vehicles, watercraft, gift certificates, entertainment tickets, food and beverage comps, home appliances, sports memorabilia/equipment, cruises, VIP tours, preferred parking/line entry, car wash, entry into tournaments (GETR-000126), travel, Promotional Chips (GEAR-001152), drawing entries (GEAR-001144, GEAR-000976, GEAR-001145), spinning the wheel (GEAR001150), and hotel accommodations. The actual prize(s) that players are eligible to redeem shall be predetermined and conspicuously posted in the Casino that this gaming activity is being offered. All promotions offered in conjunction with the Player's Club Promotion shall be approved by the Bureau prior to offering the promotion for play.

## Funding

The Players Club Promotion gaming activity is fully funded by the Casino. There will be no additional gaming activity fees, jackpot fees or collection in order to fund this gaming activity or for players to participate. All collections and table limits are for the designated base game and are Bureau approved, pre-determined and posted at each table.

## Administrative Fees

The Casino shall not retain an administrative fee as the Players Club Promotion gaming activity is funded by the Casino.

## No Purchase Necessary

The Players Club Promotion does not contain the element of chance. Therefore, it does not constitute an illegal lottery and does not require a No Purchase Necessary table to be offered while conducting this promotion.
