TO: ALL CALIFORNIA LAW ENFORCEMENT TELECOMMUNICATION SYSTEM (CLETS) USERS

The purpose of this information bulletin is to inform all criminal justice agencies that the California Department of Justice will be updating the California Restraining and Protective Order System (CARPOS) in accordance with the National Crime Information Center (NCIC)'s Technical and Operational Update (TOU) 21-04, which announced the creation of the Extreme Risk Protection Order (ERPO) File in NCIC.

Effective **August 23, 2022**, the CARPOS will automatically forward gun violence restraining order records to the ERPO File based on the guidelines outlined in TOU 21-04. NCIC Wanted Persons File and Vehicle File inquiries will return a hit response on the file if a match occurs.

Sample ERPO File record response:
