**(Notice Amended on January 13, 2020)**

Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the California Department of Justice (the "Department") is providing notice of changes made to the proposed regulations concerning the Fair and Accurate Governance of Shared Gang Database Systems. These regulations were originally the subject of a Notice of Proposed Rulemaking Action published in the California Regulatory Notice Register (Register 2019, No. 2019-0430-05) on May 10, 2019, and a Notice of Modification posted on the Department's website on July 31, 2019. These additional changes are in response to comments received regarding the proposed regulations, as modified, and for purposes of clarification. A copy of the proposed additional changes is attached to this notice. The Department has also attached a Second Addendum to Initial Statement of Reasons.
