

EXPLANATION OF WHY line 2N plus line 3 does not equal line 1G:

Gold Coast Productions (CF #367) contracted with the above mentioned sponsor to bring a benefit show to Eureka guaranteeing the sponsor 20% of the revenue generated by the solicitation on their behalf, with Gold Coast receiving 80% to cover the solicitation expenses, cost of entertainment and commission.

Expenses of conducting the solicitation, plus cost of the entertainment, exceeded the amount received by the commercial fundraiser by \$634.42
