Jay,

I received a message from Ken on Friday following our discussion on Thursday evening indicating that he expected we would hear from your legal team on Sunday or more likely Monday on next steps / the issues list.

As we indicated during our call, we are concerned that despite sending you the APA legal issues list almost three weeks ago and following up periodically since, your team has been unwilling to engage on the documentation process. After consideration with the DCHS team and as discussed on Thursday, we are looking for CHA/HPMC to demonstrate some effort to move the legal process along in order to maintain the pace of information responses to the requests you have / are making (especially in light of the timetable that we have been contemplating – legal has substantial catch-up to do).

Further, we have some other conflicts scheduled for the first part of this coming week so we will not be able to accommodate yesterday's request for facility visits on Monday or Tuesday.

As discussed, let's get the legal process started to help us prioritize the company's resources on pulling information requests and to facilitate scheduling additional site visits.
