CRIMES

Burglary

Burglary - The unlawful entry of a structure to commit a felony or a theft. Attempted burglary is included.

Comparing 1994 to 1999:

- The rate of reported burglaries decreased 45.0 percent.

From 1998 to 1999:

- The burglary rate decreased 18.1 percent.

In 1999, of 223,828 burglaries and attempted burglaries reported:


- Burglary accounted for 93.3 percent (208,783).
- Attempted burglary accounted for 6.7 percent (15,045).

Of the 208,783 burglaries that occurred:

- Structures entered by force accounted for 62.6 percent (130,776).
- Structures entered without force accounted for 37.4 percent (78,007).


The 1999 burglary rate of 657.6 is the lowest since 1955 (see Table 1).

Rate per 100,000 Population





By Type of Burglary and Type of Entry



In 1999, of all burglaries reported:

- Residential burglary accounted for 59.3 percent (132,803).
- Nonresidential burglary accounted for 40.7 percent (91,025). Included in this category are commercial establishments, public buildings, etc.
- Daytime burglary accounted for 38.8 percent (86,745).
- Nighttime burglary accounted for 28.3 percent (63,297).
- Burglaries that occurred during an unknown hour accounted for 33.0 percent (73,786).

CRIMES

Motor Vehicle Theft

Motor Vehicle Theft - *The theft or attempted theft of a motor vehicle.*


Comparing 1994 to 1999:

- The rate of reported motor vehicle thefts decreased 48.4 percent.

From 1998 to 1999:

- The motor vehicle theft rate decreased 15.2 percent.


MOTOR VEHICLE THEFT CRIMES, 1994-1999

The 1999 motor vehicle theft rate of 495.0 is the lowest since 1966 (see Table 1).

Motor Vehicle Theft (continued)

In 1999, of 168,465 motor vehicle thefts reported:

- Autos accounted for 72.6 percent (122,228).
- Trucks and buses accounted for 22.5 percent (37,843). Included in this category are pickup trucks, vans and motor homes.
- Other vehicles accounted for 5.0 percent (8,394). Included in this category are motorcycles, snowmobiles, motor scooters, and trail bikes.

Larceny-theft

Larceny-theft - The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another (except embezzlement, fraud, forgery, and worthless checks).

Comparing 1994 to 1999:

- The rate of total reported larceny-thefts decreased 32.7 percent.


From 1998 to 1999:

- The total larceny-theft rate decreased 10.0 percent.

In 1999, of 661,643 larceny-thefts reported:


- Thefts under \$50 in value accounted for 37.1 percent (245,588).
- Thefts \$50 to \$199 in value accounted for 21.2 percent (140,138).
- Thefts \$200 to \$400 in value accounted for 16.1 percent (106,668).
- Thefts over \$400 in value accounted for 25.6 percent (169,249).

Rate per 100,000 Population



Larceny-theft (continued)

In 1999, of 661,643 larceny-thefts reported:

- Shoplifting accounted for 15.0 percent (99,509).
- Thefts from motor vehicles accounted for 33.6 percent (222,586).
- Thefts of motor vehicle accessories accounted for 10.1 percent (66,537).
- Thefts of bicycles accounted for 5.3 percent (35,218).
- Thefts from buildings accounted for 15.4 percent (101,963).
- All other types of larceny-thefts accounted for 20.5 percent (135,830).

In 1999, more than four out of ten (43.7 percent) larceny-theft crimes involved theft from motor vehicles and theft of motor vehicle accessories.

Value of Stolen and Recovered Property

As part of the UCR Program, law enforcement agencies submit monthly reports showing the estimated dollar value of property stolen and property recovered. In these reports, the type of property is categorized in a uniform manner. However, agencies do not report these data consistently and frequently vary in their methods of estimating the dollar value of stolen property. Furthermore, property stolen and property recovered in any given time period are not necessarily the same property. For these reasons, dollar values of such property must be viewed as rough estimates.


From 1998 to 1999:

- There was a 5.0 percent decrease in the dollar value of all stolen property.
- There was a 5.1 percent decrease in the dollar value of motor vehicles stolen.
- There was a 5.0 percent decrease in the dollar value of all other stolen property.

In 1999, of the total dollar value (\$1,968,091,000) of all property reported stolen:

- Motor vehicles accounted for \$923,122,000 (46.9 percent).
- All other property accounted for \$1,044,969,000 (53.1 percent).


VALUE OF STOLEN PROPERTY, 1999

Value of Stolen and Recovered Property (continued)

From 1998 to 1999:

- There was a 5.2 percent decrease in the dollar value of all recovered property.
- There was a 5.3 percent decrease in the dollar value of motor vehicles recovered.
- There was a 4.5 percent decrease in the dollar value of all other recovered property.

In 1999, of the total dollar value (\$725,957,000) of property reported recovered:

- Motor vehicles accounted for \$666,297,000 (91.8 percent).
- All other property accounted for \$59,660,000 (8.2 percent).

Arson

Arson - Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, or the personal property of another, etc.

Comparing 1994 to 1999:

- The rate of reported arsons decreased 27.0 percent.


From 1998 to 1999:

- The arson rate decreased .5 percent.

In 1999, of 14,454 arsons reported:


- Structural properties were targeted in 32.2 percent (4,655) of the offenses.
- Mobile properties were targeted in 28.6 percent (4,133) of the offenses.
- Other properties were targeted in 39.2 percent (5,666) of the offenses. Included in this category are crops, timber, fences, signs, etc.


ARSON CRIMES, 1999

Arson (continued)

In 1999, the total estimated value of all property damaged was \$138,057,000. The value of damage resulting from arsons directed at:

- Structural properties accounted for \$110,030,000 (79.7 percent).
- Mobile properties accounted for \$23,826,000 (17.3 percent).
- Other properties accounted for \$4,201,000 (3.0 percent).

Clearances


Crimes can be cleared by arrests or "exceptional means." An offense is cleared or "solved" for crime reporting purposes when at least one person is arrested, charged with the commission of the crime, and turned over to the court for prosecution or referred to juvenile authorities. In certain situations a clearance may be counted by "exceptional means" when the police definitely know the identity of the offender, have enough information to support an arrest, and know the location of the offender but for some reason cannot take the offender into custody. A clearance rate is the percentage obtained when the number of clearances reported are divided by the number of crimes reported.

Comparing 1994 to 1999:

- The clearance rate for California Crime Index offenses increased from 22.3 to 25.6 percent.
- The violent crime clearance rate increased from 46.5 to 50.8 percent.
- The property crime clearance rate increased from 11.2 to 12.2 percent.


From 1998 to 1999:

- The clearance rate for California Crime Index offenses increased from 25.3 to 25.6 percent.
- The violent crime clearance rate decreased from 51.8 to 50.8 percent.
- The property crime clearance rate increased from 12.1 to 12.2 percent.

Clearances (continued)

In 1999,

- The clearance rate for total California Crime Index offenses was 25.6 percent.
- Aggravated assault had the highest clearance rate (61.1 percent).
- Motor vehicle theft had the lowest clearance rate (10.3 percent).
