Message From the Attorney General

The passage of Proposition 21 in March 2000 significantly reformed the administration of juvenile justice in California, requiring significant changes to the Juvenile Court and Probation Statistical System (JCPSS). In 2003, modifications to the JCPSS were completed enabling the collection of data to measure the effects of this landmark legislation.

Through the persistent efforts of the Chief Probation Officers of California and the Department of Justice, data from 50 counties, as well as fitness hearing, direct filing, and adult disposition information, are included in this report. These data represent 97 percent of the state's population and provide an accurate representation of the juvenile delinquency problem and justice system's response in California.

With more than one-third of California's population consisting of young people under the age of 25, deterring criminal behavior by juveniles is an important step in improving public safety in California. It is my hope that this report will provide law enforcement and policymakers with valuable information to achieve that goal.

Introduction

Juvenile Justice in California, 2003 is organized to display the flow of the juvenile justice process and provide specific information on the juvenile population, race/ethnic groups, gender, number of arrests, referrals to probation departments, petitions, juvenile court dispositions, offenses, and dispositions for those juveniles tried in adult courts.

The reader should also know that the California Department of Justice, Criminal Justice Statistics Center (CJSC) is required by statute to collect, tabulate, analyze, and interpret data that describe the administration of juvenile justice in California. To aid in the collection of data, Welfare and Institutions Code section 285 provides that "...all probation officers will make such periodic reports to the CJSC as required...." Penal Code section 13012 subdivision (d) requires CJSC to include the administrative actions taken by law enforcement, judicial, penal, and correctional agencies in the juvenile justice system. Penal Code section 13012.5 also requires the inclusion of fitness hearing information and outcomes, direct filings in adult criminal court, and the outcomes of those cases involving minors who are prosecuted in adult criminal courts, in the annual report to the Legislature.

This report is based on data submitted by 50 of California's 58 county probation departments representing approximately 97 percent of the state's population. Of the remaining eight counties, Del Norte, Plumas, San Joaquin, and Sierra were unable to provide any data, while Kings, Mariposa, Shasta, and Tehama only provided partial data for 2003. Therefore, the data from these counties are not included in this report.

The presentation of data in this report is organized to display the flow of the juvenile justice process. Each section examines the relevant data as follows:

- Arrests by gender, age, offense, and disposition.
- Referrals by gender, age, offense, disposition, and direct files in adult court.
- Petitions by gender, age, offense, disposition, and fitness hearings and outcomes.
- Group representation by arrest, offense, direct files in adult court, referral to probation, detention, petitions filed, fitness hearings and outcomes, type of defense representation, juvenile court disposition, and wardship placement.
- Adult dispositions by gender, age, and race/ethnic group.

Comparisons between 2002 and 2003 data are presented in this report at key decision points in the juvenile process; i.e., law enforcement, probation department, and juvenile court. Comparisons at all points in the process or for all data are not presented because of changes in the number of reporting probation departments and changes in the number of reportable offenses. In 2002, only the most serious offenses were reported; in 2003, up to five offenses could be reported.

The offenses presented in this report were "selected" based on the seriousness of the arrest offense and comparability to the national Uniform Crime Reporting System. The use of these offenses is intended to provide a valid and comparable measure of offenses and the juvenile justice process. The felony offenses are homicide (includes non-vehicular manslaughter), forcible rape, robbery, assault, burglary, theft, motor vehicle theft, and drug violations (includes narcotics, marijuana, dangerous drugs, and other drug violations). The misdemeanor offenses are assault and battery, petty theft, vandalism, disturbing the peace, alcohol-related offenses (including drunk and liquor laws), and drug violations (including marijuana and other drugs). The status offenses are curfew violations, truancy, running away, and incorrigibility.

This logo, which appears repeatedly throughout the report, will alert the reader to featured analyses or items of special interest.

Highlights

ARRESTS

In 2003, less than one-quarter of one percent of juvenile arrests resulted in the arrestee being sent to adult court. (Source: Table 2)

In 2003, juveniles aged 15-17 were arrested nearly 2.5 times more than juveniles aged 12-14 (69.4 vs. 28.1 percent). (Source: Table 1)

In 2003, misdemeanor arrests exceeded felony arrests by more than two to one (59.5 vs. 26.5 percent) and status offense arrests by more than four to one (59.5 vs. 13.9 percent). (Source: Table 1)

In 2003, running away and incorrigibility were the only selected offenses not dominated by males. (Source: Table 1)

REFERRALS

In 2003, less than one-fourth of the total referrals were female (22.0 percent). (Source: Table 2)

More than one-third of the truancy and incorrigibility referrals to probation were for offenders aged 12-14 (34.7 and 33.4 percent, respectively). (Source: Table 3)

In 2003, more than half (56.7 percent) of the referrals to probation resulted in a juvenile court action. (Source: Tables 2 and 16)

PETITIONS

Of the petitions filed for formal juvenile court action, the percentage of misdemeanor and felony petitions were virtually the same (43.0 and 42.6 percent, respectively). (Source: Table 9)

Nearly two-thirds of the new petitions filed in juvenile court were for offenders aged 15-17 (66.2 percent). (Source: Table 4)

In 2003, less than one percent of the juveniles petitioned in juvenile court had fitness hearings (586 out of 87,927). (Source: Table 12)

The majority (57.5 percent) of juveniles made a ward of the court were allowed to go home. (Source: Tables 4 and 8).

GROUPS

In 2003, when compared to their statewide race/ethnic group population of arrestees, of those arrested for a misdemeanor offense, whites were over-represented and blacks were under-represented. (Source: Tables 1 and 4)

In 2003, when compared to their statewide race/ethnic group population of referrals, Hispanics and Asian/Pacific Islanders were sent to adult court more than any other race/ ethnic group. (Source: Tables 1 and 4) In 2003, when compared to their statewide race/ethnic group population of petitions filed, blacks and Asian/Pacific Islanders were subject to a fitness hearing more than any other race/ethnic group. (Source: Tables 9 and 13)

In 2003, when compared to their statewide race/ethnic group population of wards of the court, Hispanics were over-represented in commitments to secure county facilities while blacks were overrepresented in commitments to the Youth Authority. (Source: Table 4)

ADULT DISPOSITONS

In 2003, more than half (54.3 percent) of the adult dispositions received were for misdemeanor offenses. (Source: Table 15)

In 2003, more than two-thirds (68.1 percent) of the juveniles tried as adults were convicted. (Source: Table 15)

In 2003, when compared to their statewide race/ethnic group population of juveniles sent to adult court, blacks were convicted and committed to prison more than any other race/ethnic group. (Source: Table 15)

Juvenile Justice System, 2003 Fallout Chart

The juvenile justice system in California differs from the adult system in the type of offenders received and the manner in which they are processed. The juvenile system primarily deals with persons under 18 years of age who have either violated criminal statutes or have committed "status offenses." Status offenses are acts that are offenses only when committed by a juvenile, such as incorrigibility, truancy, running away, and curfew violations.

Arrests of law violators and status offenders are received from law enforcement agencies throughout California. The law enforcement agency may refer the juvenile to the probation department, counsel and release, or turn the juvenile over to another law enforcement jurisdiction. The law enforcement agency, given the severity of the crime, may refer the juvenile offender to the District Attorney for direct filing in adult court.

Referrals of law violators and status offenders to probation departments are from law enforcement, other public agencies or individuals, other sources, transfers from other counties or states, or from schools, parents, or private agencies or individuals.

The accompanying fallout chart depicts the path of a juvenile through the juvenile justice system in California from arrest to final disposition, including the outcomes of juvenile cases transferred to the adult system for prosecution.

^bIn 2003, probation departments reported information on 814 transfers to the adult system. The adult disposition information being discussed here is for the 608 dispositions received in 2003. It is anticipated the adult court dispositions for the remaining 206 juveniles will be received in subsequent years.



- Typically, referrals are made to the probation department in the juvenile's county of residence. The majority come from police and sheriff's departments (89.0 percent in 2003), with the remainder coming from other sources.
- Probation departments decide how to process referred cases. A case may be closed or transferred, a juvenile may be placed on informal probation or in a diversion program, or a petition may be sought for a court hearing.
- Most formal juvenile court hearings resulted in the juvenile being made a ward of the court. Most wards (57.7 percent in 2003) were allowed to go home under the supervision of the probation department.
- Juveniles can be transferred to the adult criminal justice system for prosecution by failing a fitness hearing in the juvenile court or sent directly by the District Attorney. More than two-thirds of dispositions received in 2003 resulted in a conviction (68.1 percent).

Arrests

A juvenile arrest may be for delinquent acts or status offenses. A delinquent act would be considered a crime if committed by an adult and is typically called a referral action. A status offense is an act that is only illegal because of the age of the offender. Status offenses include curfew violations, truancy, running away, and incorrigibility.

This section examines arrests by gender, age, offense, and law enforcement disposition.

The age groupings used throughout this report represent the most active age groups for the area being discussed.

The data used were compiled from arrests reported, via the Monthly Arrest and Citation Register, to the DOJ by law enforcement agencies in the 50 JCPSS reporting counties.



ARRESTS

Level of Offense

From 2002 to 2003, the number of juveniles arrested for a:

- Felony offense increased 0.2 percentage points (26.3 to 26.5 percent).
- Misdemeanor offense increased 2.2 percentage points (57.3 to 59.5 percent).
- Status offense decreased 2.5 percentage points (16.4 to 13.9 percent).
- Note: Because of the differences in the number of reporting probation departments from 2002 to 2003 and the differences in the number of allowable reportable offenses, caution should be used when comparing data reported for 2002 to data reported for 2003.

In 2003, misdemeanor arrests exceeded felony arrests by more than two to one (59.5 vs. 26.5 percent) and status offense arrests by more than four to one (59.5 vs. 13.9 percent).

Level of Offense

Arrests Reported

In 2003, of the 221,875 juvenile arrests reported in 2003:

26.5 percent (58,892) were for felonies; 59.5 percent (132,123) were for misdemeanors; and 13.9 percent (30,860) were for status offenses.

Arrests by Gender

In 2003, of the 221,875 juvenile arrests reported in 2003:

- Females represented more than one-fourth of arrestees (26.3 percent - 58,378).
- Males accounted for more than eight out of ten felony arrests (82.7 percent - 48,686).



<u>ARRESTS</u>

Selected Arrests by Gender

Of the 8 selected felonies:

- Males accounted for nearly 9 out of 10 arrests for homicide (89.7 percent).
- Females accounted for more than 2 out of 10 arrests for theft and assault (21.3 and 20.4 percent, respectively).

Of the 6 selected misdemeanors:

- Males accounted for more than 8 out 10 arrests for vandalism and drug-related offenses (87.6 and 81.0 percent, respectively).
- Females accounted for more than 4 out of 10 arrests for petty theft (42.1 percent).

Of the 4 selected status offenses:

- Males accounted for more than two-thirds of the arrests for curfew violations (68.0 percent).
- Females accounted for more than 6 out of 10 arrests for running away (61.4 percent).

Of the 221,875 juvenile arrests reported in 2003:

- Juveniles in all age groups were arrested for similar proportions of felony, misdemeanor, and status offenses.
- More than two-thirds of all felony, misdemeanor, and status offense arrestees were aged 15-17 (69.7, 68.4, and 73.2 percent, respectively).

Selected Arrests by Age Group

Of the 8 selected felonies:

- Juveniles aged 12-14 accounted for less than one-third of the assault arrests (31.1 percent).
- More homicide arrests were for juveniles aged 15-17 than any other age group (89.1 percent).

Of the 6 selected misdemeanors:

- Juveniles aged 12-14 accounted for 42.3 percent of the disturbing the peace arrests.
- Juveniles aged 15-17 accounted for more than 8 out of 10 alcoholrelated arrests (84.8 percent).

Of the 4 selected status offenses:

- Juveniles aged 12-14 accounted for nearly 4 out of 10 arrests for incorrigibility (38.2 percent).
- Over three-fourths of the arrestees for curfew violations were juveniles aged 15-17 (76.2 percent).

When dealing with juvenile arrestees, law enforcement agencies may counsel and release the juvenile, refer them to the probation department, or turn them over to another law enforcement jurisdiction.

From 2002 to 2003, the number of juveniles:

- Referred to probation increased 3.0 percentage points (76.7 to 79.7 percent).
- Counseled and released decreased 2.7 pecentage points (20.8 to 18.1 percent).
- Turned over decreased 0.3 percentage points (2.5 to 2.2 percent).

Of the 221,875 law enforcement dispositions reported in 2003:

- 79.7 percent resulted in a referral to probation (176,810).
- 18.1 percent resulted in counseling (40,155).

Arrest Dispositions by Level of Offense

Of the felony arrests in 2003:

- 89.2 percent resulted in a referral to probation (52,516).
- 8.7 percent resulted in counseling (5,148).

Of the misdemeanor arrests in 2003:

- 79.9 percent resulted in a referral to probation (105,570).
- 17.5 percent resulted in counseling (23,089).

Of the status offense arrests in 2003:

- 60.7 percent resulted in a referral to probation (18,724).
- 38.6 percent resulted in counseling (11,918).

Of the 410 reported direct filings in adult court in 2003:

- 89.3 percent (366) were male.
- 10.7 percent (44) were female.

Direct Files by Age Group

Of the 410 direct filings in adult court in 2003:

- 6.6 percent (27) were for juveniles aged 12-14.
- 67.3 percent (276) were for juveniles aged 15-17.
- 26.1 percent (107) were for all other age groups.

Referrals

Juvenile referrals to a probation department may come from several sources, with the largest percentage coming from law enforcement. However, referrals may also be made by schools, parents, public or private agencies and individuals, or by transfers from another county or state.

This section examines referrals by gender, age, offense, disposition, and direct filings in adult court.

The age groupings used throughout this report represent the most active age groups for the area being discussed.

The data used were compiled from referrals reported, via the JCPSS, to the DOJ by county probation departments in the 50 JCPSS reporting counties.

Juvenile referrals to a probation department consist of two types: new and subsequent. The term "new referral" refers to a juvenile who is not currently being supervised by the probation department. A new referral is typically a first-time offender. The term "subsequent referral" refers to a juvenile who is currently being supervised by the probation department. A subsequent referral is generally the result of a new arrest or a violation of probation.



REFERRALS

Referrals to Probation

Of the 154,954 referrals to probation reported in 2003:

- 89.0 percent (137,939) were from law enforcement.
- 6.5 percent (10,041) were from public agencies or individuals.
- 1.7 percent (2,603) were transfers from another county or state.
- 1.6 percent (2,499) were from other sources.
- 1.2 percent (1,872) were from schools, parents, and private agencies and individuals.

- 53.6 percent (95,184) were for misdemeanors.
- 11.3 percent (20,153) were for status offenses.

- Males accounted for 91.6 percent of the homicide referrals.
- Females accounted for 20.2 percent of the assault referrals.

Of the 6 selected misdemeanors:

- Males accounted for 89.9 percent of the vandalism referrals.
- Females accounted for 37.4 percent of the petty theft referrals.

Of the 4 selected status offenses:

- Males accounted for 74.5 percent of the curfew referrals.
- Females accounted for 59.8 percent of the runaway referrals.

Of the 8 selected felonies:

- Juveniles aged 12-14 accounted for slightly more than one-fourth of the assault referrals (25.1 percent).
- Juveniles aged 15-17 accounted for slightly more than three-fourths of the drug referrals (75.8 percent).

Of the 6 selected misdemeanors:

- Juveniles aged 12-14 accounted for less than one-third of the disturbing the peace referrals (31.1 percent).
- Juveniles aged 15-17 accounted for slightly more than three-fourths of the alcohol-related referrals (75.8 percent).

Of the 4 selected status offenses:

- Juveniles aged 12-14 accounted for more than one-third of the truancy referrals (34.7 percent).
- Juveniles aged 15-17 accounted for more than two-thirds of the curfew referrals (69.3 percent).

More than one-third of the truancy and incorrigible referrals to probation were for offenders aged 12-14 (34.7 and 33.4 percent, respectively).



REFERRALS

Referral Dispositions

From 2002 to 2003, the number of juveniles whose cases were:

- Closed at intake decreased 6.3 percentage points (40.0 to 33.7 percent).
- Informal probation decreased 1.0 percentage point (4.5 to 3.5 percent).
- Diversion increased 0.5 percentage points (3.6 to 4.1 percent).
- Transferred increased 0.3 percentage points (1.4 to 1.7 percent).
- Petitions filed in juvenile court increased 6.2 percentage points (50.5 to 56.7 percent).
- Note: Because of the differences in the number of reporting probation departments from 2002 to 2003 and the differences in the number of allowable reportable offenses, caution should be used when comparing data reported for 2002 to data reported for 2003.

Of the 154,954 referrals handled by probation departments in 2003:

- 56.7 percent (87,927) had a petition filed in juvenile court.
- 33.7 percent (52,236) were closed at intake.
- 3.5 percent (5,490) received informal probation.
- 4.1 percent (6,293) were placed in a diversion program.
- 1.7 percent (2,598) were transferred to other jurisdictions.
- 0.3 percent (410) were direct filed in adult court.

In 2003, more than half (56.7 percent) of the referrals to probation resulted in a juvenile court action.

Petitions

In the juvenile justice system, a case may be handled informally by the probation department or formally by the juvenile court. If the case is going to proceed for formal processing, the District Attorney files a petition with the juvenile court to initiate the court action.

This section examines petitions by gender, age, offense, fitness hearings, and disposition.

The age groupings used throughout this report represent the most active age groups for the area being discussed.

The data used were compiled from petitions reported, via the JCPSS, to the DOJ by county probation departments in the 50 JCPSS reporting counties.

Petitions filed in juvenile court consist of two types: new and subsequent. The term "new petition" refers to a juvenile who is not being supervised by the probation department and is typically a first-time offender. The term "subsequent petition" refers to a juvenile who is currently being supervised by the probation department and generally follows a new arrest.



<u>PETITIONS</u>

Type of Petition

Of the 87,927 reported petitions filed in juvenile court in 2003:

- 55.6 percent (48,898) were new petitions.
- 44.4 percent (39,029) were subsequent petitions.

Level of Offense

Of the 104,812 petitioned offenses filed in 2003:

- Juveniles aged 12-14 accounted for 23.1 percent of the petitions filed for assault.
- Juveniles aged 15-17 accounted for 75.9 percent of the petitions filed for motor vehicle theft.

Of the 6 selected misdemeanors:

- Juveniles aged 12-14 accounted for 25.2 percent of the petitions filed for assault and battery.
- Juveniles aged 15-17 accounted for 73.5 percent of the petitions filed for drug-related offenses.

Of the 4 selected status offenses:

- Juveniles aged 12-14 accounted for 21.6 percent of the petitions filed for running away.

From 2002 to 2003, the number of juveniles who were:

- Made a ward of the court decreased 6.8 percentage points (74.4 to 67.6 percent).

- Given diversion/deferred entry of judgment increased 0.4 percentage points (5.1 to 5.5 percent).
- Given informal probation increased 1.8 percentage points (3.8 to 5.6 percent).

- 5.6 percent (4,922) received informal probation.
- 3.3 percent (2,889) received nonward probation.
- 0.5 percent (404) resulted in the juvenile being remanded to the adult court.

Wardship Placements

Of the 59,405 juveniles made a ward of the court in 2003:

- 57.7 percent (34,299) were allowed to go home.
- 26.1 percent (15,512) were committed to a secure county facility.
- 6.0 percent (3,541) were sent to a non-secure county facility.
- 8.5 percent (5,044) were sent to other public or private facilities.
- 1.7 percent (1,009) were committed to the California Youth Authority.

The majority (57.7 percent) of juveniles made a ward of the court were allowed to go home.

Race/Ethnic Group Representation

This section examines minority representation in the California Juvenile Justice system based on the data received from the 50 JCPSS reporting counties. Arrests, offenses, referrals to probation, direct files in adult court, detention, petitions filed, fitness hearings, type of defense representation, juvenile court dispositions, and wardship placements are discussed.

Population data used throughout this analysis are for individuals aged 0-25. Typically, the analyzed at-risk population for juveniles is 10-17; however, this age group was selected because it ensures inclusion of individuals referred to county probation departments who were under the age of 18 at the time of the offense but were receiving probation services through age 25.

The race/ethnic groups presented in this section include Hispanic, white, black, Asian/Pacific Islander, and American Indian. Because no population data were available for juveniles whose race/ethnic group was reported as "other," 5,149 arrests and 4,823 referrals were excluded from discussion in this section.

The subjectivity of the classification and labeling process must be considered in the analysis of race/ethnic group data. As commonly used, race refers to large populations that share certain similar physical characteristics such as skin color. Because these physical characteristics can vary greatly within groups as well as between groups, determination of race is frequently, by necessity, subjective. Ethnicity refers to cultural heritage and can cross racial lines. For example, the ethnic designation "Hispanic" includes persons of any race. Most commonly, self-identification of race/ethnicity is used in the classification and labeling process.

Statewide juvenile population data is used to calculate the "Minority Over-Representation Index" only when comparing the number of juveniles arrested. For all subsequent comparisons, the population of the group being discussed (e.g., referred to probation, tried in juvenile court), is used to calculate the Minority Over-Representation Index. For example, the percentage of juveniles referred to juvenile court is compared to the percentage of juveniles referred to probation for each race/ethnic group. The Minority Over-Representation Index computation formula is used throughout this section (see Appendix 4).

An index value of:

- More than one indicates minority over-representation.
- One indicates proportional representation.
- Less than one indicates minority under-representation.

To provide perspective throughout this report, it will be helpful for the reader to know the racial and ethnic composition of California's overall juvenile population.

In 2003, when compared to their statewide race/ethnic group population:

- Hispanics were arrested 1.1 times more (46.3 vs. 41.7 percent).
- Whites were arrested 0.8 times less (31.1 vs. 38.3 percent)
- Blacks were arrested 2.5 times more (17.8 vs 7.1 percent).
- Asian/Pacific Islanders were arrested 0.4 times less (4.4 vs. 12.3 percent).

- Blacks were arrested 1.3 times more (23.0 vs.17.8 percent).
- Asian/Pacific Islanders were arrested 1.1 times more (4.8 vs. 4.4 percent).

Of those arrested for a misdemeanor offense:

- Whites were arrested 1.1 times more (33.6 vs. 31.1 percent).
- Blacks were arrested 0.9 times less (16.6 vs. 17.8 percent).

Of those arrested for a status offense:

- Hispanics were arrested 1.2 times more (54.8 vs. 46.3 percent).
- Asian/Pacific Islanders were arrested 0.8 times less (3.5 vs. 4.4 percent).

In 2003, when compared to their statewide race/ethnic group population of arrestees, of those arrested for a misdemeanor offense, whites were overrepresented and blacks were under-represented.

Selected Arrest

In 2003, when compared to their statewide race/ethnic group population of arrestees, of those arrested for a selected felony offense:

- Blacks were arrested 3.0 times more for robbery (52.7 vs. 17.8 percent).
- Asian/Pacific Islanders were arrested 2.6 times more for homicide (11.3 vs. 4.4 percent).
- American Indians were arrested 1.4 times more for assault and burglary (0.5 vs. 0.4 percent for both).

Of those arrested for a selected misdemeanor offense:

- Hispanics were arrested 1.2 times more for vandalism (55.8 vs. 46.3 percent).
- Whites were arrested 1.8 times more for alcohol-related offenses (55.8 vs. 31.1 percent).
- Asian/Pacific Islanders were arrested 1.6 times more for petty theft (7.1 vs. 4.4 percent).

Of those arrested for a selected status offense:

- Whites were arrested 1.5 times more for running away 44.9 vs. 31.1 percent).
- American Indians were arrested 2.3 times more for incorrigibility (0.9 vs. 0.4 percent).



Referrals

In 2003, when compared to their statewide race/ethnic group population of arrestees:

- Hispanics and whites were referred in close proportion (44.6 vs. 46.3 percent and 31.1 vs. 31.1 percent, respectively).
- Blacks were referred 1.1 times more (19.9 vs. 17.8 percent).
- Asian/Pacific Islanders were referred 0.9 times less (3.8 vs. 4.4 percent).
- American Indians were referred 1.5 times more (0.6 vs. 0.4 percent).

Level of Referral

In 2003, when compared to their statewide race/ethnic group population of referrals, of those referred for a felony offense:

- Whites were referred 0.9 times less (26.6 vs. 31.1 percent).
- Blacks and Asian/Pacific Islanders were referred 1.2 times more (24.8 vs. 19.9 percent and 4.5 vs. 3.8 percent, respectively).

Of those referred for a misdemeanor offense:

- Whites were referred 1.1 times more (33.8 vs. 31.1 percent).
- Blacks and Asian/Pacific Islanders were referred 0.9 times less (17.1 vs. 19.9 percent and 3.4 vs. 3.8 percent, respectively).

Of those referred for a status offense:

- Whites were referred 1.2 times more (35.8 vs. 31.1 percent).
- American Indians were referred 1.8 times more (1.1 vs. 0.6 percent).

Selected Referrals

In 2003, when compared to their statewide race/ethnic group population of referrals, of those referred for a selected felony offense:

- Blacks were referred 2.7 times more for robbery (52.9 vs. 19.9 percent).
- Asian/Pacific Islanders were referred 2.2 times more for homicide (8.3 vs. 3.8 percent).
- American Indians were referred 2.0 times more for forcible rape (1.2 vs. 0.6 percent).

Of those referred for a selected misdemeanor offense:

- Hispanics were referred 1.3 times more for vandalism (59.9 vs. 44.6 percent).
- Whites and American Indians were referred 1.8 times more for alcoholrelated offenses (57.3 vs. 31.1 percent and 1.1 vs. 0.6 percent, respectively).
- Asian/Pacific Islanders were referred 1.4 times more for petty theft (5.3 vs. 3.8 percent).

Of those referred for a selected status offense:

- Hispanics were referred 1.4 times more for truancy (64.2 vs. 44.6 percent).
- Whites were referred 1.9 times more for running away (57.6 vs. 31.1 percent).
- American Indians were referred 2.8 times more for running away (1.7 vs. 0.6 percent).



Detentions

In 2003, when compared to their statewide race/ethnic group population of referrals, of those receiving detention:

- Hispanics were detained in close proportion (46.7 vs. 44.6 percent).
- Whites were detained 0.8 times less (24.7 vs. 31.1 percent).
- Blacks were detained 1.2 times more (24.4 vs. 19.9 percent).
- Asian/Pacific Islanders were detained 0.9 times less (3.6 vs. 3.8 percent).
- American Indians were detained in proportion (0.6 vs. 0.6 percent).

Informal Dispositions

In 2003, when compared to their statewide race/ethnic group population of referrals, of those directly filed in adult court:

- Hispanics were directly filed 1.2 times more (52.3 vs. 44.6 percent).
- Whites were directly filed 0.6 times less (20.2 vs. 31.1 percent).
- Blacks were directly filed at nearly the same rate (19.0 vs. 19.9 percent).
- Asian/Pacific Islanders were directly filed 2.1 times more (8.1 vs. 3.8 percent).

- Whites were sent 0.8 times less (21.6 vs. 27.2 percent).
- Blacks were sent 0.9 times less (17.2 vs. 19.0 percent).
- Asian/Pacific Islanders were sent at the same rate (3.2 vs. 3.2 percent).
- American Indians were sent 0.7 times less (0.4 vs. 0.6 percent).

Of those offenders sent to the Youth Authority:

Adult Dispositions

Juveniles can be transferred to the adult justice system for prosecution by either failing a fitness hearing in the juvenile court or being sent directly by the District Attorney. In 2003, probation departments reported information on 814 transfers to the adult system. The adult disposition information being discussed here is for the 608 dispositions received in 2003. It is anticipated the adult court dispositions for the remaining 206 juveniles will be received in subsequent years.

This section examines adult dispositions by gender, age, race/ethnic group, offense, and disposition. When multiple offenses were received from the courts, only data regarding the most serious offense with the most serious disposition for the event were used in the discussion. The data used were obtained from the Department of Justice's Automated Criminal History System (ACHS).

The race/ethnic groups presented in this section include Hispanic, white, black, Asian/Pacific Islander, American Indian, and other. The "other" category is included in this discussion because "other" represents 13 percent of the adult dispositions.

Many of the large and small percentages displayed throughout this section are the result of percentages being calculated using the small number of incidents received.

Appendix 1 Background

The Department of Justice, Criminal Justice Statistics Center (formerly the Bureau of Criminal Statistics), has been compiling and publishing data describing California's juvenile justice system since 1947. In 1969, the first computerized juvenile probation caseload file system was developed to receive information on juveniles being supervised by probation departments or in detention facilities. The system was designed to track transactions that took place within the juvenile probation system and to provide information on the chain of events that depicted a juvenile's progress through the probation and court processes from the time of referral to final disposition. Individual transactions were linked together to form a comprehensive record of the court and probation activities for a single offender.

In 1979, in an effort to upgrade the first computerized data collection system, the Juvenile Court and Probation Statistical System (JCPSS) was developed as a pilot study. Ten counties participated in the initial study, and in 1980 the pilot system was made operational statewide.

Appendix 1 Background

From 1980 to 1989, the JCPSS collected, compiled, and reported statistical data on the administration of juvenile justice in California by collecting individualized records on delinquent juveniles referred to California probation departments. These records contained information about the youth, referral source, referral offense, pre-adjudication detention, probation and court disposition, and current supervision status, and changes in prior supervision status. During this period, transaction reports were submitted at the time a disposition was made or when supervision was terminated.

In 1990, the JCPSS was eliminated because of budget reductions.

In 1995, with the help of Assemblyman Baca and the support of the Chief Probation Officers of California, Assembly Bill 488 was passed, directing the Department of Justice (DOJ) to reestablish the JCPSS. In June 1996, representatives from 14 probation departments and the DOJ met to finalize the reporting standards and system development began. In January 1997, several probation departments were submitting data to the JCPSS data.

In 1999, the Legislative Analyst's Office (LAO) recommended that the Legislature withhold 50 percent of the Temporary Assistance to Needy Families (TANF) funds from those probation departments not "certified" by the DOJ as submitting JCPSS data by March 2000. At that time, only 22 probation departments were submitting data to the JCPSS.

In 2000, the LAO again recommended that the Legislature withhold 50 percent of the TANF funds from those probation departments not certified by the DOJ as submitting JCPSS data by March 2001. In May 2000, a permanent JCPSS Advisory Committee was established to discuss improving county participation and legislative changes affecting JCPSS; no funds were withheld.

In 2001, the Legislature directed the DOJ, via Senate Bill 314, to include in its annual juvenile justice report, statistics on the administrative actions taken by law enforcement agencies regarding juveniles whose cases are transferred to or directly adjudicated in adult criminal court. This legislation also prompted discussions about replacing the existing JCPSS software, first provided to the probation departments in 1996, with a web-enabled application. In February 2002, development of the web-enabled JCPSS application began, and by October 2002, the DOJ began connecting county probation departments to the DOJ network.

In 2003, the JCPSS web-application became fully operational. Probation departments were trained and data submission began. Currently, 55 counties are connected to the web-enabled application, with 53 of those counties certified and submitting data. The DOJ continues to work with the remaining counties to achieve 100 percent participation.

Appendix 2 Penal Code Sections

Welfare and Institutions Code Section 285

All probation officers shall make such periodic reports to the Bureau of Criminal Statistics as the bureau may require and upon forms furnished by the bureau, provided that no names or social security numbers shall be transmitted regarding any proceeding under Section 300 or 601.

Penal Code Section 13010

It shall be the duty of the department:

(a) To collect data necessary for the work of the department from all persons and agencies mentioned in Section 13020 and from any other appropriate source;

(b) To prepare and distribute to all such persons and agencies, cards or other forms used in reporting data to the department. Such cards or forms may, in addition to other items, include items of information needed by federal bureaus or departments engaged in the development of national and uniform criminal statistics;

(c) To recommend the form and content of records which must be kept by such persons and agencies in order to insure the correct reporting of data to the department;

(d) To instruct such persons and agencies in the installation, maintenance, and use of such records and in the reporting of data therefrom to the department;

(e) To process, tabulate, analyze and interpret the data collected from such persons and agencies;

(f) To supply, at their request, to federal bureaus or departments engaged in the collection of national criminal statistics data they need from this state;

(g) To present to the Governor, on or before July 1st, a printed annual report containing the criminal statistics of the preceding calendar year and to present at such other times as the Attorney General may approve reports on special aspects of criminal statistics. A sufficient number of copies of all reports shall be printed or otherwise prepared to enable the Attorney General to send a copy to all public officials in the state dealing with criminals and to distribute them generally in channels where they will add to the public enlightenment; and

(h) To periodically review the requirements of units of government using criminal justice statistics, and to make recommendations for changes it deems necessary in the design of criminal justice statistics systems, including new techniques of collection and processing made possible by automation.

Penal Code Section 13010.5

The department shall collect data pertaining to the juvenile justice system for statistical purposes. This information shall serve to assist the department in complying with the reporting requirement of subdivisions (c) and (d) of Section 13012, measuring the extent of juvenile delinquency, determining the need for and effectiveness of relevant legislation, and identifying long-term trends in juvenile delinquency.

Appendix 2 Penal Code Sections

Penal Code Section 13012

The annual report of the department provided for in Section 13010 shall contain statistics showing all of the following:

(a) The amount and the types of offenses known to the public authorities.

(b) The personal and social characteristics of criminals and delinquents.

(c) The administrative actions taken by law enforcement, judicial, penal, and correctional agencies or institutions, including those in the juvenile justice system, in dealing with criminals or delinquents.

(d) The administrative actions taken by law enforcement, prosecutorial, judicial, penal, and correctional agencies, including those in the juvenile justice system, in dealing with minors who are the subject of a petition or hearing in the juvenile court to transfer their case to the jurisdiction of an adult criminal court or whose cases are directly filed or otherwise initiated in an adult criminal court.

(e) The number of citizens' complaints received by law enforcement agencies under Section 832.5. These statistics shall indicate the total number of these complaints, the number alleging criminal conduct of either a felony or misdemeanor, and the number sustained in each category. The report shall not contain a reference to any individual agency but shall be by gross numbers only.

It shall be the duty of the department to give adequate interpretation of the statistics and so to present the information that it may be of value in guiding the policies of the Legislature and of those in charge of the apprehension, prosecution, and treatment of the criminals and delinquents, or concerned with the prevention of crime and delinquency. The report shall also include statistics which are comparable with national uniform criminal statistics published by federal bureaus or departments heretofore mentioned.

Penal Code Section 13012.5

(a) The annual report published by the department under Section 13010 shall, in regard to the contents required by subdivision (d) of Section 13012, include the following statewide information:

(1) The annual number of fitness hearings held in the juvenile courts under Section 707 of the Welfare and Institutions Code, and the outcomes of those hearings including orders to remand to adult criminal court, cross-referenced with information about the age, gender, ethnicity, and offense of the minors whose cases are the subject of those fitness hearings.

(2) The annual number of minors whose cases are filed directly in adult criminal court under Sections 602.5 and 707 of the Welfare and Institutions Code, cross-referenced with information about the age, gender, ethnicity, and offense of the minors whose cases are filed directly to the adult criminal court.

(3) The outcomes of cases involving minors who are prosecuted in adult criminal courts, regardless of how adult court jurisdiction was initiated, including whether the minor was acquitted or convicted, or whether the case was dismissed and returned to juvenile court, including sentencing outcomes, cross-referenced with the age, gender, ethnicity, and offense of the minors subject to these court actions.

(b) The department's annual report published under Section 13010 shall include the information described in subdivision (d) of Section 13012, as further delineated by this section, beginning with the report due on July 1, 2003, for the preceding calendar year.

Appendix 3 Data Limitations

Juvenile Court and Probation Statistical Systems

- Each year there is a difference between the number of referrals to probation via the JCPSS and the number of juvenile arrests reported by law enforcement agencies as "referred to juvenile court and probation" via the Monthly Arrest and Citation Register (MACR). The differences are due, in part, to the different programs and definitions used by law enforcement agencies and probation department for submitting data to the DOJ. However, there are two primary reasons for the difference:
 - a. Probation departments report caseload information while law enforcement agencies report information on individual arrests.
 - b. The JCPSS counts only those juveniles who have a final disposition reported to the DOJ. Many probation departments divert juveniles out of the system into other "community based" programs. As a result, many juveniles who are diverted after being referred by law enforcement agencies are not reported on JCPSS.
- 2 All juvenile referrals for law violations and status offenses are reported in the JCPSS.
- 3. The information presented in this report represents the data received from 50 JCPSS certified counties (Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, El Dorado, Fresno, Glenn, Humboldt, Imperial, Inyo, Kern, Lake, Lassen, Los Angeles, Madera, Marin, Mendocino, Merced, Modoc, Mono, Monterey, Napa, Nevada, Orange, Placer, Riverside, Sacramento, San Benito, San Bernardino, San Diego, San Francisco, San Luis Obispo, San Mateo, Santa Barbara, Santa Clara, Santa Cruz, Siskiyou, Solano, Sonoma, Stanislaus, Sutter, Trinity, Tulare, Tuolumne, Ventura, Yolo, and Yuba).
- 4. Adult disposition information includes those juveniles aged 14 to 17 who received an adult level disposition in 2003. The number of adult dispositions received in 2003 that meet the above criteria will not equal the number of juveniles transferred to the adult system for prosecution. Because of differences between the adult and juvenile systems, not every case transferred to the adult system is adjudicated in the same year.
- 5. For adult dispositions with multiple offenses, the most serious offense with the most severe punishment was used in the analysis.
- 6. In 2003, the JCPSS was modified to accept up to five offenses per referral or petition. Previously, the JCPSS would only accept the most serious offense per referral or petition.

Arrests

Monthly Arrest and Citation Register (MACR)

If a person is arrested for multiple offenses, MACR selects only the most serious offense based on the severity of possible punishment.

Appendix 4 Computational Formulas

Minority over-representation index:

% of cases involving minority youth at each stage

% of cases received involving minority youth

An index value of:

- More than 1 indicates minority over-representation.
- 1 indicates proportional representation.
- Less than 1 indicates minority under-representation.

The following example shows how the index value is calculated and interpreted.

	Minority juveniles	Juvenile population	Percent minority
Justice-involved juveniles	640	2,000	32%
Overall juvenile population	720	4,500	16%

The index value is calculated as 32% divided by 16% = 2. An index value of 2 indicates that minority youth are represented among justice-involved juveniles at twice their rate of the overall juvenile population.

Appendix 7 Juvenile Justice Glossary

California Youth Authority (CYA) – the state agency which has jurisdiction over and maintains institutions as correctional schools for the reception of wards of the juvenile court and other persons committed from superior courts.

Caseload – the number of juveniles under the supervision/jurisdiction of a probation department, excluding courtesy supervision, but including juveniles on diversion, informal probation (654 or 654.2 WI), non-ward probation (725(a) WI), deferred entry of judgment (790 WI), and those who are wards of the juvenile court.

Closed at Intake – a referral is closed at intake by the probation department following an investigation of the circumstances and nature of the alleged offense. No further action is taken.

Deferred Entry of Judgment – a treatment program for first-time felony offenders aged 14 to 17 (pursuant to 790 WI).

Deferred Entry of Judgment Failure – a felony offender who fails the treatment program (pursuant to 793 WI).

Detention – the status of a juvenile immediately after arrest and prior to any court action.

Direct File in Adult Court – the transfer of a juvenile offender who is alleged to have committed murder, rape, spousal rape, forcible sex offense, lewd and lascivious acts on a child under the age of 14 years, forcible sexual penetration, sodomy, or oral copulation to a court of criminal jurisdiction (pursuant to 602(b) WI).

 $\ensuremath{\text{Dismissed}}$ – a petition is dismissed by the juvenile court with no further action taken.

Disposition – an action taken by the probation officer or juvenile court as a result of a referral.

Diversion – any delivery or referral of a minor, by the probation department, to a public or private agency with which the city or county has an agreement to provide diversion services. Diversion services must meet the following criteria:

- 1) The probation department must have referred the minor and continued to be responsible and maintained responsibility for that minor's progress.
- 2) Placement and monitoring of a minor must have a beginning and ending date.

Fitness Hearing (707(b) WI) – a hearing to determine whether the juvenile is a fit and proper subject to be dealt with under the juvenile court law. If the juvenile is found fit, adjudication remains in the juvenile court. If the juvenile is found unfit, adjudication is transferred to the adult court.

Informal Probation (654 WI) – supervision of a minor, in lieu of filing a petition, for a period not to exceed six months. The supervision is based on a contractual agreement between a probation officer and a minor's parents or guardian provided for under 654 Welfare and Institutions Code (WI).

Informal Probation (654.2 WI) – supervision of a minor, in lieu of declaring a minor a ward of the court, for a period not to exceed six months. The supervision is based on a contractual agreement between a court and a minor's parents or guardian. The period of supervision may be extended.

Non-Secure Facility – a facility where a juvenile is not physically restricted from leaving.

Non-Ward Probation (725a WI) – probation grant, without wardship, from juvenile court for a specific time not to exceed six months.

Appendix 7 Juvenile Justice Glossary

Population at Risk – that portion of the total population who, because of like characteristics to the specific study group, are considered "at risk." For juveniles, all persons between 10 and 17 would constitute the at-risk population.

Private Facility - a facility operated by a private individual or group.

Public Facility – a facility operated by a governmental agency other than a county probation.

Race/Ethnic Groups:

American Indian – a person whose ancestry is any of the original peoples of North America and who maintains cultural identification through tribal affiliation or community recognition.

Asian/Pacific Islander – a person whose ancestry is Cambodian, Chinese, Filipino, Guamanian, Hawaiian, Japanese, Korean, Laotian, Other Asian (a person who may be Asian but whose specific ethnic origin is not known or declared, or none of the other Asian codes apply), Pacific Islander, Samoan, or Vietnamese.

Black – a person whose ancestry is any of the black racial groups of Africa.

Hispanic – a person of Mexico, Puerto Rico, Cuba, Central and South America or other Spanish culture or origin regardless of race.

Other/Unknown – a person who cannot be linked to any of the general or specific racial/ethnic groups listed.

White - a person whose ancestry is any of the original peoples of Europe, North Africa, or the Middle East.

Referral – a juvenile who is brought to the attention of the probation department for alleged behavior under 601 and 602 Welfare and Institutions Code (WI).

Remand to Adult Court – a disposition resulting from a fitness hearing that finds a juvenile unfit for the juvenile system and transfers a juvenile to the adult system.

Reopen – a disposition that refers to a case previously closed at intake.

Reverse Remand – occurs when a case is sent back to the juvenile system from the adult system.

Reverse Waiver for Sentencing – occurs when the adult system sends a juvenile back to the juvenile system for sentencing.

Secure Facility – a facility where a juvenile is held behind a locked door, gate, or fence, or in which some person is responsible for physically preventing the juvenile's escape or departure from the facility.

Technical Violation – occurs when a juvenile violates a condition of his/her probation but does not commit a new offense.

Traffic Court – a disposition indicating the case was transferred to the traffic court for processing.

Transfer – a disposition which transfers the juvenile to another county juvenile court or probation department.

Ward Probation – a probation grant in which a minor is declared a ward of the juvenile court and placed on formal probation.
