INSTRUCTIONS FOR ANNUAL EVENT AND SECURITY PLAN

Penal Code section 27210, subdivision (b), states, "The annual event and security plan shall be submitted by either the producer or the facility's manager to the Department of Justice and the law enforcement agency with jurisdiction over the facility." An annual event and security plan must be submitted each calendar year for each facility site at which gun show(s) or event(s) are held by the producer. The annual event and security plan must be submitted no later than fifteen (15) days prior to the gun show(s) or event(s).

Penal Code section 27210, subdivision (d), states, "The annual event and security plan shall be approved by the facility's manager prior to the event or show after consultation with the law enforcement agency with jurisdiction over the facility." No gun show or event shall commence unless the requirements of Penal Code section 27210 are met.

Only the licensed gun show producer and the facility's manager may complete and sign the Annual Event and Security Plan form (BOF 104). Please use additional sheets of paper as necessary to complete the form.

- To another government agency as required by state or federal law.
