INSTRUCTIONS

Requirements:

The Dangerous Weapons permit holder (permittee) must maintain the Report of Security Compliance form (FD 045) for all vehicles and facilities where the dangerous weapons will be transported and stored in California (Subdivision (a) of Section 4140 of Article 3 of Chapter 12.5 of Division 1 of Title 11 of the California Code of Regulations (*11 CCR 4140(a)*). Current vehicle and storage facility information must be maintained on form BF 045 or a computer generated printout of the same format (*11 CCR 4140(b)(1)*). The permittee must make these records available to any peace officer or other persons designated by the Attorney General upon request (*11 CCR 4130(h)*).

The permittee must submit any change to the storage facilities or transportation vehicles information within 10 days on a new copy of the Report of Security Compliance form (BF 045) (*11CCR 4140(c)*). A violation of this section establishes grounds for revocation pursuant to *CCR 4147(a)(5)*. Completing the Security Compliance Report Form:

You must read and understand Article 5 of Chapter 12.5 of Division 1 of Title 11 of the California Code of Regulations, commencing with Section 4140 (*11 CCR 4140*). The form provides two entry sections for reporting up to three separate vehicles or trailers and three separate storage facility locations (Use an additional sheet(s) of paper to report more than three vehicles or trailers or three storage facilities). Make as many copies of this form as required to complete your reporting requirement.

You must enter the Make (e.g. Ford, Dodge, etc.), Model (e.g. F-150, Ram, etc.), Year of vehicle, Color of vehicle, License Plate number or Vehicle Identification Number (VIN), and the State where the License plate was issued from.

You must enter the Storage Facility Address, the Storage Facility City, and State, the Storage Facility zip code, the Storage Facility Phone Number (with area code) and the Storage Facility Business Name (if applicable).

You must read and understand the declaration, and affix your signature under penalty of perjury (Sections 118, et seq., and 672 PC) that all statements made by you hereon are true and complete. In the appropriate space print your name, date and your license/permit(s) number(s).
