If a customer has a choice of whether they are going to pay a collection fee per wager or not, they will always prefer the casino that does not charge a collection fee. For the past few decades, cardrooms have provided entertainment for the citizens of the community while also contributing living wage jobs and vital tax revenue. This all could be lost if these regulations become law.
