Pursuant to the requirements of Government Code section 11346.8(c), and section 44 of Title 1 of the California Code of Regulations, the California Department of Justice (the “Department”) is providing notice of changes made to the proposed regulations and associated forms concerning the Fair and Accurate Governance of the CalGang Database. These regulations and forms were originally the subject of a Notice of Proposed Rulemaking Action published in the California Regulatory Notice Register (Register 2019, No. 2019-0430-06) on May 10, 2019, a Notice of Modification posted on the Department’s website on July 31, 2019, and a Notice of Modification posted on the Department’s website on December 31, 2019. These additional changes are in response to comments received from the Office of Administrative Law regarding the proposed regulations and forms, as modified, and for purposes of clarification. The additional changes are indicated by blue highlighted italicized underline for proposed additions, and blue highlighted italicized strikethrough for proposed deletions.
