RE: Proposition 65 Notices re Web Sales of Alcohol.

Dear Ms. Snider:

We have reviewed the 60-day notices of violation that John Devlin served on a number of businesses over the past few weeks pursuant to Proposition 65 (Health and Safety Code section 25249.5 et seq.) These notices are identified in the attached table (Table A). The notices allege that the businesses listed in Table A failed to provide clear and reasonable warnings to customers who purchased alcoholic beverages from the businesses' websites.

We currently are involved in discussions with Mr. Devlin and his lawyers concerning potential deficiencies with the notices, as well as the supporting information submitted to our office with the notices which we are required to maintain in confidence. (Health & Saf. Code, § 25249.7, subd. (i).) Unless you hear otherwise from Mr. Devlin's lawyers or from our office, however, the notices continue to be in effect and you should treat them as such. We expect to conclude those discussions within the next two weeks.

Meanwhile, regardless of the outcome of our discussions with Mr. Devlin, we note that, in order to take advantage of the applicable safe harbor warning regulation, web-sellers, including web sellers of alcohol, must provide website warnings so that the purchaser receives them "prior to completing the purchase." Cal. Code. Regs. title 27, section 25602, subd. (b). Please review section 27602(b) itself for additional requirements.

This letter addresses compliance with Proposition 65. It is the responsibility of the businesses to ensure that they are in compliance with any other laws or regulations applicable to the sales of alcoholic beverages.
