Executive Summary

The 2019 Attorney General's Electronic Interceptions Report is issued in compliance with Penal Code section 629.62, and is available on the Attorney General's website at: https://oag.ca.gov. Each county was directed to provide certain mandatory information regarding its electronic interception activity for the 2019 calendar year by January 3, 2020. This report reflects the information submitted.

Electronic interceptions are the interceptions of wire or electronic communications via wire, cable, radio, and other systems. In California, court-authorized interceptions of wire or electronic communications are used to target specific criminal offenses when conventional investigative techniques are inadequate or simply too dangerous to pursue. As such, the use of electronic interceptions constitutes an essential tool in law enforcement agencies' battle against crime. Dangerous individuals and criminal entities, such as drug trafficking organizations ("DTOs") and criminal street gangs, frequently rely on telecommunications to advance their criminal activity. Accordingly, electronic interceptions are essential in identifying, disrupting, and preventing crimes including murder, drug trafficking, and human trafficking. Such interceptions have successfully uncovered conspiracies to commit murder and have led to the seizure of remarkable amounts of narcotics, firearms, and criminally derived proceeds that facilitate ongoing criminal activity. Discoveries and seizures like these effectively remove harmful elements from our communities and further public safety.

This report contains electronic interception data and details about how the authorized use of electronic interceptions enable local, state, and federal law enforcement agencies to effectively combat crime at various levels. From preventing and solving murders, to disrupting large-scale drug trafficking operations, the following examples underscore the importance of the continued use of authorized electronic interceptions:

- Los Angeles County's use of electronic interceptions resulted in seizures of over 5,000 fentanyl pills, 239 kilograms of methamphetamine, 103 kilograms of cocaine, 13 kilograms of heroin, and over \$3.1 million in narcotics proceeds.
- Riverside County's use of electronic interceptions resulted in seizures of over 529 kilograms of methamphetamine, 283 kilograms of cocaine, 474 kilograms in other narcotics, and over \$3.3 million in narcotics proceeds.
- San Joaquin County's use of electronic interceptions confirmed an ongoing violent conflict between two gangs and resulted in the seizure of evidence of offenses including homicide, human trafficking, drug trafficking, and firearms offenses. In addition to 16 felony arrests, this investigation led to the identification of victims of human trafficking, pimping, and domestic violence (2019-SJ-33).

Although this report sets forth information in nine separate tables, the tables should be read collectively to evaluate the impact that electronic interceptions have had on public safety. Tables 1, 2, and 3 reflect statistics related to arrests, convictions, the nature of interception orders, and post-interception court activity. Table 4 contains data describing the electronic interceptions and optional comments about the usefulness of those interceptions. Table 5 sets forth information regarding compliance with the requirement that inventory notices be sent to persons subjected to interceptions. Table 6 shows the cost of each interception. Table 7 lists counties that reported no electronic interception activity in calendar year 2019. Table 8 provides supplemental information for interceptions completed prior to 2019, for which additional information later became available. Finally, Table 9 lists electronic interception orders that were never used.

Appendix A: Penal Code section 629.62 "Report by Attorney General"

(a) The Attorney General shall prepare and submit an annual report to the Legislature, the Judicial Council, and the Director of the Administrative Office of the United States Courts on interceptions conducted under the authority of this chapter during the preceding year. Information for this report shall be provided to the Attorney General by any prosecutorial agency seeking an order pursuant to this chapter.

(b) The report shall include all of the following data:

- (1) The number of orders or extensions applied for.
- (2) The kinds of orders or extensions applied for.
- (3) The fact that the order or extension was granted as applied for, was modified, or was denied.
- (4) The number of wire or electronic communication devices that are the subject of each order granted.
- (5) The period of interceptions authorized by the order, and the number and duration of any extensions of the order.
- (6) The offense specified in the order or application, or extension of an order.
- (7) The identity of the applying law enforcement officer and agency making the application and the person authorizing the application.
- (8) The nature of the facilities from which or the place where communications were to be intercepted.
- (9) A general description of the interceptions made under the order or extension, including (A) the number of persons whose communications were intercepted, (B) the number of communications intercepted, (C) the percentage of incriminating communications intercepted and the percentage of other communications intercepted, and (D) the approximate nature, amount, and cost of the manpower and other resources used in the interceptions.
- (10) The number of arrests resulting from interceptions made under the order or extension, and the offenses for which arrests were made.
- (11) The number of trials resulting from the interceptions.
- (12) The number of motions to suppress made with respect to the interceptions, and the number granted or denied.
- (13) The number of convictions resulting from the interceptions and the offenses for which the convictions were obtained and a general assessment of the importance of the interceptions.
- (14) Except with regard to the initial report required by this section, the information required by paragraphs(9) to (13), inclusive, with respect to orders or extensions obtained in a preceding calendar year.
- (15) The date of the order for service of inventory made pursuant to Section 629.68, confirmation of
- compliance with the order, and the number of notices sent.
- (16) Other data that the Legislature, the Judicial Council, or the Director of the Administrative Office of the United States Courts shall require.

(c) The annual report shall be filed no later than April of each year, and shall also include a summary analysis of the data reported pursuant to subdivision (b). The Attorney General may issue regulations prescribing the content and form of the reports required to be filed pursuant to this section by any prosecutorial agency seeking an order to intercept wire or electronic communications.

(d) The Attorney General shall, upon the request of an individual making an application, provide any information known to him or her as a result of these reporting requirements that would enable the individual making an application to comply with paragraph (6) of subdivision (a) of Section 629.50.
