# FIRE CAMP

- Screens list for all inmates eligible for Fire Camp and takes them off list
- Once screened, send the list to the PMB South Facility PPO Officer at the CHU North Office

# PMB SOUTH FACILITY PPO OFFICER

- Screens list for those inmates meeting the BOT criteria
- Places those meeting the BOT criteria on BOT tracking list
- Sends the BOT tracking list to the South Facility Clinical Nurse Director for medical housing clearance at South Facility
- · One day to screen list

#### CLINICAL NURSE DIRECTOR - PDC

- Has South Facility medical staff screen list for appropriate housing at South Facility
- Document on Bot tracking list those inmates who do not qualify and reason why
- Send BOT tracking list back to PMB South PPO Officer
- 2-3 days to screen list

## SOUTH FACILITY OSJ DEPUTIES

- Screens list for any active ties to active gangs
- Document on BOT tracking list those inmates who are disqualified due to gang ties
- Return BOT tracking list back to PMB South PPO Officer
- 2-3 days to screen list

### PMB SOUTH FACILITY PPO OFFICER

 Send the BOT tracking list to South Facility Operation Safe Jails (OSJ) deputies for gang screening

#### PMB CHU NORTH SERGEANT

- PMB CHU North Sergeant reviews BOT tracking list
- Have CHU North staff move all the AB109 inmates from the BOT tracking list who qualify for the BOT program into Barrack 36 at South Facility
- Send BOT tracking list to PMB CTU Sergeant for COMPAS screening



## **PMB CTU SERGEANT**

- Have CTU staff conduct a COMPAS of all inmates on BOT tracking list for risk to recidivate
- Update BOT tracking list with COMPAS score
- Send the BOT tracking list back to PMB CHU North Sergeant
- 1-3 days for COMPAS assessments

## **PMB CHU NORTH SERGEANT**

- PMB CHU North Sergeant reviews BOT tracking list
- Have CHU North staff transfer the inmates that were disqualified for the BOT program based on COMPAS score out of Barrack 36 and into an inmate worker or EBI program barrack
- Daily contact the South Facility BOT staff for any reports on bed vacancies due to an inmate leaving the BOT program.
- Have CHU North staff transfer an inmate from BOT feeder Barrack 36 to BOT Program Barrack 46
- Housing moves completed within 24 hours
