AB 953 Subcommittee – Searches & Seizures

This subcommittee will advise the Racial and Identity Profiling Advisory Board (Board) regarding recommendations the Board may wish to make to the Office of the Attorney General concerning the Data Values to collect for any searches of persons and/or property, and any seizure of property as a result of a stop.

I. BACKGROUND

A "Data Element" is the category of information that is collected – for example, the "gender" of the person stopped. "Data Values" are fields that an officer would select in responding to the data element. AB 953 does not provide the particular data values that must be assigned to each data element. For example, "female, male, transgender, and gender non-conforming" are possible data values that could be assigned within the data element of "Perceived Gender" of the person stopped.

AB 953 requires officers to report on actions taking during a stop, including the following required categories:

"(7) Actions taken by the peace officer during the stop, including, but not limited to, the following:

(A) Whether the peace officer asked for consent to search the person, and, if so, whether consent was provided.

(B) Whether the peace officer searched the person or any property, and, if so, the basis for the search and the type of contraband or evidence discovered, if any.

(C) Whether the peace officer seized any property and, if so, the type of property that was seized and the basis for seizing the property." (Gov. Code, \pounds 12525.5, subd. (b)(7).)

This subcommittee may wish to consider the appropriate Data Values provided below in responding to the bases for searches and seizures, as well as the actual contraband or property discovered and/or seized during a search.
