
- 75.4 million subjects with over 284+ million arrest cycles, including:

  - ▶ 640,000+ sex offenders
  - ▶ 15+ million photos (8 Million subjects)
  - ▶132,000+ Known and Suspected Terrorists

- FY10: 61.3 million
- FY09: 52.7 million
- FY08: 35.5 million
- Tenprint Criminal Submission Rate: 57%
- Tenprint Civil Submission Rate: 43%




## Core IAFIS Service Electronic Tenprint Submission Criminal

### **NGI Core Services**



- Identification: Positive identification or non-identification of an individual based on a one-to-many biometric search.
- Verification: Confirmation of an identity based on a one-to-one comparison.
- ▶ <u>Information:</u> Supports user requests for biographic and/or biometric information for a specific individual.
- ▶ <u>Investigative</u>: Provides a list of candidates based on a one-to-many biometric and/or biographic search. The result set may include an ordered listing of candidates and corresponding information to facilitate the investigative decision process.



### **NGI Core Services**




- Notification: Event notification to users for their data contained within any of the NGI repositories
  - (e.g., Criminal and Civil Files, Special Population Cognizant [SPC] Files, Unsolved Latent File [ULF], Unsolved Iris File [UIF], and Unsolved Photo File [UPF]).
  - With this service, a data owner will receive an unsolicited notification from the system based on event criteria (triggers).
  - In addition, events that trigger a notification on Immigration Violator File (IVF) records will be provided to the Law Enforcement Support Center (LESC).

### Increment 3 Readiness

- Compliant with 9.3 ULW 2012 6.3
  - Dependencies
  - Local/Regional & State have most up to date version of Interoperability standards
- Default is "Not-Ready" until testing is complete

No loss of service, but no gains without 9.3



### **Improvements & Enhanced Latent Services**



- ➤ Increases fingerprint search accuracy to over 99%
- ➤ Faster Identification and Responses
- ➤Increased Latent Search Accuracy > 70 %
- Expanded Latent Search of Civil Repository Not all states participating
- Search using Image only, Quick Minutiae mark-up or Region of Interest



## Palm Prints, Latents and Rapid Response (Increment 3) Completed



#### **Deployment Completed-May 5, 2013**

- All contributors immediately benefited from 3 times increased accuracy
- Expanded Cascaded searches already producing results
  - > 677 ULMs as of 5/29/2013
    - > First 5 Days:

### Palms - 2013



- Currently 32 States 11 Federal agencies participating
  - Repository built
    - Seeking new and legacy prints from Arrest & Booking Process – need to be associated with FNU
  - ▶ Received over 5.5 + million electronic palm prints Many are unusable.
  - Ability to store fingerprint submissions at 1,000






NGI NATIONAL PALM PRINT SYSTEM (NPPS)









- Photo search capability
  - New search function for photo repositories
    - (including SMT and mug shot photos)
- Facial recognition investigative tool
  - Conduct searches to generate ranked candidate lists of potential matches
- Image Retrieval
  - AFIS System if you have that capability
  - ▶ FR System
  - ▶ NGI Provided tool UFW -2012

### **NGI** National Photo Repository



- ➤ Interstate Photo System Repository
  - Many states have submitted photos for searching
    - ➤ NGI staff working with states that are not submitting (NFF)
  - Approximately 15 million photos (Mug Shots) 8 million subjects
    - ➤ NGI staff working with contributors to increase gallery images through Bulk Photo Submissions



### **IPSFRP**



- ➤ Users submit searches against a National repository of photos (AFIS FR System Mugshot System)
  - ➤ Gallery contains booking images collected at the arrest event (along with tenprint submission to the FBI)
- ➤ Law Enforcement Users will receive a ranked investigative candidate list
  - Minimum 2, default 20, maximum 50
  - Access within CJIS Security Policies



### **Investigative Candidate List**



- > Search Results Biometric (SRB) response
  - Includes the number/default of candidates requested
  - Candidates will be ranked
  - ➤ The Universal Control Number (UCN /FNU) of each candidate will be returned
  - Caveat regarding investigative response







### **Universal Face Workstation (UFW)**


- FBI user software to support access to NGI Face Pilot and NGI System face search capabilities
- Search preparation, submission, and candidate list review
- Cross Platform (Windows, OSX, Linux)
- Built on open source frameworks
- Extensive support for user developed plugins
- Available for authorized Law Enforcement use free of charge





### **Basic UFW/BIP Installation**








### **Important Note**



- UFW does NOT provide a means for a States or Agencies to search face images not contained within the FBI pilot repository
- The FBI Pilot only searches
  Type-10 records submitted
  to the FBI in **CRIMINAL**transactions (CAR)

Supports mobile fingerprint identification operations on a national level with FNU

#### 2.1 Million - Subset of Criminal Master File - IAFIS and III

- Biometric searches of the worst of the worst searching fingerprints of
  - Wanted persons With FNU 600k Felony & some Misdemeanor
  - Known or appropriately Suspected Terrorists 132,000
  - Sex offenders 640,000
  - Immigration Violator File 283,000
  - Violent Offender File To be added
- >75% NY warrants contain an FNU 25K Wants, 35K sex offenders
- >83% of NJ warrants have an FNU 27K Wants, 13K sex offenders
- **▶45% of PA warrants have an FNU 17K wants, 10K sex offenders**



### Repository for Individuals of Special Concern (RISC)

- •RISC may be used for authorized Criminal Justice Purposes
  - Consideration needs to include review of all relevant laws, policies and court rulings.
  - Guidance for appropriate use of the devices.

Who can use devices and access the data

When to use – pre-arrest

What to do with information returned

- Guidance for actions to be taken by personnel RISC Response <u>RISC responses do not provide actionable information!!!</u>
  - •What to do after you use it

#### ➤ NGI Iris Pilot (Increment 5)

- Completed Iris Concept of Operations
- Develop and deploy a iris pilot system capable of performing iris image recognition services
- ➤ Finalizing Technical Specification Document and MOU's for pilot participation and bulk iris submissions
- ➤ Working with; CA, MO, NY, TX, RI, US Customs and Border Protection, Department of Defense, & U.S. Probation and Parole
- Provide operational observations to assist the FBI in planning efforts for NGI's national iris service

### NGI Offers Bigger, Better, Faster Biometric Services to Support Federal, State, and Local Stakeholders

- Development of future services currently underway
  - Check with Program Office for technical assistance
  - Store all biometrics with FNU
  - Palms must have distal region to validate Training and awareness of orientation issues
  - Upgrades to booking equipment include interface for submission of mugshots
  - Update to newest EBTS 9.3, 9.4 2014 EBTS 10.0
  - ULW Integration 6.3
- ▶ Time to plan for participation in future NGI Services
