#### California-Criminal Index and Identification (Cal-CII) Status Updates

Staff Services Manager II Sharlyn Miller provided an update on the California-Criminal Index and Identification (Cal-CII) systems.

- Automated Fingerprint Identification System (AFIS) DOJ is currently working on fixing bugs and updating system.
- Automated Latent Print System DOJ is currently working on fixing bugs and updating system.
- Integra Archive System Imaging and Live Scan Program Manager II Troy Meza, DOJ provided an update on the Integra Archive System. DOJ is working on modernizing system. DOJ is actively scanning manual folders into the system. Next year all folders from 1985 to the present will be scanned into the

system. Older manual folders will still be available through the DOJ Command Center.

• Other Projects – DOJ has a grant to modernize the live scan system, allows system to be more adaptable to organization.

# State Summary Criminal History Information Status Updates/Discussion on Legislation

Assistant Director Marc St. Pierre provided an update on legislation affecting criminal history information.

- **Consolidated Record Relief Project-** SB 731 is to be implemented by July 2024- DOJ is working with Courts and the Judicial Council on how to close reporting gaps so that criminal history information is up to date and relief can be granted appropriately. - AB 1793/1706 Cannabis Resentencing of Cannabis Convictions DOJ has submitted to the Legislation three quarterly reports. Three more reports are due from now to July 2024. DOJ is meeting with the Judicial Council to discuss court perspectives. If any agencies have questions, please reach out to Marc St. Pierre.
- AB 1076/SB 731 (PC 1203.425) Automatic Record Relief –DOJ is working on implementing SB 731 by July 2024. AB 134 changed SB 731 implementation date.
- **AB 898 Probation Transfer** Part of the Consolidation Records Relief Project to be implemented by July 2024

**Discussion on Supervised Release Files (SRF) in CLETS for pre-conviction terms** Assistant Director Marc St. Pierre provided an update on the Supervises Release Files (SRF).

• DOJ has spoken with Sheryl Wolcott, SLO DA, and the Judicial Council. The groups have action items to follow up on. They will continue to work together and may need to look at new legislation to move forward.
