Summary of December 1, 2020 CLETS Advisory Committee Meeting

Action Item 1- In relation to AB 1747 and the requirement of transmitting purpose codes, DOJ is to send out contact details to CPOA, CPCA and CSSA (**Reference page 21, lines 1-16**)

Action Taken – The general email address for DOJ's Client Services Program, which was included on the Information Bulletin was sent to each of the associations in addition to a new email that is more specific to AB 1747 questions and/or concerns: AB1747@doj.ca.gov.

Action Item 2 – Review NextGen 9-1-1 Network for possible CLETS Usage (Reference transcript page 33, lines 5-24)

Action Taken – In preparation for a meeting with OES to discuss end-to-end security from a law enforcement confidentiality perspective, DOJ staff has scheduled a meeting with various internal members from our Network Services Group, Network Information Security Unit and the CLETS Administration Section to prepare for the meeting with OES. The internal meeting will identify specific areas for detailed discussions. A meeting with OES staff is currently being coordinated.

Action Item 3 – Review radio encryption language in the CLETS Policies, Practices and Procedures (Reference page 38-39, lines 21-25, line 1)

Action Taken – Existing language surrounding encryption requirements will be presented during the Executive Secretary's Report to determine if additional language should be added to clarify the existing policy.

Action Item 4 – Determine if DOJ provides statistical reports on county link down times. (Reference page 39, lines 3-11)

Action Taken – Downtime Statistical Reports for all Direct Connections are available and will be presented during the Executive Secretary's Report.

Action Item 5— Provide a report on what the most recent CLETS Strategic Plan status is and the elements of that plan that (DOJ) adopted and deployed, and determine whether or not CAC members need to start work on updating that. (Reference page 40, lines 17-22)

Chief Chris Childs has been a member of the California Highway Patrol for 26 years, having worked in the Los Angeles, Sacramento, and San Francisco Bay Area. He survived all that trifecta. Good for you. He is a graduate of the FBI's National Academy for law enforcement executives and has served as commander of multiple CHP areas, including Napa, Santa Rosa, and Golden Gate Communications Center.

His most recent assignment was at the CHP's

Enforcement and Planning Division where he represented the department in implementation of the autonomous vehicles in California. He must have been doing pretty good work.

Haven't seen any cracks up and down 99 or State Route I-5, so congratulations, Chris Childs. And he will now take command of the CHP's Information Management Division and will serve as its Chief Information Officer.

Congratulations, and welcome aboard, Chris.

MR. CHILDS: Thank you, Mark. Appreciate it.

VICE-CHAIRMAN PAZIN: Representing, uh, Cal Peace, CPOA, will be Andrew White, succeeded Mark Shaw upon his retirement.

Chief White began his law enforcement career as a public safety dispatcher with the Napa Police Department.

He used to be a little common denominator there with Napa in

2002. In 2004, he went on to serve as a police officer with Suisun City Police Department. In addition to working patrol, he served as a school resource officer, recruit training officer and traffic. He was promoted to Sergeant, then in 2015 to commander overseeing and managing the operations of the department.

1st through September 30th, we've had a total of inbound/outbound messages around 233 million and 234 million outbound. The monthly average was approximately 78 million both inbound and outbound. Daily average both ways was about two and a half million. And peak day was about 2.9 million, which is down from the previous quarter, which was about three and a half.

Next slide, please. Misuse statistics. This is for the annual misuse forms that local agencies are required to submit. Um, we did things a little bit differently as was presented last meeting.

Normally, we would report based on agencies. With COVID, and we were out of the office, it was a little bit more challenging to do that. So this time, we're reporting based on ORIs.

And what that means is, some agencies such as district attorneys offices and probation offices can have an ORI for each physical location. So, if you were to use L.A. County Probation, for example, they could have 50 to 100 different ORIs.

So that's why the number of agencies submitting the form is significantly higher for last reporting period versus 2018.

So we still have not received 216 forms for various

ORIs. We are still reaching out. However, one of the problems is, uh, we have either — the agencies have either changed their reps and we're having a difficult time getting ahold of somebody at the agency, or the numbers have changed and so we're trying to find numbers and contact people for the agencies. So we are continuing to work on that.

Hopefully, we can get this result by the end of the year.

We've had 1,459 agencies' ORIs that did submit the forms, and no misuse was reported in 1,307. 152 agencies did report misuse, and there were 198 investigations performed. And then it's identified what type of action was taken. There can be multiple actions in one scenario. For example, somebody may have been counseled and also retrained, or in some cases, maybe they were counseled and then they ended up resigning.

And then we do go through and conduct analytics on all of the documents submitted. So there were -- this is the first time we had an online submission, so there were a lot of errors that were submitted. So we've gone through and made sure to work with the agencies on correcting any of the errors that we noticed.

For some agencies that identified that there was misuse, um, but they had marked no action taken, we did reach out to the agencies to ensure, if there's no action taken, what does that mean, what happened, and, you know, we

            I'd like to provide some status updates on the

bills that were covered in the previous meeting's legislative summary. I'll be going by topic beginning with peace officers lease (phonetic) practices.

Assembly Bill, AB-846, Public Employment. Public officers are employees declared by law to be peace officers. AB-846 requires that a potential peace officer be evaluated by a physician and surgeon or psychologist and be found to be free from bias against race or ethnicity, gender, nationality, religion, disability, and sexual orientation, in addition to other factors currently evaluated.

It also requires every department or agency that employs peace officers to review the job descriptions used to recruit and hire those peace officers and make changes that emphasize community interaction and collaborative problem solving and de-emphasize the paramilitary aspects of the job. This bill chaptered.

AB-1196, Peace Officers' Use of Force.

AB-1196 prohibits a law enforcement agency, or LEA, from authorizing the use of a carotid restraint or chokehold. This bill chaptered.

AB-1506, Police Use of Force.

AB-1506 subject to appropriation requires the

Attorney General to investigate incidents of an

office-involved shooting that results in the death of an

unarmed civilian. As defined, it authorizes the Attorney

General to prepare and submit a written report and, if one is completed, requires the Attorney General to post the report to a publicly-accessible website.

Commencing July 1, 2023, AB-1506 requires the Department of Justice to, upon request of a local LEA, review the use of deadly force policies of that agency and make recommendations on those policies. This bill also chaptered.

Next we have the firearms bills.

AB-2061, Firearms Inspections.

Beginning July 1, 2022, AB-2061 allows the DOJ to inspect firearms dealers, ammunition vendors, or manufacturers participating in a gun show or event to ensure all transfers or sales are conducted in compliance with State and local laws. It also allows the DOJ to inspect ammunition vendors to ensure compliance with applicable State and Federal laws. This bill chaptered.

AB-2617, Firearms Prohibited Persons.

AB-2617 requires a law enforcement officer who requests a temporary emergency gun violence restraining order to file a copy of the order with the court within three court days of the issuance.

The bill makes it a misdemeanor for a person to own or possess a firearm or ammunition with the knowledge that they are prohibited from doing so by an out-of-state gun

violence restraining order. It also extends the period for which the person is prohibited from owning or possessing a firearm or ammunition for five years beyond the expiration of the existing gun violence restraining order. This bill chaptered.

AB-2699. By March 1, 2021, AB-2699 requires the DOJ to issue a one-time notification to all individuals and LEAs that are in possession of an unsafe handgun, according to the DOJ's current records. Thereafter, it requires the DOJ to issue a notice to the individual or LEA taking possession of an unsafe handgun pursuant to an exemption at the time of purchase or transfer.

Lastly, it requires individuals and LEAs in possession of an unsafe handgun to notify the DOJ of any sale or transfer of that handgun within 72 hours of the transaction. This bill chaptered.

AB-2847, Firearms Unsafe Handguns.

Existing law requires manufacturers to imprint a microstamp in two or more places on the internal working parts of a newly manufactured automatic pistol.

By July 21, 2022, AB-2847 requires firearms manufacturers to imprint a microstamp in one place on the interior of a newly manufactured semi-automatic pistol. For each new firearm added to the roster of handguns that have been tested and determined not to be unsafe handguns, the

bill requires the DOJ to remove three firearms from the roster that are not compliant with the microstamping requirements. This bill also chaptered.

And then SB, or Senate Bill, 914, Firearms.

This bill failed passage. It would have required the DOJ to confirm the validity of a hunting license with the Department of Fish and Wildlife during a background check when a person is under the age of 21 and using the hunting license for just a firearm. But, again, this bill failed passage.

And lastly, the miscellaneous bills.

AB-1969, Secondhand Goods, Tangible Personal Property Reporting Requirements.

Beginning July 1, 2023, AB-1969 exempts a seller or pledger who verifies their identity using a matricular consular (phonetic) from their requirements that their personal identifying information, or PII, be reported to the California Pawn and Secondhand dealer system, or CAPS.

It requires each secondhand dealer or coin dealer to record and maintain a specified PII of such seller or pledger for three years from the date the item was reported to CAPS and provided to the law enforcement upon receiving notification that the item has been reported lost, stolen, or embezzled. This bill chaptered.

AB-2606, Criminal Justice Supervised Release File.

Every ten days, AB-2606 requires each County

Probation Department or other supervising County agency to

update any supervised release file that is available through

CLETS by entering any person that is placed on

post-conviction supervision in their jurisdiction. This

bill chaptered.

And that concludes my legislative update.

VICE-CHAIRMAN PAZIN: Thank you -- (clearing throat) excuse me, Kelly.

Are there any questions or comments? Please -- if there are, please identify yourself from the committee.

(No audible response.)

VICE-CHAIRMAN PAZIN: There being none, we will move on to Item No. 8, the CLETS message header changes under AB-1747. I would like to introduce Erin Choi (phonetic), to give us an update on that.

MS. CHOI: Good morning, everyone. Thank you for this opportunity to be with you all this morning.

For today's agenda topic, I just wanted to spend a few minutes to give you an update. I know that AB-1747 is a topic of great interest in the law enforcement community, and we always want to be as -- as transparent as possible.

So, just to, you know, kick things off as a quick recap, um, all of your agencies should have received an information bulletin about AB-1747 back in the spring. We

issued that in early April. And, really, we wanted to get the word out to let everyone know what to expect as far as upcoming changes to CLETS.

So effective July 1, 2021, all incoming CLETS transactions must be accompanied with a purpose code. And there's three options. We're trying to keep this simple and straighforward, but you must send us that purpose code.

So since the information bulletin went out, um, our focus has been on readying the CLETS system, and we have some additional DOJ resources on the line that can speak to that. Kirk Beardwood (phonetic) has joined us this morning from our IT team, and Maria -- Maria's area in the CLETS administration section has been involved with that as well.

So we have some agencies that are already submitting successful transactions with that new format, and what our focus is going to be on right now is continued testing and outreach to make sure that all agencies are ready to go by July 1st in getting us this additional purpose code information.

Um, and then related to that, we've also been having a series of internal meetings just so far about how we may start conducting audits on this information, because that's another component that is part of the legislation as well, that agencies will not only give us this information, but then it could be subject to audit by Cal DOJ. So this

is a type of topic that we're pulling together a lot of resources from within the department to make sure that we address it the right way. So not only are IT sources within my area, I oversee the audit team, but as well our legal team and representatives from the DOJ research center.

As I'm sure you can all appreciate from the stats that Maria shared a little while ago, since we're receiving 2.5 million daily transactions for CLETs, we have to really come up with a smart strategy on how to audit those in a meaningful way and make sure that agencies are prepared to be successful.

So if it can give you any kind of peace of mind, if you haven't heard from us, it's not for lack of wanting to -- to reach out, but we are still trying to finalize what that approach is going to be, and there have been representatives from all of your associations as well as some vendors that have reached out. If you have any questions, please, please don't hesitate, so you can pick up the phone, e-mail me, or give me a call, and I'm happy to -- to go over some things with you. It has been really helpful to get feedback from agencies about particular scenarios that they're worried about the most.

So just as an example, one thing that was passed along to me is that, um, a very popular type of inquiry is going to be just on a plate number only. And the plate is

being run to make sure that it's not a stolen vehicle. And if there's no hit, then nothing else may typically be documented, and it doesn't have a ticket number or a case number or something else that could -- you know, it could be tied back to. So that's an example of a really helpful scenario that we're trying to make sure would be accounted for before we started doing some sampling of records for potential audits.

Um, some other things just to kind of put out there, we have been able to be successful partners with the CLETS user groups before. I was just thinking back over the last ten years that I've been working on audits within CJIS, we have rolled out three other new audit types, so this is going to be our fourth, just another evolution of our existing audit process, and we approach it not to ding agencies, not to try to have a gotcha, but more of a training and outreach to always make sure that the policies that are being set are clear. So that's gonna be how we approach this new audit for AB-1747 as well as a collaborative process.

And, you know, I'm happy to announce that we have some staff that are going to be coming onboard, new hires to focus just on this project. So we have a new manager that will be leading up this section within client services program. She starts tomorrow, so she is not able to join us

1 today, but some of you may have worked with her in the past.

2 For the last several years, she's been working on DOJ

3 | legislation and other things.

So Jamie Tackett (phonetic) is going to be the new manager effective tomorrow heading up the specific AB-1747 audit team. So with that addition of Jamie to the team, we'll really be able to ramp up our outreach and communication over the next several weeks.

Um, you know, I'm speaking to someone yesterday who mentioned that it might be helpful just to send out an e-mail blast to all of our agency CLETS coordinators to share this information, so that's something that we'll take as an action item. We're developing our communication plan, but one of the things that we are planning is, starting in January, to start sending out monthly clinter (phonetic) messages, and we'll also be running reports and do target outreach to those agencies that have not yet tested this new CLETS format.

So that kind of gives you an idea of where we're at, but happy to hear any more feedback or suggestions that you have. And, really, this is going to be the kickoff of a lot more to come within the next six months.

Okay. This is, staff recommends approval. It's for a location in Sacramento. They're what is known as a Class 3 agency, which means they are a law enforcement sub-unit of a non-law enforcement agency. They meet the requirements per California Penal Code 830.3(b) and Welfare & Institutions Code 4023.6.

Their primary responsibility is to investigate incidents at developmental centers or state hospitals that involve developmental center or state hospital law enforcement personnel that meets the criteria of Section 4023 or 4427.5 or alleges serious misconduct by law enforcement personnel.

They do have five sworn officers, and they are moving into a location that currently has a CLETS terminal, so they won't be adding their own access. They'll just be using a device that's already in that facility.

So staff recommends approval for this new service request.

of the outreach meetings we've had. But really, the purpose of today is just to start the collaboration with your board and with the members that you represent.

So if you go on to the next slide. We -- we have a network that we're building out in California.

We selected four vendors to provide next Gen 911 services, and this is just a snapshot of which vendors are providing services in different parts of the state. The northern part of the state will by Synergen (phonetic). The central area and L.A. will be provided by MGA (phonetic), and down south, we're working with Lumen (phonetic). And then Autos (phonetic) will be connected to every single public safety answering point in the state.

We started our project last August when we signed contracts, and we expect to have the network built out by July of 2021, and we're on track with the schedule in spite of all the disasters we've had and COVID and the pandemic and everything else. We have had to move some of the dates, but we are still tracking here.

So on the next slide, for those of you that have an IT background, you may appreciate the complexity of this project. But we -- we broke it up into different lanes.

And this gives you kind of a high level of where we're at in the process. So you can see we've made a significant amount of progress in the schedules.

And we're at the point now where we're connecting IP services through the public safety answering points to the peace apps around the state, and we're starting to conduct the testing that needs to happen. And between the different service providers and to make sure that we can integrate with the equipment that's already at your peace app.

We anticipate in January will be our earliest go live, and then we have a cut-over schedule that takes us from January through July.

On the next slide is really one I want to focus on, and I'm certainly not going to go through everything on this graphic. It's -- it's quite complex.

However, the point is, we're building out a redundant (unintelligible) reliable IP network to every single public safety answering point in the state. And this is just a high-level network topology, but to make it a little simpler, if you go to the next slide, this is what it looks like from a peace app perspective.

Every peace app will have two fixed IP connections, if available, from their region provider shown in the kinda reddish or orange on the bottom there, and two from the prime network service provider. So that's Autos.

And then we're building out a robust LTE solution as well. And all this is integrated into a (unintelligible)

controller to make it appear like one connection. And this pipe that we're putting in will be secure. We're bringing in a third party vendor.

Matter of fact, we just hired Net Force (phonetic) to come in and, um, to come in and do the -- the cyber security assessment on the network. And so we'll have a path in every peace app that is very reliable, and it's secure. Everything on this network is encrypted and -- and runs through out, um, you know, firewalls and through the -- the network topology.

So really what we're asking and considering is, once this network's built and in and stable, which should happen by this summer, what other things could this network be used for? And that's really the question that we're asking. We know it's going to be used for 911 calls. That's certainly what it's designed for, but there are other applications that could potentially run across this network, including things like CLETS.

And so the idea is to start the conversation to see that that might look like, if there's synergies between what we're doing, uh, with this network and the actions that are being taken to provide CLETS data statewide as well.

So, really, that's -- that's the purpose of the conversation, to see how could this project be used as a catalyst. And then, certainly to answer any questions you

might have about next Gen 911 and what's happening in your specific peace app, those are absolutely important, and we can certainly entertain those questions as well.

1.3

But that's really the high-level overview we wanted to provide and just give you a timeline of where we're at.

And with that, Chief, I'll turn it over to you for -- for questions from either you or -- or the board members.

VICE-CHAIRMAN PAZIN: Again, Budge, thank you. I got to tell you, Budge came into this like a couple years ago and just appreciate all the work, the perseverance and focus. This is a huge tasking, 58 counties, multiple jurisdictions, multiple peace apps, and, um, just a yeoman's task.

And, Budge, I know we kid around with each other a lot, but congratulations to you and your team that has got us here. I know Director Gilarducci (phonetic) is very focused on this because this will help everybody and making sure we are connected and that whatever spinoff usages we have will be well worth it.

So I will open up for any comments of the committee members. Please identify yourselves.

MR. DOMINIC: Yeah, hi, it's Joe Dominic. I've just got to thank you for the presentation. I appreciated that.

Just a question when you mentioned running, uh, using this for other purposes, and I think it's great to leverage, you know, all this infrastructure and services that were pretty overlaying here.

Uh, it would be good to have kind of more of a deeper discussion from that perspective, just kind of a end-to-end security and looking at confidentiality. You know, there's all these things we -- somebody (unintelligible) look at network security or infrastructure security. We don't -- we don't think about the personnel screening and security. Anybody who has physical or logical access to the data that's traversing across the network, whoever de- -- you know, decription points are happening across that travel, and so I was, um, a part of the CGA and kind of AT&T, Verizon, whole thing with CDT early on, ten years ago, and it was still problematic because they came and did this bolt-on, and I did this assessment, and it was quite complicated.

But I would just, um, I think it's great to -- to look at that, and I'm glad you brought that up. So, um, I would -- I would welcome maybe more of a conversation with Maria and the CLETS administration section initially to get that conversation started to kinda get deeper into the weeds, not necessarily in this forum, but appreciate you showing that. I think it's fantastic. Thank you.

MR. COURIER: Yeah. Thank you for that feedback, and we certainly would welcome an in-depth conversation. I, you know, in a forum like this, it's very difficult to get down to the technical weeds, but we have the, you know, the staff members to actually have this conversation and to begin those types of deliberate planning processes that would have to go in place. So we're looking forward to that.

great question.

MR. PARK: Thank you, Joe. This is Park. And a quick question for Budge related to a little more detail on disaster recovery.

I know a number of our agencies just over the last year and a half or so have had some challenges with backhoes and other related items on the CLETS lines. How would perhaps this new network overcome some of those challenges?

MR. COURIER: Yes. So thank you, Greg. That's a

The network has, um, multiple IP connections in every peace app, and then we overlay that with -- with LTE.

And we also got the approval to build out our microwave network, the state-owned microwave network, out into each of these peace apps.

So, essentially, you've got three connections from a region provider independent of four connections from the prime provider. So in areas where all of those connections

are available, that's seven different paths in, all managed through a (unintelligible) and controller, and we can do, um, a -- a -- a VPN (phonetic) tunnel through that to make sure it's secure, and nobody has access to it. So, really, we're talking about transport layer redundancy that we then apply application layer security through, and so we're really just the pipe provider at that point.

We'd have to look at -- as Joe mentioned, there's a number of things we have to look at. But it would make sense to have those conversations. And in the end, it might not be possible. There may be a barrier somewhere that we don't see. But it's certainly a more redundant and reliable path than what you have today. I -- I can guarantee that.

As we've presented this to our vendors, they -they cannot believe the lengths we're going to to ensure
that these calls continue to be delivered, and our response
is, this is 911. It can't go down. And so we're hoping to
leverage that type of reliability and other critical
connections provided, you can make security work and all the
other, you know, approvals that need to be in place.

And those are not insignificant. We understand that. But we want to begin to have those conversations to just see if it's possible.

MR. PARK: Thank you.

However, I think, you know, you guys are leveraging the latest in technology, specifically SD (unintelligible) and redundancy and being a person who's been out there on the street numerous times when CLETS goes down, um, you know, it's a strong network, but it's brittle when you look at what's available now, leveraging LTE and these other things for the, uh, the back haul.

So I do hope that the discussions continue. I'm not sure what the process is with this group, but I'd like to see a continual update, um, as to how those discussions are going with Chief Dominic's team, um, because, again, you know, I think that with technology, almost anything's possible. It's just figuring out the funding and, obviously, maintaining security.

I was glad to hear about the band width. It sounds like you planned it out to, uh, to accommodate other stuff.

- 1 I think that looking at CLETS, where it's at now and where
- 2 | we see it, you know, 10, 20, 30 years in the future, I think
- 3 band width's going to be huge, um, as well as, uh,
- 4 redundancy, particularly, you know, different reasons and
- 5 different parts of this state. Rural has different issues

The plan is, over the next couple of years to complete this project, but we continue to applaud and thank the efforts of Mark St. Pierre and his group on making this effort a success and anticipate even in January having the new codes available that have been passed by the Legislature this year.

So thank you again, DOJ, for your support and work on that.

And the second item, this body here has adopted strategic plans in the past. I know they've been prepared and presented to the CLETS advisory committee and was just curious that perhaps at the next meeting, we can get a report on what the most recent strategic plan status is and the elements of that that we've been able to adopt and successfully deploy and determine whether or not we might need to start work on updating that.














CLETS Advisory Committee (CAC) Legislation Update Updated 11.24.2020

PEACE OFFICERS/POLICE PRACTICES

1) Assembly Bill (AB) 846 (Burke) – Public Employment: Public Officers or Employees Declared by Law to be Peace Officers

Status: Chaptered (Chapter 322, Statutes of 2020).

AB 846 requires that a potential peace officer be evaluated by a physician and surgeon or psychologist and be found to be free from bias against race or ethnicity, gender, nationality, religion, disability, and sexual orientation in addition to other factors currently evaluated. It also requires every department or agency that employs peace officers to review the job descriptions used to recruit and hire those peace officers and make changes that emphasize community interaction and collaborative problem solving, and deemphasize the paramilitary aspects of the job.

2) AB 1196 (Gipson) - Peace Officers: Use of Force

Status: Chaptered (Chapter 324, Statutes of 2020).

AB 1196 prohibits a law enforcement agency (LEA) from authorizing the use of a carotid restraint or a choke hold.

3) AB 1506 (McCarty) - Police Use of Force

Status: Chaptered (Chapter 326, Statutes of 2020).

AB 1506, subject to appropriation, requires the Attorney General to investigate incidents of an officer-involved shooting that results in the death of an unarmed civilian, as defined. It authorizes the Attorney General to prepare and submit a written report, as specified, and, if one is completed, requires the Attorney General to post the report to a publicly-accessible website.

Commencing 7/1/2023, AB 1506 requires the Department of Justice (DOJ) to, upon request of a local LEA, review the use of deadly force policies of that agency and make recommendations on those policies.

FIREARMS

4) AB 2061 (Limon and Petrie-Norris) – Firearms: Inspections

Status: Chaptered (Chapter 273, Statutes of 2020).

Beginning 7/1/2022, AB 2061 allows the DOJ to inspect firearms dealers, ammunition vendors, or manufacturers participating in a gun show or event to ensure all transfers or sales are conducted in compliance with state and local laws. It also allows the DOJ to inspect ammunition vendors to ensure compliance with applicable state and federal laws.

5) AB 2617 (Gabriel) - Firearms: Prohibited Persons

Status: Chaptered (Chapter 286, Statutes of 2020).

CAC Legislation Update

Updated 11.24.2020

AB 2617 requires a law enforcement officer who requests a temporary emergency gun violence restraining order to file a copy of the order with the court within three court days of the issuance. The bill makes it a misdemeanor for a person to own or possess a firearm or ammunition with the knowledge that they are prohibited from doing so by an out-of-state gun violence restraining order. It also extends the period for which the person is prohibited from owning or possessing a firearm or ammunition for five years beyond expiration of the existing gun violence restraining order.

6) AB 2699 (Santiago) - Firearms: Unsafe Handguns

Status: Chaptered (Chapter 289, Statutes of 2020).

By 3/1/2021, AB 2699 requires the DOJ to issue a one-time notification, as specified, to all individuals and LEAs that are in possession of an unsafe handgun according to the DOJ's current records.

Thereafter, it requires the DOJ to issue a notice, as specified, to the individual or LEA taking possession of an unsafe handgun pursuant to an exemption at the time of purchase or transfer. Lastly, it requires individuals and LEAs in possession of an unsafe handgun to notify the DOJ of any sale or transfer of that handgun within 72 hours of the transaction.

7) AB 2847 (Chiu and Gabriel) - Firearms: Unsafe Handguns

Status: Chaptered (Chapter 292, Statutes of 2020).

Existing law requires manufacturers to imprint a microstamp in two or more places on the internal working parts of a newly manufactured semiautomatic pistol.

By 7/1/2022, AB 2847 requires firearms manufacturers to imprint a microstamp in <u>one</u> place on the interior of a newly manufactured semiautomatic pistol.

For each new firearm added to the roster of handguns that have been tested and determined not to be unsafe handguns, the bill requires the DOJ to remove three firearms from the roster that are not compliant with the microstamping requirements.

8) Senate Bill (SB) 914 (Portantino) – Firearms

Status: Failed Passage.

By 7/1/2021, SB 914 would have required the DOJ to confirm the validity of a hunting license with the Department of Fish and Wildlife during a background check when a person under the age of 21 is using the hunting license to purchase a firearm.

MISCELLANEOUS

9) AB 1969 (Blanca Rubio) – Secondhand Goods: Tangible Personal Property: Reporting Requirements

Status: Chaptered (Chapter 185, Statutes of 2020).

CAC Legislation Update

Updated 11.24.2020

Beginning 7/1/2023, AB 1969 exempts a seller or pledger who verifies their identity using a Matricula Consular from the requirements that their personal identifying information (PII) be reported to the California Pawn and Secondhand Dealer System (CAPSS). It requires each secondhand dealer or coin dealer to record and maintain specified PII of such a seller or pledger for three years from the date the item was reported to CAPSS, and provide it to law enforcement upon receiving notification that the item has been reported lost, stolen, or embezzled.

10) AB 2606 (Cenvantes) – Criminal Justice – Supervised Release File

Status: Chaptered (Chapter 332, Statutes of 2020).

Every 10 days, AB 2606 requires each county probation department or other supervising county agency to update any supervised release file that is available through CLETS by entering any person that is placed on post-conviction supervision in their jurisdiction.



Next Generation 9-1-1 Overview for the CLETS Advisory Committee December 1, 2020




Next Gen 9-1-1 Deployment

Optimistic Next Gen 9-1-1 Project Timeline




NG 9-1-1 System Diagram
