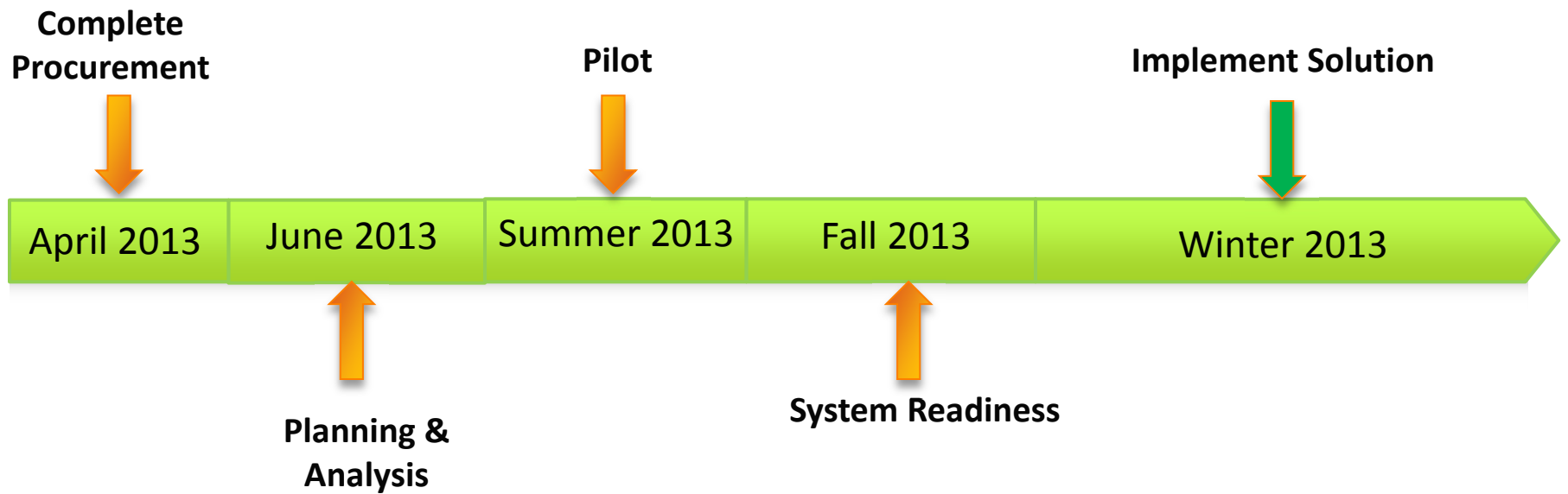
Capabilities

- Request for Offer released to vendors - March 26, 2013
- Contract awarded to ENS/Palantir - April 30, 2013
- Planning and Analysis - June 2013

Accomplishments to Date

- Conducted three site visits with potential county pilots to discuss business and technical environment.
- Announce county pilot August 2013.
- Providing one county connection for law enforcement and one connection for probation.
- Portal/service will provide the same level of security, audit controls as CLETS.
