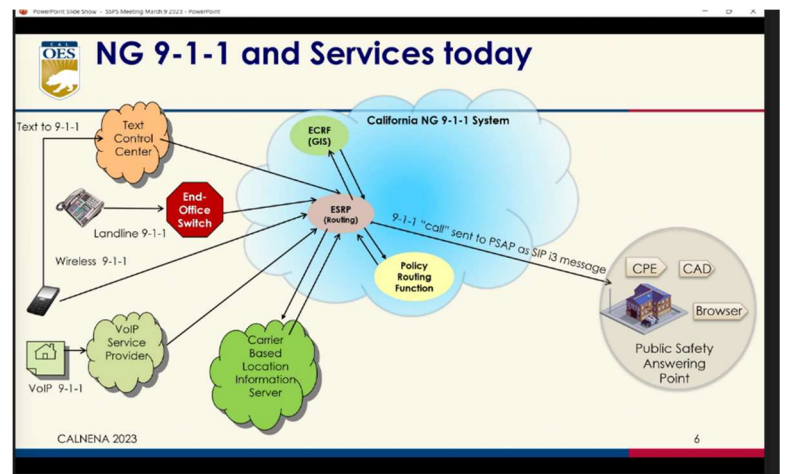
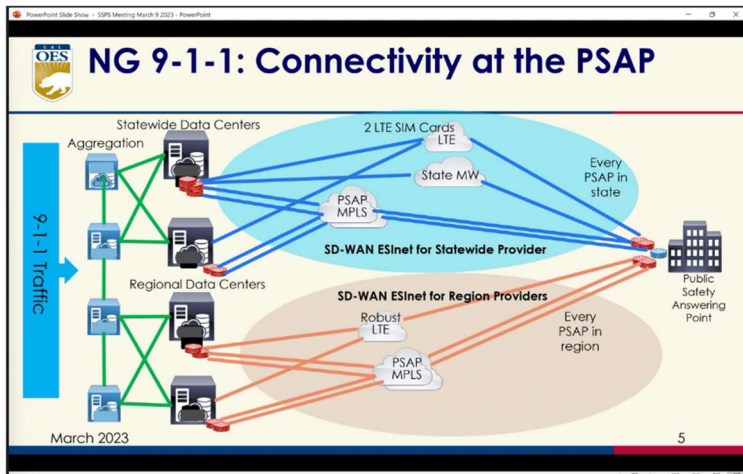
**Ashish Kakkad** asked for public comment; no raised hands as of 10:10.

**Ashish Kakkad:**

One of the main reasons this demo was given is because it was requested by CAD and Chief White. Are there any specific topics that CAD wanted us to address? Opening it up if there are any specific issues?

**Maria Cranston:**

We need to speak to the feasibility of using NG 9-1-1 for CLETS. Some limitations I see: we connect to local agencies, Net Gen doesn't connect to those local agencies. Does it meet CJIS-level security? DOJ doesn't believe it's feasible, they want to send it to SSPS.

**Ashish Kakkad:**

We can look into local site differences between CLETS and NG 9-1-1. Security-wise, we can work with Cal OES and see how that will work with NG 9-1-1. The current method is determined peace app by peace app. We need to see what is more connected to the end point, look at the connect as the most important first, then see what else is needed. DOJ, what do you need to be able to share data, to look at NG 9-1-1 as a vendor?

**Maria Cranston:**

They want SSPS to see how it can be leveraged. What potential does it bring to be back-up or can it carry the traffic? Not many agencies have connected.

**Ashish Kakkad:**

This is big enough to create a subgroup out of SSPS. We will need a team who is focused on this. Open to discussion.

**Kirk Beardwood:**

I don't understand it enough to work on it; I am swamped, so I can't do it.

**Ashish Kakkad:**

Since they are concerned with feasibility – Cal OES can reach out to DOJ.

**Paul Troxel:**

When a new agency wants to get onto CLETS, they need an application. Can Cal OES get that application so we can have our documentation in place in order to move forward?

**Ashish Kakkad to Paul Troxel:**

Look at Policy 5.9.2 and see what that means for feasibility. What does that bring to the table for local agencies?

**Maria Cranston:**

We will go ahead and send Policy 5.9.2 and a copy of the application and a copy of the matrix to you [Paul] and Budge, but Cal OES would not be the ones to submit the application, that would need to be the individual agencies. At this point, nobody is ready to move forward, and more research is necessary.

**Ashish Kakkad:**

If no one can help with this project, we can keep it on the table. Let's do research. Who is willing to step up and help with research? This is crucial and critical, we might need to bring more subject matter experts. Are we allowed to bring them in? They can work with Cal OES and answer any questions.

**Maria Cranston:**

We can't commit our network staff, but they can attend meetings. It shouldn't be only DOJ that has input.

**Ashish Kakkad:**

When I said network people, I meant for sharing their knowledge and input. I would bring people from my team in CAD on an as-needed basis. What are the limitations, or what are some options to work through this on a compliance perspective?

**Milad Dalju:**

Open meeting laws are: if it's less than 3 members collaborating with no executive power, it doesn't have to be at a public meeting. Three or more, then it must be at a public meeting. Best practice is having the meeting over the phone or via email, and no more than two people.

**Maria Cranston:**

If there are two SSPS members, you can still have people from your team, just no additional SSPS members.

**Milad Dalju:**

It will be OK if one of those two members reach out to Cal OES for information, and as long as they're not included as a formal member, then you'd still be within the Bagley-Keene requirements

**Ashish Kakkad:**

Anyone else interested in volunteering? Joey and I can work on the feasibility part of this and will give updates accordingly.

**Milad Dalju:**

Are we asking for public comment, or comment from committee members?

**Ashish Kakkad:**

Any questions?

Agreed. We want to share what we can with our vendors.

On question # 8 on the plan, can we wrap that up?

**Justin Riedel:**

Are you asking what the goals are for CLETS? One of those goals is to review those recommendations.

**Maria Cranston:**

At the last meeting, we discussed an outage where a lot of agencies had lost CLETS access. There'd been a request for an update on what happened at the June CAC meeting -- how CAS can assist with agencies partnering with other agencies so we can forward calls or make other connections to help mitigate the risks.

**Justin Riedel:**

Can it be network connectivity?

**Maria Cranston:**

What are the opportunities to local agencies? How can they assist in case the connectivity goes down?  
What is something you have in place to prevent this from happening again?

**Maria Cranston:**

Agree to streamline process for the application.

**Ashish Kakkad:**

We want to be able to streamline this application. How high- or low-level can we ask?

**Maria Cranston:**

The issue is I'm not a programmer, so I don't know what is available to make it better. I would like the opportunity to talk about what's wrong.

**Ashish Kakkad:**

Agree. Maybe we can discuss that at the next meeting. Any other comment?

**Justin Riedel:**

Agree, to review and upgrade process. It should be high priority, since we are looking at more cloud-based solutions.

**Ashish Kakkad:**

Any other comments on this item?

**Kirk Beardwood:**

Agree.
