Notice of Data Breach

Dear _____:

The Department of Public Social Services (DPSS) is writing to inform you of a data privacy breach involving your personally identifiable information. As a precautionary measure, we are providing this notice and outlining steps you may take in response to this breach.

What Happened?

DPSS is writing to you because of a privacy incident that occurred between January 2024 and May 2025 at the County of Los Angeles (County) DPSS. A County employee accessed your personal information contained in our electronic systems without a legitimate business reason. County personnel discovered the incident on May 28, 2025, and the incident was confirmed during an internal investigation completed on May 7, 2026.

What Information Was Involved?

The information about you that was accessed included your first and last name, case number, date of birth, CIN number, social security number, and information relating to your public assistance benefits (CalWORKs, General Relief, and/or CalFresh).

What We Are Doing?

DPSS deeply regrets any inconvenience this incident may cause you. To help prevent something like this from happening in the future, the matter has been referred to the County Department's human resources for assessment of corrective and disciplinary actions.

What You Can Do

DPSS recommends that you remain vigilant to the possibility of fraud and identity theft by reviewing credit reports and bank and other financial statements for any unauthorized activity.

You may also obtain a copy of the credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies.
