Dear Sample A. Sample:

AgelessRx is writing to inform you of an incident that impacts some of your personal information. This letter provides details of the incident, our response, and steps you may take to better protect against the possible misuse of your information should you feel it is appropriate to do so.

What Happened? On April 22, 2026, AgelessRx became aware of potential unauthorized access to certain files on its system. AgelessRx promptly launched an investigation with the assistance of third-party specialists to determine the nature and scope of the activity. As a result of that investigation, AgelessRx identified that between April 17, 2026 and April 22, 2026, certain help-desk tickets were accessed by an unauthorized actor. AgelessRx is notifying you of this incident because after reviewing the affected data, on May 27, 2026 we determined that your information was included in the affected help-desk tickets.

What Information Was Involved? The impacted information includes your name and the following: date of birth, health diagnosis or condition, medications, and/or other treatment information.

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities. We are reviewing existing security policies and have implemented additional cybersecurity measures to further protect against similar incidents moving forward. As an added precaution, we are offering you access to credit monitoring and identify restoration services for twelve (12) months at no cost to you, through Experian. Enrollment instructions are enclosed within this letter. We encourage you to enroll in these services as we are unable to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Any suspicious activity should be promptly reported to your bank, credit card company, or other applicable institution.

Enroll in Monitoring Services

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
