NOTICE OF DATA BREACH

June 30, 2017

Dear Current or Former Alliance Student and Parents:

We write to inform you of a recent data breach impacting multiple school districts and charter networks, including Alliance College-Ready Public Schools. Alliance uses a school data platform operated by Schoolzilla Inc. to manage and store information about our current and former students. We hope that parents of minor students will discuss the contents of this notice with their children.

WHAT HAPPENED

Schoolzilla informed us that a computer security researcher performed a security analysis and detected a vulnerability in the Schoolzilla system on or about April 4, 2017. As soon as Schoolzilla received the notice on or about April 5, 2017, they immediately fixed the error and verified that nobody other than the one security researcher accessed the exposed files. Schoolzilla also assured us that the security researcher, who discovered and alerted them to this vulnerability, permanently and securely deleted the data.

WHAT INFORMATION WAS INVOLVED

We were informed that the researcher accessed partial student records. The student records included some, but not necessarily all, of the following:

- student Alliance email address used as username and associated password, which are used to access online student accounts such as their Google applications (Gmail, Gdrive, classroom, etc.) and various online learning platforms such as Achieve3000 and Pearson's System of Courses
- student name, home address, mailing address, home phone number, statewide student number, LAUSD ID, date of birth, ethnicity, race, GATE (Gifted and Talented Education), English learner status, lunch status, parents' names, address, work and cell phone number, email address, emergency contacts
- TDAP immunization records, disability status; membership codes, program start and end dates; medical diagnoses, medications, and other health care information; doctor name and health care provider name and contact information; special education status, 504 Plans
- attendance, grades, behavior, class schedules, and test scores (including SAT, ACT, CAASPP, CST, CELDT, Advanced Placement).

At this time, Schoolzilla has reported to us that the security vulnerability has been fixed and Schoolzilla logs indicate no other access to the data other than the security researcher, who signed an affidavit stating under penalty of perjury that he has (1) deleted and overwritten the data; (2) not transferred it to, or directly or indirectly shared it with, any other person, source or device; and (3) not used the information for any purpose beyond confirming and demonstrating his access through the discovered vulnerability. We have no reason to believe that data which was accessed by the cyber security researcher was ever used, and as noted above, was deleted by the cyber expert within a day of accessing it.

WHAT WE ARE DOING

The privacy of your personal information is of the utmost importance to Alliance. Schoolzilla has informed us that it has reconfigured its systems to fix the vulnerability, changed passwords, and ensured that the downloaded data has been deleted. Schoolzilla has also informed us that it is working with third-party security experts to help augment its existing data security practices, and to look for opportunities to increase its current security defenses. Schoolzilla further reports it is working to run what is known as a 'Red Team Exercise,' a drill where internet and data security experts engage in an all-out attempt to gain access to a system so the vendor can fully test and challenge its cybersecurity defenses to ensure its data is protected. We will continue to be in communication with Schoolzilla to monitor its efforts to maintain the security of Alliance student data stored on Schoolzilla's data platform.

WHAT YOU CAN DO

This situation is an opportunity to remind ourselves about important steps we can take to protect our personal data every day. Consider a family plan for digital privacy and protection and talk to your children about these important issues.

Further, while Schoolzilla reports that the researcher affirmed and swore under penalty of perjury that he deleted all the records that he downloaded, did not share the records with third parties, and does not know which school districts' data he had obtained in his process of confirming the vulnerability, in an abundance of caution, Alliance urges parents and students to change students' email passwords (and any other security credential if applicable) to protect the student's online accounts.

FOR MORE INFORMATION

We will continue to be in regular contact with Schoolzilla about this issue. At this time, we are confident that this data breach was a contained and isolated incident but if you have further questions please email security@laalliance.org.
