Solari Accountancy, Inc. is writing to inform you of a cybersecurity incident that recently affected our tax software environment.

On or about April 8, 2026, we discovered that an unauthorized individual gained access to our tax software system. While your tax return was not directly affected, we cannot guarantee that your personal information was not exposed during the breach.

Upon discovering the incident, we immediately secured the affected environment, retained cybersecurity professionals, and launched a forensic investigation. We have also notified law enforcement, reported the incident to the IRS Stakeholder Liaison, and reported the matter to the California Franchise Tax Board Fraud Division.

We encourage you to remain vigilant by reviewing your tax notices, bank account activity, and credit reports for any unusual activity. If you observe anything suspicious, please do not hesitate to contact authorities and notify us directly.

Recommended actions for clients

1. Review all recent tax filings and refund instructions, contact your financial institution to verify your current bank account information.
2. Watch for IRS or state tax notices, including notices of duplicate filings, rejected e-file submissions, requests for identity verification, or account changes.
3. Obtain an IRS Identity Protection PIN if eligible. An IP PIN is an important safeguard against fraudulent returns filed in a taxpayer's name.
4. Review bank accounts, credit card accounts, and credit reports for unusual activity. Consider placing a fraud alert or security freeze with the major credit bureaus.
5. Keep records of all suspicious activity and all communications with the IRS, Franchise Tax Board, financial institutions, and law enforcement.
