## NOTICE OF [Extra2]

Dear Sample A. Sample:

DataPath, Inc. (“DataPath”) is writing to inform you of an event that may impact the security of some of your information. This notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it is appropriate to do so.

**Who is DataPath?** DataPath is a third-party administrative services provider. This means that DataPath administers certain types of accounts, including health savings accounts (“HSA”), on behalf of its business partners. You are receiving this notice because you currently have or may have previously had an HSA that was administered by DataPath, and a limited amount of personal information provided to DataPath for purposes of administering your account was potentially impacted by this event.

**What Happened?** On December 15, 2021, DataPath discovered unusual activity on its computer network. We immediately launched an investigation with the assistance of third-party cybersecurity specialists, which determined on or before December 15, 2021, an unauthorized party gained access to certain DataPath systems and may have accessed or acquired a limited amount of data contained within certain segments of its network. Accordingly, we conducted a thorough and time-consuming review of the data to confirm the types of information potentially impacted by this event and identify the individuals to whom that information related. We recently completed this review. Although we have no evidence of any actual or attempted identity theft or fraud of your information as a result of this event, we are notifying you in an abundance of caution.

**What Information Was Involved?** The investigation determined that your name, address, [Extra1] may have been impacted. DataPath maintained your information in connection with the services it provides to National Advisors Trust of South Dakota, a third-party banking partner who currently serves or previously served as a custodian for your HSA account.

**What We Are Doing.** The confidentiality, privacy, and security of information in our care are among our highest priorities. Upon learning of the event, we moved quickly to investigate and respond to the event, assess the security of our systems, and notify federal law enforcement and potentially affected individuals. We are notifying potentially affected individuals, including you, so that you may take further steps to best protect your information, should you feel it is appropriate to do so. We sincerely regret any inconvenience or concern this event may cause. As an added precaution, we are offering credit monitoring and identity restoration services through Experian, for [Extra5] months, at no cost to you.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and credit reports for suspicious activity and to report any suspicious activity promptly to your bank or financial institution. Additional information and resources are included in the enclosed *Steps You Can Take To Protect Personal Information*. You may also enroll in the complimentary credit monitoring services available to you. Enrollment instructions are attached to this letter.

### Enroll in Credit Monitoring

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
