RE: Important Security Notification. Please read this entire letter.

Dear Sample A. Sample:

At Huntington Ingalls Industries, Inc. ("HII"), we take your privacy seriously, and have instituted processes and safeguards to prevent the unauthorized disclosure of our personnel's information. HII also seeks to be transparent with you regarding your personal data.

We are writing to inform you of a recent incident that may affect the security of your personal information. This letter provides details of the incident, our response, and resources available to you to help protect your personal information from possible misuse. While we are not aware of any misuse of your information, out of an abundance of caution we are providing this notice to you to ensure that you are aware of the incident and that you may take steps to protect your personal information. As a precautionary measure, we have hired Experian Consumer Services ("Experian") to provide you with certain services that will help you protect your personal information, as detailed below.

What happened? We discovered that between March of 2022 and May of 2022, an unauthorized party who is not associated with HII engaged in an unauthorized activity involving certain file storage systems and may have accessed files that contained some of your personal information. We immediately retained an independent forensic investigator to conduct a comprehensive investigation into the event.

As a result of the investigation, which concluded in April of 2023, we discovered that the information involved may have included your: name, social security number, phone number, credit card number, debit card, date of birth, and/or driver's license. In addition, there is slight possibility that other personal information may have been accessed, such as state identification, tax identification number (TIN), personal identification number (PIN), military identification, state identification, passport number, financial account information, routing number, health insurance, and/or medical. At this time, we are not aware of any improper use of your personal information or any disclosure of your data to unauthorized third parties.

What are we doing?

We have taken several steps to address this situation. After discovering the incident, HII quickly initiated measures to review and reinforce the security of its storage systems. We also retained a leading forensic investigator to assist us in conducting a thorough investigation in order to determine the nature and extent of this incident. We continue to monitor our systems, and we will promptly take any additional steps that may be required to ensure that your personal information is protected.

As a precautionary measure to help safeguard your information from potential misuse, HII has partnered with Experian, a safe and globally recognized credit reporting agency, to provide a complimentary 12-month membership of Experian's[®] IdentityWorksSM. This product provides you with credit monitoring, identity theft detection and resolution of identity theft. A more detailed description of this product and how to enroll is provided below.

What additional steps have we taken?

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for 12 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your

situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Please note that Identity Restoration is available to you for 12 months from the date of this letter and does not require any action on your part at this time. The Terms and Conditions for this offer are located at www.ExperianIDWorks.com/restoration. While identity restoration assistance is immediately available to you, we also encourage you to activate the fraud detection tools available through Experian IdentityWorks as a complimentary 12-month membership. This product provides you with superior identity detection and resolution of identity theft. To start monitoring your personal information, please follow the steps below:

- Ensure that you enroll by July 31, 2023 (Your code will not work after this date.)

Again, at this time, there is no evidence that your information has been misused. However, we encourage you to take full advantage of your complimentary IdentityWorks membership.

Reference Guide

Monitor Your Accounts

We recommend that you regularly review statements from your accounts and periodically obtain your credit report from one or more of the national credit reporting companies. You may obtain a free copy of your credit report online at www.annualcreditreport.com, by calling toll-free 1-877-322-8228, or by mailing an Annual Credit Report Request Form (available at www.annualcreditreport.com) to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281. You may also purchase a copy of your credit report by contacting one or more of the three national credit reporting agencies listed below.

When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

Credit Freeze

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years;
- 5) Proof of current address, such as a current utility bill or telephone bill;
- Other personal information as required by the applicable credit reporting agency; 6)

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

Fraud Alerts

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 1year and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.

Monitor Your Personal Health Information

If applicable to your situation, we recommend that you regularly review the explanation of benefits statement that you receive from your insurer. If you see any service that you believe you did not receive, please contact your insurer at the number on the statement. If you do not receive the regular explanation of benefits statements, contact your provider and request them to send such statements following the provision of services in your name or number.

You may want to order copies of your credit reports and check for any medical bills that you do not recognize. If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your medical records. You may also want to request a copy of your medical records from your provider, to serve as a baseline. If you are a California resident, we suggest that you visit the website of the California Office of Privacy Protection at www.privacy.ca.gov to find more information about your medical privacy.

Additional Information

You can further educate yourself regarding identity theft and the steps you can take to protect yourself, by contacting your state Attorney General or the Federal Trade Commission. Instances of known or suspected identity theft should be reported to law enforcement, your Attorney General, and the FTC. If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.

You also have certain rights under the Fair Credit Reporting Act (FCRA): These rights include to know what is in your file; to dispute incomplete or inaccurate information; to have consumer reporting agencies correct or delete inaccurate, incomplete, or unverifiable information; as well as other rights.
