NOTICE OF DATA <<VARIABLE DATA 1>>

Dear <<Full Name>>:

Evening Post Publishing Inc. (“Evening Post” or “We”) writes to notify you of an incident that may affect some of your information. This letter provides details of the incident, our response, and steps you may take to protect your information should you feel it appropriate to do so.

What Happened? On March 20, 2024, Evening Post became aware of suspicious activity on our network. We immediately took steps to secure our environment and initiated an investigation into the nature and scope of the activity with the assistance of third-party forensic specialists. The investigation determined that our network was subject to unauthorized access between March 13 and March 20, 2024, and that certain files were acquired by an unknown actor while on the network. In response, we undertook a thorough review of the data determined to be at risk to assess the type of information at issue, to whom that information relates, and locate address information for impacted individuals. We finalized this review on October 24, 2024, and identified information related to you could be affected.

What Information Was Involved? The information that could have been impacted by this event includes your: <<Breached Elements>>.

What We Are Doing. The confidentiality, privacy, and security of information in our care is among our highest priorities. Upon discovering suspicious activity, we immediately commenced an investigation to confirm its nature and scope. We also reported the event to law enforcement, and implemented additional safeguards related to data privacy and security.

As an added precaution, we are offering you access to complimentary credit monitoring and identity restoration services for <<CM Duration>> months through CyEx at no cost to you. The deadline to enroll in these services is <<Enrollment Deadline>>. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

What You Can Do. In addition to enrolling in the services being offered to you, we encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements for suspicious activity. You may also review the information contained in the enclosed *Steps You Can Take to Protect Personal Information*. There you will find more information regarding ways to protect and monitor your information.

Enroll in Monitoring Services

To enroll in CyEx Identity Defense Complete at no cost to you, please follow the below instructions:

1. Visit app.identitydefense.com/enrollment/activate/eveningpost

4. Follow the prompts to create your account

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;

4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
