RE: NOTICE OF DATA BREACH

Ghilotti Bros., Inc. ("Ghilotti") values and respects the privacy of your information, which is why we are writing to advise you of an incident that may have involved some of your personal information. We are writing to advise you about the incident and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? After discovering unusual activity on our network, we promptly began an internal investigation and took steps to secure our systems. We also engaged a third-party forensic security firm to investigate the issue and confirm the security of our computer systems. This investigation determined that an unauthorized third party was able to temporarily access our system and files. In light of that, we reviewed those files to identify whether they contained any personal information.

What Information Was Involved? On October 21, 2021, we determined that the files contained some of your personal information, including your << Breached Elements >>.

What We Are Doing. In addition to the actions described above, we have also taken steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. We are also notifying you of the incident so that you can be aware and take steps to protect yourself. Finally, out of an abundance of caution, we are offering a complimentary one-year membership of Experian Identity WorksSM Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. Identity Works Credit 3B is completely free to you and enrolling in this program will not hurt your credit score. Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze can be placed without any charge and is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
