Integrated Specialty Coverages, LLC (“ISC” or “we”) is writing to inform you of a recent security incident. ISC is an insurance program administrator that provides insurance products and underwriting services. Your information may have been provided to ISC by your employer, an insurance company or broker in connection with an insurance application, or as part of an insurance claim.

Please note that this incident was limited to the third-party vendor environment; ISC’s own internal network and core systems remain secure, and there is no evidence of any compromise of ISC’s internal network or systems.

We have been working with external cybersecurity experts to investigate this situation. We have no evidence at this time that your personal information has been misused as a result of this incident.

What Happened? We detected suspicious automated access activity associated with a single account on a third-party cloud platform that ISC uses to facilitate electronic document execution and management. We acted promptly to contain the activity, initiate our incident response protocols, and engage external cybersecurity experts to help us investigate and respond. Our investigation determined that an unauthorized third party accessed a single ISC workspace within the cloud platform between June 8, 2026 and June 11, 2026 and downloaded certain files available there.

What Information Was Involved? The relevant files contained your name, in combination with your [Extra1]. We currently have no indication that any files, including those containing your personal data, have been misused. We will continue to monitor online sources for any sign of data misuse.

What We Are Doing. In addition to the actions described above, we are taking steps to reduce the risk of this type of incident occurring in the future, including further enhancing our security measures. Although we have no evidence that information potentially involved in this incident has been misused, we have arranged for you to enroll in a [Extra3] month membership of Experian Identityworks' credit and identity monitoring product if you would like to do so, at no cost to you. For more information, including instructions on how to activate your complimentary membership, please refer to the additional information enclosed.

What You Can Do. We are providing this notification for your information, and there is no action you are required to take. However, we would encourage you to review the Additional Information page we have enclosed, which provides some general reference information around protecting personal information, and consider enrolling in the complimentary monitoring services we are offering.

ADDITIONAL INFORMATION

As a precautionary measure, we recommend that you remain vigilant to protect against potential fraud and/or identity theft by, among other things, reviewing your account statements and monitoring credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You should also promptly report any fraudulent activity or any suspected incidents of identity theft to proper law enforcement authorities, including the police and your state's attorney general, as well as the Federal Trade Commission ("FTC").

Under Massachusetts law, you have the right to obtain any police report filed in regard to this incident. If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.

The District of Columbia and Massachusetts law also allow consumers to place a security freeze on their credit reports. A security freeze can be placed without any charge. A security freeze prohibits a credit reporting agency from releasing any information from a consumer's credit report without written authorization. However, please be aware that placing a security freeze on your credit report may delay, interfere with, or prevent the timely approval of any requests you make for new loans, credit mortgages, employment, housing or other services.

To place a security freeze on your credit report, you must send a written request to each of the three major consumer reporting agencies by regular, certified or overnight mail at the addresses below or, if available, comply with the consumer reporting agencies' online security freeze request procedures:

In order to request a security freeze, you may need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security Number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address such as a current utility bill or telephone bill;
6. A legible photocopy of a government issued identification card (state driver's license or ID card, military identification, etc.); and
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

The credit reporting agencies have three (3) business days after receiving your request to place a security freeze on your credit report. The credit bureaus must also send written confirmation to you within five (5) business days and provide you with a unique personal identification number (PIN) or password, or both that can be used by you to authorize the removal or lifting of the security freeze.

To lift the security freeze in order to allow a specific entity or individual access to your credit report, you must call or send a written request to the credit reporting agencies by mail or, if available, comply with the consumer reporting agencies' online procedures for lifting a security freeze, and include proper identification (name, address, and social security number) and the PIN number or password provided to you when you placed the security freeze as well as the identities of those entities or individuals you would like to receive your credit report or the specific period of time you want the credit report available. The credit reporting agencies have three (3) business days after receiving your request to lift the security freeze for those identified entities or for the specified period of time.

To remove the security freeze, you must send a written request to each of the three credit bureaus by mail or, if available, comply with the consumer reporting agencies' online procedures for removing a security freeze, and include proper identification

(name, address, and social security number) and the PIN number or password provided to you when you placed the security freeze. The credit bureaus have three (3) business days after receiving your request to remove the security freeze.

Credit Reports: You may obtain a free copy of your credit report once every 12 months from each of the three national credit reporting agencies by visiting www.annualcreditreport.com, by calling toll-free 1-877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348. You can print a copy of the request form at <https://www.annualcreditreport.com/manualRequestForm.action>.

Alternatively, you may elect to purchase a copy of your credit report by contacting one of the three national credit reporting agencies. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name.
