Dear Sample A. Sample:

M&Y Personal Injury Lawyers (“M&Y”) writes to inform you of an event that affects the confidentiality of certain archived information related to you. Although we have no indication of identity theft or fraud in relation to this event, we are providing you with information about the event, our response, and additional measures you can take to help protect your information, should you determine it is appropriate to do so.

What Happened? On November 25, 2025, M&Y identified suspicious activity within a server maintained for historical record keeping. We promptly undertook an investigation, with the assistance of cybersecurity specialists, to determine the nature and scope of the activity and promptly terminated access to the server once identified. We also reported the event to federal law enforcement. The investigation subsequently determined that certain files were viewed and downloaded by an unknown actor on or about November 23, 2025. There is no indication that any data subject to unauthorized access was misused following the download. M&Y then conducted a comprehensive analysis of the affected files to determine what information was contained within the files and to whom the information related. Following the review, we undertook additional efforts to validate the information and identify address information to provide notifications. This review was recently completed.

What Information Was Involved? The information present within the impacted files may include information collected as part of our legal representation of you and varies by individual. This data may include your name, Social Security number, financial account information, driver’s license number or identification number, date of birth, health insurance information, and/or medical information.

What We Are Doing. We take this event and the security of information in our care seriously. Upon learning of the event, we moved quickly to investigate and respond, assess the security of our systems, and determine what information was potentially impacted. As part of our ongoing commitment to information security, we reviewed our existing policies and procedures to reduce the likelihood of a similar future event. As an added precaution, we are offering complimentary credit monitoring and identity restoration services for [Extra3] months through Experian. This offer is out of an abundance of caution as we have no indications of identity theft or fraud as a result of the event.

What You Can Do. As a further precaution, we encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. We also encourage you to review the information contained in the enclosed *Steps You Can Take to Help Protect Personal Information*. In addition, you may enroll in the complimentary credit monitoring services available to you. Enrollment instructions are enclosed with this letter.

Enroll in Monitoring Services

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. You should be aware, however, that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps consumers can take to protect personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state attorney general. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. To file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the consumer’s state attorney general. This notice has not been delayed by law enforcement.
