## NOTICE OF DATA BREACH

Dear Sample A. Sample:

Phoenix Business Consulting (“Phoenix”) is a third-party professional services firm that provides information consulting services to certain entities, including the Los Angeles Unified School District (“LAUSD”). We are writing on behalf of LAUSD to let you know about an incident that may have involved your information. This letter provides you with information about the incident, measures we have taken, and steps you may take in response.

**What Happened?** On or about December 4, 2023, Phoenix learned of a misconfiguration that inadvertently made certain information publicly available online. Upon becoming aware of the misconfiguration, we immediately took steps to correct the misconfiguration and launched an investigation into the nature and scope of the incident with the assistance of third-party investigative specialists. The investigation determined that due to the misconfiguration, information related to certain individuals associated with LAUSD may have been publicly available online between November 12, 2023, and December 4, 2023.

**What Information Was Involved?** The investigation determined that your name, address, date of birth, and Social Security number were involved.

**What We Are Doing.** We take this matter and the security of information in our care very seriously. Since discovering this incident, we corrected the misconfiguration and confirmed the security of the information, reviewed our policies and procedures, implemented enhanced security measures, and put additional measures into effect to further protect the security of information in our possession. As an added precaution, we are offering you access to twelve (12) months of complimentary credit monitoring and identity theft protection services through Experian.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You can also enroll to receive the complimentary monitoring services that we are offering to you. Please also review the attached *Additional Steps You Can Take* for more information, including instructions on how to activate your complimentary one-year membership of monitoring services.

### Enroll in Offered Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 12 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
1. Social Security number;
2. Date of birth;
3. Addresses for the prior two to five years;
4. Proof of current address, such as a current utility bill or telephone bill;
5. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
6. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
