Rivers Casino Philadelphia recognizes the importance of protecting the personal information we maintain. We are writing to let you know of a data security incident that may have involved some of your information. This notice explains the incident, measures we have taken, and some additional steps you may consider taking in response.

**What Happened?** We recently responded to and investigated an incident that involved unauthorized access to certain Rivers Casino Philadelphia computer systems. Upon identifying the incident, we immediately secured the involved systems and launched an investigation. Through the investigation, we determined that between October 14, 2024 and October 22, 2024, an unauthorized actor accessed and/or took certain files stored on our computer servers.

**What Information Was Involved?** We reviewed the files that may have been involved and on February 16, 2025, we identified file(s) containing your name and one or more of the following: date of birth, Social Security number, driver's license number and/or financial account number.

**What We Are Doing.** We regret any inconvenience or concern this incident may cause you. To help prevent another incident from occurring, we have implemented additional measures to enhance the security of our network. We have arranged for you to receive a complimentary one-year membership to credit monitoring services. Enrolling in these services will not hurt your credit score.
