RE: Notice of Data Breach

San Dieguito Union High School District (“SDUHSD”) is writing to inform you of an incident that may impact the privacy of some of your personal information. We wanted to provide you with information about the incident, steps we are taking in response, and steps you may take to better protect against the possibility of misuse of your information, should you feel it necessary.

What Happened? SDUHSD became aware of unusual activity related to certain employees’ email accounts. SDUHSD immediately launched an investigation, with the aid of forensic experts, to determine the nature and the scope of the activity. SDUHSD learned of unauthorized access to certain employees’ email accounts. The unauthorized access occurred between July 1, 2019 to July 17, 2019. SDUHSD undertook a lengthy and labor-intensive process to identify the personal information contained in the affected email accounts along with the contact information for the affected individuals. While the investigation was unable to determine the scope of information that was actually accessed within the affected email accounts, SDUHSD is notifying you in an abundance of caution because we have confirmed that your information was present in the affected email accounts.

What Information Was Involved? While SDUHSD was unable to confirm whether your information was actually accessed by the unauthorized individual, our investigation confirmed that the information present in the affected email accounts includes your <<b2b_text_1(ImpactedData)>><<b2b_text_2(ImpactedData)>>.

What We Are Doing. We take this incident and the security of personal information in our care very seriously. We have security measures in place to safeguard the data on our systems and we continue to assess and update security measures and training to our employees to safeguard the privacy and security of information in our care. We are also notifying regulatory authorities, as required by law.

As an added precaution, we are also offering twelve (12) months of complimentary identity monitoring services, fraud consultation, and identity theft restoration services through Kroll. Individuals who wish to receive these services must activate by following the attached instructions.

What You Can Do. We encourage you to activate the identity monitoring services through Kroll. SDUHSD encourages you to remain vigilant against incidents of identity theft and fraud, to review your account statements and to monitor your credit reports for suspicious activity. Please review the enclosed *Steps You Can Take to Help Protect Your Personal Information*, which contains instructions on how to enroll and receive the complimentary identity monitoring services.

Activate Identity Monitoring

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

Monitor Your Accounts

We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity. Under U.S. law you are entitled to one free credit report annually from each of the three major credit reporting bureaus. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

You have the right to place a “security freeze” on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a security freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, military identification, etc.);
7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft.

As an alternative to a security freeze, you have the right to place an initial or extended “fraud alert” on your file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself, by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.
