## NOTICE OF DATA BREACH

Dear <<Name 1>>:

We are writing to notify you of a recent incident involving some of your personal information. This letter provides details about the incident, measures taken to date, and resources available to help protect your information.

### Background

You are a part of a DaVita Inc. program known as VillageHealth. VillageHealth uses a vendor, PracticeMax, to share information for care coordination services.

### What Happened

The PracticeMax network experienced a ransomware attack, during which it was subject to unauthorized access, beginning on April 17, 2021 and ending on May 5, 2021. On May 1, 2021, upon discovery of the incident, PracticeMax immediately initiated a review of the incident, engaged legal counsel and hired a security forensics firm to conduct a thorough investigation.

PracticeMax regained access to its systems on May 6, 2021 and determined one server containing Protected Health Information (PHI) was accessed and certain files may have been removed.

On August 19, 2021, PracticeMax concluded its investigation, conducted by its third-party security forensics firm. The investigation revealed that some of your personal information may have been accessed by an unauthorized individual.

### What Information Was Involved

The information that was potentially accessed includes your first and last name, date of birth, address, phone number, Social Security Number, Member ID number and clinical data pertaining to services that you received through VillageHealth.

### What We Are Doing

PracticeMax is committed to safeguarding your personal information. Upon learning of the incident, PracticeMax moved quickly to confirm the security of their systems. As part of PracticeMax's ongoing commitment to the privacy of information in our care, we reviewed our existing policies and procedures and implemented additional safeguards to further secure the information in our systems. These included rebuilding systems, enhancing firewalls, and installing additional endpoint software, among other things. We also notified regulatory authorities and law enforcement.

As an added precaution, we arranged to have Equifax provide credit monitoring services for twenty-four (24) months at no cost to you. Instructions for enrollment are included in the enclosed "Steps You Can Take To Protect Your Information."

### What You Can Do

We do not have reason to believe your personal information will be used inappropriately because of this incident. However, we ask you to remain vigilant. There are steps you can take to protect yourself.

Review the following for suspicious activity:

- Explanation of Benefit (EOB) letters
- SmartSummary statements
- Medical records
- Account statements
- No cost credit reports

Watch for services you did not receive. If you find unfamiliar activity on the statements you receive, please notify us immediately. Keep a copy of this notice in case of future problems with your medical records.

<sup>1</sup>WebScan searches for your Social Security Number, up to 5 passport numbers, up to 6 bank account numbers, up to 6 credit/debit card numbers, up to 6 email addresses, and up to 10 medical ID numbers. WebScan searches thousands of Internet sites where consumers’ personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. However, the Internet addresses of these suspected Internet trading sites are not published and frequently change, so there is no guarantee that we are able to locate and search every possible Internet site where consumers’ personal information is at risk of being traded.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
