Notice of Data Breach

Dear <<Name 1>>:

Sweetwater Union High School District is writing to let you know of an incident that may have involved some of your information. This letter explains the incident, measures we have taken, and additional steps you may consider taking in response.

What Happened?

We identified a security incident which impacted the availability and functionality of our computer systems on February 12, 2023. We immediately began to investigate, notified law enforcement, and engaged a cybersecurity firm to help address the incident and restore operations. The investigation determined that an unauthorized person gained access to SUHSD's computer network.

What Information Was Involved?

Findings from our investigation indicate that between February 11, 2023 and February 12, 2023, the unauthorized party took some files from our network. We reviewed the files that may have been taken and on May 12, 2023, unfortunately, we determined your personal information was included in the potentially taken files. Our review of those files found that they included your <<variable data>>.

What We Are Doing.

We want to assure you that we take this very seriously. To prevent something like this from happening again, we have implemented additional safeguards and technical security measures, including multi-factor authentication, to further protect our data.

We are also offering one-year of credit monitoring and identity theft protection services through Equifax. This product helps detect possible misuse of your personal information and provides you with identity protection support. For more information on Equifax's identity monitoring including instructions on how to activate your complimentary one-year membership, as well as some additional steps you may consider taking to protect your personal information see the pages that follow this letter.

What You Can Do.

It is always advisable to remain vigilant to the possibility of fraud by reviewing your credit reports and financial account statements. You should immediately report any suspicious activity to the appropriate financial institution or agency. We also encourage you to enroll in the complimentary credit monitoring being provided.

If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. Fraud Alerts and Credit or Security Freezes:

Fraud Alerts: There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

Credit or Security Freezes: You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That is because most creditors need to see your credit report before they approve a new account. If they cannot see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You will need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.
