The purpose of this letter is to notify you of an incident that may impact the privacy of certain information related to you. This letter describes the incident and immediate actions that Trinity Health and Saint Alphonus have taken to address the incident. This letter gives you important details on the impact to you and how you can enroll in the free credit monitoring service we are offering you.

On January 6, 2021 we became aware of unusual activity related to an employee email account. Upon discovery of this activity we moved quickly to identify the source and nature of this activity. Through the investigation we determined that an employee email account may have been subject to unauthorized access on January 4, 2021 to January 6, 2021. As soon as the activity was identified we secured the email account and other measures were taken including re-training employees in an effort to avoid being involved in future cyber-attacks.

Unfortunately, the investigation was unable to specifically determine what, if any, emails may have been viewed during this timeframe. While we have no evidence of any misuse of information in the email account, we undertook a review of the contents of the account to determine what information might have been accessible at the time of this event. Through this review we determined that a combination of the following types of information related to you might have been accessible within the email account at the time of the event: full name, address, telephone, date of birth, email, and medical information such as medical record number, treatment information and billing information. <<b2b_text_1(VariableSentence)>>

We take these matters extremely seriously. Upon discovery of the incident Trinity Health immediately secured the employee's email account to ensure the unauthorized individual could no longer access the account. We have no evidence of any misuse of the information within the email account. We are providing you with access to one year of free identity monitoring services in an abundance of caution and as part of our ongoing commitment to help you protect your identity, insurance benefits, and credit rating.

To help relieve concerns and restore confidence following this incident, we have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

Free Credit Report. It is recommended that you remain vigilant by reviewing account statements and monitoring your credit report for unauthorized activity, especially activity that may indicate fraud and identity theft. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

To order your annual free credit report please visit www.annualcreditreport.com or call toll free at **1-877-322-8228**.

You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available from the U.S. Federal Trade Commission's ("FTC") website at www.consumer.ftc.gov) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281.

For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents: You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Fraud Alerts. There are two types of fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for at least one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and you have the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. You can place a fraud alert on your credit report by contacting any of the three national credit reporting agencies.

Security Freeze. You have the ability to place a security freeze, also known as a credit freeze, on your credit report free of charge.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may use an online process, an automated telephone line, or submit a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that, if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past 5 years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, and display your name, current mailing address, and the date of issue.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or minimize the risks of identity theft.

Reporting of identity theft and obtaining a police report.

For Iowa residents: You are advised to report any suspected identity theft to law enforcement or to the Iowa Attorney General.

For Oregon residents: You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.
