TEAM Software writes to inform you of an event that may have affected some of your information. Although we have received no indication of any actual or attempted identity theft or fraud as a result of this event, this notice provides information about the event, our response, and resources available to you to help protect your information from possible misuse, should you feel it is necessary to do so.

What Happened? On July 26, 2024, TEAM Software detected unusual activity on a limited number of platforms within the TEAM Software application. We promptly launched an investigation, with the assistance of third-party cybersecurity and forensics specialists to determine the nature and scope of the event. The investigation determined that an unauthorized actor gained access to certain TEAM Software systems and that information contained in those systems was potentially accessed or taken by the unauthorized actor between July 25 and July 26, 2024.
