Dear Congressman Langworthy:

As Attorneys General of South Carolina, Oregon, North Carolina, and Mississippi, we are joined by the Attorneys General of the undersigned states in supporting the Child Exploitation and Artificial Intelligence Expert Commission Act of 2024.

In September 2023, a coalition of 54 state and territorial Attorneys General called upon Congress to establish an expert commission to determine how Artificial Intelligence (AI) was being used to exploit children and recommend legislation based upon the commission's findings. We are pleased to see our request was heard and that you have worked diligently to introduce this legislation in an effort to protect America's children.

Al can be an incredible tool in changing our world for the better, but there are loopholes for criminals to exploit. A knife or hammer is a useful tool in the right hands. 




