Seq.; and 2) Enter Order (the "Proposed Order"), and Exhibit A thereto, the Joint Stipulation To: 1) Approve Settlement Terms with California Attorney General Pursuant to California Corporations Code Section 14700 Et. Seq.; and 2) Enter Order (the "Proposed Stipulation", together with the Proposed Order, the "Stipulation and Consent Order"), a copy of which is attached hereto as Exhibit 1, and respectfully state as follows:

 On the record of the hearing held on June 28, 2024, the Court confirmed the Second Amended Joint Plan of Reorganization of Rite Aid Corporation and Its Debtor Affiliates [Docket No. 2511] (the "<u>Plan</u>"), subject to the entry of an order confirming the Plan.

2. Debtor Rite Aid Corporation has pharmacy operations throughout the State of California. The People of the State of California, as represented through the California Attorney General, contend they have the power to review the transfer of voting control or assets of all remaining pharmacies and associated operations in this state under California Corporations Code section 14700 *et. seq.* 

3. Further, it is important that liquidity of Rite Aid Corporation is preserved so that a transfer of ownership of Rite Aid Corporation to new shareholders take place as part of the Debtor Rite Aid Corporation's emergence from Chapter 11 Bankruptcy. The emergence of the Debtor Rite Aid Corporation and its continued operation of the remaining pharmacies and associated services in California post-bankruptcy is important to prevent the growth of pharmacy deserts, and safeguard competition, in California.

4. The parties to the Stipulation and Consent Order desire to expeditiously effectuate the transfer of Rite Aid Corporation, including remaining pharmacies and associated services in

California, and to resolve any issues involving the closure of pharmacies in California and the sale of their scripts to third parties. The parties have reached a settlement of the Attorney General's jurisdiction to review those matters, and take further action, under California Government Code section 12533, with the settlement involving the Attorney General approving the transfer of ownership of remaining pharmacies and associated conditions, as well as approving the closure of other pharmacies and the sale of their scripts, all subject to the settlement terms attached as Exhibit A to the Proposed Order.

5. This Application is submitted pursuant to D.N.J. LBR 9021-1(b) in lieu of a motion in support of the Debtors' request that the Court enter the Proposed Stipulation and Consent Order as presented. The Debtors submit that the Proposed Stipulation is in the best interest of the Debtors and their estates as it will facilitate the transfer of ownership the remaining pharmacies pursuant to the Plan.

6. No previous application for the relief sought herein has been made to this or any other Court.

# Exhibit A

Settlement Terms

Settlement Terms between Rite Aid Corporation and the California Attorney General on Behalf of the People of the State of California Pursuant to California Corporations Code Section 14700 et seq. in Connection with Rite Aid Corporation's New Ownership as Part of its Emergence from Chapter 11 Bankruptcy

In connection with these settlement provisions:

(i) On October 15, 2023, Rite Aid Corporation and certain of its affiliates filed voluntary Chapter 11 bankruptcy cases (the "Chapter 11 Cases") in the United States Bankruptcy Court for the District of New Jersey (the "Bankruptcy Court") (Case No. 23-18993).

(ii) the Attorney General and Rite Aid Corporation acknowledge that they have entered or will enter into a Stipulation in connection with the Chapter 11 Cases and the emergence of the Remaining Assets of Rite Aid Corporation in California.

(iii) pursuant to the Stipulations, these provisions shall become effective upon the occurrence of the Effective Date (as defined in the *Second Amended Joint Chapter 11 Plan of Reorganization of Rite Aid Corporation and Its Debtor Affiliates (As Further Modified)* (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Chapter 11 Plan")) filed with the Bankruptcy Court in the Chapter 11 Cases, conditional on the Bankruptcy Court's confirming or having confirmed Rite Aid Corporation's Chapter 11 Plan to emerge from bankruptcy under new ownership.

(iv) These provisions are also contingent on Rite Aid Corporation and its new owners using all best efforts to secure all required licensing and regulatory approvals in California for the Remaining Assets, including those of the California State Board of Pharmacy.

## I.

These provisions shall be legally binding under state and federal law as if they are injunctive terms on the following entities: Rite Aid Corporation,<sup>1</sup> including new ownership as described within the Chapter 11 Plan, and its affiliates, as to any Remaining Assets in California and, with respect to this Section I and XV of this settlement on the Attorney General.

Unless otherwise specified, as used in this settlement, the following definitions apply:

"Remaining Assets" means the Rite Aid pharmacies in California that will continue to be open for business, and their related operations, that will continue under new ownership after the Effective Date. The Rite Aid pharmacy locations listed in <u>Exhibit A</u> to this settlement are the pharmacies that constitute Remaining Assets.<sup>2</sup>

"Commercially Reasonable" shall mean reasonable, diligent, good-faith efforts to accomplish the provisions of this settlement, as would be exercised by similarly situated operators of pharmacies in similar markets in California, with comparable resources, payor/pharmacy benefit manager mix, and payor/pharmacy benefit manager rates servicing similar community needs.

"Affiliate" shall mean any person or entity directly or indirectly controlling, controlled by or under common control with Rite Aid Corporation.

Except where specifically provided otherwise in these provisions or as otherwise required by law, the Commercially Reasonable standard shall apply to all obligations under these provisions. Unless otherwise specified herein, this settlement, and each of its provisions, shall remain in effect for a period of five (5) years from the Effective Date. These provisions shall be null and void, however, at the discretion of the Attorney General, if the Effective Date does not occur.

Rite Aid Corporation acknowledges and agrees that its pharmacies must comply with applicable state and federal laws, regulations, and rules, including those governing the practice of pharmacy. The requirements of this settlement are in addition to, and not in lieu of, any other requirements of federal, state, or local law, other than California Corporations Code section 14700 et seq. Nothing in this settlement shall be construed as relieving Rite Aid Corporation of its obligation to comply with all federal, state, and local laws, regulations, or rules, nor shall any of the provisions of this settlement be deemed as permission for Rite Aid Corporation to engage in any acts or practices prohibited by such laws, regulations, or rules. Notwithstanding the foregoing, the Attorney General acknowledges and agrees that, in consideration of the promises and agreements contained in this settlement, the provisions of California Corporations Code section 14700 et seq. are hereby waived.

### II.

For five (5) years from the Effective Date, Rite Aid Corporation will use Commercially Reasonable means to continue to operate any and all of the Remaining Assets in California and shall not propose, nor agree to, any Chapter 11 reorganization plan inconsistent with this obligation. Rite Aid Corporation will provide written notice to the Attorney General of any proposed cessation or termination of any pharmacy operations, including any plans to sell scripts, of any of the Remaining Assets in California, or any change in its operations that may, in a materially adverse manner, impair operations of any or all of the Remaining Assets. Rite Aid Corporation shall provide such notice reasonably enough in advance of any such event so as to provide the Attorney General with a reasonable opportunity to seek information

concerning any such event and/or object to any such event as being inconsistent with the requirement to operate the Remaining Assets in a Commercially Reasonable manner. Ninety (90) days' notice of any such event shall be presumed to be reasonable.

## III.

For five (5) years from the Effective Date, Rite Aid Corporation shall be required to provide written notice to the Attorney General ninety (90) days prior to entering into any agreement or transaction to effectuate any of the transactions described below:

a) Sell, transfer, lease, exchange, option, convey, or otherwise dispose of substantially all of the Remaining Assets in California to an independent third party; or

b) Transfer control, responsibility, management, or governance of substantially all of the Remaining Assets in California to an independent third party.

The notice required by this section shall set forth the material terms of the transaction. Any arrangement, written or oral, that would transfer voting control or operational control of any corporation set up by Rite Aid Corporation to operate the Remaining Assets in California shall also be deemed a transfer for purposes of this provision. For the avoidance of doubt, this provision shall supersede and abrogate the notice obligations imposed by California Corporations Code Section 14700 et. seq., requiring only 90 days' prior notice as set forth above.

For the avoidance of doubt, Rite Aid Corporation shall not be required to file or obtain consent from the Attorney General with respect to any transactions contemplated by the Chapter 11 Plan, in connection with the current Rite Aid Corporation Chapter 11 Bankruptcy.

### IV.

For five (5) years from the Effective Date, Rite Aid Corporation shall use Commercially Reasonable efforts to (i) operate the Remaining Assets in California as they are currently being operated and (ii) maintain all required licenses in the operation of the Remaining Assets in California. This provision shall not supersede or abrogate any obligations to maintain licensing and regulatory approvals in California, including those of the California State Board of Pharmacy, should any or all of the Remaining Assets be operated in California for a period longer than five (5) years.

### V.

For five (5) years from the Effective Date, Rite Aid Corporation shall use Commercially Reasonable efforts to provide levels of staffing for any or all of the Remaining Assets in California, at least at legally mandated minimum levels of staffing or legally approved flex models of staffing, to promote the viability of the Remaining Assets in California. This provision shall not supersede or abrogate any obligations to maintain at least legally mandated minimum staffing levels at any or all of the Remaining Assets in California should any or all of the Remaining Assets be operated in California for a period longer than five (5) years.

## VI.

Within five (5) years from the Effective Date, Rite Aid Corporation shall use Commercially Reasonable efforts to maintain provision of the pharmacy services, operations, or locations for pharmacy operations in California as they are currently provided as of the date of this settlement.

### VII.

For five (5) years from the Effective Date, Rite Aid Corporation shall use Commercially Reasonable Efforts to offer employees of any pharmacy that it closes, whether to sell its scripts to another pharmacy or to transfer its scripts to one of its other pharmacies, comparable employment in a Rite Aid pharmacy as close as is reasonably possible to the pharmacy that it is closing, or if there is no reasonably proximate Rite-Aid pharmacy, then instruct the applicable buyer of those assets to offer employment to any terminated employees of the closed Rite-Aid pharmacy. For purposes of this settlement, Rite Aid Corporation also represents that as of the Effective Date, it has no current plans to terminate employees *en masse* in its pharmacies located in California.

For five (5) years from the Effective Date, for any pharmacy that it intends to close, whether to sell its scripts to another pharmacy, or to transfer its scripts to one of its other pharmacies, Rite-Aid shall, no less than 30 days prior to the closure, provide to the Attorney General a list of the name, address, date of hire, employment occupation classification, and, if known, the cellular telephone number and email address of each employee of the pharmacy who was employed at the subject pharmacy for at least six months prior to the closure. The information so provided shall be treated as confidential and exempt from disclosure under public records law. This list shall be confidential and used by Rite Aid Corporation as a preferential hiring list and Rite Aid Corporation shall use Commercially Reasonable efforts to hire from this list, or allow a buyer to hire from this list, for 90 days after the pharmacy in question closes. The Attorney General acknowledges and agrees that compliance with this provision shall not constitute a violation of Cal. Civil Code § 1798.185 et seq.

### VIII.

For five (5) years from the Effective Date, Rite Aid Corporation will use Commercially Reasonable efforts to contract with Medicare Managed Care (e.g., Medicare Advantage and/or Medicare Part D) payors, including pharmacy benefit managers acting as, or behalf of, such payors, Medi-Cal Managed Care payors, including pharmacy benefit managers acting as, or behalf of, such payors, and the State of California insofar as it substitutes itself for any or all Medi-Cal managed care payors in negotiating with Rite Aid for inclusion in Medi-Cal pharmacy networks pursuant to its fee-for-service program, see, e.g., Medi-Cal Rx FAQ.

## IX.

(a) Within thirty (30) calendar days following the Effective Date, and (b) every three (3) months thereafter for a period of one (1) year and one (1) month following the Effective Date, Rite Aid Corporation shall contact patients who received free courier deliver services from the now-closed Rite Aid store formerly located at 1670 Garnet Ave., San Diego, CA 92109 (the "Garnet Store") during the one (1) month period prior to the closure of the Garnet Store (the "Former Patients"), to notify them that they are eligible to receive free delivery services from the Rite Aid location located at 3081-B Clairemont Dr., San Diego, California, or such other Rite Aid location that is close to Garnet Avenue, San Diego, California that is able to fulfill such services, for a period of five (5) years following the Effective Date. Rite Aid Corporation shall use Commercially Reasonable efforts to contact the Former Patients via a telephone call.

## X.

For five (5) years following the Effective Date, Rite Aid Corporation shall use Commercially Reasonable efforts to consider in good faith means by which uninsured indigent individuals may receive financial assistance, either directly such as through drug manufacturers or Rite Aid Corporation, or indirectly via other means (e.g., third party reimbursement or cash discounts). Any financial assistance policies Rite Aid Corporation has, or adopts, for providing drugs to patients in California shall be prominently posted in Rite Aid stores in California along with a plain language summary in a manner consistent with California Code of Regulations, title 16, section 1707.6.

### XI.

Rite Aid Corporation shall prohibit unlawful discrimination in California on the basis of any protected personal characteristic identified in state and federal civil rights laws, including section 51 of the California Civil Code and title 42, section 18116 of the United States Code Categories of protected personal characteristics include:

a) Gender, including sex, gender, gender identity, and gender expression;

b) Intimate relationships, including sexual orientation and marital status;

c) Ethnicity, including race, color, ancestry, national origin, citizenship, primary language, and immigration status;

d) Religion;

e) Age; and

f) Disability, including disability, protected medical condition, and protected genetic information.

### XII.

For five (5) years following the Effective Date, Rite Aid Corporation shall submit an annual report to the Attorney General, no later than six (6) months after the conclusion of each calendar year, describing compliance with each provision set forth herein. The Chair(s) of the Board of Directors of Rite Aid Corporation and the Chief Executive Officer of Rite Aid Corporation shall each certify that the report is true, accurate, and complete to their actual

knowledge, following reasonable inquiry, and provide documentation of the review and approval of the report by the Board of Directors.

### XIII.

At the request of the Attorney General, Rite Aid Corporation shall provide such information as is reasonably requested by the Attorney General and reasonably necessary for the Attorney General to monitor compliance with these provisions. The Attorney General will, at the request of Rite Aid Corporation, keep confidential any information so produced to the extent that such information is a trade secret or is privileged under state or federal law, or if the private interest in maintaining confidentiality clearly outweighs the public interest in disclosure, unless such disclosure is required by law.

## XIV.

Rite Aid Corporation shall reimburse the Attorney General for its reasonable attorney's fees and reasonable costs incurred in connection with any investigative follow-up by the Attorney General.

## XV.

For a period of five (5) years following the Effective Date, Rite Aid shall use Commercially Reasonable efforts to pay its retirement plan contributions pursuant to collective bargaining agreements to which it is a party as of the Effective Date or any subsequent collective bargaining agreements Rite-Aid enters into within that five (5) year period, which provides for it to make retirement plan contributions.

### XVI.

For a period of five (5) years after the Effective Date, Rite Aid shall use Commercially Reasonable efforts to abstain from contesting unemployment for individuals who are laid off as a result of the sale or closure of Rite Aid stores that occurred after the Effective Date where said closed or sold store is located in an urban area that is more than three (3) miles away from a Rite-Aid store offering employment, or is located in an suburban area that is more than seven (7) miles away from another Rite-Aid store offering employment, or is located in a rural area that is more than twenty (20) miles away from another Rite-Aid store offering employment.

### XVII.

The Attorney General reserves the right to enforce each and every provision set forth herein to the fullest extent provided by law under California Corporations Code section 14700 et seq., Business & Professions Code section 321, and Government Code section 12533 and shall be entitled to all of the remedies provided for by California Government Code section 12533. Notwithstanding anything herein to the contrary, the Attorney General acknowledges and

agrees that it shall waive, and shall not pursue any action against Rite Aid Corporation with respect to California Corporations Code section 14700 et seq., and California Business & Professions Code section 321 provided that Rite Aid Corporation is in material compliance with the provisions of this settlement and Stipulation. Any action by the Attorney General to enforce these provisions may be brought in the Bankruptcy Court in which Rite Aid Corporation filed its Chapter 11 Bankruptcy, or in the Superior Court of Los Angeles as if this were an injunction entered in state court, and any applicable appellate court therefrom. Rite Aid Corporation shall not assert as a defense to enforcement that an action for enforcement must be brought, whether under any applicable state law, including for the avoidance of all doubt California Corporations Code section 14700 et. seq. or Business & Professions Code section 321, and Government Code section 12533 or under bankruptcy law, in the Bankruptcy Court in which it brought this Chapter 11 Bankruptcy. Rite Aid Corporation further agrees that consent from that Bankruptcy Court to bring an action in the Superior Court for the County of Los Angeles is not required, and Rite Aid Corporation hereby waives any jurisdictional argument against any action brought by the Attorney General in the Superior Court for the County of Los Angeles to enforce these provisions, including for the avoidance of all doubt that this settlement does not comply with the requirements for bringing an action to enforce and enforcing its terms as if it were an injunction entered in that court or for the avoidance of all doubt under Corporations Code section 14700 et. Seq., Business and Professions Code section 321, and Government Code section 12533. For purposes of compliance with state law requirements on the direct enforceability of settlement agreements in state court, the Parties agree to execute a consent to the settlement agreement, whether by signature to any stipulation and order or otherwise, in accordance with California Code of Civil Procedure section 664.6.
