August 19, 2005, in Nevada County, Penal Code section 487(a), Grand Theft, a felony; May 4, 2010, in El Dorado County, Penal Code section 518, Extortion, a felony; May 4, 2010, in El Dorado County, Penal Code section 518, Extortion, a felony; and May 4, 2010, in El Dorado County, Penal Code section 518, Extortion, a felony.
