RE: Demand under Business and Professions Code Section 17508 for Substantiation of Advertising Claims Made by Center for Covid Control

Dear Center for Covid Control Representatives:

We are writing to you to request information substantiating advertising representations and claims you have made on the internet and at your California locations concerning COVID-19 testing. We also want to ensure your compliance with California laws. <sup>1</sup>

The Attorney General is charged with enforcing the State's consumer protection laws, including the Unfair Competition Law, Business & Professions Code section 17200, et seq (UCL), and the False Advertising Law, Business & Professions Code section 17500, et seq (FAL). The UCL prohibits, among other things, any unlawful, unfair, or fraudulent business act or practice. The "unlawful" practices prohibited by the UCL are any practices forbidden by law, be it civil or criminal, federal, state, or municipal, statutory, regulatory, or court-made. The FAL prohibits false or misleading advertising.

Your website contains numerous representations concerning rapid COVID-19 testing, including specific turnaround times for results. This office is investigating complaints that results were not received within the times advertised, and in some cases were never received. There are also concerns about your collection of protected health information for services that were not rendered.

It is unlawful under the FAL and UCL to advertise that a service will be given in a specified period of time if that statement is untrue or misleading. It is further unlawful under the FAL and UCL to indicate a testing service will be provided, or to indicate that a service is "effective," and then to provide inaccurate or falsified test results. It is further unlawful under the FAL and UCL to indicate a service will be free, and then charge customers for that service. It is further unlawful under the FAL and UCL to indicate certain privacy practices will be followed, and then to not sufficiently implement privacy protections.

Please be advised that it is also unlawful to operate a specimen collection site in California and send the specimens to a clinical testing laboratory for analysis if the clinical laboratory lacks certification under the federal Clinical Laboratory Improvement Amendments (CLIA) program and California licensure or registration from the California Department of Public Health.<sup>2</sup>

Under FAL, the Office of the Attorney General may require any person doing business in California to substantiate any advertising claim, including any claim that (1) purports to be based on factual, objective, or clinical evidence, (2) compares a product's effectiveness or safety to that of other brands or products, (3) or purports to be based on any fact. (Bus. & Prof. Code, § 17508, subd. (b).) This correspondence serves as a formal demand under Business and Professions Code section 17508, subdivision (b), that you provide evidence, within ten (10) calendar days of the date of this letter, of the facts on which the advertising claims listed below are based. Failure to adequately substantiate the claims listed below may result in further action. (Bus. & Prof. Code, § 17508, subd. (c).)

We request that your response include any and all business records, memoranda, or other documents that you believe substantiate the claims identified in this letter during all time periods when such claims have been made. These supporting business records, memoranda, or other documents should include any and all analyses, research, studies, or other evidence. Further, please provide evidence that you were and are in compliance with California's requirements regarding laboratory licensing. You may also provide a narrative response, provided that you produce any and all documents referenced in the narrative response. After we receive and review your response, we may request further clarification or request to arrange a telephonic conference with you to discuss the claims and evidence at issue.
