**FINAL JUDGMENT AND
PERMANENT INJUNCTION ON
CONSENT**

1 WHEREAS, THE PEOPLE OF THE STATE OF CALIFORNIA ("the People"), by and
2 through its attorneys, Xavier Becerra, Attorney General of the State of California, the District
3 Attorneys of Alameda, Monterey, Riverside, San Diego, San Francisco, San Joaquin, Solano,
4 Ventura, and Yolo Counties, and the City Attorney for the City of Los Angeles, and
5 AUTOZONE, INC., AUTOZONE WEST, INC., AUTOZONE WEST, LLC, and AUTOZONE
6 PARTS, INC. (hereinafter collectively referred to as "AutoZone Defendants") appearing through
7 their attorneys, Buchalter, by Peter W. McGaw, have agreed to settle the above captioned matter
8 without further litigation and have entered into a Stipulation for Entry of Final Judgment and
9 Permanent Injunction in this matter ("Stipulation") and thereby have consented to entry of this
10 Final Judgment and Permanent Injunction on Consent ("Final Judgment on Consent") without
11 trial or adjudication of any fact or law herein. The AutoZone Defendants and the People are
12 collectively referred to as "the Parties";

13 AND WHEREAS, the Court finds that the settlement between the Parties is fair and in the
14 public interest;

15 NOW THEREFORE, upon the consent of the Parties, it is hereby ORDERED,
16 ADJUDGED, AND DECREED:

17 1. **JURISDICTION**

18 The Superior Court of California, County of Alameda, has subject matter jurisdiction over
19 the matters alleged in this action and personal jurisdiction over the Parties to this Final Judgment
20 on Consent.

21 2. **SETTLEMENT OF DISPUTED CLAIMS**

22 This Final Judgment on Consent is not an admission or denial by the AutoZone
23 Defendants regarding any issue of law or fact in the above-captioned matter or any violation of
24 any law. The Parties have stipulated and consented to entry of this Final Judgment on Consent
25 pursuant to a compromise and settlement of disputed claims alleged in the Complaint.

26 All Parties have stipulated and consented to the entry of this Final Judgment on Consent
27 prior to the taking of any proof, and without trial or adjudication of any fact or law herein. The

Parties also waive their right to appeal the allegations in the Complaint, except as expressly provided herein.

3. DEFINITIONS

Except where otherwise expressly defined in this Final Judgment on Consent, all terms shall be interpreted consistent with the Hazardous Waste Control Law (Health & Saf. Code, § 25100 et seq.), the Hazardous Materials Release Response Plans and Inventory Law (Health & Saf. Code, § 25500 et seq.), the Customer Records Law (Civ. Code, § 1798.80 et seq.) and the Transportation of Hazardous Materials Law (Veh. Code, § 32000 et seq.), and the regulations promulgated under these laws. The regulations implementing the Hazardous Waste Control Law are found at California Code of Regulations, title 22, section 66260.1 et seq. ("Title 22"). The regulations implementing the Hazardous Materials Release Response Plans and Inventory Law are found at California Code of Regulations, title 19, section 2620 et seq. ("Title 19").

"CALIFORNIA AUTOZONE FACILITIES" means the AutoZone Defendants': 1) retail stores and distribution centers in the State of California that are owned, operated or leased by the AutoZone Defendants as of the date of entry of judgment of this Final Judgment on Consent, which are listed in **Exhibit A-1**; and 2) new retail stores and distribution centers that are owned, operated or leased by the AutoZone Defendants in the State of California after the date of entry of this Final Judgment on Consent.

"COVERED MATTER FACILITIES" means the AutoZone Defendants' retail stores and distribution centers and former retail stores and distribution centers in the State of California that were owned, operated or leased by the AutoZone Defendants as of December 12, 2018, all of which are listed in **Exhibit A-2**, attached and incorporated herein by this reference.

"CUSTOMER RECORDS" means customer and records as defined in Civil Code section 1798.80, subdivisions (b) and (c).

"DTSC" means the California Department of Toxic Substances Control.

"HAZARDOUS WASTE" shall have the same definition as set forth in Health and Safety Code section 25117 and California Code of Regulations, title 22, section 66260.10, and includes "extremely hazardous waste" as defined in Health and Safety Code section 25115.

1 “HAZARDOUS MATERIAL” shall have the same definition as set forth in Health and
2 Safety Code section 25501, subdivision (n).

3 “PERSONAL INFORMATION” means personal information as defined in Civil Code
4 section 1798.80, subdivision (e).

5 “RECORDS” means records as defined in Civil Code section 1798.80, subdivision (b).

6 “TRASH RECEPTACLES” means waste bins, front-loader dumpsters, dumpsters, trash
7 compactors, roll-off boxes, and any other receptacles the contents of which are picked up by
8 commercial or municipal trash haulers for transport to municipal landfills or other disposal
9 facilities.

10 “UNIFIED PROGRAM AGENCY” or “UPA” shall have the same definition as set forth
11 in Health and Safety Code section 25404, subdivision (a)(1)(C).

12 “UNIFORM HAZARDOUS WASTE MANIFEST” means the shipping document that is
13 required by law to accompany shipments of HAZARDOUS WASTE from the point of
14 generation, through transportation, to the final permitted treatment, storage, and disposal facility.

15 “UNIVERSAL WASTE” shall have the same definition as set forth in California Code of
16 Regulations, title 22, sections 66261.9 and 66273.9.

17 “WASTE” shall have the same definition as set forth in Health and Safety Code section
18 25124.

19 **4. INJUNCTIVE RELIEF**

20 Pursuant to the provisions of Health and Safety Code sections 25181, 25515.6, 25515.8,
21 and Business and Professions Code section 17203, and subject to Paragraph 19 below, the
22 AutoZone Defendants are each permanently enjoined and shall comply with the injunctive
23 provisions in Paragraphs 4.1 and 4.2, below. Notwithstanding any other provision in this Final
24 Judgment on Consent, nothing in this Final Judgment on Consent shall relieve the AutoZone
25 Defendants from prospectively complying with all applicable laws and regulations.

26 Failure to comply with this injunction or any of the specific additional injunctive
27 provisions that follow may subject the AutoZone Defendants to sanctions including, but not
28 limited to, contempt and/or additional penalties, in accordance with California law.

1 **4.1 Mandatory Injunctive Provisions**

2 The AutoZone Defendants shall each comply with each of the following provisions:

3 4.1.a. For a period of five (5) years following the entry of this Final Judgment on
4 Consent, the AutoZone Defendants shall conduct independent third-party audits to evaluate
5 compliance with the requirements of this Final Judgment on Consent as follows:

6 (i.) **General Audit Program:** The AutoZone Defendants shall retain the services of an
7 independent third-party auditor (“Auditor”) to be selected by the AutoZone Defendants and
8 subject to reasonable approval by the People. The AutoZone Defendants shall select the
9 proposed Auditor and submit the name and qualifications of the proposed Auditor to the People,
10 in writing and electronically via e-mail, within thirty (30) calendar days of the entry of the Final
11 Judgment on Consent. The AutoZone Defendants’ proposed Auditor will become the Auditor
12 unless the People raise concerns in writing about the proposed Auditor within fourteen (14)
13 calendar days after the AutoZone Defendants submit the proposed Auditor to the People. Any
14 disputes about the selection of the Auditor will be resolved by the Court pursuant to Paragraph
15 13 herein if the Parties are unable to reach agreement. The Auditor shall be engaged by the
16 AutoZone Defendants within ninety (90) calendar days of the date of entry of this Final
17 Judgment on Consent. If, after engagement by the AutoZone Defendants, the Auditor becomes
18 unavailable to perform any services specified herein, the AutoZone Defendants will propose an
19 alternate auditor to the People following the procedure of this paragraph.

20 (ii.) The Auditor will complete three (3) independent audits – phase one within eighteen
21 (18) months, phase two within thirty-six (36) months, and phase three within fifty-four (54)
22 months, after entry of this Final Judgment on Consent. All three audit phases shall include
23 facility-specific field audits of certain CALIFORNIA AUTOZONE FACILITIES as follows:
24 The eighteen (18) month (Phase One) audit shall include facility-specific field audits at one
25 hundred (100) of the CALIFORNIA AUTOZONE FACILITIES; the thirty-six (36) month
26 (Phase Two) audit shall include facility-specific field audits at fifty-eight (58) of the
27 CALIFORNIA AUTOZONE FACILITIES; and the fifty-four (54) month (Phase Three) audit
28 shall include facility-specific field audits at fifty-eight (58) of the CALIFORNIA AUTOZONE

1 FACILITIES. The CALIFORNIA AUTOZONE FACILITIES to be field audited shall be
2 selected by the Auditor, with input by the People and the AutoZone Defendants, using a random
3 process. The People's and the AutoZone Defendants' input may include designating one or
4 more specific stores or distribution centers to be included within the group of facilities selected
5 by the Auditor to be field audited (in place of a like number of randomly selected facilities) for
6 the purpose of assuring audits are performed at a representative sample of stores and/or
7 distribution centers, taking in consideration, customer volume and customer traffic. While the
8 AutoZone Defendants may have input into the designation of a store or distribution center for
9 inclusion in the field audit, the AutoZone Defendants shall not share any portion of any audit
10 schedule with a targeted CALIFORNIA AUTOZONE FACILITY or contact that facility in any
11 manner so as to impede the integrity, impartiality or objectiveness of the audit. The field audits
12 will be conducted without advance notice to the affected CALIFORNIA AUTOZONE
13 FACILITY, except to the minimum extent deemed necessary by the Auditor to ensure the
14 presence of persons required for interviews and access. In addition, the eighteen (18) month
15 (Phase One) audit and the fifty-four (54) month (Phase Three) audit shall include a review of
16 the store-level execution by the AutoZone Defendants, and each of them, of the corporate
17 management program then in place for ensuring compliance with the requirements of this Final
18 Judgment on Consent.

19 (iii.) All three audit phases shall be conducted pursuant to an Audit Protocol that shall
20 be developed by the selected Auditor, in consultation with the AutoZone Defendants, and
21 provided to the People for review, comment, and approval. The People may provide any
22 comment to the Auditor and the AutoZone Defendants within thirty (30) calendar days of
23 receiving the proposed Audit Protocol. The Auditor shall incorporate any comments by the
24 People into a revised Audit Protocol, except if the AutoZone Defendants disagree with any of
25 the comments, they may engage in good-faith discussions for no more than 15 (fifteen) calendar
26 days with the People to resolve the issue and develop a mutually acceptable protocol. The Audit
27 Protocol will specify the required date of submission of written reports of the audits conducted,
28 at the intervals specified below. Any disputes about the content of the Audit Protocol will be

1 resolved by the Court pursuant to Paragraph 13 herein if the Parties are unable to reach
2 agreement.

3 (iv.) The Auditor shall prepare an audit report for each audit phase completed and
4 submit the audit reports to the AutoZone Defendants, with a simultaneous copy to the People, in
5 accordance with the time frames specified in the final Audit Protocol, but in no event later than
6 ninety (90) calendar days after the completion of each specific phase of the field audits. At the
7 request of the AutoZone Defendants, the Auditor may submit to the People and the AutoZone
8 Defendants drafts of audit reports. The three (3) audit reports referenced above shall include,
9 but not be limited to, a complete description and discussion of all environmental audit
10 objectives, scope, and criteria, activities, findings, conclusions, and recommendations, and the
11 reports shall identify and discuss all evidence considered or relied upon to support the audit's
12 findings, conclusions and recommendations. Such reports shall also include, but not be limited
13 to, whether the AutoZone Defendants have implemented sufficient compliance management
14 systems to satisfactorily address and implement the provisions of this Final Judgment on
15 Consent, an evaluation of potential noncompliance with the injunctive provisions of this Final
16 Judgment on Consent at any of the CALIFORNIA AUTOZONE FACILITIES, a description
17 and evaluation of corrective measures, if any, that were taken by the AutoZone Defendants, a
18 chart summarizing all of the material facts indicating incidents of potential noncompliance
19 found during each phase of the field audits, and the Auditor's notes of observations taken
20 during each field audit. In reaching audit conclusions regarding compliance with the injunctive
21 provisions of this Final Judgment on Consent, the Auditor shall consider, evaluate and discuss:
22 (a) the probable reasons for noncompliance with the injunctive provisions of the Final Judgment
23 on Consent that are discovered during any of the three (3) audit phases; and (b) whether there
24 are patterns of noncompliance at any or all of the CALIFORNIA AUTOZONE FACILITIES.

25 (v.) Within thirty (30) calendar days after transmittal to the People of each
26 environmental audit report (or longer if approved by the People based on a request for
27 additional time for good cause by the AutoZone Defendants), the AutoZone Defendants shall
28 provide the People with evidence that they have corrected each incident of noncompliance with

1 the injunctive provisions of this Final Judgment on Consent, or with a written plan endorsed by
2 the AutoZone Defendants. The written plan shall include a description of corrective measures,
3 a schedule for the correction of each such incident of noncompliance, a description of the
4 compliance system shortcomings, if any, discovered during the audits and discussed in the
5 environmental audit reports, and a detailed explanation of why the noncompliance could not be
6 immediately cured. The AutoZone Defendants shall implement the schedule for correction.

7 4.1.b. The AutoZone Defendants shall undertake the following annual assessments for
8 TRASH RECEPTACLES at the CALIFORNIA AUTOZONE FACILITIES:

9 (i.) **TRASH RECEPTACLE Audit Program:** The AutoZone Defendants will
10 commission a program of audits of HAZARDOUS WASTE and UNIVERSAL WASTE
11 management and CUSTOMER RECORDS related to TRASH RECEPTACLES at the
12 CALIFORNIA AUTOZONE FACILITIES using an independent third-party auditor. These
13 audits shall be conducted annually at the CALIFORNIA AUTOZONE FACILITIES throughout
14 California over a five-year period as set forth below.

15 (ii.) **Selection of the TRASH RECEPTACLE Auditor:** Within thirty (30) calendar days
16 of the entry of this Final Judgment on Consent, the AutoZone Defendants shall identify an
17 independent third-party TRASH RECEPTACLE Auditor ("TRASH RECEPTACLE Auditor") to
18 be selected by the AutoZone Defendants and subject to reasonable approval by the People. The
19 AutoZone Defendants' proposed auditor will become the TRASH RECEPTACLE Auditor unless
20 the People raises reasonable concerns in writing about the proposed auditor within fourteen (14)
21 calendar days after the AutoZone Defendants submit to the People, in writing and electronically
22 via e-mail, the name and qualifications of its proposed auditor. Any disputes about the selection
23 of the TRASH RECEPTACLE Auditor will be resolved by the Court pursuant to Paragraph 13
24 herein if the Parties are unable to reach agreement. The TRASH RECEPTACLE Auditor shall be
25 engaged by the AutoZone Defendants within ninety (90) calendar days of the date of entry of this
26 Final Judgment on Consent. If, after engagement by the AutoZone Defendants, the TRASH
27 RECEPTACLE Auditor becomes unavailable to perform any services specified herein, the
28 AutoZone Defendants will propose an alternate TRASH RECEPTACLE auditor following the

1 procedure of this paragraph.

2 (iii.) *Conduct of TRASH RECEPTACLE Audits:* The TRASH RECEPTACLE Auditor
3 will complete annual independent audits of TRASH RECEPTACLES at CALIFORNIA
4 AUTOZONE FACILITIES at forty (40) facilities located in the eight (8) counties with the largest
5 numbers of CALIFORNIA AUTOZONE FACILITIES (Fresno, Kern, Los Angeles, Orange,
6 Riverside, Sacramento, San Bernardino, and San Diego), and at twenty-one (21) CALIFORNIA
7 AUTOZONE Facilities in the remaining California counties selected by the TRASH
8 RECEPTACLE Auditor using a random process, and one (1) California distribution center over
9 five (5) years commencing from the date of entry of this Final Judgment on Consent, and
10 pursuant to a schedule that the TRASH RECEPTACLE Auditor will develop and share with the
11 People and the AutoZone Defendants. While the AutoZone Defendants may verify that TRASH
12 RECEPTACLES which are the subject of the audit will not be empty at the time of the audit, the
13 AutoZone Defendants shall not share any portion of the audit schedule with a targeted
14 CALIFORNIA AUTOZONE FACILITY or contact that facility in any manner so as to impede
15 the integrity, impartiality or objectiveness of the audit. The audits will assess the AutoZone
16 Defendants' compliance with the Injunctive terms in Paragraphs 4.2., regarding the disposal of
17 HAZARDOUS WASTE, HAZARDOUS MATERIALS, and UNIVERSAL WASTE, and the
18 making of PERSONAL INFORMATION unreadable or undecipherable in CUSTOMER
19 RECORDS. The managers or employees of any targeted CALIFORNIA AUTOZONE
20 FACILITY shall not be provided with the schedule for the audits. Solely for the purpose of
21 verifying that the TRASH RECEPTACLES which are the subject of the scheduled audit will not
22 be empty at the time of the scheduled audit, not more than 24 hours prior to the scheduled audit,
23 the AutoZone Defendants may contact the manager of the targeted CALIFORNIA AUTOZONE
24 FACILITY to ensure that the TRASH RECEPTACLES will not be empty. If such contact is
25 made, the AutoZone Defendants shall inform the People in writing by email of the information
26 conveyed to, and received from, the manager. At the People's sole discretion, a representative of
27 the People shall be entitled to observe and photograph the field activities related to any TRASH
28 RECEPTACLE audit performed by the TRASH RECEPTACLE Auditor. The AutoZone

1 Defendants shall be entitled to have one or more representatives available during field work
2 performed by the TRASH RECEPTACLE Auditor.

3 The TRASH RECEPTACLE Audits shall be conducted pursuant to a TRASH
4 RECEPTACLE Audit Protocol that will be developed by the TRASH RECEPTACLE Auditor
5 and provided prior to implementation to the People for review, comment and approval within
6 thirty (30) calendar days of transmittal of the proposed TRASH RECEPTACLE Audit Protocol to
7 the People. The TRASH RECEPTACLE Audit Protocol shall identify the process to be followed
8 in conducting TRASH RECEPTACLE Audits, including but not limited to, safety measures to be
9 followed by the TRASH RECEPTACLE Auditor, protocols to be followed in executing the
10 TRASH RECEPTACLE Audits, methodology to be used in identifying, segregating and lawfully
11 disposing, any suspected HAZARDOUS WASTE, UNIVERSAL WASTE and CUSTOMER
12 RECORDS found, and proposed formats for reporting specific findings with respect to
13 HAZARDOUS WASTE, UNIVERSAL WASTE and CUSTOMER RECORDS found in audited
14 TRASH RECEPTACLES. The TRASH RECEPTACLE Auditor shall incorporate any comments
15 by the People into a revised TRASH RECEPTACLE Audit Protocol, except if the AutoZone
16 Defendants, or any of them, disagree with any of the comments, they may engage in good-faith
17 discussions for no more than 15 (fifteen) calendar days with the People to resolve the issue and
18 develop a mutually acceptable protocol. The TRASH RECEPTACLE Audit Protocol will specify
19 the required date of submission of written reports of the audits conducted, at the intervals
20 specified below. Any disputes about the content of the TRASH RECEPTACLE Audit Protocol
21 will be resolved by the Court pursuant to Paragraph 13 herein if the Parties are unable to reach
22 agreement.

23 Subject to the requirements regarding the representative location of the CALIFORNIA
24 AUTOZONE FACILITIES set forth in Paragraph 4.1.b.(iii)., above, the specific facilities to be
25 subjected to a TRASH RECEPTACLE audit shall be selected using a random process by the
26 TRASH RECEPTACLE Auditor, with input by the People and by the AutoZone Defendants,
27 from the CALIFORNIA AUTOZONE FACILITIES. The People's input may include
28 designating one or more specific stores or distribution centers to be included within the group of

1 CALIFORNIA AUTOZONE FACILITIES selected by the auditor to be field audited (in place of
2 a like number of randomly selected facilities). The AutoZone Defendants input will be solely for
3 the purpose of assuring that audits are performed at a representative sample of stores and/or
4 distribution centers, taking in consideration customer volume and customer traffic. If there is a
5 disagreement between the People and the AutoZone Defendants regarding the designation of
6 specific store or distribution center, the People shall make the final determination regarding
7 which stores or distribution center will be audited. The audits will be conducted without advance
8 notice to the affected CALIFORNIA AUTOZONE FACILITY, except to the minimum extent
9 deemed necessary by the TRASH RECEPTACLE Auditor to ensure the presence of persons
10 required for access to the TRASH RECEPTACLE. The Audit Protocol should, to the extent
11 practicable and without providing notice to any facility or distribution center to be audited, seek
12 to ensure that receptacles being audited are full.

13 (iv.) **Reports:** The TRASH RECEPTACLE Auditor shall prepare a TRASH
14 RECEPTACLE Audit Report for each audited TRASH RECEPTACLE and submit the audit
15 reports to the AutoZone Defendants, with a simultaneous copy to the People, in accordance with
16 the time frames specified in the final TRASH RECEPTACLE Audit Protocol, but in no event
17 later than thirty (30) calendar days after the completion of each TRASH RECEPTACLE audit.
18 The TRASH RECEPTACLE Audit Reports shall include, but not be limited to, the TRASH
19 RECEPTACLE Auditor's notes of observations taken during each such audit, a complete
20 description and discussion of all activities, specific findings with respect to HAZARDOUS
21 WASTE, including UNIVERSAL WASTE, and CUSTOMER RECORDS with PERSONAL
22 INFORMATION present in the TRASH RECEPTACLE, along with the TRASH RECEPTACLE
23 Auditor's conclusions and recommendations for corrective measures, if any, that should be taken
24 by the AutoZone Defendants.

25 Within thirty (30) calendar days (or longer if approved by the People based on a request
26 for additional time for good cause by the AutoZone Defendants) after receipt of each TRASH
27 RECEPTACLE Audit Report, the AutoZone Defendants shall provide the People with evidence
28 that they promptly remedied any alleged environmental compliance violation or deficiency, or

1 any alleged CUSTOMER RECORD violation or deficiency, and properly disposed of any
2 alleged unlawfully placed items found during the audit, and made unreadable or undecipherable
3 through any means any alleged PERSONAL INFORMATION. The AutoZone Defendants
4 shall further provide to the People a written plan endorsed by the AutoZone Defendants to
5 address compliance system shortcomings, if any, identified by any TRASH RECEPTACLE
6 Audit. The AutoZone Defendants shall implement the plan for correction.

7 **4.2 Additional Injunctive Provisions**

8 The AutoZone Defendants, and each of them, are hereby prohibited from violating
9 California law in connection with the ownership or operation of the CALIFORNIA
10 AUTOZONE FACILITIES as follows:

11 4.2.a. Disposing, or causing the disposal of, any HAZARDOUS WASTE at a point not
12 authorized according to the provisions of the Hazardous Waste Control Law as required by
13 Health and Safety Code section 25203, including, without limitation, to any TRASH
14 RECEPTACLE, drain, sink or toilet at any of the CALIFORNIA AUTOZONE FACILITIES,
15 or onto the surface or subsurface of the ground at any unauthorized location in California, or at
16 a landfill or transfer station in California not authorized to receive HAZARDOUS WASTE.

17 4.2.b. Failing to determine, at each CALIFORNIA AUTOZONE FACILITY, whether
18 each item or product returned by a customer to that facility is a WASTE, and if so, whether it is
19 a HAZARDOUS WASTE, as required by California Code of Regulations, title 22, section
20 66262.11 [Hazardous Waste Determination].

21 4.2.c. Failing to determine, at each CALIFORNIA AUTOZONE FACILITY, whether
22 each item of WASTE generated or otherwise located at that facility as a result of a spill, customer
23 return or other customer activity, container breakage or other means, is a HAZARDOUS
24 WASTE, as required by California Code of Regulations, title 22, section 66262.11.

25 4.2.d. Failing to manage at each CALIFORNIA AUTOZONE FACILITY every item of
26 HAZARDOUS WASTE as required by Hazardous Waste Control Law and its implementing
27 regulations in the California Code of Regulations, title 22.
28

1 4.2.e. Transporting, transferring custody of, or causing to be transported in California,
2 any HAZARDOUS WASTE unless the transporter is properly licensed and registered to transport
3 HAZARDOUS WASTE as required by Health and Safety Code Section 25163. This prohibition
4 includes, without limitation, the transportation of any HAZARDOUS WASTE by a person that is
5 not properly licensed and registered to transport HAZARDOUS WASTE on a VEHICLE owned
6 or operated by the AutoZone Defendants, unless otherwise permitted by Health and Safety Code
7 section 25163 or applicable regulations.

8 4.2.f. Transporting, or causing to be transported, in California any HAZARDOUS
9 WASTE to an unauthorized location, in violation of Health and Safety Code section 25203.

10 4.2.g. Failing to lawfully and timely dispose of all accumulated HAZARDOUS WASTE
11 at each CALIFORNIA AUTOZONE FACILITY, as required by California Code of Regulations,
12 title 22, section 66262.34 [Accumulation Time]; failing to timely cause to be prepared and filed
13 with DTSC a UNIFORM HAZARDOUS WASTE MANIFEST for all HAZARDOUS WASTE
14 that is transported, or submitted for transportation, for offsite handling, treatment, storage,
15 disposal, or any combination thereof, from any CALIFORNIA AUTOZONE FACILITY, as
16 required by Health and Safety Code section 25160(b)(3) and California Code of Regulations, title
17 22, section 66262.23 [Use of the Manifest]; or failing to timely notify DTSC by filing an
18 exception report concerning the treatment, storage, or disposal facility's failure to return any
19 executed UNIFORM HAZARDOUS WASTE MANIFEST as required by Health and Safety
20 Code section 25160(b)(3).

21 4.2.h. Failing to contact the transporter of, and/or the owner or operator of the designated
22 facility which was to receive, any HAZARDOUS WASTE from a CALIFORNIA AUTOZONE
23 FACILITY to determine the status of the HAZARDOUS WASTE in the event of non-receipt of a
24 copy of the UNIFORM HAZARDOUS WASTE MANIFEST with the handwritten signature of
25 the owner or operator of the designated receiving facility within thirty-five (35) days of the date
26 the waste was accepted by the initial transporter, as required by California Code of Regulations,
27 title 22, section 66262.42.

1 4.2.i. Treating, storing, disposing of, transporting, or offering for transportation, any
2 HAZARDOUS WASTE at or from a CALIFORNIA AUTOZONE FACILITY without having
3 received and used a proper identification number for the originating facility from the U.S.
4 Environmental Protection Agency or the DTSC, as required by California Code of Regulations,
5 title 22, section 66262.12, subdivision (a) [Identification Numbers for the Generator].

6 4.2.j. Failing to maintain a program for the lawful storage, handling and accumulation of
7 HAZARDOUS WASTE, and for the lawful segregation of HAZARDOUS WASTE in leaking
8 containers, at each CALIFORNIA AUTOZONE FACILITY, as required by Health and Safety
9 Code section 25123.3 and California Code of Regulations, title 22, sections 66262.34
10 [Accumulation Time], 66265.173 [Management of Containers] and 66265.177 [Special
11 Requirements for Incompatible Wastes].

12 4.2.k. Failing to maintain at each CALIFORNIA AUTOZONE FACILITY properly
13 designated and designed HAZARDOUS WASTE storage areas, which include the segregation of
14 HAZARDOUS WASTES as required by California Code of Regulations, title 22, section
15 66262.34.

16 4.2.l. Failing to conduct inspections of HAZARDOUS WASTE storage areas, at each
17 CALIFORNIA AUTOZONE FACILITY, as required by California Code of Regulations, title 22,
18 section 66265.174 [Inspections (weekly)].

19 4.2.m. Failing to comply with employee-training obligations required by California Code
20 of Regulations, title 22, section 66265.16 [Personnel Training] pertaining to the management of
21 HAZARDOUS WASTE.

22 4.2.n. Failing to immediately report any release or threatened release of a reportable
23 quantity of any HAZARDOUS MATERIAL at or from any CALIFORNIA AUTOZONE
24 FACILITY into the environment, as required by Health and Safety Code section 25510.

25 4.2.o. Failing to, for each CALIFORNIA AUTOZONE FACILITY, continuously
26 implement, maintain, and submit to the responsible UNIFIED PROGRAM AGENCY, a complete
27 hazardous material business plan, as required by Health and Safety Code sections 25507, 25508,
28 25508.2 and California Code of Regulations, title 19, section 2650 [Minimum Standards for

1 Business Plans]. Each hazardous material business plan shall include procedures for emergency
2 response to a release or threatened release of a HAZARDOUS MATERIAL, as required by
3 Health and Safety Code sections 25505 and 25507. Each such plan shall also include an
4 employee-training program that meets the requirements of Health and Safety Code section 25505,
5 subdivision (a)(4), and California Code of Regulations, title 19, section 2659 [Training]. Each
6 hazardous material business plan shall annually be reviewed, certified, and electronically
7 submitted to the statewide information management system (CERS) in accordance with the
8 requirements of Health and Safety Code sections 25508 and 25508.2.

9 4.2.p. Failing to properly manage, mark, and store HAZARDOUS WASTE non-empty
10 aerosol cans at each CALIFORNIA AUTOZONE FACILITY in compliance with the standards
11 for management of non-empty aerosol cans set forth in Health and Safety Code section 25201.16.

12 4.2. q. Failing to properly manage, mark, and store UNIVERSAL WASTE at each
13 CALIFORNIA AUTOZONE FACILITY in compliance with the standards for UNIVERSAL
14 WASTE management set forth in California Code of Regulations, title 22, sections 66273.33
15 [Universal Waste Management Requirements for Batteries, Lamps, and Mercury-Containing
16 Equipment] through 66273.36. [Personnel Training]. In the alternative, the AutoZone Defendants
17 shall manage any UNIVERSAL WASTE as HAZARDOUS WASTE pursuant to the
18 requirements of the Hazardous Waste Control Law and its implementing regulations in the
19 California Code of Regulations, title 22, including, but not limited to, California Code of
20 Regulations, title 22, section 66262.34.

21 4.2.r. Failing to keep a record of each shipment of UNIVERSAL WASTE sent from
22 each CALIFORNIA AUTOZONE FACILITY, as required by California Code of Regulations,
23 title 22, section 66273.39.

24 4.2.s. Failing to comply with the requirements for the transportation of HAZARDOUS
25 MATERIAL in California, as required under Vehicle Code section 32001, subdivisions (b) - (c).

26 4.2.t. Failing to establish and follow procedures at each of the CALIFORNIA
27 AUTOZONE FACILITIES for the management of all containers previously used to contain
28 used oil, and containers previously used to contain other fluids that are compatible with used oil,

1 as empty containers or to manage such containers in accordance with all applicable laws and
2 regulations.

3 4.2.u. Failing to properly manage, mark, and store used oil and used oil filters at each
4 CALIFORNIA AUTOZONE FACILITY in compliance with the standards for management of
5 used oil and used oil filters set forth in California Health and Safety Code Article 13
6 [Management of Used Oil]

7 4.2.v. Failing to secure all TRASH RECEPTACLES of which the AutoZone
8 Defendants have exclusive use and control at each of the CALIFORNIA AUTOZONE
9 FACILITIES, and that are capable of being locked, with a locked lid or other exclusion device
10 so as to discourage the unauthorized addition of any WASTE regulated under the Hazardous
11 Waste Control Law and Title 22; except that the AutoZone Defendants are not required to
12 secure with locks or other exclusion devices such receptacles where the AutoZone Defendants
13 do not have exclusive use or control of such receptacles, where local trash haulers will not pick
14 up from locked receptacles, or where circumstances or conditions make locking TRASH
15 RECEPTACLES not reasonably feasible.

16 4.2.w. Failing to comply with requirements to dispose, or arrange for the disposal, of
17 CUSTOMER RECORDS containing PERSONAL INFORMATION within the custody or
18 control of the AutoZone Defendants, or any of them, when CUSTOMER RECORDS are no
19 longer to be retained by the AutoZone Defendants, by: i) shredding, ii) erasing, or iii) otherwise
20 modifying the PERSONAL INFORMATION in those records to make PERSONAL
21 INFORMATION unreadable or undecipherable through any means, as required by Civil Code
22 section 1798.81.

23 **5. CIVIL PENALTIES, SUPPLEMENTAL ENVIRONMENTAL PROJECTS,**
24 **COSTS, AND HAZARDOUS WASTE MINIMIZATION**

25 **5.1 Total Payment Amount to, or at the Direction of, the People**

26 In settlement of this matter, the AutoZone Defendants shall be jointly and severally liable
27 for obligations of ELEVEN MILLION DOLLARS (\$11,000,000) to, or at the direction of, the
28 People as set forth in Paragraphs 5.2 through 5.6 below.

1 **5.2 Delivery of Payment**

2 The AutoZone Defendants shall deliver, within twenty-one (21) business days after entry
3 of this Final Judgment on Consent, all required payments in paragraphs 5.4 through 5.6 to the
4 District Attorney's Office for the County of Alameda, attention: Kenneth A. Mifsud, Assistant
5 District Attorney, for distribution pursuant to the terms of this Final Judgment on Consent.

6 **5.3 Failure to Make Payment**

7 Failure to make any payment as required herein will subject the AutoZone Defendants to a
8 late penalty fee of TWENTY-FIVE THOUSAND DOLLARS (\$25,000) per day for each day the
9 payment is late.

10 **5.4 Civil Penalties**

11 The AutoZone Defendants shall be jointly and severally liable to pay EIGHT MILLION,
12 NINE HUNDRED THOUSAND DOLLARS (\$8,900,000) as civil penalties pursuant to Health
13 and Safety Code Sections 25189 and 25515, Business and Professions Code Section 17206, and
14 Government Code Section 26506, less the credit against penalties of ONE MILLION DOLLARS
15 (\$1,000,000) set forth in paragraph 5.7, below. Payments shall be made to the prosecuting
16 agencies/regulatory agencies identified in, and in accordance with the terms of, **Exhibits B-1 and**
17 **B-2**, attached.

18 **5.5 Supplemental Environmental Projects**

19 The AutoZone Defendants shall be jointly and severally liable to pay, in lieu of additional
20 civil penalties, ONE MILLION, THREE HUNDRED AND FIFTY THOUSAND DOLLARS
21 (\$1,350,000) for supplemental environmental projects identified in, and in accordance with the
22 terms of, **Exhibit C**, attached.

23 **5.6 Reimbursement of Costs of Investigation and Enforcement**

24 The AutoZone Defendants shall pay SEVEN HUNDRED AND FIFTY THOUSAND DOLLARS
25 (\$750,000) for reimbursement of attorneys' fees, costs of investigation, and other costs of
26 enforcement, to the entities identified in, and in accordance with the terms of, **Exhibits D-1 and**
27 **D-2**, attached.

1 **5.7 Hazardous Waste Minimization and Enhanced Compliance**

2 The AutoZone Defendants shall be entitled to a credit against civil penalties in the amount
3 of ONE MILLION DOLLARS (\$ 1,000,000) if, within the period from August 14, 2014 to five
4 years after the entry of the Final Judgment on Consent, the AutoZone Defendants demonstrate
5 that they have spent at least TWO MILLION DOLLARS (\$2,000,000) on measures to enhance
6 performance of HAZARDOUS WASTE management in California, as identified in, and in
7 accordance with the terms of, **Exhibit E**, attached. The AutoZone Defendants shall identify and
8 certify to the People under penalty of perjury in accordance with the terms of **Exhibit E** the
9 amount of money spent and the activities performed pursuant to this Paragraph 5.7 .

10 **6. ENFORCEMENT OF FINAL JUDGMENT ON CONSENT**

11 The People may move this Court for relief for any violation of any provision of this Final
12 Judgment on Consent including, but not limited to, contempt, additional injunctive provisions, or
13 additional penalties consistent with the provisions of this Final Judgment on Consent and
14 applicable law. Except as expressly stated in this Final Judgment on Consent, nothing herein
15 shall limit any rights of the People to seek any other relief or remedies provided by law, or the
16 rights of the AutoZone Defendants to defend against any request of the People for such other
17 relief or remedies.

18 **7. MATTERS COVERED BY THIS FINAL JUDGMENT ON CONSENT**

19 7.1 This Final Judgment on Consent is a final and binding resolution and settlement of
20 all claims, violations and/or causes of action expressly alleged by the People in the Complaint and
21 all claims, violations and/or causes of action arising out of the same facts and circumstances
22 alleged in the Complaint that could have been alleged against the AutoZone Defendants. The
23 matters described in the previous sentence are "Covered Matters." Any claim, violation, or cause
24 of action that is not a Covered Matter is a "Reserved Claim." Reserved Claims include, without
25 limitation, any unknown violation, any violation that occurs after the filing of this Final Judgment
26 on Consent, and any claim, violation, or cause of action against the AutoZone Defendants'
27 independent contractors or subcontractors. The People reserve the right to pursue any Reserved
28

1 Claim and the AutoZone Defendants, and each of them, reserve the right to defend against any
2 Reserved Claim.

3 7.2 Any claims or causes of action against the AutoZone Defendants for performance
4 of cleanup, corrective action, or response action for any actual past or future releases, spills, or
5 disposals of HAZARDOUS WASTE or hazardous substances, including, but not limited to, those
6 that were caused or contributed to by the AutoZone Defendants at or from any CALIFORNIA
7 AUTOZONE FACILITY or any COVERED MATTER FACILITY, are not Covered Matters.

8 7.3 In any subsequent action that may be brought by the People based on any
9 Reserved Claim, the AutoZone Defendants agree that they will not assert that failing to pursue
10 any Reserved Claim as part of this action constitutes claim-splitting. The Parties acknowledge
11 that any tolling agreement(s) executed by or on behalf of the Parties during the course of
12 investigation by the People or during settlement negotiations between the Parties does not apply
13 to Reserved Claims or to any other claim or alleged violation not resolved by this Final Judgment
14 on Consent.

15 7.4 The provisions of paragraph 7.1 are effective on the date of entry of this Final
16 Judgment on Consent. The continuing effect of paragraph 7.1 is expressly conditioned on the
17 AutoZone Defendants' full payment of the amounts due under this Final Judgment on Consent,
18 including late payment penalties, if any, and the AutoZone Defendants' compliance with the
19 Enhanced Compliance requirements set forth in Paragraph 5.7.

20 7.5 Paragraph 7.1 does not limit the ability of the People to enforce the terms of this
21 Final Judgment on Consent.

22 7.6 The AutoZone Defendants, and each of them, covenant not to pursue any civil or
23 administrative claims against the People or against any agency of the State of California or any
24 county or city in the State of California, or any UPA (Agencies), or against any of their officers,
25 employees, representatives, agents or attorneys, arising out of or related to any Covered Matter;
26 provided, however, that if any Agencies initiate claims against the AutoZone Defendants, or any
27 of them, the AutoZone Defendants, and each of them, reserve any and all rights, claims, demands
28 and defenses against such Agencies.

7.7 Any event that is beyond the control of the AutoZone Defendants that prevents timely or full performance of any obligation under Paragraph 4 of this Final Judgment on Consent and that could not have been prevented by the exercise of prudence, diligence and care, is a “*force majeure*” event, which shall excuse timely or full performance to the extent caused by such *force majeure* event. The requirement that the AutoZone Defendants exercise prudence, diligence and care to fulfill the obligation includes the requirement that the AutoZone Defendants use prudence, diligence and care to anticipate any potential *force majeure* event and use prudence, diligence and care to address the effects of any potential force majeure event: (1) as it is occurring, and (2) following the *force majeure* event, such that the delay is minimized to the extent reasonably feasible. “*Force majeure*” events do not include acts or omissions of the AutoZone Defendants or their employees, or financial inability to fund or complete an obligation.

8. NOTICE

14 Any Party may change its notice name and address by informing the other Party in
15 writing, but no change is effective until it is received. All notices and other communications
16 required or permitted under this Final Judgment on Consent that are properly addressed as
17 provided in this paragraph are effective upon delivery if delivered personally or by overnight
18 mail, or are effective five (5) days following deposit in the United States mail, postage prepaid, if
19 delivered by mail, or the day that electronic mail is sent if sent before 5 p.m. to the electronic mail
20 addresses of the designated recipients for notice concurrent with sending the notice by overnight
21 mail.

22 **9. EFFECT OF FINAL JUDGMENT ON CONSENT**

23 Except as expressly provided in this Final Judgment on Consent, nothing in this Final
24 Judgment on Consent is intended, nor shall it be construed, to preclude the People or any state,
25 county, city, or local agency, department, board or entity, or any UPA from exercising its
26 authority under any law, statute or regulation. The AutoZone Defendants retain all of their
27 defenses to the exercise of the aforementioned authority.

28 **10. NO WAIVER OF RIGHT TO ENFORCE**

 The failure of the People to enforce any provision of this Final Judgment on Consent shall
neither be deemed a waiver of such provision nor in any way affect the validity of this Final
Judgment on Consent. The failure of the People to enforce any such provision shall not preclude
the People from later enforcing the same or any other provision of this Final Judgment on

1 Consent, subject to Paragraph 19, below. Except as expressly provided in this Final Judgment on
2 Consent, the AutoZone Defendants, and each of them, retain all defenses allowed by law to any
3 such later enforcement. No oral advice, guidance, suggestions or comments by employees or
4 officials of any Party regarding matters covered in this Final Judgment on Consent shall be
5 construed to relieve any other Party of its obligations under this Final Judgment on Consent.

6 **11. FUTURE REGULATORY CHANGES**

7 Nothing in this Final Judgment on Consent shall excuse the AutoZone Defendants from
8 meeting any more-stringent requirement that may be imposed by applicable law or by any change
9 in the applicable law. To the extent any future statutory or regulatory change makes the
10 AutoZone Defendants' obligations less stringent than those provided for in this Final Judgment
11 on Consent, the AutoZone Defendants may apply to this Court, on noticed motion, subject to the
12 meet and confer provisions of Paragraph 13, for modification of those obligations contained
13 herein; however, any change in law or regulation shall not reduce or diminish the AutoZone
14 Defendants' obligations to comply with Sections 4.1.a. and 4.1.b., above.

15 **12. APPLICATION OF FINAL JUDGMENT ON CONSENT**

16 This Final Judgment on Consent shall apply to and be binding upon the People and upon
17 the AutoZone Defendants, including their successors and assigns.

18 **13. CONTINUING JURISDICTION**

19 The Court shall retain continuing jurisdiction to enforce the terms of this Final Judgment
20 on Consent and to address any other matters arising out of or regarding this Final Judgment on
21 Consent. The Parties shall meet-and-confer at least ten (10) business days prior to the filing of
22 any application or motion relating to enforcement of this Final Judgment on Consent, and shall
23 negotiate in good faith in an effort to resolve any dispute without judicial intervention; provided,
24 however, that the ten (10) day period referenced above shall be shortened to five (5) business
25 days regarding any alleged violation of Paragraph 4.2.a. of this Final Judgment on Consent. If the
26 Parties are unable to resolve their dispute after meet-and-confer discussions, any Party may move
27 this Court seeking a resolution of that dispute by the Court. The meet-and-confer procedure shall
28

1 not apply to any emergency relief that the People may seek, in its sole discretion, related to the
2 enforcement of the Final Judgment on Consent.

3 **14. ABILITY TO INSPECT AND COPY RECORDS AND DOCUMENTS**

4 On reasonable notice, the AutoZone Defendants shall permit any duly authorized
5 representative of the People to inspect and copy records and documents reasonably relevant to
6 determine compliance with the terms of this Final Judgment on Consent. Nothing in this
7 paragraph is intended to require access to or production of any documents that are protected from
8 production or disclosure by the attorney-client privilege, attorney work product doctrine, any
9 other applicable privilege, defense, exemption, or immunity afforded to the AutoZone Defendants
10 under applicable law, nor does it waive any of the objections or defenses to which the AutoZone
11 Defendants would be entitled in responding to requests for documents made by subpoena or other
12 formal legal process or discovery. This obligation shall not require the AutoZone Defendants to
13 alter their respective normal document-retention policies (including but not limited to policies
14 regarding backup measures for electronic documents); provided, however, that the AutoZone
15 Defendants' respective policies must comply with the Hazardous Waste Control Law and the
16 Hazardous Materials Release Response Plans and Inventory Law and their implementing
17 regulations, the Customer Records Law, Transportation of Hazardous Materials Law, and any
18 other applicable law addressed in this action. Nothing in this paragraph is intended to limit the
19 authority of any governmental agency to inspect the AutoZone Defendants' facilities or their
20 records and documents under applicable law.

21 **15. PAYMENT OF LITIGATION EXPENSES AND FEES**

22 The AutoZone Defendants shall pay their own attorney fees, expert witness fees and costs,
23 and any other costs of litigation or investigation.

24 **16. INTEGRATION**

25 This Final Judgment on Consent embodies the entire agreement between the Parties and
26 may not be amended or supplemented except as provided for herein. No oral representations have
27 been made or relied upon other than as expressly set forth herein.
28

1 **17. MODIFICATION OF FINAL JUDGMENT**

2 This Final Judgment on Consent may be modified only on noticed motion by one of the
3 Parties with approval of the court, or upon written consent by all of the Parties and the approval
4 of the court.

5 **18. STATUS REPORTS**

6 18.1. In accordance with the schedule below, the AutoZone Defendants shall provide to
7 the People's representatives listed in Paragraph 8, above, status reports, which will summarize the
8 actions that the AutoZone Defendants have taken at the corporate level related to the
9 CALIFORNIA AUTOZONE FACILITIES to comply with the AutoZone Defendants' obligations
10 during the specified periods under Paragraphs 4.1, 4.2, and 5.7, of this Final Judgment on
11 Consent. Each status report shall be signed by a responsible official of each of the AutoZone
12 Defendants with statewide oversight responsibility for the matters contained therein under penalty
13 of perjury that, to the best of his or her actual knowledge based on information and belief and
14 after reasonable investigation, the information contained therein is true and correct. Each status
15 report shall also: include copies of any notices of violation that the AutoZone Defendants, or any
16 of them, received from an UPA or other regulatory agency in the State of California pertaining to
17 environmental matters covered by Paragraph 4, above, and related to this Final Judgment on
18 Consent; describe any measures taken as a result or other response provided by the AutoZone
19 Defendants to the agency issuing the notice, which may be accomplished by attaching any "return
20 to compliance" documentation or other correspondence; identify the facilities that have TRASH
21 RECEPTACLES that cannot be locked; and state the amount of any administrative fines or
22 penalties the AutoZone Defendants paid to any California governmental agency for alleged
23 noncompliance with any statute or regulation referenced by Paragraphs 4.1 and 4.2, above, arising
24 from business operations in California.

1 18.2. Status reports shall be submitted as follows:

2 The first status report shall be submitted fifteen (15) months following entry of this Final
3 Judgment on Consent and shall cover the first twelve (12) months following entry of this Final
4 Judgment on Consent.

5 Status reports shall thereafter be submitted every twelve (12) months and shall cover the
6 twelve-month period following the end of the period covered by the previous status report.

7 The obligation to submit status report shall terminate when the injunctive provisions of
8 this Final Judgment on Consent terminate.

9 Following the submittal of any status report, the AutoZone Defendants shall, at the
10 People's request, meet to discuss with the People the status of the AutoZone Defendants'
11 compliance with Paragraphs 4.1 and 4.2 of this Final Judgment. Any such meeting shall occur in
12 person at a mutually agreed-upon time and location in California or, with the mutual assent of the
13 Parties, by telephone. Nothing in this paragraph shall or is intended to prevent the Parties from
14 agreeing at or before such a meeting that information provided at or in connection with these
15 meetings by any Party and any responses or comments by the People are made subject to the
16 settlement communication privilege in California Evidence Code section 1152, or other
17 applicable privilege. The People shall not be obligated to disclose any information at these
18 meetings. Nothing in this paragraph precludes any Party from using any lawful means to obtain
19 any factual or documentary information referenced or provided during these discussions.

20 **19. TERMINATION OF INJUNCTIVE PROVISIONS**

21 19.1. At any time after this Final Judgment on Consent has been in effect for five (5)
22 years, and the AutoZone Defendants have paid and expended any and all amounts due under this
23 Final Judgment on Consent, and have maintained substantial compliance with the injunctive
24 terms of Paragraphs 4.1. a. and b., and 4.2. a. through w., the AutoZone Defendants may file a
25 motion requesting a Court order that the injunctive provisions of Paragraphs 4.1. a. and b. and
26 4.2. a. through w., shall have no prospective force or effect based on the AutoZone Defendants'
27 showing of substantial compliance with the injunctive terms of this Final Judgment on Consent.
28 The AutoZone Defendants shall notify the People of their intent to file the motion at least 60

1 calendar days prior to filing the motion. After the AutoZone Defendants have served on the
2 People written notice of their intent to file a motion to terminate the injunctive provisions of this
3 Final Judgment on Consent, the Parties agree that they will meet and confer within 15 calendar
4 days of the People's receipt of such written notice to discuss the proposed motion and the
5 AutoZone Defendants' compliance with the terms of this Final Judgment on Consent, and to
6 determine if a stipulation for termination can be reached.

7
8 19.2. In the event that the AutoZone Defendants file a motion to terminate the injunctive
9 provisions of the Final Judgment on Consent, the motion shall be served on the People no later
10 than 90 calendar days prior to the hearing date. None of the injunctive provisions of this Final
11 Judgment on Consent will terminate pending the Court's final ruling on the AutoZone
12 Defendants' motion. The People may file an opposition to such motion within 45 days of receipt
13 of the AutoZone Defendants' noticed motion. If there is an opposition, the AutoZone Defendants
14 may file their reply within 21 days of service of any opposition by the People. In the event that
15 the People do not file an opposition to the motion, that non-opposition shall not constitute a
16 waiver or estoppel of the People's authority to otherwise enforce any violation of law or of the
17 injunction, and shall have no evidentiary effect. The Parties agree that the Court may grant the
18 AutoZone Defendants' motion upon determining that the AutoZone Defendants have
19 demonstrated that they have paid any and all amounts due under this Final Judgment on Consent
20 and have maintained substantial compliance with their obligations set forth in this Final Judgment
21 on Consent. If the Court does not grant the AutoZone Defendants' motion or does not grant a
22 termination of all injunctive requirements of Paragraphs 4.1. a. and b., and 4.2. a. through w., the
23 AutoZone Defendants may file a subsequent motion asking for termination of the unterminated
24 injunctive requirements, consistent with the terms of this paragraph, provided that such motion is
25 filed no sooner than one year after the Court issues its order denying the AutoZone Defendants'
26 prior motion.

27 19.3. In the event the injunction set forth herein is terminated upon motion of the
28 AutoZone Defendants, the termination of the injunctive provisions of this Final Judgment on

1 Consent shall have no effect on the AutoZone Defendants' obligation to comply with all
2 applicable requirements imposed by statute, regulation, ordinance, or law.

3 **IT IS SO ORDERED, ADJUDGED AND DECREED THAT THE FINAL**
4 **JUDGMENT AND PERMANENT INJUNCTION ON CONSENT BE ENTERED AS**
5 **PROVIDED HEREIN.**

Exhibit C – Supplemental Environmental Projects

- 1. Environmental Protection Prosecution Fund.** AUTOZONE INC. shall provide the amount of Two Hundred Thousand Dollars (\$200,000.00) to be used by the Craig Thompson Environmental Protection Prosecution Fund (“CTEPP Fund”) for purposes consistent with the mission of the CTEPP Fund.
- 2. CUPA Forum Environmental Protection Trust Fund.**
 - a. AUTOZONE INC. shall provide the amount of Two Hundred Thousand Dollars (\$200,000.00) to the CUPA Forum Environmental Protection Trust Fund, which is administered and to be used by the California Certified Unified Program Agency (CUPA) Forum, for purposes consistent with the mission of the Trust for the CUPA Forum.
 - b. AUTOZONE INC. shall provide the amount of Five Hundred Thousand Dollars (\$500,000.00) to fund scholarships for attendance and participation at the annual CUPA Conference. Each of these scholarships shall cover conference registration, transportation, meals, and hotel at the training conference rate. Travel and per diem expenses will be reimbursed in accordance with the reimbursement policies of the “California CUPA Forum Board Training Conference Expense Reimbursement Policies”, and any subsequent modifications thereto.
- 3. California Advanced Environmental Criminal Training Program (Cal-AECTP) with CHMIA.** AUTOZONE INC. shall provide the amount of Eighty Thousand Dollars (\$80,000.00) to be used by CHMIA to fund full scholarships for attendance and participation in their Advanced Environmental Criminal Training Program. Each of these scholarships shall cover conference registration, travel, food, lodging, and incidentals.

4. California Specialized Training Institute – Environmental Crimes Course in conjunction with the California Hazardous Material Investigators Association (CHMIA).

AUTOZONE INC. shall provide Forty-five Thousand Dollars (\$45,000.00) to fund basic investigator courses scholarships. Each of these scholarships shall cover conference registration, travel, food, lodging, and incidentals.

5. California District Attorneys Association Circuit Prosecutor Project.* AUTOZONE INC. shall provide the amount of Forty-five Thousand Dollars (\$45,000.00) to be used by the California District Attorneys Association Circuit Prosecutor Project for purposes consistent with the objectives of the Circuit Prosecutor Project.

6. California District Attorneys Association Environmental Project.* AUTOZONE INC. shall provide the amount of One Hundred Thousand Dollars (\$100,000.00) payable to the California District Attorneys Association – Environmental Project (“Environmental Project”) to be used by the Environmental Project for the purpose of providing training consistent with the objectives of the Environmental Project.

7. Department of Toxic Substances Control Training Fund. AUTOZONE INC. shall provide the amount of Forty Thousand Dollars (\$40,000.00) for Department of Toxic Substances Control staff to attend the California Hazardous Materials Investigators Association Annual Conference, Cal CUPA Forum Annual Training Conference, The Continuing Challenge Conference, McCoy’s RCRA Seminar, California Specialized Training Institute Haz Mat Technician and Specialist Training Courses, and the Western States Project Trainings and Conference. This money can include registration, travel and per diem.

8. Western States Project.* AUTOZONE INC. shall provide the amount of Forty Thousand Dollars (\$40,000.00) to be used by the Western States Project for an environmental

enforcement newsletter and the development and maintenance of a webpage with information about the Regional Environmental Enforcement Associations.^o

9. **Product Stewardship Institute.** * AUTOZONE INC. shall provide One Hundred Thousand Dollars (\$100,000.00) to be used by the Product Stewardship Institute for educational purposes in disadvantaged communities in an effort to mitigate environmental and public health impacts of mercury caused by improper disposal of fluorescent lamps. Product Stewardship Institute will focus primarily on property management companies, facilities managers, construction contractors, and tenants of commercial buildings, including schools and apartment complexes in these communities, who are often overlooked in public health educational efforts.

* If the payment provided by AUTOZONE INC., is accepted by a designated entity, the designated entity shall provide, until the exhaustion of the funds, annual letter reports describing the specific use of the funds. The annual letter reports shall be submitted to the Plaintiff's representatives identified in this Stipulation for Entry of Final Judgment and Permanent Injunction.

Exhibit E -The AutoZone Defendants' Enhanced Compliance Measures

Pursuant to Paragraph 5.7 of the Final Judgment on Consent, the AutoZone Defendants shall be entitled to a credit against civil penalties in the amount of ONE MILLION DOLLARS (\$1,000,000) for undertaking enhanced environmental compliance measures beyond those required by law, statute, regulation or ordinance. In order to receive this credit, the AutoZone Defendants shall spend TWO MILLION DOLLARS (\$2,000,000) for the enhanced environmental compliance measures specified below, during a period starting on August 1, 2014 to five years from the entry of the Final Judgment on Consent. The descriptions of the enhanced environmental compliance measures are based on the representations of the AutoZone Defendants.

ENHANCED ENVIRONMENTAL COMPLIANCE MEASURES:

Dumpster Lid Lock Program: AutoZone has arranged for the installation and maintenance of dumpster locks and metal dumpster lids at its California facilities, where reasonably feasible, to reduce the incidence of improper disposal of HAZARDOUS WASTE and UNIVERSAL WASTE by others in AutoZone-controlled dumpsters.

Dedicated California Environmental Specialist: On December, 2015, the AutoZone Defendants represent that they have hired and have retained a qualified individual with the title of California Environmental Specialist, who is located in California and whose responsibilities are dedicated to overseeing the management of HAZARDOUS WASTE and UNIVERSAL WASTE at the CALIFORNIA AUTOZONE FACILITIES in compliance with California law, including overseeing the implementation of the AutoZone Defendants' applicable policies and procedures for the management of HAZARDOUS WASTE and UNIVERSAL WASTE in California, training and counseling managerial-level and store-level employees, as warranted, responding to inquiries regarding specific issues regarding the management of HAZARDOUS WASTE and UNIVERSAL WASTE as they arise, and seeking out opportunities for improvement of the AutoZone Defendants' policies and procedures for the management of HAZARDOUS WASTE and UNIVERSAL WASTE in California and implementing such additional measures.

Post-Judgment Trash Receptacle Audits: Pursuant to Paragraph 4.1.b.i – iv of the Final Judgment on Consent, the AutoZone Defendants will implement a trash receptacle audit program and the results of the audits will be provided to the People. Consideration of the costs of this activity for a credit against civil penalties does not affect the obligation of the AutoZone Defendants to comply with Paragraph 4.1.b.i-iv.

Information Technology Improvements: Starting in September 2014, the AutoZone Defendants began implementation of improvements to their information technology systems to make their existing compliance and training programs easier to execute by creating an entirely new "Waste Management Portal" on their intranet system used by employees at the store level for training and for obtaining information regarding proper management of HAZARDOUS WASTE and UNIVERSAL WASTE. The AutoZone Defendants also developed a new capability to allow employees to input a SKU for a product sold in the California AutoZone Facilities and then determine the specific waste management

requirements for that product, improved their training programs for employees regarding WASTE management, and modified their product return labeling to reduce employee confusion about proper WASTE disposal methods. As a long-term improvement, the AutoZone Defendants, starting in February 2017, created a "Hazmat Disposal Project" to simplify the segregation of HAZARDOUS WASTE managed at the CALIFORNIA AUTOZONE FACILITIES into appropriate, compatible categories. The AutoZone

Defendants, utilizing third party assistance, developed a system to allow employees at the CALIFORNIA AUTOZONE FACILITIES to scan the bar code on any product and receive instructions on the appropriate management of that item if it became a WASTE. This technology applies to hand-held scanners used at the CALIFORNIA AUTOZONE FACILITIES. The AutoZone Defendants have the capability of adding new products to this inventory to ensure proper disposal of such new products. The Information Technology Improvements include program maintenance activities.

ACCOUNTING REPORT:

Within 30 days of entry of the Final Judgment on Consent, the AutoZone Defendants will submit an accounting report to the People, signed by an officer of the AutoZone Defendants, that provides, under penalty of perjury that, to the best of his or her actual knowledge based on information and belief and after reasonable investigation, the details and dates of the expenditures by the AutoZone Defendants for these environmental compliance measures up to the date of the entry of the Final Judgment on Consent. In the event the AutoZone Defendants have not spent TWO MILLION DOLLARS (\$2,000,000) for the specified environmental compliance measures by the date of entry of the Final Judgment on Consent, the AutoZone Defendants shall submit a second accounting report within 30 days of the completion of the expenditures required by this Exhibit E, to the People, signed by an officer of the AutoZone Defendants, that provides, under penalty of perjury that, to the best of his or her actual knowledge based on information and belief and after reasonable investigation, the details and dates of the expenditures by the AutoZone Defendants for these enhanced environmental compliance measures.
