Plaintiff, the People of the State of California ("Plaintiff" or "the People"), acting by and through Rob Bonta, Attorney General of the State of California, and Defendant the City of Beverly Hills ("City" or "Defendant"), hereby stipulate as follows:

- 1. The final Stipulated Judgment ("Judgment"), a true and correct copy of which is attached to this Stipulation for Entry of Final Judgment ("Stipulation") as Exhibit 1, may be entered in this matter.
- 2. Concurrently with the filing of this Stipulation, the People have filed its Complaint in this matter pursuant to the California Constitution, Article I, Sections 1 and 1.1 and Health and Safety Code Section 123460, et seq.
- 3. The terms of this Stipulation shall be governed by the laws of the State of California.
- 4. The City consents to the jurisdiction of this Court solely for purposes of entry and enforcement of this Stipulation and Judgment.
- 5. Upon the City's consent solely for purposes of entry and enforcement of this Stipulation and Judgment, this Court has jurisdiction over the subject matter hereof and over the People and the City (together, "the Parties"), and venue is proper in this court.
- 6. The Parties have agreed to resolve the allegations contained in the People's Complaint by entering into this Stipulation.
- 7. The Parties have stipulated and consented to the entry of the Judgment without the taking of proof and without trial or adjudication of any fact or law herein. The City enters into this stipulation solely for the purpose of resolving the People's investigation. The Parties agree that the execution of the Judgment is done solely for the purposes of compromise, and to eliminate the burden and expense of further litigation, and does not constitute, and shall not be construed as, an admission of liability. The Parties further agree that the Judgment shall not be used for any purpose in any litigation.¹ No part of the Judgment, including its statements and
